

Five varieties of pecans entered in the Trans Pecos Pecan Show, held at McCamey Monday, won three blue ribbons and one red ribbon for John Brock. John and Mrs. Brock went to the show Monday and said it was a real good show all the way through including the night program where the queen was crowned.

John's blue ribbons were won by his entries in the John Garner variety class, the Western Schley class. and the variety seedling class. The latter is a pecan of unkonwn variety, coming up from a seedling. His entry in the Mohawk class blaced second. An entry in the Wichita class failed to place even though these pecans were the largest of the class.

The first three place winners in each class will be entered in the West Texas Regional Pecan Show which will be held in the Winnwood Mall in Odessa December 13, 14, and 15. Thus, John will have at least four entries in the Regional Show and perhaps more as one or two varieties were not ripened sufficiently to enter them in the show at McCamey. Under the Regional Show rules, this can be done.

Due to the short pecan crop in Tom Green County this year, there will be no pecan show in San Angelo this year.

Pay weight of weaning steers can be increased as much as 25 pounds by implanting suckling calves with a growth stimulant. The results from trials in seven Edwards Plateau counties have shown responses from 4 to 63 pounds of additional gain at depending on the weaning, length of the test, breed of cattle, and pasture conditions. One of the tests was conducted in Sterling County on the cattle belonging to Foster & Hildebrand and S.K. Horwood.

The growth stimulant used in the trials was RALGRO, a non-hormone growth stimulant that can be used. Thirty-six milligrams of the compound were injected under the skin of the ear when the calves were approximately three months old. The 128 calves in the seven counties responded with an average 25 pound increase in weaning weight over control animals.

The calves in the Sterling County trial were on the test 87 days, mplanted Isteers gained 13 additional pounds over non-implanted steers. The heifers gained an additional 15 pounds. Some animals in other counties on the test for a longer period of time gained rore.

There were no undesirable side effects from the implants. The calves will still respond to growth stimulants in the feedlot. Implanting was done at normal calf working time with no additional labor other than the time it took to implant. Cost of the implant would be about 70c per animal.



The hope of the persons makin up this interested group is to get someone to keep it in good shape from now on. (It is the area used by the Mexican Americans for burials.)


Work or money donations are welcome, it was said.
