County Livestock Show Monday

The Sterling County Livestock Show will be held here next Monday, January 19, beginning at 9:00 a.m. In doing some research for writing the history of the 4-H Clu and the county extension office for the Sterling County History to be published, we found mention of a county show in 1936. This makes the show somewhere around forty years old depending on how many were held during the World War II years when many such activities were postponed.

Show officials this year arc Marvin Foster, president; Chas. Probandt, vice-president; Melvin Foster, treaturer; Mackey McEntire superintendent; Frank Price, assistant superintendent: Riley King and Chesley McDonald, auctioneers; Worth Durham is chief sale clerk assisted by several others to be selected. Judge for the show is D. D. White, vocational agriculture instructor at Fort Stockton.

Livestock to be shown this year by the 4-H Club and FFA members includes finewool market lambs, crossbred market lambs, medium wool market lambs, Hereford steers, crossbred stteers, Angus steers, Hereford heifers, Delaine breeding sheep and Rambuoillet breeding sheep.

Judging will begin at 9:00 a. m. with the finewool lambs. These will be followed by the remainder of the lamb classes, breeding sheep, steers and heifers. The awards will be presented at 2:30 p.m. and the sale will start at 3:00 p.m.

The dinner in the community center will be sponsored by the United Methodist Women of the local Methodist Church. A concession stand will be operated in the barn by the 4-H and FFA mothers with proceeds being used by the two organizations.

A number of trophies are being sponsored by individuals and organizations. These are as follows: Rotating plaque for champion finewool lamb by Lee Reed; a trophy for the champion finewool lamb given by Reynolds Foster; trophy for the champion crossbred crossbred lamb by Charlie Davis; champion medium wool lamb trophy given by Ralph Davis; champion market steer trophy by Foster S. Price Herefords; trophy for champion Rambouillet ram by the Epsilon Zeta Club; champion Rambouillet ewe trophy by the Noratadata Club; Rambouillet flock trophy by Betty Jo Barrett: champion Delaine ewe trophy by the Texas Delaine Association; champion Delaine ram trophy by Riley King: Delaine flock trophy by Brooks Dry Goods; champion Hereford heifer trophy by Worth Durham; and ribbons and banners sponsored by the show association and Concho Valley Electric Cooperative. The silver showmanship buckles, one for the lamb showman and one for the breeding sheep showman are given by Holland Jawelers of San Angelo.



Total expense of running the institution last year was \$259,-159.15 In 1974 expenses otaled \$238,253.91. Total income last year was \$272,520.28.

There were an average of 27 patients in the nursing home, which is capacity. Average of paient days in the hospital last year was 3. There were 12 births and three deaths.

Cost of operating the facility goes up each year, due to rising costs of utilities groceries and wages paid. The institution served 44,066 meals last year at an average cost of 67.8c. Salaries is the biggest item of expense as the minimum rates go up each year.



1976-77 Texas Almanac Out

The American Revolution of 1776 set in motion events that led to the colonization of Texas and eventually to its own struggle for self-government, notes the new 1976_77 edition of the Texas Almanac, published A.H. Belo Corporation, publish. ers of The Dallas Morning News

Those historic events affecting Texans have been traced in an article written especially for the Texas Almanac by the late R. Henderson Shuffler, editor, historian and, at the time of his death in the summer of 1975, executive director of the Institute of Texas Cultures at San Antonio.

What we call the American Revolution was simply the first stage of the revolution of the Americas, Shuffler wrote. Texas was affected directly by the American Revolution and the course of is history for centuries to come was shaped by the outcome.

Also in he Almanac's Bicencennial section, Sam Kinch Sr., chairman of the American Revolution Bicentennial Commission of Texas, tells of the American Bicentennial in Texas. A commission listing of Texas events during the bicentennial year is included.

The new edition also contains a special section on Gardening in Texas prepared by specialists of the Texas Agricultural Extension Service. It is a guide for planting vegetables, fruit and nut trees and ornamentals in all sections of the state.

The LBJ Hill Country-writen by Art and Elise Kowert, publishers of the Fredericksburg Standard, presents a description of the home of the late Lyndon B. Johnson, 36th President of the United States.

Nowhere else in this land is a place where, within a distance of a few miles, the story of an American President can be reraced through visiting the settlement of his grandparents, the birthplace, boyhood home, his White House away from Wash. ington, and his ranch where he lived in retirement and where he died and is buried, hey wrote.

Other special features of the new Almanac include a history of the Texas Railroad Commission. the latest U.S. Census on manufacturing, wholesale and retail trade, the service industries and transportation in Texas, an account of the 10 Travel Trails of Texas, and a history of Texas A&M University observing its 100th anniversary in 1976.

Included also are data on election results, listings of county, municipal and state officials appointive boards and commissions, officials of state and regional civic and trade organizations, and sections on agriculture, manufacturing, transportation and government.

Each Standard Metropolitan Statistical Area, the urban concentrations in which most Tex_ ans live, has an editorial page devoted to it.

A new Texas map in color, wih major highways, supplements 254 county maps, updated from maps prepared by the Texas Highway Department. Tourism and recreation also are featured, with listings of state and national

BROOMWEED AIDS GRASS **ESTABLISHMENT**

By Fred C. Stumberg, SCS Range Conservationist

The tremendous crop of broom weed produced this year may not be all bad for ranchers considering controlling mesquite by rootplowing or treedozing followed by range seeding. The broomweed will act as an organic mulch or litter layer, to protect the soil from erosion and protect tender seedlings from excessive heat and cold. Moisture is conserved because of a good ground cover of dead plant material and the soil is built up in fertility by the decomposition of this matter.

To insure the best possible chance of obtaining a grass stand using these practices, here are some ideas that may be useful:

1. Rootplow areas of heavy brush that might receive extra moisture from runoff. Low-lying areas around shallow-soiled hills receive more moisture than flar

2. Break-up large sod masses by using fins on the plow blade. Excessively large clods prevent seedling establishment.

3. Allow the rootplowed area to settle and become firm before seeding. The seedbed needs to be firm at the time of seeding. A good practice in this area is to roller-chop along with broadcast seeding to provide an adequate seedbed.

4. Seed as early as possible. The longer the seed is in the ground, the greater the chance of germination. Seeding dates are from December 15 to May 15.

5. Defer seeded areas at least two full growing seasons or until well established. Thereafter, defer the area a minimum of 3 months every third year during the growing season to maintain the stand's vigor.

6. Leave at least 50% of the current years growth when grazing to maintain a healthy stand.

Some area ranchers who have used mechanical brush control in 1975 and seeded to a grass stand this year are Dan Glass, William Foster, and J.W. Nix. Charlie Davis and the Caldwell & Palmer ranch are in the process of rootplowing heavy brush now.

STERLING COUNTY CERTIFIED AS FREE OF BRUCELLOSIS

Dr. H. Q. Sibley, Executive Director of the Texas Animal Health Commission, announces receipt of the certificate designating Sterling County as a Certified Bovine Brucellosis Free

This reconition signifies that there is no known foci of bovine brucellosis in the county at this time, and that if the infection is re-introduced into the county immediate steps will be taken to confine and eradicate it.

In order to qualify as a Cer-tified Bovine Brucellosis-Free Area all herds of cattle must be tested and found negative or at latest ten per cent of all breeding cattle in the county two years of age and older must be blood tested each year when shipped to market or at time of slauhter with follow-up testing of herd of origin of all reactors disclosed.

The 1976 spring livestock show circuit got underways last week in Odessa with the usual winter weather. Temperatures were in the low teens several mornings and did not get above the freezing mark on at least one day, But that was the weather menu for much of the area last week.

Lenard and Lonnie Horwood had one steer each and one Hereford heifer each entered in the show at Odessa. The show is limited to Herefords. It is generally one of the toughest Hereford steers shows in the state and last week was no exception with 247 good steers entered in competition. The wo local steers failed to place.

Lonnie's Hereford heifer, an October calf bred by Weldon Edwards of Clyde and out of a Line I bull, placed eleventh in her class.

Lenard's heifer, a half sister of Lonnie's and also bred by Edwards, placed fourteenth in in the November-December calf class.

January and February are the months to spray fruit and nut trees for scale. Scale is a tiny insect which sucks the sap from the trees and when it becomes severe enough, kills the tree. The insect derives the name from the tiny, dirty-gray hard shells that look like scale that covers the insect. They are found on the bark of the tree. There are a number of trees here affeced with this pest and now is the time to treat with the dormant oil spray.

The recommended treatment is 31/2 gallons of a 97% oil emul sion available at most feed and seed stores in one hundred gallons of water. The entire scaffolding of the tree-trunk and branches-should be reated as this is where the insect is found or located. If trees have a bad case of scale, two treatments three or four weeks apart are recommended. This oil emulsion spray should not be used after the leaf buds begin to form as it will burn them.
