Primaries Set for May 1 Over Texas

Democratic Primary in All Boxes

Texas voters will go to the polls here Saturday, May 1, and select nominees for many offices over the state. Both Democross and Republicans vote in most counties.

In the Democrat primary voters will name delegates for presidential candidates Lloyd Bentsen, Jimmy Carter and George C. Wallace. Also they can vote for a slate of uncommitted delegates. (They may vote for any candidate at the convention.)

Listed as candidates for U. S. Senator are Leon Dugi, Phil Gram, Lloyd Bentsen and Hugh Wilson.

Congressman Bob Krueger has Joe Sullivan for an opponent. Eight men are running for Railroad Commission, being Jerry Sadler, Jon Newton, Terence L. O'Rourke, R. R. Williams, Robert (Bob) Wood, Lane Denton, David Finney and Woodrow Wilson Bean.

Jack Pope is uncontested for the supreme court place 1, while Don Yarborough and Charles W. Barrow are vying for place 2. James G. Denton is the only one trying for place 3.

John F. Onion is the only candidate for presiding judge of the court of criminal appeals; and two are vying for a place on that court, being Truman Roberts and Jerome Chamber-

Three hopefuls are running for the unexpired term on that court, being Jim Vollers, Carl Dally and W.T. Phillips.

Closer to home, Mize Ezzell, incumbent legislator, has bill Atwood, Jr. for an opponent.

Jimmy Elrod is unopposed for the state board of eduaction, as is Bob Shannon for associate justice of court of civil appeals.

51st district court judge Earl Smith is unopposed for reelection, but there are three names on the list for district atorney-Gerald Fohn and F. W. Ferrell are really the only two candidates as Thomas M. Goff could not really meet the residence requirements. He has pulled out.

Locally incumbent county attorney Worth B. Durham has an opponent, Howard V. Cudd.

Jim Cantrell, incumbent sheriff, tax collector and assessor, is unopposed as are commisisoners Cledis W. Smith for precinct 1 and Billy R. Bynum for precinct number 3.

Voting will be in the usual 4 boxes over the county for Democrats and one box in the court house for Republicans. TORNADO HITS COUNTY

Last Saturday night a tornado went across the Martin Reed, the Collins Hackberry and the William Foster Spade ranch country, cutting a real swath of destruction. Fences, windmills. and other damages were reported, but no one was hurt.

Republican Primary in One Box

The Sterling County Republicans will hold a primary here on May 1 in the commissioners courtroom in the courthouse. Presiding judge will be Larry Glass.

Besides delegates for Gerald Ford and Ronald Reagan, the Republicans will vote on three candidates for U.S. Senator-Louis Lehan, Alan Steelman and Hugh Sweeney.

They have two candidates for U.S. Representative-C. J. Calnan and Bobby Locke.

They have one running for the Railroad Commission - Walter Wendlandt. Running for the State Board of Education is H. Dell Foster.

There are five propositions or items for Republicans to express themselves on-one favoring a constitutional amendment to deny bail to repeat felons who are awaiting trial, and one-favoring legislation which would require mandatory, non-parolable prison sentences for felony offenses involving the use of deadly weapons or resulting in bodily injury. And-would you favor a constitutional amendment which would allow the use of oral confessions in a trial. And-Do you favor a constitutional amendment allowing the use of electronic surveillanc to fight organized crime?

And finally-would you favor an amendment banning the use of forced busing of school children for the urose of achieving a racial balance?



Social Security News

Social security checks should be cashed within a reasonable time to prevent loss or theft, even though there's no time limit on cashing them, according to social security officials here.

'If your check is lost or stolen, get in touch with your nearest social security office at once,' a spokesman said. 'The check can be replaced, but it takes time. Handle your check carefully when you get it and you won't have to wait while it's being replaced.'

Social security pays over \$4 billion a month in benefit checks to almost 29 million people—eligible retired and disabled workers and their families and families of deceased workers who worked long enough under social security.





ALPHABET SOUP- It's not enough everyone else has has been cramming alphabet titles down our throats, now the insurance industry comes along with IRA, HR-v0, etc. What's it all about?

Okay. Let's forget the alphabet. 82% of the adult population in the United States is now at work. Most work because of necessity and most, when they quit work, need and want retirement income a result of their past efforts. Unfortunately, a high percentage of this work force either change jobs before becoming eligible for retirement or work where there is not retirement plan. On September 1, 1974 the President signed into law a portable retirement plan, making it possible to have a retirement income even if you change jobs frequentily or work where there is no retirement plan. Portable retirement plans that work for the earning individual is what the alphabet IRA (Individual Retirement Account) and HR-10 (Keogh) are all about. AROUND THE COUNTY

Four Sterling County 4-H Club members participated in the District 7 Horse Judging Contest held at Abilene on Tuesday of this week. The team was a junior team and competed in that division where they placed sixth.

Team members were Loren Cantrell, Craig Foster, Sheri Foster and Reed Stewart. Coach of the team was Mrs. Melvin Foster. They were acompained to the contest by Mr. and Mrs. Melvin Foster and I.

The team scored 835 points out of a posible 1050 in the contest. Scores of three team members are used to make up the team score: the fourth score, or low score of the group, is the alternate on the team. The group judged five classes of halter horses, one class of reining horses, and one class of Western Pleasure horses

The team members and the coach are to be complimented on their endeavors in the contest. Time was a limiting factor in preparing for the contest but the team did very well. Their scores were very consistent with only thirty-two points separating the top member of the team and the alternae.

Screwworms are continuing to move northward with one of the latest confirmed cases being within seventy miles of Sterling County. The case was in Schleicher County, southwest of Eldorado, and was found in a dehorning wound on a cow. Other

recently confirmed cases were found in Val Verde County and in counties around San Antonio.

This livestock pest is continuing to move north and west. With this in mind, livestock producers are urged to check their stock. Shearing is in full swing here and the shearing wounds offer possibilities for the pests here. Collection vials and mailing tubes are available in the county extension ofice here and the feed store—keep a couple in the pickup for any worm cases you might find.

The mild winter allowed the pest to overwinter in much of the state. In addition, the thunder shower activity recently has offered more ideal conditions for this pest.

An Easter weekend trip east revealed that much of the area east of Brownwood is in much better shape moisture-wise than it had been. They have been getting rains and the country shows the effect. The Blackland area around Waco and Corsicana is real wet. When that blackland gets wet, it is wet and that is the way it is now.

We were coming through through Brownwood Monday evening at the time the tornado was hitting north of town. The cloud looked very bad—just about as bed as it turned out to be. Residents of the area had no warning before time but the radio station there was keeping

progress minutes after the first one hit.

Speaking of tornados. Melvin Foster says that the one that hit north of Serling City Friday night was no sissy storm either. Starting on the Wilkinson ranch near the Reed ranch, it traveled over twenty miles across the open country there doing damage as it went. A number of windmills were torn up, others damaged, fences and powerlines blown down, and trees broken. It also killed a number of sheep on the Spade Ranch and narrowly missed a house on the Renderbrook Ranch in its travels to the northwest.
