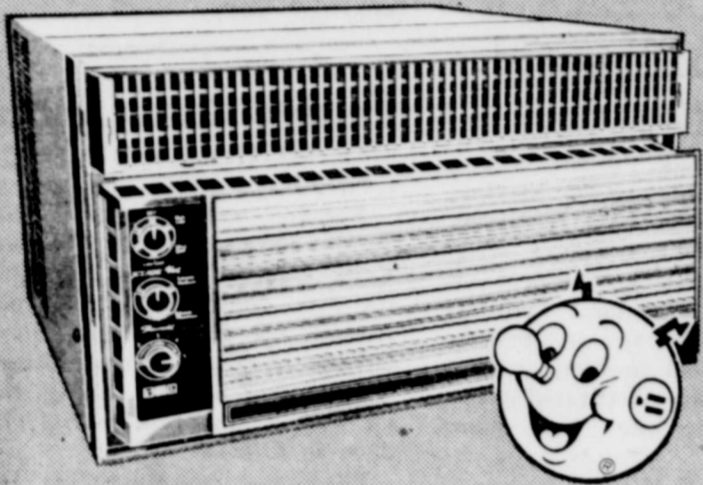
A program concerning sheep management systems will be given. Zone III is in Tom Green County and includes landowners north of the North Concho River and north of Highway 87 to Miles.

Social security checks should be cashed within a reasonable time to prevent loss or theft, even though there's no time limit on cashing them, according to social security officials here.

'If your check is lost or stolen, get in touch with your nearest social security office at once,' a spokesman said. 'The check can be replaced, but it takes time. Handle your check carefully when you get it and you won't have to wait while it's being replaced.'

Social security pays over \$4 billion a month in benefit checks to almost 29 million people—eligible retired and disabled workers and their families and families of deceased workers who worked long enough under social security.

Having just completed roof repairs from a recent storm, I need to know whether the new roof is insured in case of another storm.

If you have already collected on one roof repair necessitated by a storm it would be advisable to have receipts, contracts, etc., proving that the roof was indeed repaired competently. Satisfactory roof repair would qualify you for collecting from your insurance should another storm cause a leak. The cost of repairs would be looked at by your insurance company as being necessitated by two separate catastrophes. However, in order for your insurance to pay for the damage caused by the second storm, the deductible must once again be met. It is important to notify your company as soon as possible after such damages are incurred.

**DUMP GROUND USERS**—New regulations require burning of trash before dumping. Please dump from both sides of the pit. No car bodies or wire or old large appliances allowed.

**Do not put burnable paper or stuff any where in dump ground. Burn it first.**

Friday the thirteenth-an unlucky day, according to some beliefs. To others, it is simply TGIF—Thank goodness, its Friday. Here in Sterling County, this year, it means there is just one more Friday before school starts and families with children in school return to their old routine.

\*\*\*\*\*

The middle of August means that the pecan crop here is faced with one more insect that could be very damaging to the crop. This is the time of the year that the pecan weevil makes its appearance. It can be particularly damaging where the pecans are sold as weevil infested pecans usually cause a reduction in prices offered.

The weevil, also known as the redhead, is closely related to the cotton boll weevil which it resembles. The female chews a hole in the shell and deposits the eggs in the nuts. These hatch out and feed inside the nuts until maturity. When mature, they chew a hole about one-eighth inch in diameter in shell, emerge from the nut, and drop to the ground. They burrow into the soil four to twelve inches, construct a cell, and remain there until next year.

Where weevils have been a problem in the past, control measures should be applied shortly after the fifteenth of August and every ten to fourteen days as needed. Trees may be checked for the presence of the weevil by placing a sheet under the tree and jarring the limbs with a padded stick. If three or more weevils are found per tree, control measures should be applied.

Screwworms have been on the increase in Texas following the July rains and little relief is in sight according to program officials at Mission. Practically the entire state has now had confirmed cases. Recent cases have been as far north as Kent and Motley Counties with confirmed cases in dogs in the city limits of Dalhart.

Sterling County has had no confirmed cases since June when the third case was recorded. The inner part of one of the sterile fly drop boxes was found in our front yard on Monday of this week so it would seem that the fly drops are still being made here.

The plant in Mexico is scheduled to go into operation next week; this should give help to the overloaded plant at Mission. This plant should give the eradication program a big boost next winter when the entire production can be used to treat overwintering areas in Mexico.

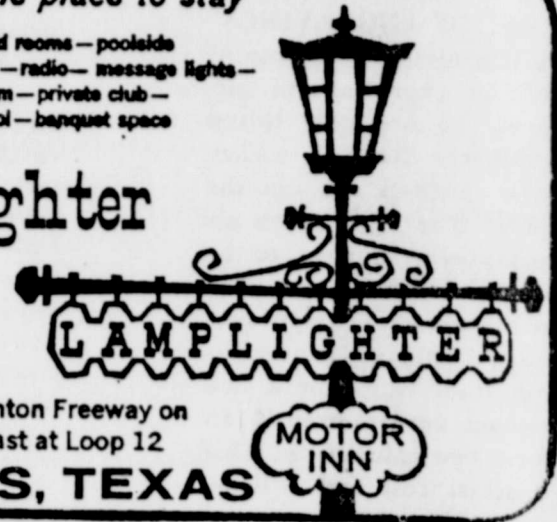

## Spotlight on HEALTH

### PROFILE OF A COLD VICTIM

What are your chances of catching a cold? According to a booklet on the subject, they're especially good if you're female, live in a large city in the western or north-eastern part of the U.S., and are the mother of a child under 6 years of age. Young children are the greatest cold-spreaders. Your chances are further enhanced if you're going through a period of stress and strain. "Contentment preserves one even from catching a cold," the great philosopher, Nietzsche once said.

The booklet, which discusses the common cold, is distributed by Winthrop Laboratories, the makers of Neo-Synephrine nose drops and nasal spray that are widely used in the U.S. and abroad.

Keeping up one's resistance helps to avoid the common cold, according to the publication, which advises getting sufficient fresh air and exercise, well-balanced meals, and as much sleep as possible in a well-ventilated bedroom. In cold weather areas, an extra hour a night is recommended.

Early stages of the common cold are the most contagious. Every sneeze fills the air with thousands of virus-laden droplets. To help

Your chances of catching a cold will be reduced if pre-
