

Sterling County 4-H Club members competing in the finewool breeds sheep show at the West Texas Fair in Abilene brought home seven of the eight championship awards in the judging Saturday. Those competing in the show from here were Becky Hodges, Wesley Hodges, Delmar Radde. Jr. and Paula Radde. Since the club members are permitted to compete in both the junior and adult shows, they were able to gather the championships in both divisions.

Wesley Hodoges showed the champion Rambouillet ram of both shows. The honors in both divisions of the Rambouillet ewe show went to Becky Hodges. Becky and Wesley also won the reserve championships in both shows.

Delmar Radde, Jr. showed the champion ewe, the reserve champion ewe, and reserve champion ram in the Delaine show. Again this was in both the junior and open shows, Delmar won the premier exhibitor trophy in the Junior Delainen Show.

Certain regulations regarding the use of machinery on agricultural lands recently became effective under standards established by the Occupational Safety and Health Administration division of the U.S. Department of Labor. The regulations include farm field equipment, farmstead equipment, and cotton gins. Standards regaarding the guarading of power take-offs. disconnect devices for electrical powered equipment, and training of employees in the safe use of such equipment are covered in the regulations.

A number of booklets covering the regulations are available in the county extension office. If you want one, contact the office and ask for it. Agricultural producers have until October 25 to comply with the regulations.

. . . . Pecan production in Texas on September 1 was estimated at 27 million pounds for 1976 compared to the 68 million pounds produced in 1975. This is a drop of sixty percent. Nationally, the crop is estimated at 112.6 million pounds, fiftyfour percent below last year's

crop of 246,800 million pounds. This section of Texas and the TransPecos area are the only areas in the state with what is termed a moderate to good crop. On the national level, only North Carolina shows a good crop. All other states are far

below last year's production. This could indicate that prices may be higher and the use of pecans in holiday goodies may be curtailed. Locally, the prospects are good for the crop with most trees beginning to droop from the weight of the crop. There is some nut shed but most of this is due to the heavy crop combined with the unfavorable conditions the trees endured late last year and this

### Social Security

Social Security benefits were being paid to residents of Sterling County at a rate of \$30,913 a month at the start of 1976, Frank Upp, social security manager in San Angelo, said.

Of the 194 social security beneficiaries living in Sterling County, 104 are retired workers and 7 are disabled workers. Another 83 are receiving benefits as the dependents of workers who are retired, disabled, or deceased.

In Sterling County, 47 people under age 65 and 147 people age 65 and over are receiving monthly social security benefits. Of total beneficiaries 74 are men, 93 are women, and 27 are children. The children receive payments because a working father or mother has died or is getting social security disability or retirement benefits.

Offensively Fleming carried the ball four times for a total of 157 yards or an average gain of 39 yards. Davis carried the ball 24 times for 88 yards or an average of 3.7 yards. Kenneth Gaston carried the ball 10 times for 44 yards or 4.4 average. Alan Phillips carried the ball for 5 times for 24 yards, average of 4.8 yards and Mickey Dodds attempted 7 passes and completed one for 12 yards.

Linebacker of the week was Leslie Rich who was graded an 84% blocker and Ross Hord got a blocker grade of 75%

On defense, Ross Hord scored 27 points and Dean Jones 24.

Hornet Randy Searcy took the second half kickoff 35 yards to the midfield. It appeared as if Mertzon was back in the ball game, but once again the Eagles defense dominated action and four plays later the Hornets had to punt.

On the Eagles third play from scrimmage, Fleming went 52 yards for his third tally of the night. Davis added a 2-point conversion to make the score 21 to 0 with 7:25 remaining.

The drive took five plays and two minutes to pay off.

# PUBLIC NOTICE

SUMMARY OF PROPOSED

CONSTITUTIONAL AMENDMENTS GENERAL ELECTION NOV. 2, 1976

#### NUMBER ONE ON THE BALLOT (S.J.R. 49)

Repealing Sections 49-d and 49-d-1 of Article III of the Texas Constitution, S.J.R. 49 amends Section 49-c of Article III of the Texas Constitution to provide for and authorize an additional \$400 million in Texas water development bonds that may be issued on approval of two-thirds of the members of each house of the Legislature for such water development purposes as the Legislature may prescribe.

The amendment contains a specific prohibition against the use of state funds for the development of water resources from the Mississippi River and also requires that before any single water development project may be undertaken requiring the expenditure of more than \$35 million in bond proceeds, it must be approved by resolution of the Legislature.

The amendment removes the constitutional requirement that certain revenues must be used to retire water development and water quality enhance-ment bonds and removes the constitutional interest rate limit on such bonds.

The wording of the proposed amendment as it will appear on the ballot is as follows:

"The constitutional amendment authorizing an increase of \$400 million in the amount of Texas Water Develop-ment Bonds that may be issued on approval of two-thirds of the legis-lature; amending and consolidating provisions of Sections 49-c, 49-d and 49-d-1 of Article III of the Texas Constitution; and repealing Sections 49-d and 49-d-1 of Article III of the Texas Constitution."

#### NUMBER TWO ON THE BALLOT (H.J.R. 99)

H.J.R. 99 proposes an amendment to the Texas Constitution to increase from \$100 million to \$200 million the aggregate principle amount of Texas water development bonds which may be issued and outstanding by the Texas Water Development Board to provide grants and loans for water quality enhancement purposes as estab-lished by the Legislature.

The wording of the proposed amendment as it will appear on the ballot is as follows:

> "A constitutional amendment to increase from \$100 million to \$200 million the amount of Texas Water Develop-ment Bonds that may be issued for water quality enhancement purposes."

Another gala week shapes up for the annual Howard County Fair Sept. 20-25.


A feature of the opening evening Sept. 20 will be the Shrine Circus in the big rodeo bowl at the Fair Grounds, also the annual barrow show






