THE HEROES OF THE "CRATER."

Capt. Colt, principal of the military school in this city, who was present at the explosion of the mine in front of Petersburg, Ya., on the 30th of July, 1864, has presented the Express with a copy of the Cheraw, B. C., Nees, containing the proceedings of a renaion of the services of the 17th South Carolina regiment. From this report we take the following letter from Maj. J. C. Coit, cousin of Capt. Editory San Autonio Express:
