Of the money available construction will receive \$2,900,000, maintenance of roads \$1,500,000 and administration and engineering expenses are estimated at \$400,000. One million dollars must be set aside to meet the interest and sinking fund requirements on outstanding debentures.

The highway departments's chief source of revenue is expected to be the state gasoline tax, which conservatively estimated to yield \$2,600,000 for 1932. Regular federal aid allotments will contribute \$1,700,000 an additional \$1,000,000 worth of highway debentures will be sold, motor vehicle fees are expected to yield \$400,000 and property taxes \$100,-





If we succeed in getting medicine to treat the prenatal cases, we hope to reduce the number of still births and deaths prior to first birthday, even lower.




