Does Sheep Raising Pay in North-West Texas? (continued)

Mr. Craven, one year ago, sold to Mr. F. P. Parlin 350 head of sheep (about half breed Merino) at \$3.50 per head, and 150 head he gave him (Parlin) on shares at the rate of half the wool and half the increase. That was one year ago, and now Mr. C. informs us that his profits from the 150 head, rating them at \$3.50 per head, nets him just 40 per cent. Now to count these sheep at their first purchase price would make for him the handsome profit of 100 per cent Col. R. H. Overall commenced in Coleman county in 1878, with an investment of \$2,800 in company with a nephew who went in as a full partner, giving his note for \$1200 and \$200 in cash. This \$2800 they invested in sheep. The first clip nearly paid them back the money invested. The second clip brought them 40 cents per pound. At the expiration of about two and a half years the Colonel bought out the nephew, paying him \$ 10,000 for his interest. Last spring he sheared 7000 head of sheep, his clip brought bringing him in Baird \$ 15,000. He also sold 2,000 head of mutton sheep at \$3.00 per head, netting him \$6,000 more. Messrs. Isaac and Arch Shaw invested \$1600 in the fall of 1876, in Mexican sheep. They began from the first by breeding to good Merino bucks and improving the blood of their flock averaged six pounds of wool to the sheep. After shearing the firm closed out the business by selling to C. & C. D. Kenyon of New York; the spring clip and the sheep bringing the Shaw brothers the snug sum of \$24,000.

# Cottonwood Annual Callahan County's jobless rate rises to 4.3% in March 2016

The unemployment rate in Callahan County rose one-tenth of one percent to 4.3% in March 2016, according to jobless figures released Friday, April 15th by the Texas Workforce Commission. The unemployment rate in Callahan County one year ago in March 2015 was 4.1 percent.

Callahan County's unemployment rate was 4.2% in February, 2016.

Previous monthly jobless rates in Callahan County included: 4.2% in January 2016, 4.4% in December 2015, 4.4% in November, 4.3% in October, 4.2% in September 2015, 4.3% in August, 4.4% in July, 4.0% in June, 3.9% in May, 3.7% in April, 4.1% in March 2015, according to the unemployment figures.

Big Country area counties, bordering Callahan County, and the counties' unemployment rates for March 2016 include: Brown, 4.4%; Coleman, 6.1%; Eastland, 5.4%; Jones, 5.9%; Runnels, 4.0%; Shackelford, 4.5%; Stephens, 5.2%; and Taylor County, 3.6%.

The Abilene MSA (Metropolitan Statistical Area) unemployment rate, which includes Taylor, Callahan and Jones Counties, stood at 3.8% in March, 2016, according to the Texas Workforce Commission. The Abilene MSA Combined Labor Force is 75,700. There were 72,800 employed during March 2016, while 2,900 were unemployed, giving the Abilene MSA an unemployment rate of 3.8%.

The Abilene MSA reported the workforce was 75,800 in February, 2016. Total employment of 73,100 was reported in February 2016, while 2,800, or 3.7% were unemployed in February 2016. 

The natural world around us can, and should amaze us humans on a daily basis. Many of the columns that I write are about animals that the majority of people do not realize live in their own backyards. However, there is a species of bird that thrives in west Texas year-round, and is one that is probably very familiar to most people, and that avian species is the Great-tailed Grackle. The Great-tailed Grackle (Quiscalus mexicanus) is a distinctive species of bird that can be observed throughout Texas. Outside of this state, it occurs north to Kansas and west to central California. It also occurs south of the border to Central America. Only the most northernmost populations migrate during the colder winter months. With such a large year-round range, this species could be considered to be a habitat generalist. It apparently prefers areas that have some form of a natural semi-permanent water source, but human habitations with items such as pools and lawn irrigations obviously suffice. Its population densities have risen in arid areas of the southwest due to agricultural irrigation. At first glance, Great-tailed Grackles appear to be just anothervariety of black bird. However, upon closer inspection the subtle iridescent purple coloration on the head, neck, back, and underparts region really stand out against the black wings and lower body. The tail on males is quite long (hence the common name) is often described to be diamond-shaped in appearance. Males and females are sexually dimorphic, which means that they differ from each other in several morphological characteristics. Females differ from the males in that they are typically dark brown on the head, neck, back, and underparts rather than being adorned with the iridescence that males possess. Both species have gray legs and beaks. The bright yellow eyes are particularly noticeable on the darker colored males. Great-tailed Grackles are birds of moderate size, with body length of roughly eighteen inches and a wingspan of just over two feet. This species of grackle is noisy and gregarious, preferring to live in large colonies of up to a hundred individuals or more. This is particularly true during the winter months when several hundred Great-tailed Grackles may congregate in prime feed-

The base bid from KBL Restoration, LLC was \$1,009,371.00. The bid had a completion date of 290 days. The bid also had an Alternate #1 bid of \$116,938, and Alternate #2 bid of \$44,855, an Alternate #3 bid of \$37,013, and an Alternate #4 bid of \$35,569.

The base bid from Joe. R. Jones Construction Inc. was for \$1,318,213.00. The bid had a completion date of 252 days.

Callahan County The bid also had an Alternate #1 bid of \$96,030, and Alternate #2 bid of \$30,580. an Alternate #3 bid of \$26,070, and an Alternate #4 bid of \$45,485.



I am angry, disappointed and disgusted with the entire situation. Our politicans/ leaders have sold us out!



Local Farm Bureau leaders work

Leaders of the Callahan-Shackelford County Farm Bureau traveled to the nation's capital April 11-14 to discuss issues of importance to Texas agriculture. It was part of the National Affairs Awards Trip organized by the Texas Farm Bureau.

Local Farm Bureau officials earned the trip by meeting contact and communications goals with elected officials. The farmers and ranchers met with U.S. Sen. John Cornyn, members of U.S. Sen. Ted Cruz's staff and with other members of the Texas congressional delegation and their staff.

"We focused on three primary

issues," said Phil Williams of Callahan-Shackelford County Farm Bureau.

"International trade, preventingcutstocropinsurance and the biotechnology labeling bill were discussed."

Also attending was Carolyn Williams, spouse of Vice-President Phil Williams.

Though the Trans-Pacific Partnership (TPP) will not likely be considered by Congress in this election year, it's still important to farmers.

The TPP is going to lock up 40 percent of the world's trade," Phil said. "We can't leave that on the table. It would be leaving the trade market in that part of the world to the Chinese.'

Phil said the Farm Bureau hopes to avoid further cuts to crop insurance to protect the already weakened food security safety net in America. Labeling of biotech or GMO crops is also of concern. Phil said the Farm Bureau favors voluntary labeling.

"We are told all the time that farmers and ranchers have to tell our own story to our elected officials," Phil said. "That's what our trip to Washington, D.C. was all about."

One hundred sixty-five Farm Bureau leaders from 70 counties traveled to Washington, D.C. to work with their elected officials as part of the National Affairs Awards Trip.

> Employment in the Leisure and Hospitality industry increased by 2,400 jobs in March, representing an increase for the 12th consecutive month. Over the year, this industry has gained 75,600 jobs. Trade, Transportation and Utilities employment rose for a fifth straight month with the addition of 800 positions in March. These gains were offset by losses in other industries including Mining and Logging which lost 7,500 jobs in March.

# Wildfire Response Workshop slated for May 7th in San Angelo

for what could be a catastrophic wildfire season, several state agencies and emergency management entities are seeking landowner participation at the Wildfire Response Workshop set for 8:30 a.m.-2 p.m. May 7 at the Tom Green County 4-H Center, 3168 N. U.S. Highway 67, San Angelo. The Texas A&M AgriLife Extension Service and Texas A&M AgriLife Research are partnering with the Texas A&M Forest Service, Concho Valley Council of Governments and the San Angelo/Tom Green

County Office of Emergency Management to host the workshop. Marvin Ensor, AgriLife

Extension regional program leader at San Angelo, said the purpose of the workshop is to open lines of communication among landowners, local, state and federal agencies.

"Our goal is to create a high level of cooperation and understanding among all parties involved," Ensor said. "The plan is to develop an

ongoing meaningful dialogue so that landowners and wildfire responders at all levels SANANGELO-Inpreparation understand and value the concerns each have from their respective standpoints."

> Ensor said as a wildfire grows in size and more agencies are called upon to fight it, confusion and misunderstandings can arise. As the situation escalates, firefighting protocols and priorities and strategies may change, as do the people in charge.

Ensor said he expects the workshop to forge a longterm climate of cooperation, understanding and appreciation among all parties affected by a catastrophic wildfire.

"To that end, we will start the program by clearly outlining the workshop objectives, so all know what is expected and what we plan to accomplish that day," he said. "We will then have a discussion on the need for protecting natural resources andagriculturalenterprisesfrom the landowners' perspective."

Participants will then engage in the first of two wildfire response exercises, he said. One will deal with the first four hours of a fire. The other will be a complete exercise covering an expanding wildfire incident, the processes for requesting regional and state assistance and the subsequent delegations of authority following those requests.

The afternoon session will open with a presentation on preparing an after-action report and subsequent discussion stemming from that presentation. Also addressed will be an explanation of relevant educational programs, Incident Command System training and available resources.

The workshop will end with a question and answer session and closing comments.

There is no registration fee and all interested persons are welcome to attend. Attendees are asked to RSVP by contacting their local AgriLife Extension office or by calling Nanette Johnson at the Texas A&M AgriLife Research and Extension Center in San Angelo at 325-653-4576, extension 216.

### The birth of the republic of Texas remembered

The Daughters of the Republic of Texas (DRT) will join area leaders and organizations in commemorating the 180th anniversary of the Battle of San Jacinto on Thursday, April 21, 2016. The ceremony will take place at 11 a.m. on the south side of the San Jacinto Monument at the San Jacinto Battleground (3523 Independence Pkwy., La Porte, TX 77571).

The event will include delivery of the San Jacinto Battle Report by Nancy Burch, the great-greatgranddaughter of General Sam Houston; remarks from former member of the San Jacinto Historical Advisory Board Nina Hendee; performances by the Deer Park High School Orchestra and JROTC Color Guard; presentation of the DRT scholarship winners; an appearance by The Texas Army, the State of Texas Official 1836 Ceremonial and Reenactment Group: and much more.

The famous battle occurred 46 days after the fall of the Alamo in the late afternoon memory of the brave heroes

Austin, TX - April 19, 2016) - of April 21, 1836. During the battle a Texas army of 910 soldiers led by General Sam Houston overwhelmed the forces of Mexican President and General Santa Anna. When the fighting had ended, more than 600 Mexican soldiers were killed and more than 700 would be captured, while nine Texans would lose their lives. After escaping the battle, Santa Anna would be captured the next day, and three weeks later would be forced to sign the peace treaty granting Texas its independence as a nation.

"The Battle of San Jacinto was the turning point in Texas' quest for independence and is remembered as one of the most decisive battles of the world," said Betty Edwards, M.D., President General of the Daughters of the Republic of Texas.

Edwards continued, "The battle gave birth to the Republic of Texas, and its story truly captures the spirit and pride the Lone Star State is recognized for around the world. We are honored to carry on the

### New Texas jobs report shows unemployment rate at or below the U.S. average for 111 consecutive months Texas creates 185,000 net nonfarm jobs in last twelve months

AUSTIN - Today, the Texas Workforce Commission released Texas labor market information for March 2016. The Texas Public Policy Foundation's Economist Dr. Vance Ginn issued the following statement:

"Texas has been rather resilient to the collapse in oil and gas prices and slower global economic growth. Although net nonfarm employment declined by 12,000 jobs in March, job creation has been positive in 64 of the last 66 months," said Dr. Ginn. "The economic headwinds are reflected in the decline of 7,500 jobs in the mining sector and 2,500 in the manufacturing sector last month. In addition, the professional and business services sector declined by 6,000, which are likely indirectly related to the mining industry downturn. Fortunately, Texas is a diversified economy with relatively fewer impediments D.C. should follow."

from government regulation. "During the last twelve months, states dependent on oil and gas activity have seen much weaker economic activity and job creation. For example, nonfarm job creation declined by 6,100 in Oklahoma, 13,200 in Louisiana, and 20,700 in North Dakota in that period. Texas, on the other hand, created a positive 185,000 jobs with private job creation of 152,300 that increased in all but the mining and manufacturing sectors. Texas' job creation has helped keep the unemployment rate low at 4.3 percent, which has now been at or below the U.S. average rate for a remarkable 111 straight months. By continuing to find ways to get government out of the way and focus only on providing essential services, Texas will be the lighthouse of providing families with more prosperity that other states and

who were part of this crucial event in our state's history."

In 1902 members of the DRT joined a group of dignitaries including legislators and a San Jacinto battle survivor in visiting the site to place temporary improvised monuments in a dozen locations where veterans identified important events had occurred. The locations included the camp where Gen. Houston lay wounded under a tree on the bayou, the same spot where Santa Anna was delivered to him as a captive.

After years of encouragement by the Sons and Daughters of the Republic of Texas, proponents succeeded in raising funds for the construction of the San Jacinto Monument which was completed in 1939. At 567 feet, the monument remains

the tallest masonry column in the world. By comparison, the Washington Monument is 555 feet tall.

Acting on behalf of the Texas Veterans Association, in 1940 the Daughters of the Republic of Texas led an effort to place a large bronze sundial on the battlefield in memory of the nine Texans that lost their lives: Benjamin Rice Bringham, Lemuel Stockton Blakey, John C. Hale, George A. Lamb, Dr. William Junius Mottley, Mathias Cooper, Thomas Patton Fowie, Ashley R. Stephens and Olwyn J. Trask.
