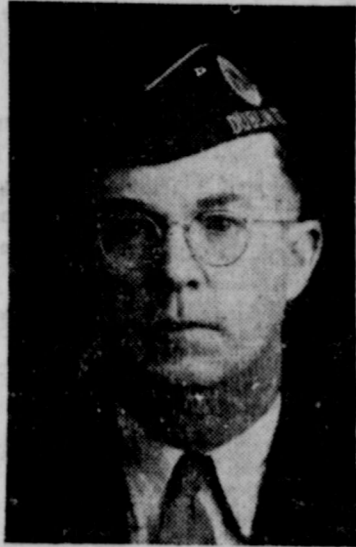

## Legion Holds Convention in Childress This Weekend

### School Heads Hold Plainview Meeting

A permanent organization of school superintendents in the area contemplated as a result of a meeting held Friday afternoon at the Plainview High school, according to F. M. McCarty, superintendent of the Silverton schools, who was in attendance. J. S. Scher accompanied McCarty. Purpose of the organization will be discussion of problems peculiar to schools in this area.

H. P. Clemons, superintendent of the Lockney schools, presided and was elected permanent chairman. Appearing on the program were T. Graves, Floydada; O. J. Laas, Plainview, and I. N. Turney, Tulia. Representatives were also present from Claude, Happy, Kress, Quitaque, Matador and Ralls.

### Enlistments Taken Here on Thursdays

Men interested in joining the regular Army are asked to contact Sgt. James E. Hodges, who is in Silverton each Thursday. He takes his headquarters at the post office. Anyone, who is accepted for enlistment, will be sent direct to the post office and will take his physical examination and be sworn in the Army there. Men between the ages of 17 and 21 may enlist for one year, one and one-half years or three years, if a person wishes to join the Army any time during the week, they may write Hodges at Childress and he will come to Silverton to take out the necessary papers.

### Red Cross Drive Reports Incomplete

Reports this week revealed that Briscoe county lacks over \$400 of raising its \$2000 Red Cross quota. With incomplete reports turned into the county chairman, \$35.75 had been collected. Complete reports have been received from Francis, Heckman, Deloche, Haylake, Gasoline, Rinaldi, Holt and San Jacinto. Incomplete reports are in from Silverton, Quitaque, Lakeview, Rock Creek, Wallace, Kent and Ward.

### Two Are Inducted

Two Briscoe county boys were inducted into the United States Army April 4 at Oklahoma City. They were sent to Camp Chaffee, Tex., for basic training. The boys are Billy Joe Pointer, son of Mr. and Mrs. Leonard E. Pointer, Quitaque, and Willard Raymond Davis, son of Mr. and Mrs. Jeff Davis, Silverton.

### SILVERTON LANDMARK MOVED TO FLOYDADA

One of the early landmarks of Silverton was moved this week when J. E. Daniel moved the old Silverton realty building to Floydada. Daniel stated that he was moving the building to Floydada where it will be used as a business building.

### Meeting Called to Discuss Cemetery

A mass meeting of Silverton residents is being called for Thursday evening, April 18, to discuss the possibilities of obtaining someone to take care of the Silverton cemetery. The meeting is being sponsored by the Briscoe County Development club. It will be held at the high school auditorium in connection with the regular meeting of the club.

All persons, who are interested in the improvement of the cemetery, as well as those who have aided in such work before, are urged to attend this meeting. The mass meeting was called after discussion of the cemetery situation when the club met last Thursday evening. At that time, the entertainment was furnished by a high school trio and the Briscoe county quartet.

George Cantrell mentioned the loud noises that have been heard over town during the night. He suggested that something be done to stop this noise, because of the reaction that it has on many soldiers who have returned from combat areas.

### Mayor, Councilman Take Office Monday

Mayor J. E. Minyard and Dee McWilliams, councilman, were sworn in at a meeting of the city council on Monday night. These men were elected at the recent city election.

The council voted to call a special election on May 10 to fill the other seat on the council which was made vacant when Virgil Ballard failed to qualify, because he had not lived in Silverton the time required by law.

In ordering the election, the council stated that any five legal voters could ask for the name of any candidate to be placed on the ballot, but such a petition must be filed at least 10 days before the election.

### Fowlers Begin Work On New Apartments

In an effort to relieve the housing situation in Silverton, Mr. and Mrs. H. E. Fowler are this week beginning construction of five, and possibly six, new apartments. According to Mrs. Fowler, the apartments will be three rooms each and will be completely furnished. They will be practically fire-proof, as the building is to be constructed of rock and tile.

The new apartment building will be located just north of the Silverton hotel and will be two stories high. Three apartments will be on the second floor, and two apartments and a garage will be on the first floor.

### Shelton Rites Held Monday

Tribute to the memory of Mrs. W. T. Shelton, 80 years old, was paid Monday morning at 10 o'clock at the Methodist church. Rev. H. W. Barnett, pastor, officiated assisted by Rev. G. A. Elrod, Baptist pastor.

Mrs. Shelton, who had been in failing health for a long time, died Sunday morning.

Born Lou Mandy Robinson on March 24, 1866 near Tuscaloosa, Ala., she was married to W. T. Shelton on Aug. 3, 1884. They moved to Texas in 1902 and lived in Lamar county until 1906 when they moved to Collingsworth county. The Sheltons moved to Quitaque, Briscoe county, in 1925. Mrs. Shelton had been a resident of Silverton since 1934.

Eight children, six sons and two daughters, were born to Mr. and Mrs. Shelton. One boy and one girl died in infancy. Survivors include her children, Mrs. E. W. Leuty, D. G. Shelton and T. H. Shelton, all of Silverton; E. O. Shelton, Borger; S. C. Shelton, Center Point, and R. R. Shelton, Crows Landing, Calif. All were present for the funeral with the exception of the latter two.

Other survivors are 25 grandchildren and 22 great-grandchildren.

Mrs. Shelton joined the Methodist church while a young woman and was active in church work until her health failed.

Pallbearers were Olen, Royce and Lloyd Shelton, Carlton Gardner, Jr., J. Turner and George Gafford.

Following the services in Silverton, the body was taken overland to Quail where interment was made beside her husband who died on Feb. 3, 1923.

### Legion Completes Deal for Building

Final papers for the purchase of the old Ford garage by the Williams-Graves Post No. 402 of the American Legion have been signed and are now in the hands of the Post officers.

The building was bought from Mr. and Mrs. H. E. Fowler for a purchase price of \$8000, but, since the building was to be used by the Legion, the Fowlers donated \$1000 to the Legion.

Plans are underway to remodel the front part of the building. Remodeling of the entire building will not be attempted until materials are more easily obtained.

The new members, who will serve three years, qualified Monday night on the board of trustees.

### Discuss Plans for Football Season

Football coaches and superintendents of District 4-B met at the Silverton high school Tuesday night to map plans for the 1946-47 football season.

Definite decision on whether to have 11-man or six-man football next season was postponed until July 15. Five of the schools represented indicated that they wish to play 11-man football. Two of the schools, because of lack of players, insisted that they could not put an 11-man team on the field next season.

Winner of the event will receive a hand tooled saddle. The 10 low roping servicemen and ex-servicemen in the previous two-day go-round will compete at the night performance on July 4 for the saddle.

In order to show the Texas Highway department that more than a few people are interested in seeing construction of two bridges across Red river and Mulberry creek north of Silverton, a large delegation from Briscoe, Hall, Donley and other nearby counties will meet with the state highway commission in Amarillo Tuesday.

The delegation will ask only for construction of the bridges and their approaches at this meeting with a feeling that completion of the road will be certain, if the bridges can be obtained.

Briscoe county will be represented by the commissioner's court, as well as by many individuals who have worked long and hard for the construction of the bridges. They will carry with them all information necessary to show members of the commission the need for such work at this time.

This is the first time in history that the State Highway commission has held a meeting in Amarillo with all members of the commission and their office staff present.

A number of road projects in the Panhandle section are expected to be given a hearing at the meeting, but the proposal for construction of the two bridges has been ordered for first consideration.

Construction of these bridges would open a new route for traffic through the Panhandle. Travel from southern Oklahoma could be guided through Silverton and on west to Clovis, while traffic from the northeast part of the Panhandle would be routed through here on the way to Floydada and points south.

Members of the State Highway commission who are expected to be in Amarillo are John S. Redditt, Lufkin, chairman; Fred E. Knetsch, Segdin, and Reuben Williams, Fort Worth. They will be accompanied by DeWitt C. Greer, state highway engineer, and members of the state highway staff.

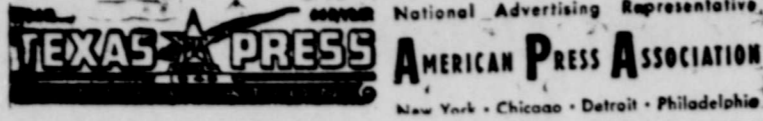

Lubbock To Build New Dormitories

Contracts for construction of four new dormitory units to cost \$4,001,145 and to house 1,320 students have been approved by directors of Texas Technological college, Lubbock. Directors also have approved construction of a new \$300,000 stadium, leaving details to be worked out by a joint committee of Lubbock citizens and Tech faculty members, subject to board approval.

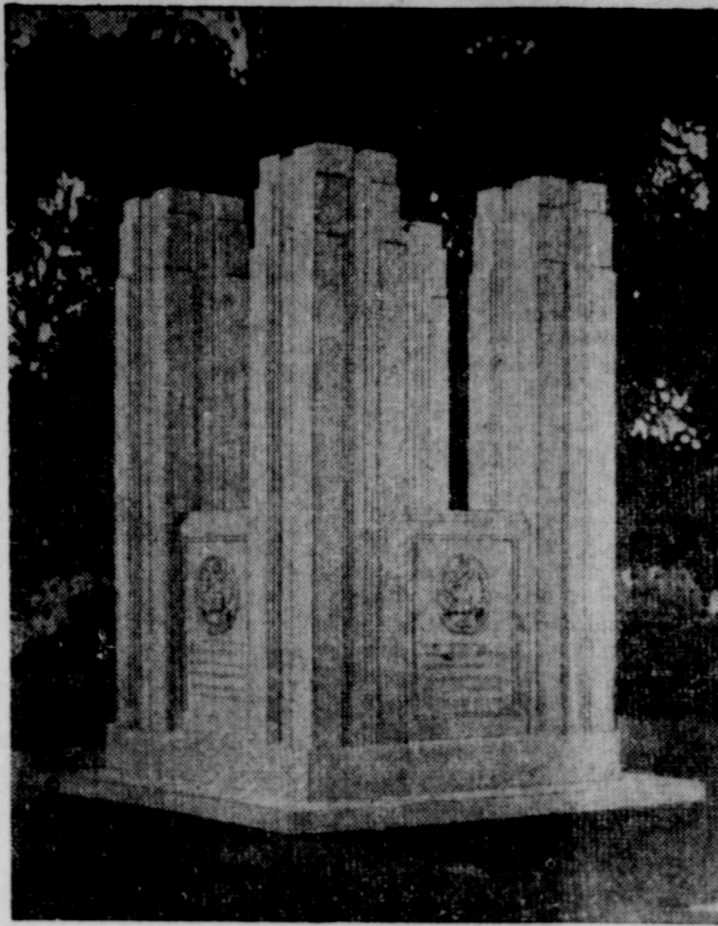

Plan Memorial in Honor of Roosevelt

Plans to commemorate the late president on the first anniversary of his death, by hundreds of memorial meetings throughout the state of Texas on the evening of April 12 have been announced by Glen S. Wilson of Austin, chairman of the Franklin D. Roosevelt Memorial Foundation.

"The meetings are called by the Foundation for the purpose of promoting and advancing the interests of the people of Texas in the life and accomplishments of Franklin D. Roosevelt and also the erection of a cenotaph on the state capitol grounds representing the "Four Freedoms," said Wilson. Permission for the erection of the cenotaph on the state capitol grounds has been granted by the State Board of Control.

The Foundation, whose charter was granted on Jan. 30, 1946, the late president's birthday, is com-

posed of 16 trustees, each representing a state-wide organization. "The erection of this cenotaph on the state capitol grounds is the Foundation's first project," said Wilson, "and will serve as the first step toward the establishment of a living memorial. Contributions toward the erection of the cenotaph are limited to one dollar per person so that all who believed in the principles for which he lived and gave his life may participate on an equal basis."

Each contributor will have a chance to vote for one of the 10 selected statements made by the late president, the four statements receiving the largest number of votes will be inscribed on the cenotaph, each contributor's name will be recorded on micro film and sealed in a special container to be deposited in the cenotaph for posterity.

The design of the monument is conceived in "International" or "Contemporary" style of architecture. Four impressive pylons are placed at the four corners of a massive monolith, which in size and form recalls a sarcophagus. The four pylons represent the Four Freedoms. Two faces of the monolith bear the great seal of the United States with space for inscription below. The two opposite faces show in sculpture a bust portrait of the late president.

Pepper Shortage Due To Continue

By JOHN CRADDOCK People who like their food well-seasoned are in for less palatable meals in the months ahead. Pepper, nutmeg, cinnamon, mace and other spices are in short supply because Far East vines were neglected during the war years.

Pepper is about the most difficult to get. It is produced in Malaya and India, but the world's pepper pot lies in the steaming equatorial jungle which covers the Lampong district of Sumatra in the Dutch East Indies. From those islands 85 per cent of the world's pepper comes. In 1939 the East Indies exported more than 66,000 tons, probably will not ship more than 20,500 tons this year. The United States normally consumes 15,000 tons of pepper annually and now has only 3,000 tons.

The Department of Agriculture has been commissioned to purchase 9,000,000 pounds in India but that would be only three-months supply. Natives neglected pepper vines during the war and it takes two to three years of cultivation to return them to full production. New vines begin bearing in three years, attain full production four to five years later. All of which indicates that pepper will be in short supply for some time.

It is much better to get the real facts on your questions concerning social security than it is to rely upon the word of someone not familiar with the law, according to field office officials. Social Security Board field offices furnish facts on many problems, such as:

Why is a social security account card necessary?  
What jobs are covered under the law?  
Why benefits may be endangered by a worker having more than one account card?

What the account number means to a wage earner?  
What are survivors' benefits and who gets them?

What are retirement benefits and to whom are they paid?  
How may a wage earner find out about his wage record?

How much will "my own" benefits amount to at age 65?  
How may a wage earner get a correction on his wage statement?

Answers to these and many other similar questions are contained in Social Security Board pamphlet No. 35 which may be obtained by calling at or writing to the Social Security Board field office, Amarillo.

**Wayland College To Build New Dormitory**

A special called meeting of the board of trustees for Wayland Baptist college in Plainview on April 2 authorized its building committee to award a contract for a dormitory for men. The building will house 88 men and is to be constructed by Neill Singleton of Amarillo from plans drawn by architects Emmett F. and James F. Rittenberry, also of Amarillo.

The building will entail unique features in that each eight men will have complete living quarters, including rooms for each two with adequate storage closets, and a living room for the group. The building will have 11 such units besides the reception rooms and living quarters for the matron.

This is the first of a group of buildings planned in the current enlargement campaign for the college, and when the campaign is complete there will be adequate facilities for hundreds more students. The college has been in operation since 1910, being the oldest college now in operation in the Plains-Panhandle country of Texas. Dr. John W. Cobb, dean of the college, is also chairman of the enlargement campaign.

Date for ground-breaking for this new dormitory will be announced as soon as priority permits and other arrangements can be made. The contractor hopes to have it ready for use sometime during next school year.

**Q. How much can high quality hay and pasturage cut grain costs for dairy cattle without cutting milk production?**

A. Tests recently conducted on two herds of high-producing cattle revealed that cattle given high quality hay and an improved pasture program needed only half as much grain as the cattle who had ordinary pasture and hay.

**Q. How much litter is needed for baby chicks and poulters?**

A. It usually requires from 1 to 1½ pounds of litter per square foot of floor space to make a cover two inches deep.

**Q. How deep do weed roots grow?**

A. The depth of weed roots varies. Bindweed roots in dry season may grow to a depth of 20 feet. For this reason, it is necessary to use a weed killer which enters the system of the plant and kills all parts of the weed.

**Q. Is the practice of breeding rabbits 21 days after their litters have been born scientifically sound?**

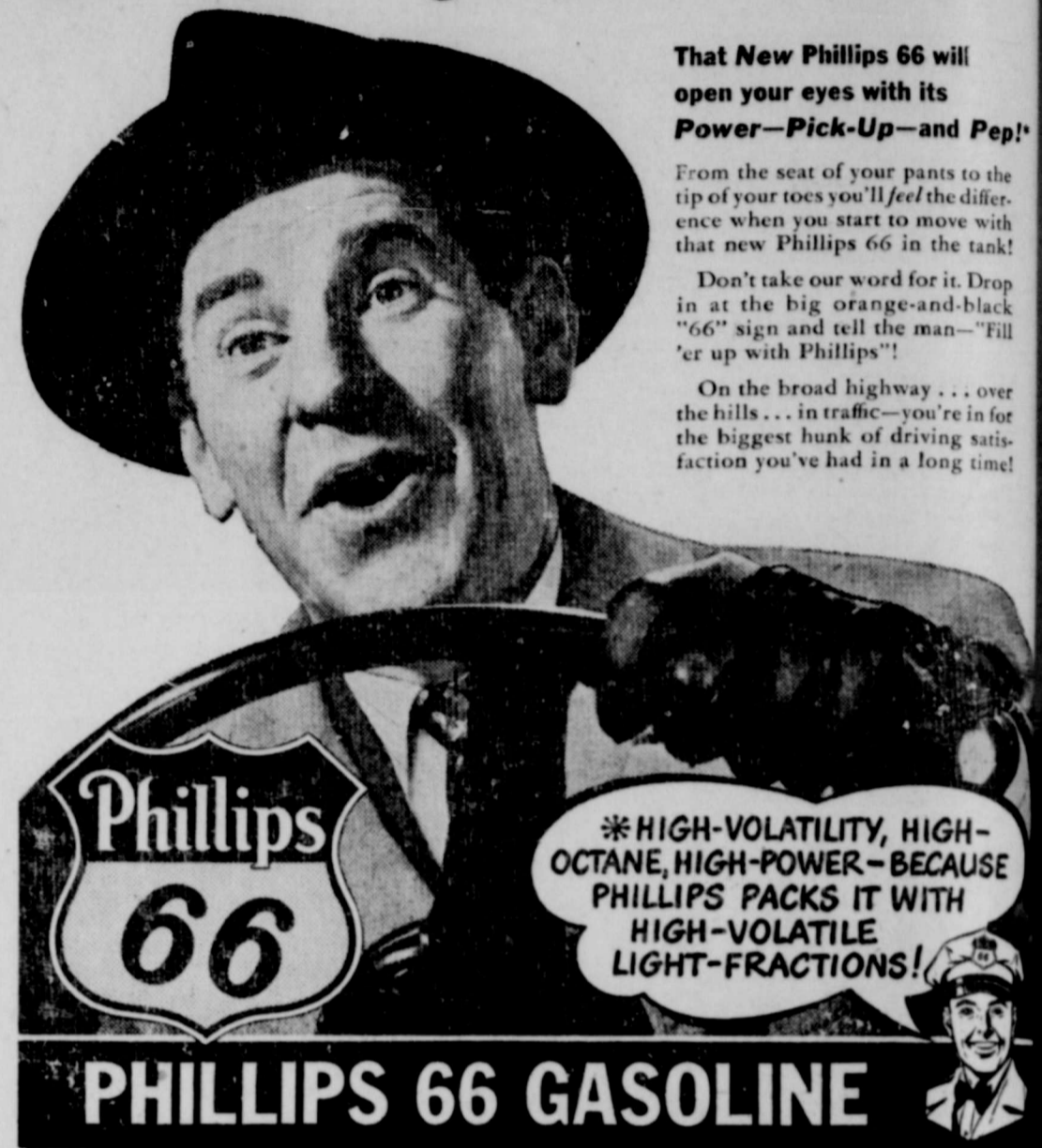
A. Yes. A three-year research project at the Research Farm of the Ralston Purina Company indicates that production can be increased by breeding does three weeks after their litters have been born and weaning the nursing litter three weeks later. This practice results in more young rabbits per year, more pounds of meat, and less cost per pound. The size of rabbits, their health and condition were as good as under the old system.

**Q. What is the relationship of color of turkey eggs to hatchability?**

A. At the Maryland Experiment Station it was observed that varying degrees of brown spotting on the turkey egg shell had no relationship to hatchability. However, the turkey grower should not set turkey eggs which have chalk-white, porous shells, because they are indicative of poor hatchability.

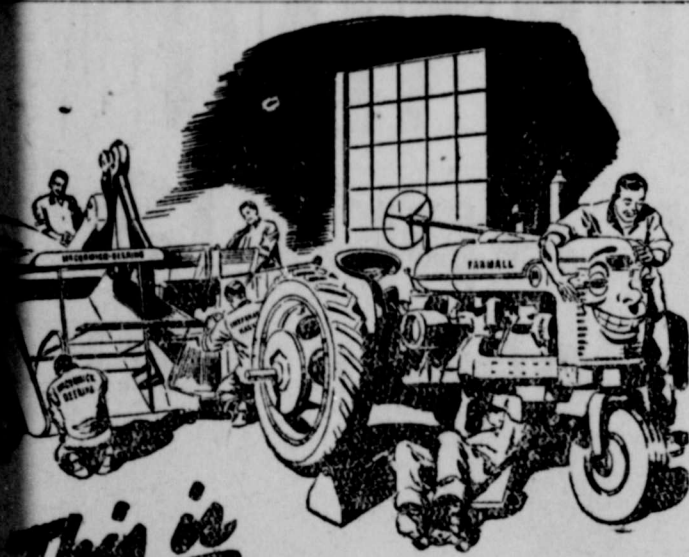

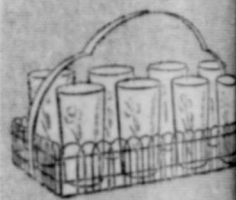
