

## Mason named head basketball coach at MHS

Ralph Mason has been named head boy's basketball coach at Muleshoe High School. The Muleshoe Independent School District Board of Trustees on Monday night approved the hiring of Mason following an executive session.

Mason will replace Leon Hagerman, who resigned in March as head boy's basketball coach.

Mason is currently head boy's basketball coach in Gilmer.

"I believe in discipline of the player's mind and body," Mason said when asked about his coaching philosophy. "Through hard work, team unity, and personal student goals, this can be accomplished."

"I believe a player should

have a goal to reach in sports as well as in life and that that my job is to make available every means possible to meet these goals."

Mason has 15 years of teaching and coaching experience. He began his career in Morton, where he coached for eight years.

He served as an assistant basketball coach on six play-

off teams that included three State Championships, one State Finalist and two State Semi-Finalists.

He served as an assistant coach in the Texas High School Coaches Association All-Star game.

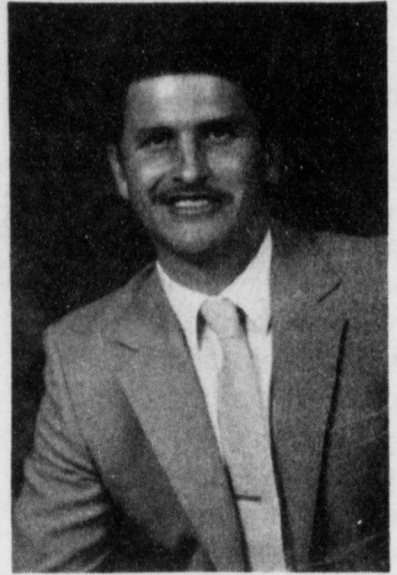
From Morton, Mason went to Gilmer High School, where he has coached for seven years. Five of those years, he has taken

## Crosnoe appointed county attorney

The Bailey County Commissioners Court on Monday appointed Crosnoe acting county attorney following an executive session.

Crosnoe will serve as acting attorney for Luther Thompson, who resigned as county attorney. Thompson's resignation will become effective April 24.

Thompson has been attorney for Bailey County since Jan. 1, 1993.

The commission accepted Thompson's letter of resignation on Monday. In his letter, Thompson stated that he was resigning his position due to "family, personal and financial reasons." According to the letter, Thompson is in the process of moving.

In addition to Crosnoe, there were two other attorneys from Muleshoe who were considered for the appointment, Chris Clevinger and Linda Elder.

Crosnoe will serve as acting county attorney for Bailey County until the November election.

## MISD to administer summer food program

After considerable discussion Monday night, the Muleshoe Independent School District Board of Trustees gave Food Service Director Laine Meek the go ahead to proceed with plans for the Muleshoe Schools to administer a Summer School Food Service Program.

Under the program, free meals are served to local children for a 45-day period during the summer months. The program is sponsored by the Texas Department of Human Services. While the school's facilities will be used during the summer, the MISD will be reimbursed by Austin for the cost of preparing the meals.

Meek was instructed though, to keep the board updated so guidelines can be established for the program.

"I think this will be a good program because we may have many kids in the community who go hungry during the summer," said Bill Moore, superintendent for Muleshoe Schools. "This program may

also help us get kids to attend summer school who have a need for extending learning."

Under the program, any child age 1-18 who lives in the district will be served free of charge. MISD is not sure yet how many meals will be served a day, but lunch will most likely

## County seeks options, funds to comply with mandate

The Bailey County Commissioners Court on Monday heard a presentation from Harts Forms of Austin on preparing records control schedules.

The State of Texas has issued a mandate, requiring that all counties have records control schedules up-to-date by 1995. Counties are required to keep documents which are not permanent for a certain number of years and then dispose of them when they are no longer needed on file.

Based on quotes given by Adele Rehder-Craboni of Hart Forms, it will cost the county between \$11,900 and \$14,600 if the county hires them. The county has received proposals

from three other companies interested in preparing records control schedules.

Marilyn Cox, Bailey County Judge, has said that while the state has issued this mandate, there are no funds in the current county budget to pay for the records control schedules.

Cox said part of the work could be paid for possibly out of the next budget, even if the work is done before then. And the remaining balance could be paid for out of the budget after that.

According to Rehder-Craboni, there are three requirements from the Local Government Records Act that

### Lazbuddie schools to hold kindergarten registration

Pre-kindergarten and kindergarten registration will be held at Lazbuddie Elementary School on Friday, April 22 in the school library from 9 a.m. to 11:30 a.m.

To be eligible for pre-kindergarten, a child must be age four on or before Sept. 1, a child must qualify for free or reduced lunches and a child must lack English language skills.

To be eligible for kindergarten, a child must be five years of age on or before Sept. 1.

Parents must furnish a state birth certificate, immunization records and social security numbers for the child at the time of registration. Children will visit their classrooms, take a bus ride, tour the school and be given refreshments.

### Early voting to begin

Early voting by personal appearance will begin Monday, April 18 for people wanting to vote in the May 7 School Trustee and Hospital District elections in Muleshoe.

Early voting for the School Trustee election will be held at the School Administration Office during normal school hours. Early voting for the Hospital District Election also begins April 18 at the Administration Offices at each school.

May 3 is the last day to vote by personal appearance for both the school and hospital elections.

April 29 is the last day to receive applications for early voting ballots to be voted by mail.

all local governments are required to comply with.

The county must have a records management officer, develop a record management plan and develop a records control schedule and designate which records are to be permanent.

The company said they will charge the county a flat fee for the service, based on population.

Cox said that she plans to talk with officials at Parmer County to get an estimate on how much they paid. Harts Forms did some records control schedules for Parmer County recently.

Offices in Bailey County that have not filed Record Management Plans which were due on Jan. 1, 1991 with the Texas State Library, are the Justice of the Peace, Precinct #4, Constable 1, Constable 2 and Constable 3.

A records control schedule must be prepared and filed with the director and librarian at the Texas State Library. After a records control schedule is accepted for filing, the local government may then proceed to dispose of records according to the schedule without further reference from the state.

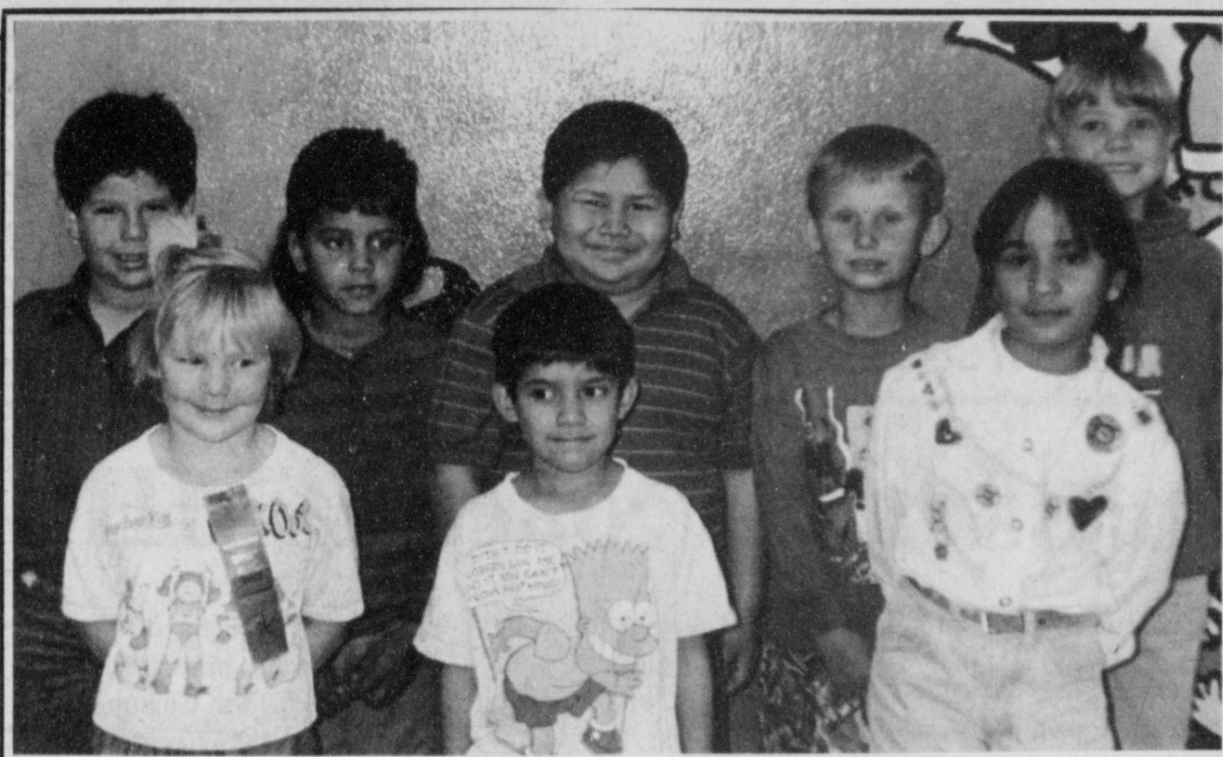

According to Reher-Craboni, the mandate was designed to give local governments more control over records.

The commission did not take any action on hiring Hart Forms during the meeting Monday.

In other business Monday, the commission heard a report from Diana Townsend and Gail Davis of Mental Health Mental Resources Center.

Davis gave the commissioners an update on feedback they received after a public

hearing last week.

"The hearing was held to see what MHMR can do to better serve people in our patron area," Davis said.

According to Davis, MHMR served 2,000 people last year in their coverage area, which includes Bailey County.

Townsend said that a needs assessment was done for counties, based on poverty level, and Bailey County ranked 19.

Davis said that MHMR currently has three people working at the Muleshoe office. She

said they hope to get a person who can travel to see patients with mental illnesses so people here don't have to go out of town to get treatment they need.

On Monday, the commission also granted an easement to Bailey County Electric so they can place a buried line in Precinct #4. The line will be buried in a right of way belonging to county.

Commissioners also recommended Dan Henson to serve as coordinator of the Wes-Tex RC & D Council

be served.

Meek said that two-thirds of the children in the school district currently qualify for free or reduced lunches at the schools.

"In the summer months, the Texas Health Services receive lots of emergency applications for food," Meek said. "This is one of the reasons why this summer food program was created, so we have a little bit of control."

It will be MISD's first time to sponsor such a program and the board of trustees do not know what kind of response they will get.

Board President Cindy Purdy asked about liabilities and the school. Laine said that he has not seen any guidelines concerning this yet.

The summer food program will start the same day as summer school. Board members discussed the possibility of serving children who attend summer school first, who could then help supervise some of the children eating.

Board Trustee Max King expressed some doubt, saying, "I don't think this is a good idea. We are talking about 150 to 300 free meals a day. That is a lot."

According to Adrian Meador, assistant superintendent of instruction, more than 100 students attended summer

school last year.

King said the schools should then expect more than 100 students to participate in the program.

Discussion was also raised about charging adults \$1 or \$2 who want to eat with their children. The board did not make a decision Monday night on whether or not to charge adults.

While the board did approve the administering of the summer good program Monday night, they said guidelines will need to be established concerning supervision of children and other things.

In other business Monday, the board voted to renew a three-year lease for a building used as an alternative learning center. The center, which was operated three years ago, has not been used the past two years. But Moore said the lease gives the school the option to use it again.

The board also approved the renewal of a three-year contract with Whittle Communication Educational Network. The network provides Channel 1, an educational channel, to schools. The board also approved campus and departmental budgets for 1994-95.

It was also announced that the MISD Board of Trustees will be nominated as outstanding school board of the year.



She is 34 years old and married to Edwin, who is assistant manager of Pay-n-Save Grocery at Earth.

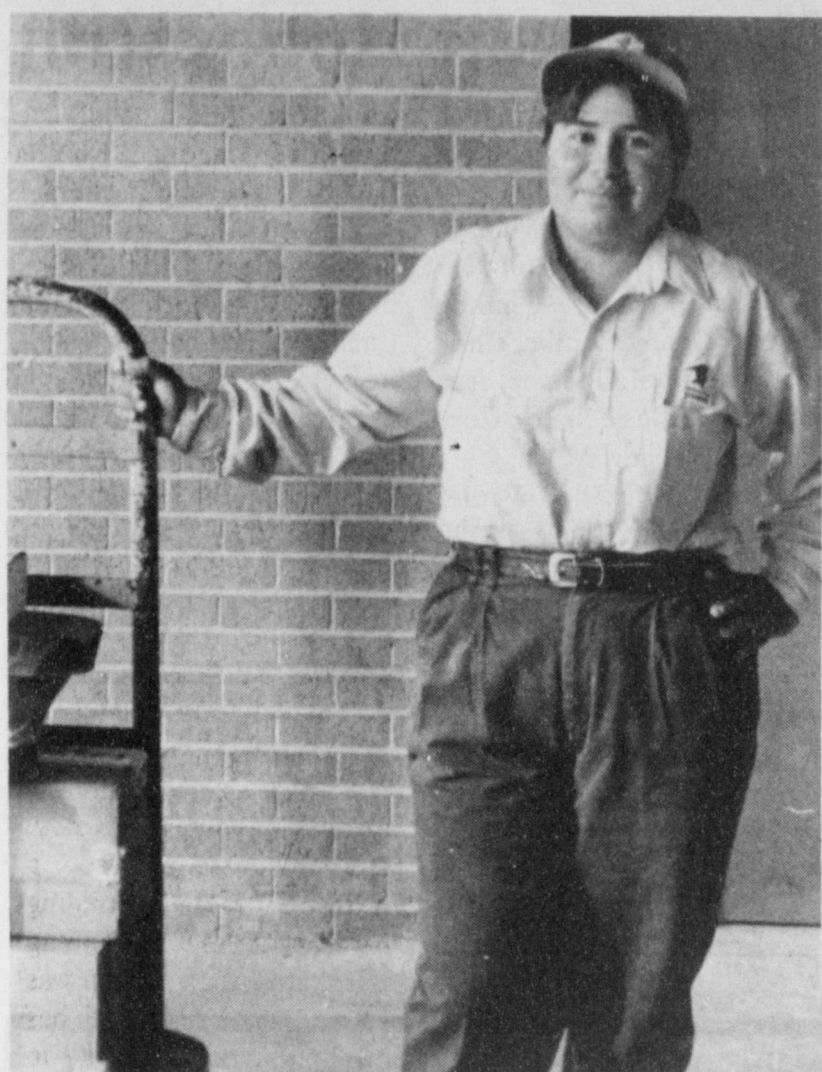
They have one child, Stephanie Irene, age four.

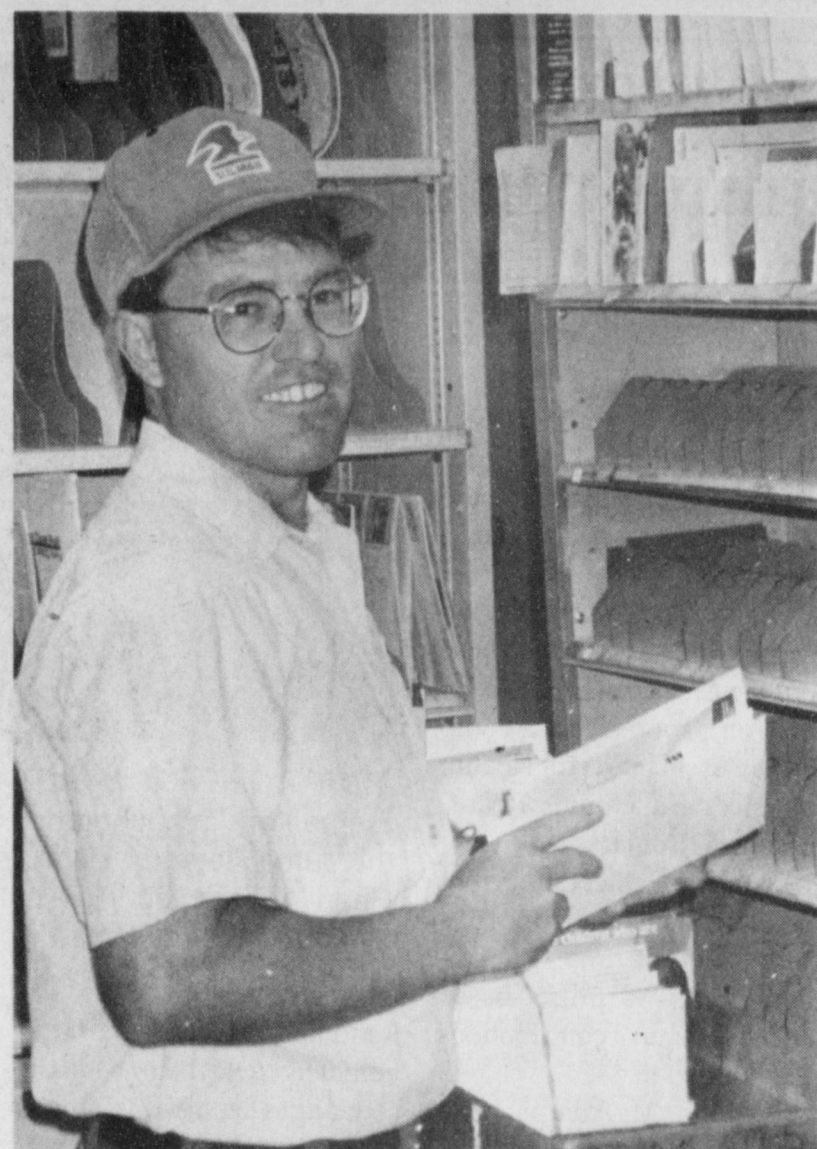
He is 30 years old and a 1982 graduate from Friona High School and also graduated from West Texas State University in 1988.

## State law prohibits dumping of oil and filters in landfills

The Texas Natural Resource Conservation Commission is taking the offensive to help people who change the oil in their own vehicles comply with a new state law that makes it illegal for anyone to dispose of used oil filters in Texas landfills.

The new law, which takes effect April 1, means that used oil filters can no longer be thrown in the trash anywhere in Texas. Instead they must be drained and taken to a business that accepts filters for recycling.

It is already against the law to dump used oil on the ground. Like filters, oil must be taken to a collection facility. The steel from filters can be recycled into new steel products.

It is estimated that about 30 million used oil filters go into Texas landfills annually and each filter contains about eight

ounces of oil. That's over 3 million gallons of oil each year dumped on Texas which threaten water supplies.

The TNRCC has been working with businesses and local governments to develop a system of collection points for used oil and oil filters across Texas. A TNRCC survey identified over 400 retail businesses and local government operations that will accept used oil filters and the number is growing steadily.

A majority of those businesses will accept filters without charge. Some, however, will charge a small fee ranging from 50 cents to about \$1.

Many auto supply stores, auto repair shops, retail stores with automotive repair services and other businesses will accept used oil filters.

The TNRCC also will be sponsoring collection days this

spring and summer in 38 rural communities across Texas for used oil and oil filters, tires, lead-acid batteries and empty pesticide containers.

The collection events will be advertised in advance. Also, a major public education campaign on oil filter recycling will be held in May in partnership with both public and private organizations. At that time additional collection locations will be announced.

Initially, there may still be some rural areas of Texas where citizens do not have a business or governmental entity that will accept oil filters. The TNRCC has provided grants to help many local governments establish oil collection programs and additional funding is available so those programs can also accept oil filters.

People who change their own

oil should drain filters before taking them to a collection center. One technique that can be used involves placing a funnel in the top of the receptacle for

your used oil and placing the filter in the funnel to drain.

Studies indicate that in about 24 hours, approximately 80

percent of the oil residue will drain out of a filter. Both the filter and the oil should be taken to a collection center.

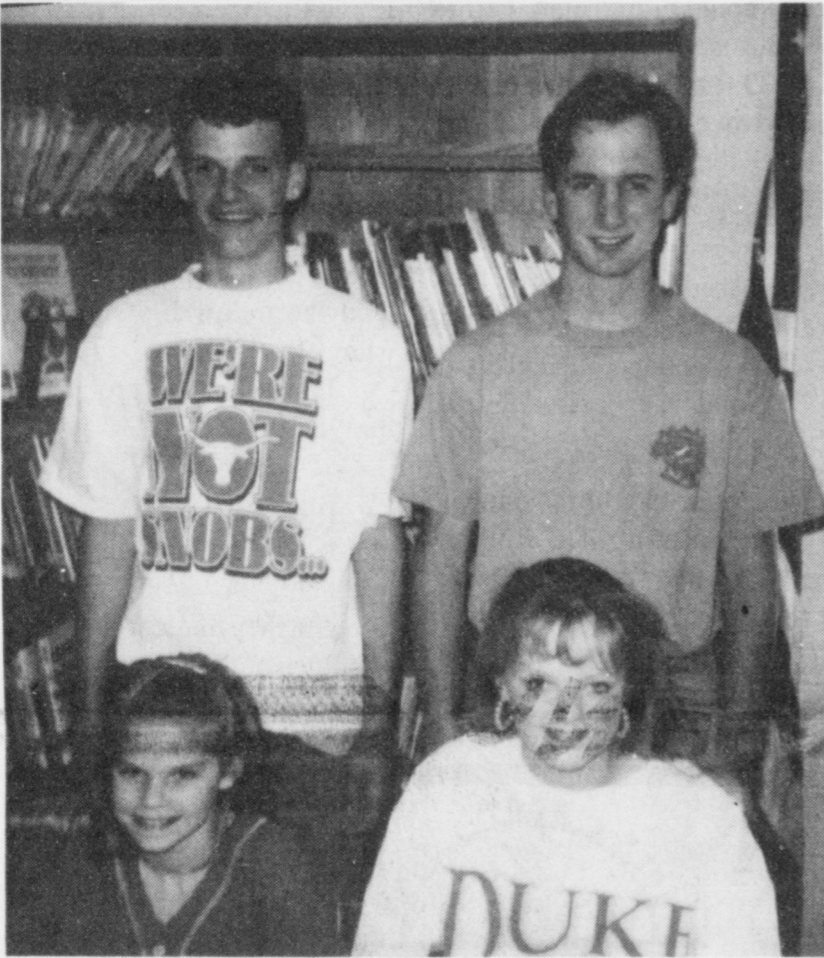

## Cancer pain: Relief in sight for patients/family

Much-needed relief for cancer patients and their families has finally come through the release of the new Agency for Health Care Policy and Research Clinical Practice Guidelines for the Management of Cancer Pain in early March.

These guidelines reflect a growing national consensus that cancer pain can oftentimes be avoided, and that a patient's quality of life does not have to be severely diminished as a result of this disease.

This announcement was welcomed by Texas physicians, who have been in the forefront of the battle against cancer pain. Directed by a team of leading cancer pain experts, the Texas Cancer Council (TCC) published a set of

guidelines on cancer pain management in 1989, documenting how pain can be effectively managed in cancer patients. The recently released national guidelines further validate the conclusions reached by the Texas physicians.

The work already done in Texas and now joined by the federal government should bring an end to the undertreatment of cancer pain.

A free booklet for patients, "Questions and Answers about Pain Control," can be obtained by calling the American Cancer Society toll-free at 1-800-ACS-2345. A copy of the new federal guidelines can be obtained by calling the Cancer Information Service at 1-800-4-CANCER.

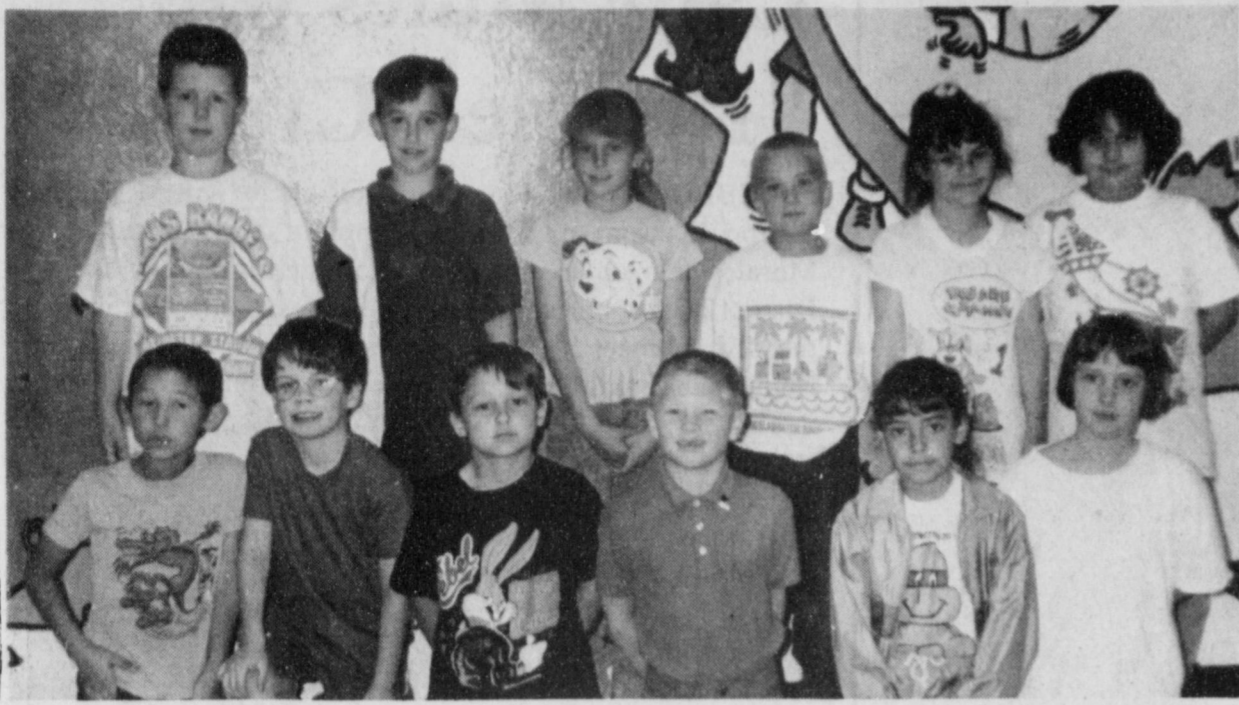

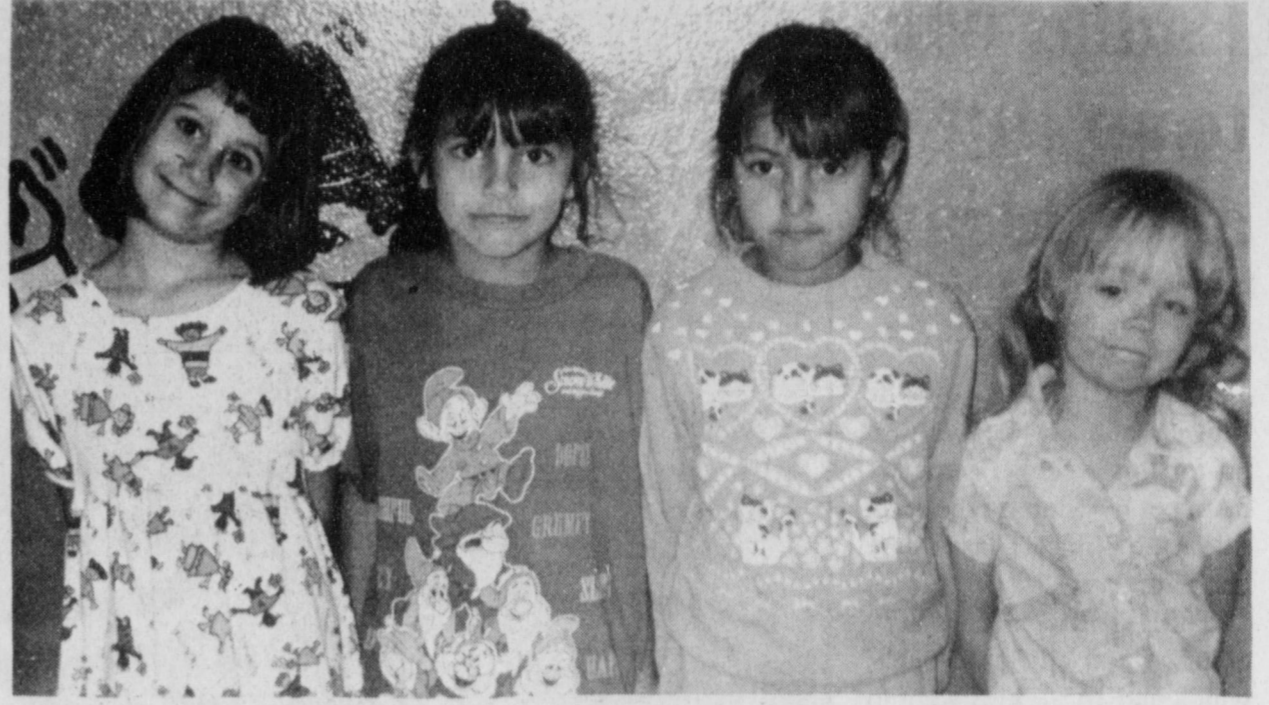

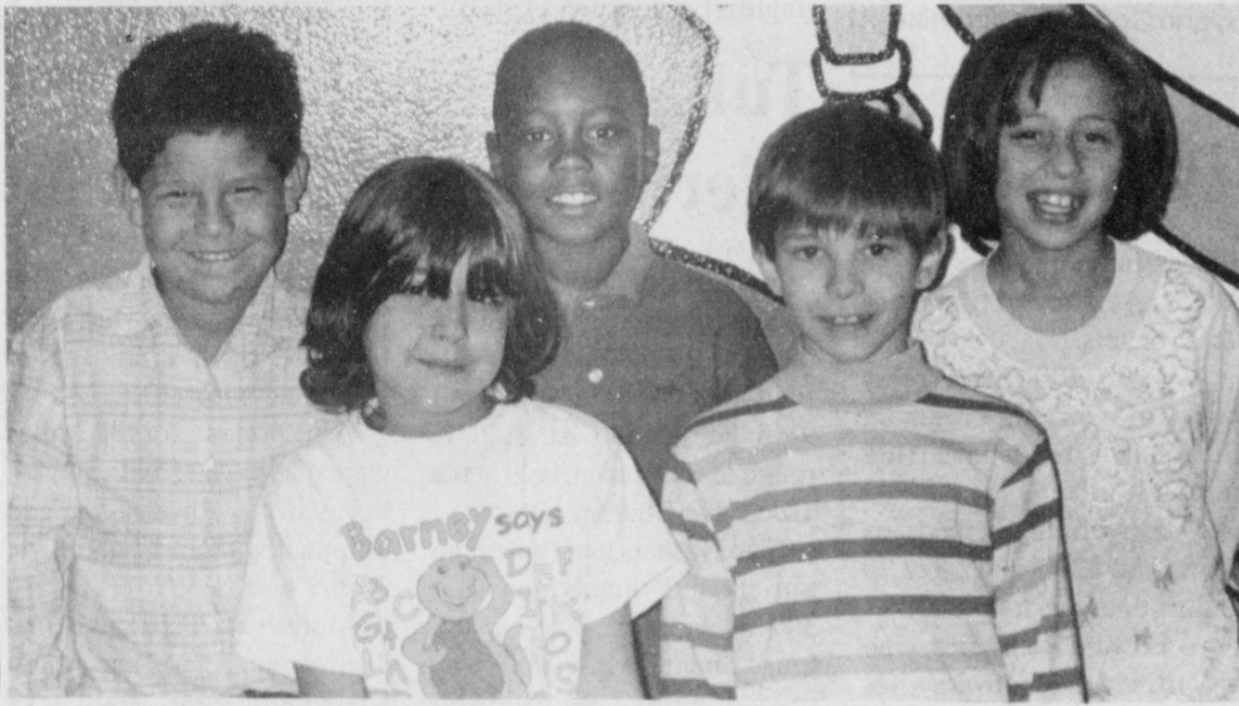

### THE MAO YEARS 1949-1976

In October 1949, Mao Zedong stood above a huge crowd at the Gates of Heavenly Peace in Beijing and declared the establishment of the People's Republic of China. From that day until his death in 1976, Mao dominated the lives of one-quarter of the world's people.

The Mao Years 1949-1976, a two-hour documentary, examines China under Mao Zedong, a time when the Chinese built the foundations that enabled them to become one of the world's economic powerhouses. It was also a period marked by brutal campaigns and purges that culminated in perhaps Mao's most colossal and tragic mistake, the Cultural Revolution.

The Mao Years begins in a country devastated by years of Japanese occupation and civil war. For many in 1949, the new Communist government was a welcome change, bringing economic and social reforms that offered land

and new opportunities. But the Communists also initiated frightening campaigns during which thousands of people were jailed or executed.

The Mao Years also documents two of Mao's pivotal programs: the Great Leap Forward of 1958 — a plan Mao claimed would make China the industrial equal of western nations in just 15 years but instead led to a catastrophic famine in which at least 30 million people died — and the Cultural Revolution, 10 years of epic upheaval that rent the fabric of Chinese society. In 1966, Mao urged China's youth to attack all authorities and replace them with true revolutionaries. The young people responded en masse, and formed Red Guard groups, rallying and marching across the country to destroy the "four olds" — old customs, ideas, culture, and habits.

The Mao Years airs Wednesday, April 13th at 8:00 p.m. It repeats Saturday, April 16th at 10:00 p.m.

## Legal Matters

Protecting the rights of citizens from fraud, neglect, and mistreatment is a major responsibility of the Office of the Attorney General. Not long ago, my staff uncovered a pattern of patient abuse throughout the psychiatric hospital industry in our state.

While the vast majority of mental health care providers are reputable — no one should be afraid to seek needed treatment — consumers should be informed of their rights.

Triggered by a single consumer complaint, our investigation uncovered widespread abuses and culminated in successful litigation against four major national psychiatric hospital chains.

More importantly, it resulted in the passage of a comprehensive mental health care reform package by the Texas Legislature. The new laws provide needed legal protection to patients in psychiatric care, and serve as a model for the rest of the country.

Initially, we focused on consumer complaints about a

practice called "bounty hunting," in which psychiatric hospitals illegally pay counselors and others, such as ministers, teachers and probation officers, to refer patients for admission.

We learned that some hospitals paid counselors who were also employed by schools and treatment centers for crime victims. In some cases, counselors would read police reports to identify crime victims who might be referred for admission.

The hospital chains also provided incentives to hospital employees who met or exceeded a set number, or quota, of patients that they admitted.

But those are just the bare facts. Case histories illustrate why my office took action and why necessary reforms were put into place by the Legislature.

In one case, a young man suffering from a drug and alcohol problem voluntarily checked into a psychiatric facility for a 10 day treatment program.

After about four days, he decided to forego further treatment. However, an orderly told him that the hospital would have him legally committed for 30 days if he tried to check out.

In another case, a school counselor recommended that a student be admitted to a psychiatric hospital for in-patient treatment. When the parents indicated that they desired an alternative method of counseling, the counselor threatened to report the parents to the authorities. As it turned out, the counselor was an employee of the psychiatric hospital who received a "bounty" for referring the child.

These stories sound unbelievable, but they actually occurred here in Texas less than three years ago. Shockingly, they were not isolated incidents.

We were particularly concerned because many of the hospitals bills were being claimed against the Crime Victims Compensation Fund, which my office administers.

In some cases, a patient's

life-time benefits were exhausted by a psychiatric detained treatment beyond necessity to justify larger claims.

Other patients were released before they recovered, simply because the money had been exhausted. In any reputable mental health care facility, the length of a person's stay is entirely determined by that person's mental health needs.

We prosecuted a number of the worst offenders, enforcing comprehensive settlements. Millions of dollars in claims against the Crime Victims Compensation Fund were dropped as a direct result.

In addition, the Texas Legislature has enacted a series of reforms to address the mar-

keting practices employed by psychiatric hospitals and provide needed legal protection to the citizens of our state.

Under the new law, a psychiatric facility must provide you with a copy of the "Patient's Bill of Rights" during the admissions process. A copy of this important document is available to anyone from the Texas Department of Health (512/458-7111.)

Before admitting yourself to a facility, you have the right to know how much the treatment will cost. The hospital must tell you the daily rates and additional costs. And it cannot misrepresent how much of your bill will be covered by insurance.

As a patient, you must have free access to a telephone. And if you entered the facility voluntarily, you are free to leave, except under extreme circumstances. Finally, be cautious of anyone who approaches you regarding psychiatric treatment. And always seek a second opinion from a qualified mental health professional.

Although the new law makes it illegal for individuals to profit by referring psychiatric patients, some unscrupulous organizations continue to run bounty hunting scams.

## Work program aims to help collect Child Support

Texas Attorney General Dan Morales' Child Support Program is recruiting businesses to help increase the number of children receiving child support by participating in the Employer New Hire Reporting Program enacted by the Texas Legislature last session. The Employer New Hire Reporting Program is a voluntary project that allows employers to assist with locating non-custodial parents who owe child support by reporting new employees to the Office of the Attorney General. Nearly 100 businesses are already participating.


"Many of the parents we are trying to reach have been deliberately avoiding their responsibility to their children by frequently changing jobs," Morales said. "The program helps to locate parents so their court-ordered child support can be collected directly from their employers. By providing us basic information in a method

convenient to them, businesses can help us go a long way toward increasing child support collections."

"Taxpayers paid more than \$538 million in 1993 in welfare to single-parent families in Texas who did not receive child support," Morales said. "We can reduce this figure if we locate more non-custodial parents who owe child support and get them paying on a regular basis."

"Every month thousands of Texas children fail to receive the financial support they are entitled to by law. This program provides a way that businesses can make a difference in these children's lives by providing information that helps us hold their parents accountable."
