Council members, who determine policy and provide general direction for the agency's work, are designated by the presiding officers of the House of Representatives and the Senate after each regular session of the Legislature. They participate actively in dealing during the interim with problems of statewide significance confronting the next Legislature. Appoint ments to the Council are considered choice assignments by legislators because of the influence and

In addition to the sandwiches serve carrot sticks, celery, or cherry tomatoes as a vegetable; apples, bananas, or oranges for your fruit. Children like to suck oranges; "roll" the orange to make it juicier, then cut a hole at one end. It's easier than hav-ing to peel off the rind, and not nearly so messy. Most picnicking is done in warm weather, but on crisp fall days or the first tantalizing days of spring, you may feel the urge to take off for the great open space. Just add to the basic above menu pattern a thermos of a hot beverage, such as cocca, or a hot soup that can be drunk from paper cups, and you're set to go!

Try combining peanut butter with honey, applesauce, cottage cheese or horseradish (for the daring!) for exciting variations on the peanut butter and jelly theme. Most sand-wiches, if wrapped properly, will keep fresh up to two hours with-out refrigeration.
