

August 23, 1968-Final date to receive nominating petitions. The purpose of this action is to allow farmers to nominate men to serve as community committeemen.



BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS: Section 1. That the Consti-tution of Texas, Article III, be and the same is hereby amend-ed by deleting therefrom Sec-tion 18, and substituting in lieu thereof the following: "Section 18. No Senator or Representative shall, during the term for which he was elected, be eligible to (1) any civil office of profit under this State which shall have been created, or the emoluments of
