Many citizens asked why an election was held to name a successor for Ezzell, since the legislature is not in session. One explanation is that it will give Shaw seniority over the other freshman representatives when the legislature convenes in January.

## Local Bank To Enlarge Facility

Some big changes are in the making at Robert Lee State Bank, as the firm is making good progress in adding 2,000 square feet to present facilities. The addition will give the bank 6,000 square feet of space and allow for expanded services and convenience for customers.

The Roe Building between the present bank building and the post office was demolished and a completely new structure erected in its place.

Gerald Allen, president of the bank, said this week that they hope to have the improvements completed by the latter part of December or early January, depending on the arrival of materials and equipment.

Allen said the bank's facilities have become inadequate to keep up with the growth experienced

the past few years. He said the bank was short on vault space, offices and in the bookkeeping area.

The new part of the bank will provide space for three offices, another vault so that more safety deposit boxes can be installed and records stored, a refreshment room for employees, two rest rooms and storage space. There will also be a room to house heating and cooling equipment.

G.W. Anderson is general contractor for the building, and Allen said he is running about two weeks ahead of schedule.

"I thought when we moved into this building in 1956," Allen said, "that we would have enough room to last from now on." That is not the case, however, due to the increase in business, the installation of computerized bookkeeping equipment and other needs for space.

"We are grateful to our customers, both local and out of town," the bank president said, "for making our growth possible, and we feel these improvements will help us to do a better job in providing for all their banking needs."

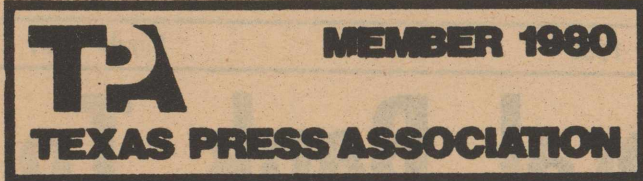

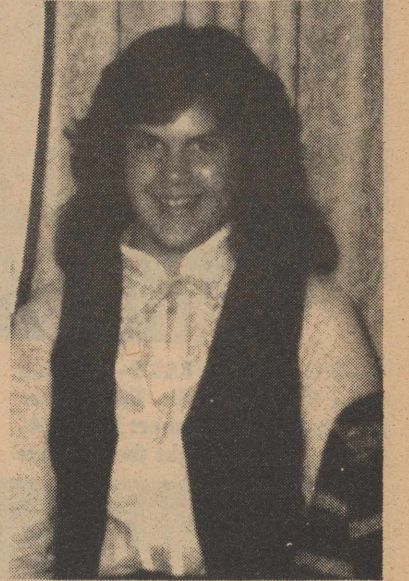

### Time to Gather Tax Information

Taxpayers, especially those who itemize, should begin compiling receipts and other records to support claims on their Federal tax returns, the Internal Revenue Service advises. These records can be used to back up claims in case the return is examined and also assist taxpayers by reminding them of potentially overlooked deductions.

For easy reference, the records should be sorted into the categories which appear on Schedule A of Form 1040, the IRS says. When itemizing, taxpayers should bear in mind interest paid on loans and mortgages, as well as payments for medical insurance which are documented on various financial statements. These amounts are often deductible, and frequently overlooked.

Medical expenses, union dues and charitable contributions are a few other commonly claimed deductions for which IRS examiners often request supporting evidence. Keeping cancelled checks, pay stubs, and bills can be helpful in supporting these claims. However, the IRS notes that taxpayers should not attach receipts or cancelled checks to their tax returns.

### LIVESTOCK REPORTS BEING REQUESTED

From mid-November to early January, many Texas farmers and ranchers will receive a crop or livestock questionnaire from the Texas Crop and Livestock Reporting Service or will be personally interviewed by the Service's field staff. All of the estimates published by the Texas Crop and Livestock Reporting Service are based on the data provided by Texas farmers and ranchers. County Extension Agents, ASCS offices, and many others in agriculture. This cooperation provides the necessary data which is, in turn, returned to farmers and ranchers and others in the form of accurate estimates, which are so essential in making the wisest production and marketing decisions. Each farmer or rancher receiving a questionnaire is urged to fill it out carefully and return it promptly to the Agricultural Statistician in Austin. Individual reports are confidential and used only for state and county estimates.

### BRONTE BLAST BELIEVED CAUSED BY DYNAMITE

### County Agents News Column

About this time of the year people begin to think about planting another pecan tree. Dr. George R. McEachern, Extension Horticulturist, has some suggestions for those of you that are considering planting pecan trees.

Whether you are planting a pecan tree for its shade or nuts, you can help assure its success by following proven directions.

Plant pecan trees from December through March and space them no closer than 35 feet apart in full sun.

Vigorous, fresh stock obtained from a reliable nursery is recommended. Shop for a tree with a 4-to 8-foot top. The scion should be 1-year-old on a 3-year-old rootstock. Roots should be free from black knots, nematodes or drying out.

An important step is making sure the root system remains moist (not wet) from purchase to planting. If roots dry up the tree will die.

Moistening the tree's packing medium and root system as soon as you get the tree home is a good practice. Plant it immediately or place it in cold storage.

Before planting, remove all broken or twisted roots. Also, cut back one-third to one-half of the tree top at planting to compensate for root loss during digging.

He suggests digging the hole only deep and wide enough to accommodate the roots without bending them. Set the tree in at the same depth at which it grew in the nursery.

Fill the hole three-fourths full with soil. Pour a small amount (about 2 quarts) of water into the hole to keep roots moist. Eliminate air pockets by packing the soil but do not pack it extremely tight. Do not place commercial fertilizer in the planting hole. Leave a basin around the tree to make watering easy.

Be sure to keep the root zone moist, especially during the first growing season. Treat the basin area with Roundup herbicide to control grass and weeds competing for water. Use Roundup in April, June and September. Wrap the lower 18 inches of the tree trunk with aluminum foil to prevent herbicide injury.

During the first two growing seasons, allow all shoots above the aluminum foil to grow. Pinch back all shoots to 12 to 18 inches when they start vigorous growth in the spring except for a central leader, and keep them pinched back. This "trashy trunk" method of training will protect the trunk from sunscald and wind damage and will also help the trunk to increase in diameter.

At the end of the second or third growing season the tree top should be able to shade the trunk enough so that lower branches can be removed. After five to six years the lowest branch should be 5 to 6 feet above the ground.

The recommended varieties for this area are Western, Tejas, Mohawk, Wichita, Sioux and Cheyenne. Generally speaking, the varieties with Indian names are preferred.

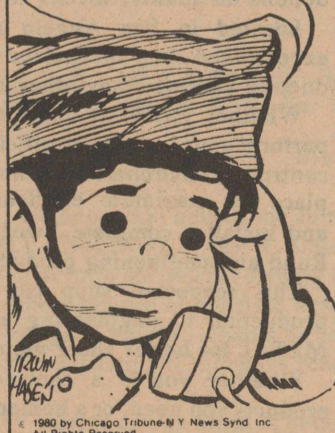

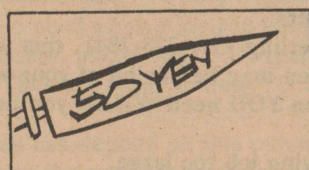
