Salaries Set by Commissioners

Coke County Commissioners' Court met Monday and passed an order for county and precinct officials and employees be paid an annual salary instead of being paid on an hourly basis. Salaries for all the officials and employees were set.

In other business the commissioners court:

- * Met with Kay Robbins who represented the '69 Study Club of Bronte. She requested the help of the county in purchasing some playground equipment for the Bronte County Park. The commissioners tabled her request and will take it up at a later date after it is determined what is needed and the cost.

- * Met with Lt. Pete Skains of the Tom Green Sheriff's Department. He requested that Coke County pay \$520 per month for the investigation of cattle thefts. The project would be a cooperative effort by Tom Green, Coke, Sterling and Irion Counties. The commissioners tabled his request in order to contact ranchers in the area to determine how badly the service is needed.

- * Drew names from the grand jury list of public members to serve on the county grievance committee. Their names will be released after they are notified of their selection.

- * Approved the quarterly report of the county treasurer.

- * Appointed members to serve on the Coke County Historical Society.

- * Paid bills.

Loeffler Given Important Job

House Republican Whip Trent Lott today announced the appointment of Congressman Tom Loeffler, R-Texas, as Deputy House Republican Whip for the 97th Congress. Loeffler represents the 21st District of Texas which includes Coke County.

Lott said he chose Loeffler to become the number three-ranking member in the Whip organization because of his experience with White House congressional liaison and the executive branch as well as his work with the U.S. Senate.

"Tom Loeffler is one of the most experienced young Members of Congress," Lott said. "His friendship with members on the Democratic side of the aisle will be invaluable as we go about trying to pass the Reagan legislative package."

"He is one of my closest advisors," Lott said. "He will be particularly helpful in budgetary matters because of his membership on the Appropriations Committee and in energy and defense legislation because of his knowledge in those fields."

Taken into custody was Ronald Charles Hicks, 28, who was living in Coke County under the alias, Jerry Sillinder. Hicks was charged with escaping from Los Angeles County, Calif. jail while standing trial for murder. A warrant was issued Feb. 5, 1980 charging Hicks with escape from custody.

Sheriff Marshall Millican said Hicks was arrested on a warrant issued in Coke County as a fugitive from justice. He was taken before Justice of the Peace Opal Jacoby, who set his bond at \$300,000. He was then taken to Tom Green County jail. California authorities are in the process of extraditing the man.

Hicks was employed by Chapman Construction Co. and was working on the job of enlarging and remodeling the Sun Gas Plant. He had been living in Robert Lee about three months.

Sheriff Millican said he and other Coke County law enforcement officers gained information on the identity of the man through the Texas Department of Public Safety communications system. They decided they needed additional help in making the arrest and area officers beefed up the operation by giving them plenty of assistance.

In addition to Millican, State Trooper Bobby Hart, Deputy Sheriff J.P. McGuire and Game Warden Sparks Burdett, all of Coke County, helped with the investigation. They were assisted by State Troopers Sgt. Eddie Boyd, Ed Dixon and Larry Hood, all of San Angelo, and Roy Blair of Sterling City; Sheriff David Daniels of Sterling County; and Deputies Lowell Ballentine and Pete Skains, of the Tom Green County Sheriff's Department. Millican said that Deputy Melvin Childress handled communications at the Coke County office and that a great deal of help was given by former Coke County Sheriff Douglas Robertson, now dispatcher with the DPS in San Angelo.

MORE BURGLARIES

Sheriff Millican said four more burglaries at Oak Creek Lake have been reported in the past week. The crimes are believed to have been done during the Christmas - New Year holiday season but were not discovered until some time later by the absentee owners of the cabins.

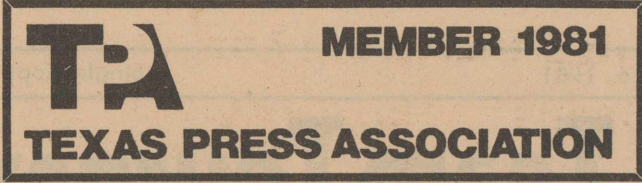

Civil War Vets to be Honored

Texans in over 200 counties will gather at high noon on Jan. 19 in pilgrimages to historic sites and official markers commemorating the roles of Texans in the Civil War.

Jan. 19 has been designated by the legislature as Texas Confederate Heroes Day, a time for a special observance honoring soldiers, civilians, and officials who distinguished themselves during this period of conflict.

Speeches, memorial services, wreath-layings, graves and marker decorations and other activities will be conducted at the locations of military and naval installations, manufacturing plants, scenes of battles and skirmishes and other significant sites. A number of these locations recognize activities of Federal Forces within the State.

An educational poster honoring the public service of 20 outstanding Texans in the Civil War will be displayed in schools, museums, and other prominent places.

This Heritage and Pilgrimage Day is one of ten to be sponsored annually by the Texas Heritage Project, a joint endeavor of the Texas Historical Foundation and the Texas Historical Commission. Local chapters of the United Daughters of the Confederacy, and the 254 County Historical

Commissions are also sponsors.

Mrs. W.R. Knowles of Houston is coordinating the statewide activity.

Mrs. Jessie N. Yarbrough is Coke County's Historical Commission Chairman.

Shaw Is New Representative

Larry Don Shaw, the new state representative from the 63rd District, has taken over his duties in the current session of the Texas Legislature. In fact, Shaw got a head start on the other freshmen members of the House of Representatives when he was sworn in Nov. 30, instead of Jan. 13.

The reason for his early swearing in was due to the resignation of Mike Ezzell, Shaw's predecessor. Gov. William Clements called a special election to name Ezzell's successor and Shaw won the contest.

Shaw has sent out a questionnaire to citizens of the district, asking opinions on some of the more important matters the legislature will be facing. He has requested that everyone fill out the questionnaire and return it to him as soon as possible.

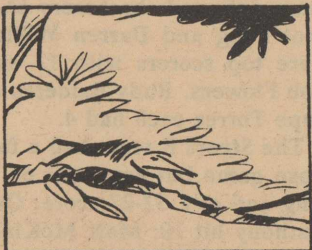
TSTI OFFERING SPECIAL COURSES

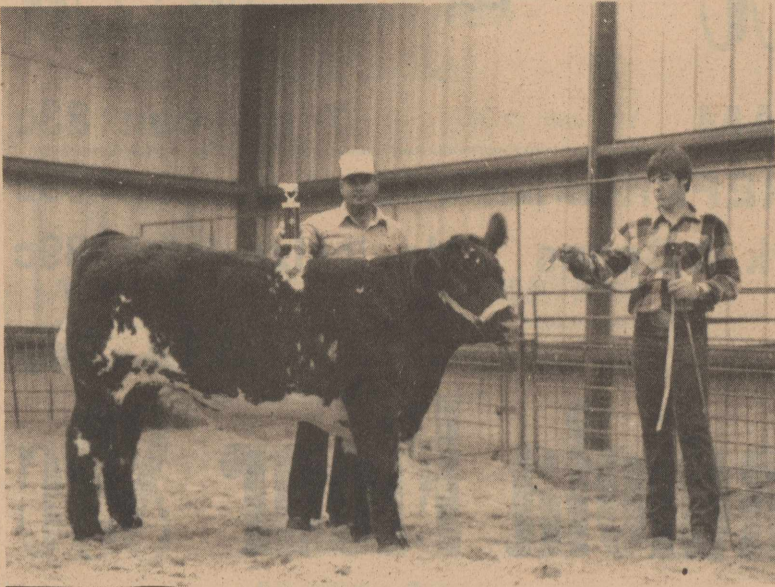

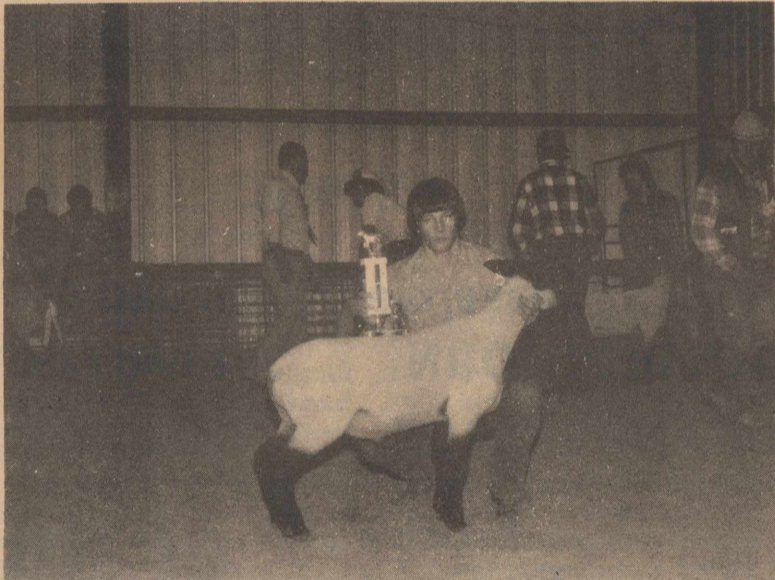

It's just a little black and white sticker unimpressive and unimposing. It just sticks to the outside of a refrigerator. But it could save your life.

The sticker is a part of the "Vial of Life" program to be started this month by the '64 Study Club.

It reads, "Emergency Medical Information, Vial of Life." That message indicates that inside your refrigerator is a bottle containing important medical information about you or a member of your family.

In an emergency, police, firemen or Emergency Medical Service paramedics will see the sticker and be able to quickly get the information they might need, information you might not be able to tell them.

The idea originated with diabetic patients who felt they needed some way in emergencies to convey their medical history. The program operates in 34 states.

Sponsoring the program with the '64 Study Club is the Coke County Pharmacy. The program will be available, free of charge, to anyone who is interested and has need for the service.

The form inside the vial, which is placed on the top right hand shelf of the refrigerator, details everything from name to medica-

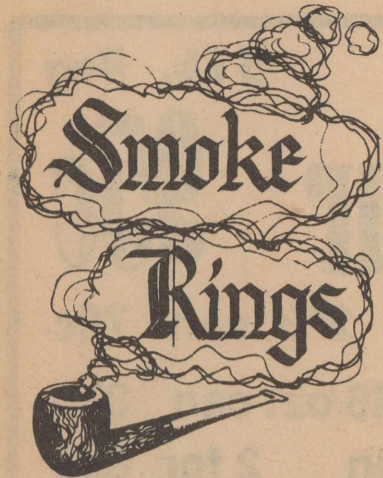

Conservative Denver, Colo. attorney James G. Watt has been roasted by extreme conservation groups since the day President Ronald Reagan made it known he wanted him for Secretary of Interior.

For more than a month, many of the country's largest conservation groups -- including the Audubon Society, the Sierra Club, Friends of the Earth and the Wilderness Society -- have tried to rally enough support in the Senate to block the nomination. Not since Richard Nixon nominated Walter Hickel in 1969 has the selection for interior drawn such fire.

Why? The environmental groups want to paint Watt as a man whose entire career makes him unsuited to act as chief custodian for the 700 million acres of parks, wilderness areas and other public lands managed by the Department of Interior.

These groups focus their criticism on Watt's role for three years as head and chief legal officer of Mountain States Legal Foundation. That 10-attorney foundation has specialized in fighting a variety of environmental regulations proposed by the Interior Department and other government agencies.

These environmental extremist groups charge the foundation's board of directors and chief contributors read like a Who's Who of Western mining, oil, timber and real estate interests. They contend that under Watt's leadership, the foundation became one of the foremost advocacy groups for private exploitation of public lands.

One writer suggests Democrats as well as Republican moderates should ask, set a goat to guard the cabbage patch?

Well, I object to these many challenges. It seems the cabbage patch has been so grown up in goat heads for so long the American people can't get to the cabbage.

For over 10 years, I was editor for the Texas Sheep & Goat Raisers' Association and was employed by the National Wool Growers and American Sheep Producers Council handling spec-

ial assignments in Texas and Colorado. Many times I have toured public lands where sheepmen and cattlemen herded their livestock like they did for centuries. And let me tell you, those lands were more balanced by the grazing of animals.

Since the many public lands have been "turned back to wilderness and nature walks" we have seen uncontrolled fires break out and destroy more acres than the environmental groups could count.

Protecting the predators in these areas have put more ranchmen out of business. I see in James Watt an opportunity for sheep and goat and cattle raisers at least to have an audience before the government. It will give us a chance to let it be known that the largest industry in the world - agriculture - is in serious trouble because environmental extremists have had their way too long.

I remember a bumper sticker we put out some years back to promote lamb. "Eat more lamb--100,000 coyotes can't be wrong." Too long it has been sheep and goat numbers on the extinct list instead of the national bird.

Also under fire are Watt's thoughts concerning the private exploitation of public lands. Think about that a minute. Why shouldn't we? After the coal or whatever is extracted from the earth, the land is re-soiled, re-seeded and in a few years appears natural again. Why not acquire our own energy and develop our lands and be less dependent of the expensive foreign products.

If President Reagan follows the dictates of the people when they gave him the landslide election last November, he is going to need a number of James Watts on his team.

Help Available On Fuel Costs

The Home Energy Assistance Program (HEAP) is designed to assist low income Texans in paying for the increasingly high cost of energy necessary for the heating of their homes. Cash benefits will be provided to eligible households in the form of a State (warrant) check mailed directly to the household.

Coke County is contracting this program for Coke County citizens. Persons who think they are eligible for this program should come by County Judge D.W. Sims office between 8 a.m. and 5 p.m., Monday through Friday and fill out an application form. If you cannot get to the office phone an application can be mailed to your home, You have from Jan. 5, 1981, to Feb. 28, 1981, to sign up for this program.

Federal regulations require HEAP information activities be directed toward the priority low-income households, with elderly, ill, handicapped or homebound individuals, non-English-speaking households, migrant laborers, and young children.

EMPLOYERS MUST PROVIDE TAX STATEMENTS BY FEB. 2

Employers must provide each employee with a completed Wage and Tax Statement, Form W-2, for 1980 by February 2, 1981, the Internal Revenue Service says.

If the Wage and Tax Statements are not issued on time, employers may be penalizing employees who will have to wait until February or later to file their tax returns, possibly missing out on the faster refunds available to early filers.

For additional information on the proper distribution and handling of Wage and Tax Statements, employers may get a free copy of IRS Publication 15, "Circular E, Employer's Tax Guide," from the IRS.

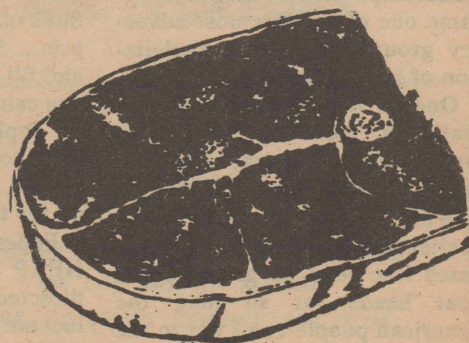
