The first phase of the water care of financial matters. system consists of approximately 50 miles of line which has been laid west and southwest of Robert Lee. Residents of the area around Lake Spence and on both sides of Highway 158 will be served by the project.

The first meeting of the Coke County Water Supply Corporation was held Oct. 2, 1975. The was in charge until a chartered organization could be formed, consisted of Don Fields, chairman, Floyd Harmon, Bobby Roberts and Fred McCabe Jr. These men and others spent long hours in forming an organization.

Mrs. Rowena Raindl, bookkeeper and acting secretary, said, "A big thanks goes out to all members for their time spent and we want to give Don Fields a special thanks for all his long, hard, free hours spent on the project.'

Phase I was built with the help of the Farmers Home Administration. A \$250,000 grant and a \$250,000 loan were approved to get the job going. Later another loan in the amount of \$187,300 and another grant of \$108,300 were approved to finance the project to completion.

William E. Fox was hired as engineer for the project, but due to his death more work was required in setting up records and hiring another engineer.

On Jan. 10, 1980, the final bid on the project was awarded to R.T. Swilling & Sons, Inc., of Whitney. Yeatts & Decker was employed as engineer and Clyde Watts named superintendent. The project got to going full swing on May 20, 1980, and the


begin the second week in February and completion is to be in approximately five months. Projected cost of the new structure is \$225,000. The church already has raised \$180,000 of this amount.

Cong. Tom Loeffler Appointed **To Powerful House Committee**

WASHINGTON-Second-term U.S. Congressman Tom Loeffler today was formally appointed to the prestigious House Committee on Appropriations, the first Republican from Texas in history to sit on the powerful committee controlling the federal purse strings.

Loeffler, recently appointed Deputy House Republican Whip by Congressman Trent Lott, will relinquish his seat on the Committee on Energy and Commerce to assume his responsibilities on the Appropriations Committee. In announcing his new

assignment, made official today by the full House Republican Conference. Loeffler said he would now have an opportunity to help shape policy across a whole range of issues.

Serving on what was formerly the Interstate and Foreign Commerce Committe." Loeffler said. "primarily I worked on energy, transportation, and communications issues, all of which are extremely important to the people of the 21st Congressional District.

On the Appropriations Committee. I will continue to work on responsibe policy in these areas. but also expand my legislative activities in such areas as defense, agriculture, and foreign policy because each of the Federal departments and agencies must present their budgets to the Appropriations Committee for funding.

"I believe those of us on this important Committee, and certainly those of us in the leadership must direct all our energies to the clear expression of American people for a halt in the growth of Federal spending." Loeffler said that the Republican House leadership would be working hard for the implementation of the Reagan Administration's legislative agenda, "first and foremost which must and will be the restoration of a sound economy and a national defense second to

"One of my main objectives as a member of the Appropriations Committee will be a comprehensive review of funding for all of the Federal agencies. If we are to balance the federal budget -and I am committed to this objective -- then we must look for areas where spending can be reduced or halted in a responsible manner. At the same time. we must also assure that spending levels in such critical areas as defense are adequate to meet our security needs.

"I look forward to this new assignment with great anticipation. The 97th Congress faces many challenges -- and many opportunities. Those of us in the Republican leadership will be working hard to change the direction of national policy to the more conservative, responsible form of government those of us in the 21st Congressional District

1980 IRA CONTRIBUTIONS ARE STILL ACCEPTABLE

Eligible workers have until April 15, 1981, to make contributions to their Individual Retirement Savings Arrangements (IRA'S) and still claim them as deductions on their 1980 Federal tax return. However, if they request an extension to file their returns, they have until June 15. 1981, to make their contributions, the Internal Revenue Service savs.

Eligible employees are allowed up to \$1,500 in contributions to an IRA. Since penalties are assessed for excessive contributions taxpayers should be careful to closely calculate the amount of the contribution

IRA's are taxpayer-initiated retirement plans set up by workers not covered by qualified pension or retirement plans where they work. IRA's are also available to non-working spouses of eligible workers, the IRS adds. Banks, insurance companies. credit unions and other financial institutions can provide assistance in setting up and maintaining IRA's. Detailed information on IRA's is contained in IRS Publication 590, "Tax Information on Individual Retirement Arrangements." available by mail by using the order form in the tax package, or by calling the IRS forms/tax information number listed in the local telephone directory.

Dependent Can **Be Claimed By Only 1 Person**

If you share responsibility for the support of an aged parent. here's an important tax tip. Even though several persons may together contribute over half of a dependent's support, a dependent can be claimed as an exemption by only one taxpayer.

If no one person in a family contributes more than one-half of the cost of supporting an individual. the group should choose one of its members to claim the exemption. Usually the taxpayer who paid the most in support is the one receiving the exemption. However, that taxpayer must bns have contributed more than 10 percent of the total support and must meet all other dependency tests.

The remaining contributors in the group must complete and sign Form 2120, "Multiple Sup-port Delcaration," stating that they will not claim the exemption that year. The forms are filed with the income tax return of the person claiming the exemption.

Shaw Happy With Assignment

Spring) said Wednesday that he is "very happy" with his assignment to the Elections Committee and the Environmental Affairs Committee for the 67th Legislature.

The committee assignments were announced Wednesday morning by the office of House Speaker Billy Clayton.

'I had no idea what to expect." Shaw said. "I had visited with the Speaker recently. and when he asked me if I had a preference, I told him I was especially interested in the water situation in West Texas and that I would just trust his judgment on the committee assignments. He must have been listening--the Environmental Affairs Committee assignment is right up my alley. We've had some water problems in our district, and that's precisely the sort of thing this committee will be dealing with.

"The Elections Committee should be very interesting, too," Shaw continued. "We'll handle the presidential primary legislation, and we'll be responsible for handling an extensive package of proposals to clarify exactly what a candidate or office holder can or can't do under the ethics laws Also. I understand we're going to be working on a complete rewrite of the Election Code. In fact, I've already started work on a bill to correct the situation we had in District 63 last November when the taxpayers had to pay for a special election to fill the vacant seat three weeks after I had already won the general election. That was such a waste of money. In the future, I think it should be set up so the winner of the general election automatically fills the vacancy by taking office immediately instead of putting everybody through the expense

BONUS YEAR FOR POISONOUS PLANTS

1981 looks like a bonus year for poisonous range plants due to last summer's drought followed by a wet fall, according to a range specialist with the Texas Agricultural Extension Service. However, ranchers can keep livestock losses to a minimum with sound management practices. These include moving livestock to weedfree pastures where possible, controlling weeds with chemical or mechanical methods, and proper supplemental feeding. Planned grazing systems that offer periodic rest for pastures can boost forage quantity and vigor, thereby reducing the availability of poisonous plants.

If your first thought was "Well, I can't help" you are 100 percent wrong.

There are definitely ways in which you can help. For example:

1. The volunteers of the West Coke County Ambulance Service (EMS) announced the date for the start of the Emergency Medical Technician (EMT) course to be offered in Robert Lee.

Registration will be held at 6:30 p.m. Monday, Feb. 9. Classes will be held from 6:30 -10:30 p.m. each Monday and Thursday.

For volunteers willing to sign up to serve at least a year on one of Coke County's ambulance services, the county will pay \$100 toward the cost of the course. The textbook charge of \$12.50 will be paid by the student.

5. You can help us spread the word that our service is all VOLUNTEER. This means that all personnel serving on the ambulance donate their time and receive no pay for any duties they his does NOT mean erform the ambulance service is free since there are expenses with vehicle maintenance, gasoline, supplies, etc. It DOES mean our cost is much less than would be the case if the personnel had to be paid for their time. He was a member of the Methodist Church and had been a member of the Masonic Lodge




No. 853 in Stamford since 1945.

MISSION FLY PLANT IS CLOSING

Significant progress toward eradication of the costly livestock pest, the screwworm, is the prime factor in shifting production of sterile flies from the U.S Department of Agriculture's Mission Laboratory to the larger and newer fly plant at Tuxtla Gutierrez, Mexico. A small administrative and maintenance staff, along with lab identifiers of worm samples, will remain at Mission after the March 6 closing. This staff will be ready to re-activate the plant in a matter of two weeks, if circumstanc s make it necessary, says the USDA.

WOOD DECAY IN HOMES

Lumber, plywood and other wood products used in construction are all subject to wood decay that can lead to structural failure and expensive repairs. The best control of wood decay is keeping wood products dry in manufacturing, shipment and use, says a wood products specialist with the Texas Agricultural Extension Service, Texas A&M University System. Most decay problems result from basic construction faults that allow excessive moisture to enter a house from the ground level or from rainfall.

Reagan and I go back along way. When I was editor for the Sheep & Goat Raiser magazine, he was at College Station with the Extension Service. He is the father of a small community renewal in Texas, a project I have pushed with every ounce of energy since my youth of growing up on a Hill Country ranch. We both worked for former Texas governer Dolph Briscoe and now we both work for the advancement of farmers and ranchers in the Lone Star state.

Mr. Brown was in San Angelo recently speaking to the Mohair Council of America membership meeting. And he reported some 8.7 million pounds of mohair was produced in Texas during 1980. That figure was down slightly from the 1979 figure of 9.3 million pounds and I would guess the decrease is largely due to the increase of predators. A producer survey indicates the average price for mohair averaged \$3.45 per pound for 1980.

Brown addressed the labor problems in ranch country and suggested President Reagan and his administration might look into the 'wetback'' programs. 'We've got to have adequate labor but farmers and ranchers must also maintain profitable operations,'' he said.

He also cited the fireant problem and said: "the fireants are moving westward from East Texas at a rate of 30 miles per year." I was the first Texas journalist to introduce fireants to Texas in print. I remember 15 years ago viewing their giant mounts in Louisanna as the dangerous little things were on the move toward the Texas border.

"We have determined that 1 percent of the population is susceptible to death from fireant stings," explained Brown.

Quickly turning to other reports by Commissioner Brown, he reported a trip last year in Japan, Taiwan and Korea by MCA representatives produced positive results. "Foreign exports of Texas mohair doubled in 1980," he added.

He spoke briefly of his meeting with new U.S. Agriculture Secretary John Block of Illinois. "He's a hog farmer who knows a lot about our problems," he said. "He's going to be sympathetic to the farmers and ranchers and I think he will turn things around. He's a mover."
