#### Award Winning Film To Show Here July 12

"No Longer Alone," winner of three prestitious film-industry awards, will be shown on Sunday, July 12, at the Robert Lee Baptist Church. The showing, open to the public free of charge, is scheduled to begin at 7 p.m.

The film, a true story, takes a close look at a woman who was searching desperately for love and acceptance, but whose cries went unheard by those who surrounded her.

Originally released by World Wide Pictures in commercial theatres, the film is now one hour in length in preparation for its eventual presentation as a television special.

'No Longer Alone' traces the life of and English actress, Joan Winmill Brown. Though she skyrocketed to fame on the British stage, her life was marked by a frantic grasp for personal fulfillment and love. Tormented by a past she was unable to forget, she succumbed to a series of nervous breakdowns; and, at one point, attempted to her own life. In her ultimate moment of despair, Joan was invited by a "chance" phone call to attend a Billy Graham crusade. It was here that she first discovered her worth as an individual and began her long struggle to piece her shattered life back together.

Those who have followed Billy Graham's ministry will be interested to know that Dr. Graham appears in the film in some of the footage of his 1954 London Crusade, and also in the introduction and conclusion to the film, photographed recently for this special version.

No Longer Alone was filmed in color on location in London, and stars Belinda Carroll, Wilfrid Hyde White, James Fox, Samantha Gates, and Gordon DeVol. Simon Williams, who has one of the leading roles in the BBC production, "Upstairs, Downstairs", also stars in the film. The title song was perfomed by the popular recording artist, B.J. Thomas.



## **Commissioners Talk About Road**

Coke County Commissioners
Court met Monday at the courthouse in Robert Lee and heard a
report by County Attorney Bill
Helwig on the opening of a road
in Precinct 2 which was closed in
1963 when flood control dams
were built on the Kickapoo
Creeks north of Bronte.

Cecil Coalson met with the commissioners on June 1 and requested that the road be reopened. L.W. Duncan also met with the commissioners and opposed the reopening.

Judge D.W. Sims said Tuesday that the commissioners are considering all aspects of the matter and had a long discussion. However, no decision was reached and the matter will be considered at a later meeting. "I feel the commissioners want to attend this matter in an orderly manner," Judge Sims said, "and they are looking at all sides of it."

Ulmer Bird, chairman of the Coke County Historical Commission, met with the court and presented some of the interests of that organization. He noted the needs of the county in the preservation of historical relics and sites and other matters

STATEMENT OF INTENT TO CHANGE RATES

On April 28, 1981, the Public Utility Commission of Texas issued its order in Docket 3690, creating a separate Docket 3861 to consider the impact and effect of the accounting changes ordered by the Federal Communications Commission (CC Docket 79-105).

The Federal Communications Commission has changed the method of accounting for inside wiring costs associated with the one-time station connection, move, or change activity. The new rate schedule will increase the Company's gross annual revenue derived from local service by no more than three percent.

The schedule of rates and charges is available for inspection at each Company business office in the State of Texas.

county. Judge Sims reported to the commissioners that he had received two bids on the installation of galvanized cans (culverts) at a crossing on Sand Creek about 3.6 miles south of Silver. A low water crossing was built after the old bridge across the creek was found unsafe. However, the crossing has been heavily damaged by rains of the past several months and the commissioners feel a lasting solution should be found. The crossing is in Precinct 1.

The judge also gave a report on a school to be set up by the Concho Valley Council of Governments, which possibly could take the place of the present alcohol and drug program the county now has with Tom Watson of Sweetwater. If the change is feasible, the judge said, it could save the county about \$2400 a year.

The commissioners approved bills for payment before adjourning.

# **Highway Work Slated For Coke**

The State Highway and Public Transportation Commission has approved the 1982 Rehabilitation and State Highway Safety and Betterment and Farm to Market Road Improvement Program at an estimated cost of \$218.9 million

The program includes improvement and rehabilitation of 5,33-5.3 miles of state-maintained highways. In all, there are 892 separate projects in 214 counties of the state.

The work includes projects which will upgrade existing highways to handle heavier volumes of traffic, enhance safety, reduce the amount and kind of maintenance necessary and to protect the large public investment in the highways of Texas.

Almost 70 percent of the work is on US and State-numbered highways in Texas with the remainder being on FM roads.

District Engineer D.R. Watson, of San Angelo, said the work in the Coke County area is part of the statewide effort to modernize roads and highways which are worn out or inadequate for today-straffic. The projects for this county includes:

State Highway 208 from FM 2662 to the Tom Green County Line, a distance of 7.0 miles, recondition and surface shoulders.

State Highway from the Nolan County Line to U.S. 277, a distance of 5.0 miles, seal coat.



Those changes--new limits on the size of contributions to candidates for federal office, a tightening of the comtribution reporting requirements, and a new state law outlining specifically how political action committees (P-ACs( must be set up and administered--resulted in an explosion in both the number and the size of

PACs formed by business and

professional associations and oth-

er special interest groups. Prior to these changes, a few associations had political committees but the law was so vague that the legal questions discouraged many groups from setting up their own PACs. Once the guidelines were set down in the law, PACs proliferated rapidly until, today, and group or company with a lobbyist also feels obligated to have a PAC to help out friendly candidates. PACs now account for as much as 80 percent of the money contributed

to some campaigns. This year, because of the increasing influence of PACs, I sponsored a bill to expand the campaign reporting requirements of these "committees." My bill, along with several other campaign finance bills, was combined by Speaker Billy Clayton into a single "omnibus ethics reform bill," and I'm pleased to report that it passed.

Currently, PACs are required to report only their treasurer's name, the name of each contributor and the amount given, and the amount contributed by the PAC to each candidate. My bill (and the omnibus bill) will require PAC reports to also include: (1) the occupation or employer of each contributor, (2) the treasurer's address and phone number, and (3) the name of each corporation, union or association that provides administrative support or cosigns or assists the PAC in obtaining credit or determines which candidates receive contrib-

Other provisions in the omnibus bill will: (1) prohibit legislat-

Nothing has had greater impropers from accepting campaign contributions during a legislative session or during the 30 days prior to a session, (2) prohibit cash contributions larger than \$100, (3) strict rules specifying when a campaign donation is considered to be officially accepted and a deadline for returning a donation that is rejected or declined, and (4) establish a 15-member Ethics Advisory Committee to issue guidelines on the conduct of public officials and make recommendations on ethics legislation to the next regular session of the Legislature.

# EXTENSION

Are you one of the 35 million Americans taking unprescribed vitamin supplements? There are many times when vitamin supplements may be necessary but a proper diet rarely needs the supplement. Those times when a supplement is needed usually involve cases in which there is a sub-normal intake of food.

Physicians may prescribe vitamin supplements for patients more than 65 years of age or for some expectant mothers or for some mothers breast feeding their infants. Other instances include malabsorption or an acute illness which decreases the appetite.

Massive doses of vitamins and minerals reach beyond the realm of nutritional therapy. This practice, then, becomes drug Therapy, and it requires the supervision of a physician.

Excessive amounts of the fatsoluble vitamins (A,D,E and K) can be toxic (poisonous), because these vitamins are stored in the

The term "megavitamin therapy" refers to treating the person with doses of vitamins a thousand times greater than the requirement for those vitamins as set forth by the Recinnebded Dietary Allowances of the national Food and Nutrition Board. Again, this massive-dose therapy requires a physician's supervision for safe-
