Things have not been all love and light the past week in regard to the tax appraisal situation in Coke County. A large number of citizens have expressed disagreement with the valuations determined by the appraisers, the McMorries Co., and are seeking some kind of redress in an effort to have the property values lowered.

A meeting was held Sunday afternoon in the home of Mr. and Mrs. Cumbie Ivey Jr. in Robert Lee to discuss the strategy for getting some changes made.

A second event transpired Monday morning when an emergency meeting of the Coke County Commissioners' Court was called. A number of property owners were present and asked the commissioners to use powers of their office to force another look at property values.

## R-Lee Receives 2.65 Inches of Moisture Wed.

The Robert Lee area received some good rains Tuesday night and Wednesday morning, giving a boost to crops and growth of grass and cover crops in pastures.

Robert Lee missed the Tuesday afternoon and night rains, but the bottom fell out about 5 a.m. Wednesday. A total of 2.65 inches was recorded over a short period. There was a colorful electrical display, but no damage was reported from wind or hail.

Bobby Baker reported the heaviest rainfall in the area. At his place in the Wildcat community, he received 3 inches Tuesday night and another 1½ inches Wednesday morning for a total of 4½ inches.

J. P. James reported 1.90 inches at his place in the Silver area.

A small amount of moisture fell later Wednesday morning, but clouds were getting thinner by noontime.

the complaints, the board arrived at a final figure and approved it late in the day.

However, that meeting is thought to have been in violation of the Open Meetings Law, and has been rescheduled for Thursday, Sept. 10 from 1 to 8 p.m. A public notice concerning the rescheduling is being run in this newspaper.

Meanwhile, the citizens who are seeking lower valuations have been busy. A public mass meeting was scheduled for last night (Thursday) at the courthouse to make plans for opposing the action of the board of equalization in approving the tax roll. Since the meeting was called after last week's papers were printed and before this week's papers came out, the group had 1,000 circulars printed and distributed urging everybody to attend.

Some relief was given by the McMorries appraisers when they allowed a 15 per cent across-the-board reduction in valuations of property in the city limits of Robert Lee and Bronte. The opposing group says, however, that 15 per cent is not enough. County Judge D. W. Sims, speaking for the commissioners' court, said their "motive in taking the action is to be assured our taxpayers are assessed fair market values for Coke County." He said they were not talking about values in San Angelo or Dallas or any other place, except Coke County.

"We certainly are not casting any stones at the board of equalization," the judge said. "We simply want to see that our taxpayers get assessed at a fair market value."

Small businessmen in the county have expressed serious concern that the forced increase in taxes will force them to close their doors. Officials have stated that persons who own residential or business property in the two cities will be the ones who will bear the burden of the highest increase in taxes.

Rural properties, for the most part, are being valued on the basis of production, rather than market value, and increases are not as great as on city property. Oil and gas properties will enjoy a considerable decrease in taxes, compared to what they have been paying for years, it has been reported.

School taxes for those living in the City of Bronte probably will take the biggest jump of all, since property valuations in the district have not risen as rapidly as they have on the west side of the county.

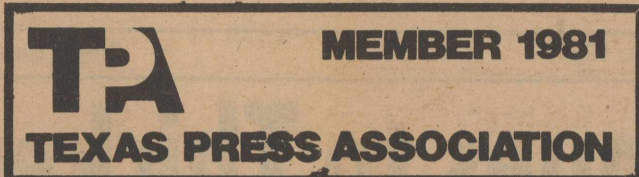
It has been reported that Lynn County rejected figures set by an appraisal firm and used local appraisers to re-value all property in the county. The Texas Supreme Court also has ruled that local appraisal valuations take precedent over those made by outside firms. The reason

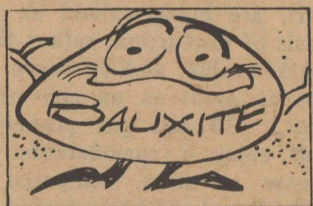

**Midland Men Drown Aug. 29 At Lake Spence**

Two Midland men were drowned Saturday afternoon, Aug. 29, at Lake Spence. The accident occurred in the Wildcat Creek picnic area about 2:30 p.m. The men who lost their lives in the accident were David L. Hardin, 40, and James Clifton Clark, 53, both of Midland. According to officers who worked the case, one of the men either fell or jumped into the lake and the other jumped in to try to rescue him. One of the bodies was recovered in a few minutes and the other was recovered in about two hours in 25 feet of water. The points of recovery were within five feet of each other. Investigating and conducting the rescue operations were Royce Hood, lake patrolman; Mike Ross, lake superintendent; Johnny Page, lake patrolman; Sparks Burdett, game warden; and Sheriff Marshall Millican.

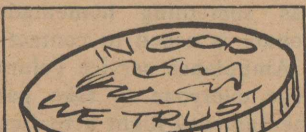

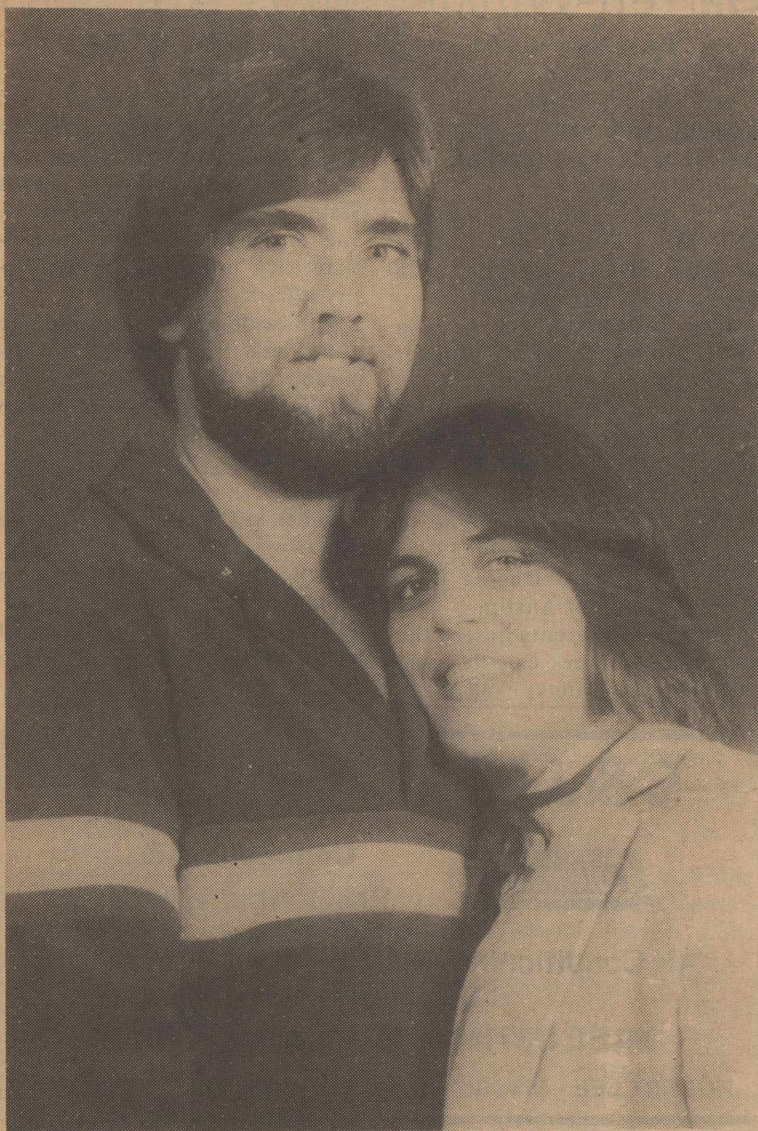

## REDESIGN KEEPS SUN GAS JAMESON PLANT IN TOUCH

Improved recovery techniques and increased drilling for oil and gas are once again helping Sun Gas Company's Jameson Gas Plant adapt to new business opportunities.

A \$4.5 million redesign of the old plant in Coke County has increased liquids recovery from natural gas brought to Jameson by gathering lines covering 200 miles of West Texas. The liquids are separated from raw gas by a series of pressure and temperature changes. The new plant design uses a molecular sieve drying process and expansion-type cooling system instead of the less efficient oil absorption process. The more efficient equipment allows better recovery of ethane (from 48 to 85 percent), butane and propane (from 92 to 100 percent).

The project was made possible because the price of ethane has increased from 2 to 30 cents per gallon since 1965, the last time Jameson expanded. The Jameson Plant is designed to remove nearly 350,000 gallons of natural gas liquids from 50 million cubic feet of gas daily. Residue natural gas

is sold to interstate and intrastate gas pipelines, and liquids are distributed to local markets by truck and pipeline.

When Jameson was built in 1949, the growth that has become the plant's trademark was hard to imagine. Originally, Jameson was designed to reinject gas into oilfield reservoirs to maintain pressure while producing oil. Gas sales commenced about 28 years ago, with a 1953 contract to Lone Star Gas.

Initially, recovery of liquids was accomplished by propane refrigeration. As the market for propane improved, the process was improved. In 1965, modifications allowed the Jameson plant to recover and sell ethane.

While some predicted Jameson to shrivel and die by the 1980s, improved gas prices have stimulated a new wave of drilling--producing new supplies for the 40-acre plant to process. The latest expansion is another tribute to the longevity and growth of the Jameson Gas Plant.

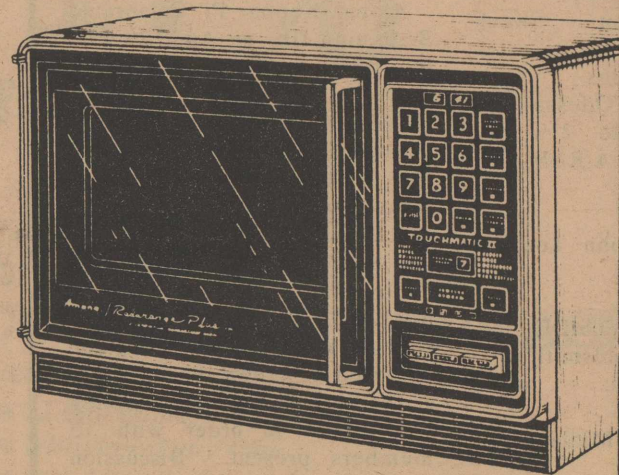

## EPA REQUEST FOR PUBLIC COMMENT ON MODIFIED PSD PERMIT FOR SUN GAS COMPANY, SILVER, COKE COUNTY, TEXAS

Sun Gas Company, 2525 NM Expressway, Oklahoma City, Oklahoma 73112 is currently permitted to construct two 1200 horsepower and one 600 horsepower natural gas-fired internal combustion compressor engines at their existing Jameson Gasoline Plant located one mile south of Silver, Coke County, Texas. The company has submitted an application to modify this permit to the U. S. Environmental Protection Agency (EPA) pursuant to the requirement for Prevention of Significant Deterioration (PSD) of air quality in the Clean Air Act, 42 U.S.C. 7470, and regulations promulgated by the EPA in the Federal Register on June 19, 1978, and amended August 7, 1980. The EPA is proposing to modify this permit (PSD-TX-372) and is hereby extending the opportunity for comment concerning the following proposed modifications.

Sun Gas Company is currently permitted for the emission of nitrogen oxides from the three compressor engines described above. Sun has requested that the present permit be revised to reflect their proposed replacement of the 600 horsepower compressor engine with a 1200 horsepower compressor engine. The project will result in a significant net emissions increase of nitrogen oxides (52 tons per year). In addition, Sun has requested the removal of the permit condition requiring the use of oxygen flue gas monitors.

EPA has determined that the proposed installation of the 1200 horsepower engine will not violate the National Ambient Air

Quality Standards (NAAQS) for nitrogen oxides and is therefore proposing to approve Sun's request for a modified permit. EPA has also determined that the removal of the oxygen flue gas monitor requirement is acceptable and is replacing this requirement with the requirement for a monthly check and adjustment of the air-to-fuel ratio.

A PSD Increment Analysis was not required for emissions of sulfur dioxide or particulate matter from the proposed project since the project will not be a significant source of these pollutants.

The changes proposed to the permitted project are not expected to have a significant adverse impact on visibility, soils, vegetation or air quality in the area of the proposed project nor in any PSD Class I area.

given for the ruling is that local appraisers know more about local values than outsiders. Three West Texas counties which have either rejected outside appraisal figures, or have used local appraisers from the start, include Crockett, Sterling and Garza.

Judge Sims emphasized that the Coke County Commissioners' Court needs the active support of everybody in the county who is against the appraisal figures listed on the new tax roll. "If we are to have a chance of carrying this matter to a successful conclusion, we must make it known that the citizens of the county are behind us (the commissioners' court)," the judge said.

"The county officials need the support of every taxpayer who feels these values are too high or unequal," Sims added.

Sims said his personal position is: "I am of the opinion that the appraised values for Coke County are too high and may even endanger our local economy. I believe we would be wise to follow some other counties' examples and have our local appraisers revalue the properties in Coke County."

With the meeting which was to be held last night by those opposed to the appraised valuations and the meeting of the board of equalization next Thursday, there may be some eventful developments by this time next week.
