Man Killed in Rig Accident **Near Silver**

A 36-year-old white male was killed in an oil rig accident about 4:15 p.m. Saturday, Sept. 19, on the Wimberly lease about one mile south of Silver. The rig belongs to Swanson Drilling Co. of Electra.

Sheriff Marshall Millican said he is withholding the name of the victim, since he has been unable to locate the man's fam-

The sheriff said the man was hit in the head by elevators on the rig when a cable broke. The man was pronounced dead at the scene by Justice of the Peace Opal Jacoby. As of Tuesday afternoon, the man's body was still at Shaffer Funeral Home in Robert Lee.

Also injured in the same accident was another member of the crew. John Askins of San Angelo received a severely broken leg and was taken to Shannon Hospital in San Angelo. He remained in the intensive care unit, according to the report released Tuesday afternoon.

Sheriff Millican reported that a house between Robert Lee and Bronte belonging to Cumbie Ivey was burglarized Tuesday, Sept. 15. Approximately \$2400 worth of property was removed from the house by the intruders. However, about \$2000 worth of the stolen items were recovered in San Angelo, part of them from a house and part from an apartment.

A Robert Lee man has been charged with felony theft of livestock in an incident which occurred Sunday, Sept. 20. Dennis Cornell, 20, of Robert Lee was charged with stealing a sheep from the I. A. Bird Ranch north of Robert Lee. The animal belonged to Mrs. Evelyn McKinley.

Sheriff Millican said the sheep was killed and its hindquarters removed. The accused man and some others were discovered cooking the meat over an open fire near Lake Spence by Deputy Sheriff John Paul McGuire.

Cornell was arrested and taken to Tom Green County jail where he remains under \$5,000 bond.

Sheriff Millican also reported that county law enforcement officers have recovered a boat in Midland which was stolen from Lake Spence. Value of the stolen boat was placed at \$4500, Millican said.

New Ambulance Result of Huge Effort by All The Community

The new long-awaited ambulance has arrived in Robert Lee and represents a concerted effort of the entire community in raising the almost \$25,000 cost of the new vehicle. The driving force behind the drive was made up of members of the West Coke County Ambulance Service, who spent hundreds of hours on various projects to raise the money.

The ambulance is a 1981 Ford Collins II van and the total cost was \$24,623.73. Delivery charges were saved by canville to pick up the ambulance. He arrived back in Robert Lee at 5:30 p.m. Thursday, Sept. 17.

equipment for the new emergency vehicle. Estimated cost of the insurance will be \$2200 for this year, and cost of muchneeded equipment will be expensive. A good start on raising additional funds was made at the Coke County Fair last weekend when about \$1300 was raised at the concession stand and from the sale of arts and crafts items.

The new ambulance is a vast improvement over the old 1971 model. It will carry up to four patients, compared to only one in the old vehicle. Other features include three oxygen outlets and wiring for inverture care of newborn infants. There is much more storage space and equipment and supplies are more accessible to the ambulance attendants. An intercom system makes it possible for the attendant to talk with the driver. The ambulance service members plan to transfer the two-way radio from the old vehicle to the new one.

Ambulance service volunteers said they want to thank everyone who helped in any way to raise money to buy the new vechicle. Lots of hours of work and money donations have been contributed during the past 18 months since the fund drive

Incidentally, the new ambulance was called out for its maiden run Saturday afternoon when the EMS was called to an accident scene and a patient was transported to Shannon Hospital in San Angelo.






