### CATTLE.

Steer Trade Was Slow With Values Steady to Easy.

While the local supply of cattle was more than double the number arrived one week ago, it was not above a normal Tuesday average but proved amply sufficient for all demands of the trade. A combined total of 28,000 at five leading points was not above an average for Tuesday but the effect of a big Monday total for the same markets was reflected in the trade tone of today. The proportion of steers on the South St. Joseph market was quite large and was made up mostly of medium quality steers that were not fully fat—a condition that has been the rule rather than an exception for some time. Buyers were out in force but were all disposed to be bearish and it was only on a steady to easy basis of prices compared with Monday, or weak to the lower than close last week that the trade could be got to going. A good class of dressed beef and shipping steers weighing about 1,250 pounds and up went at \$4.40-4.70, but fully fat, smooth quality of the same weight would sell around \$5.00-5.25, light to medium weights of fair to good quality went in a range of \$4.00-4.50 and trashy light killers, \$3.50-4.00 around \$3.00.

MISSOURI LEGISLATURE.

Senate Enacts the Dickinson Bill Fixing Railroad Rates—Anti-Bribery Bill Up Again.

Jefferson City, Mo., Feb. 21.—The senate sent to engrossment the Dickinson bill to give the railroad commissioners power to fix railroad rates.

The senate failed to pass Senator Bradley's bill to require railroads to furnish cars to shippers within 48 hours after they are ordered.

The senate passed Avery's bill providing that in cases of death due to accident the amount to be recovered by the relatives shall be not less than \$2,000 nor more than \$10,000.

The question of forcing a witness to testify in bribery cases is being considered in Missouri and the senate understands that fact.

Senator Clark introduced a bill to make all pipe lines common carriers.

Gov. Folk signed, thereby causing it to become a law, house bill No. 77 which provides that if two-thirds of the qualified voters of a county shall vote to remove the county seat the county court shall appoint five commissioners to select a site upon which the new courthouse is to be built.

Representative Speer's bill providing for a state mine commissioner to have supervision over all the mine inspectors in the state was ordered to engrossment.

The commissioner is to have an office at the state capital and is to receive a salary of \$2,000 a year.

The senate passed a house bill to authorize each of the seven judges of the supreme court to appoint a stenographer to aid in his work.

The salary of each stenographer is to be \$1,200 a year. This bill is now ready for the governor's signature.

John L. Blittinger has asked the house committee on appropriations to recommend an appropriation of \$1,000 to erect a memorial tablet of William A. Davis in the St. Joseph post-office.

The republicans are getting up a joint conference of the members of both houses for to-night. The call says they will consider matters of legislation, but the senate is also to be taken up.

Dr. E. B. Clements, of Macon, is here on his way home from Washington, but does not claim authority to do anything for the administration.

SHAFT TO KANSAS SCOUTS.

Topeka, Feb. 20.—The house ways and means committee has reported favorably upon the bill making an appropriation to build a monument to the Forsythe scouts, who fought an Indian battle on Arickaree river, just over the Colorado line.

The bill as originally proposed carried an appropriation of \$5,000, but the ways and means committee cut this to \$2,500.

The reason Kansas is asked to contribute to this fund is that the battle was fought by fifty Kansas scouts under the leadership of Colonel George A. Forsythe, in the year 1868.

The Kansas appropriation will not become available until the Colorado legislature has made a similar appropriation. The proposed monument will be located at the Beecher Island Memorial park, which has been created by Colorado at the scene of battle.

SAW VENEZUELEAN BEEVES.

National Provisioner: The Venezuelan cattle trade which was to have been diverted to the United States has not as yet turned this way.

There are excellent business reasons for this. In the meantime, however, Venezuelan cattle are finding their way to Cuba.

The Norwegian steamer El Carmelita has made several trips from Puerto Cabello to Cuba with cattle. Her last trip was made towards the end of December.

She arrived in Cuba with 1,200 head of beeves without losing any of them. This ship is especially fitted and designed for carrying livestock.

A good judge of cattle saw some of these Venezuelan stock and said that they were only fit for ranch purposes. They would not suit the American market until improved.

The stock were either small and chunky or tall and angular.

UNITED STATES SUPREME COURT SAYS THE STATE GRAIN DEALERS' ASSOCIATION IS A TRUST.

Washington, Feb. 21.—The validity of the Kansas anti-trust law was upheld by the supreme court of the United States in the case of Edmund J. Smiley, plaintiff in error, vs. the state of Kansas.

Smiley in 1900 was secretary of the State Grain Dealers' association and the allegation in this case was that he organized the wheat dealers' in the town of Biron, Rush county, into a trust to control the price of wheat at that place.

The supreme court of the state sustained the prosecution against him and Justice Brewer's opinion upholds that verdict.

He based his decision on the ground that the law was in harmony with the power of the state to control its own police affairs and therefore not antagonistic to the federal constitution.

KANSAS LAW UPHHELD.

Congressman Baker Takes Exception to President's Message of Sympathy Over Sergius Affair.

Washington, Feb. 21.—There was a digression from the debate upon the naval bill in the house when Mr. Baker, of New York, criticized President Roosevelt for sending to the Russian government a message of sympathy on account of the assassination of Grand Duke Sergius.

Mr. Baker declared that no such message had been sent when the massacre occurred at St. Petersburg on January 22.

"I deny," he vehemently asserted, "that the American people are shocked by the 'Blime of the Grand Duke Sergius.' The people, he insisted, were, however, shocked 'at the wanton massacre on January 22'."

FOSTER MAKES DENIAL.

President of Indian Territory Oil Company Says Rockefeller Has No Stock in His Concern.

New York, Feb. 21.—H. V. Foster, president of the Indian Territory Illuminating Oil Company, which owns lease of oil lands in the Osage Indian reservation, made the following statement: "The Standard Oil company does not own or control a single share of stock in the Indian Territory Illuminating Oil company.

The controlling interest in this company is owned by the original lessees and there is no agreement or understanding between the Standard and this company as to its policy or management."

MORE SECRETS OUT.

Witnesses Before Missouri Senate Committee Tell of Deals.

PHELPS WORKED FOR REPUBLICANS

Well-Known Democratic Lawyer of Carthage Solicited Funds to Help Defeat Congressman Benton—Haughwout in Bad Light.

Jefferson City, Mo., Feb. 21.—The senate investigating committee had before it D. K. Wenrick, former postmaster at Joplin, Mo., and Dr. C. R. Woodson, superintendent of the hospital for the insane at St. Joseph.

Wenrick, of Webb City, had given Thomas Wout, of Webb City, had given Thomas A. Atkins \$100, but he said Haughwout had contributed \$50 to the republican campaign fund.

Wenrick testified that he had received about \$15,000 as postmaster and had contributed in all a sum of about \$1,400 to republican campaign funds.

Dr. Woodson testified regarding contributions of employees to democratic funds, and said they were made voluntarily. He denied that an employee of the hospital had been dismissed because of refusal to contribute, but asserted that "she had been discharged because she was disreputable with patients."

He admitted that the manager of the stock yards company had contributed \$100 to the democratic fund.

R. E. Lee, deputy warden at the penitentiary, was subpoenaed, but was excused until Wednesday evening.

He was wanted to testify in regard to the distribution of the Folk campaign fund raised by St. Louis business men.

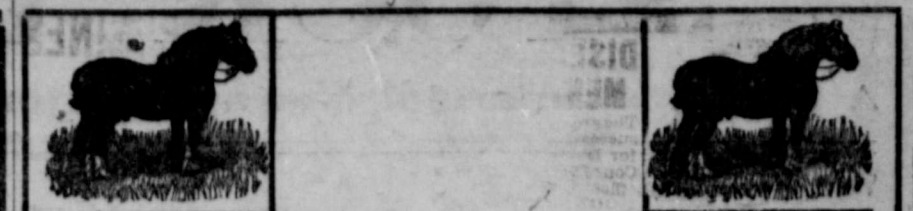

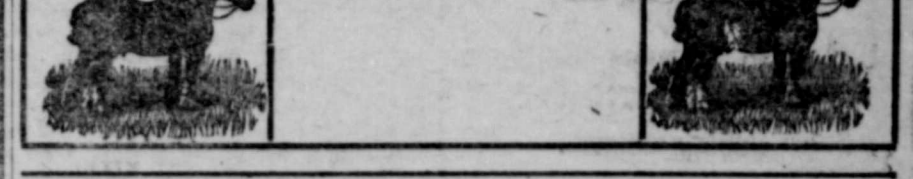
