Lions and 4-H Clubs to Have Annual Pancake Supper Friday

The big annual Pancake Supper takes place tonight in the Robert Lee School lunchroom. Pancakes will be served from 6 to 8 p.m. with entertainment beginning at 6:30 p.m. in the school auditorium. Everyone is encour-

aged to spend the night out and enjoy a supper of pancakes followed by enjoyable music.

Approximately 80 Lions Club members and 4-H parents, leaders, and 4-H members will be busy preparing the supper and hosting the event. Again this year Edna Havins and Addison Davis are heading up the musical variety show.

The meal will be hot buttered pancakes, syrup and bacon, with coffee or milk to drink. The tickets are \$2.00 for children 12 and under; \$3.00 for persons over 12 years of age. Tickets will be available at the door if one of the 4-H members has not already sold you a ticket.

The pancake supper is sponsored by the Robert Lee-Silver Lions Club and the Coke County 4-H Clubs. Proceeds from the supper will be used for community projects by the two organizations.

Judge Smith Is Honored

Coke County was well represented Tuesday night when the Young Democrats of Tom Green County honored Judge Earl Smith. Friends of the judge from over the 51st Judicial District were invited to attend the supper and program in honor of the veteran judge.

There were about 75 persons present with nine from Coke County, including Mr. and Mrs. Cumbie Ivey Jr., Mr. and Mrs. Weldon Fikes, Mr. and Mrs. Billy Joe Luckett, Stover Taylor, Judge D.W. Sims and Bill Helwig.

Rep. Dick Burnett made a few opening remarks. Judge Curt Steib told the group that Judge Smith was being elected to a newly approved appeals court. He said the back log of criminal appeals cases goes back 36, adding that the new position "will be no bed of feathers but a bed of work."

Judge Smith said he came to San Angelo in 1947 and he was always glad to see young people interested in their government. He said he had always been a democrat because he felt "the Democratic Party was the party with a heart."

The judge urged voters to study the candidates before voting. He pointed out the tragedy that occurred when voters elected Don Yarbrough to a high state judicial position purely on his name, as he did not have any qualifications for the job.

Judge Smith urged people to get involved in activities of their party, "because good government depends on good people at the precinct level."

City, School And Hospital Elections Called For April 3rd

Deadline for candidates to file for a place on the ballot in any of the elections is March 3, which is 30 days before the voting.

Contract Let To Build New Catholic Church

McRan Construction Company of San Angelo has been awarded the contract to build the new church for Our Lady of Guadalupe Catholic Mission here, according to Rev. Mark Woodruff, pastor. Groundbreaking for the new structure is scheduled for Sunday, March 7, and construction is expected to begin by the end of the month.

Plans call for a metal building, 30 feet by 60 feet, with a seating capacity of 100. The sanctuary or area around the altar will be especially spacious, in keeping with the new liturgy. Ample room will be provided for the celebrant and special ministers of the liturgy, as well as the choir.

Included in the body of the structure will be a vesting room, a room for the rite of reconciliation (confession), and a study for the pastor.

Central heat and refrigerated air will be installed in the building. At present, it has not been decided which company will receive that contract.

The interior of the building will be finished by volunteer labor from the parish. Several exterior walkways and landscaping will also be completed by parish members.

A number of new furnishings are being donated by St. Rose of Lima Catholic Church in Short Hills, N.J.

Guadalupe Mission has received a grant from the Catholic Church Extension Society of Chicago for \$25,000 toward the construction of the building. Later this month, a parish pledge drive will be conducted by the parish council to receive pledges to the building fund. The building fund has a goal of \$25,000, although some money has already been received toward the overall goal.

Annual Coke County Livestock Show Set For Feb. 19 and 20

An audit of the district's finances was discussed. No written reports of the audit were available, but an oral report indicated that "things are in good shape," the chairman said.

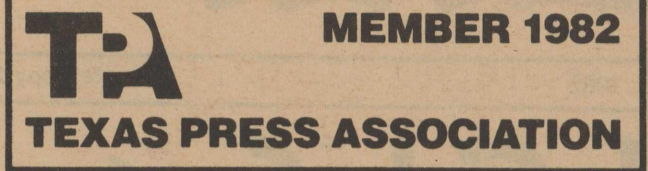

Weldon Fikes Now Retired After 31 Years of Service

On Dec. 31, 1981, Weldon Fikes retired after serving the people of Coke County for 31 years.

He was elected county and district clerk in July, 1950 and took office Jan. 1, 1951. He was reelected twice without opposition. He resigned the clerk position in October, 1955 and was appointed county auditor as required by law for counties having \$15,000,000 assessed valuation.

At the time of his appointment as county auditor Coke County had an assessed valuation of \$29,700,000.

By 1956 three precincts in the county had voted \$427,500 in road bonds to build bridges and pave county roads and streets in Robert Lee and Bronte; \$300,000 to build a new courthouse; and \$130,000 to build county parks in Robert Lee and Bronte. Adding old indebtedness on the hospital and old series road bonds dating from 1929, the county had a total indebtedness of around a million dollars.

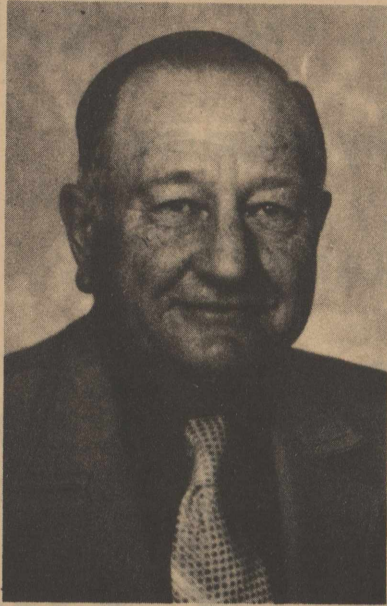
From peak values of \$29,700,000 in 1956 for the next 20 years values declined to 23 million. However, the county was able to retire all bonded indebtedness for new improvements without a tax increase (because the county already was on maximum rate) an raised values only once.

At the present time only bonds to seal coat county roads and city streets are outstanding, these having been voted in 1979 by voters of the county.

Fikes stated, "I have worked with some of the best people in Coke County. This is not only my opinion, but voters have concurred by their ballot."

Weldon was born in Coke County, graduated from the Robert Lee High School, attended Texas Tech University, served four years in the U.S. Army in the North Pacific (Aleutian Islands and Alaska). His wife is the former Bryce Stewart, and they have three daughters, Mrs. Marion Stewart, Midland; Mrs. Farrell Jean Washam, Midland; and Mrs. Elanie Miller, Ft. Worth, and four grandchildren.

During these years he has been active in the County Auditors Association of Texas having served as a director on the Advisory Committee from Small Counties; has been a member of the American Legion Post 381; executive board member of the Concho Valley Council of Boy Scouts of America; served on the

Low Rent Housing Authority; on the board of directors for the Coke County Soil and Water Conservation District; six years on the 44 county Tri-Region Health Services Area; six years on the executive board of the Baptist General Convention of Texas.

Stover Taylor was appointed to succeed Fikes as county auditor and took office Jan. 1.

Sales of Series EE & HH United States Savings Bonds in Coke County were reported today by County Bond Chairman Gerald C. Allen to be \$1,359. Sales for the first twelve-month period totaled \$36,510 for 104% of the 1981 goal of \$35,000.

Texas sales during the month amounted to \$19,354,166, while sales for the first twelve months of 1981 totaled \$252,438,142 with 100% of the yearly sales goal of \$252.3 million achieved.

A recent article in some publication stated that the ice age was returning and the winter of 1982 was nothing compared to what's coming.

If that's true, I know one editor who might entertain the idea of flying south with the birds. I like my winters cold enough to justify a glowing fireplace scene in the den and enjoy sleet and snow only when it appears in those western Christmas card pictures.

Already, snow has paralyzed West Texas in January and the thermometer has dipped to near zero too often. This winter was supposed to be mild for the most part. And I guess it was until almost Christmas, as roses and other annual flowers were blooming until a few days before. I mean plants that normally had been frost bit by Halloween.

However, when mother nature finally opened the north-gate she left it open!

The old Farmer's Almanac predicts a wet February. It states precipitation should range from one to four inches for the month. We are expected to have cold and rainy weather with possible snow several times this month. Each spell will be followed by a warming trend.

Although, moisturewise, West Texas is far short of normal rainfall by this time, the snow and showers have caused oat and wheat patches to liven up. Having turned brown in early January from lack of rain, or possible over grazing, they are green again.

Most all stockmen are calling for more rain from local politicians to congressmen and higher powers. Both sheep and cattle markets are way off, too. This adds another winter worry on top of breaking ice on water troughs and the daily feed rounds.

Matter of fact, many of the local and regional marketing centers have experienced almost double in numbers of livestock being sold at this time. The low prices, the dry and cold winter and fear of higher fee bills is no doubt playing a big part in the decision to sell before spring.

Bert Dennis, who ranches in Borden County said they had a

good snow "but it was not very wet. We need a great deal more moisture," he added.

Bill Shurley said the same thing about Marfa and the Big Bend country.

In the Texas Hill Country where Angora goats are being shorn, there is little ground cover, even of old grass. Supplemental feeding is in progress. Bill Upton had about half of his goats sheared at the Fort McKavett ranch when the January snow and ice spell hit. "The sheared goats did much better than the haired ones," he said.

"I don't understand that," someone said as I retold the story. Well imagine all that hair wet from rain and snow and the temperatures down about eight degrees. That goat is a block of ice. Those without hair can hide under a cedar bush and keep warm.

Well, I am going to try to make the winter and hope the ice age is not returning.

NEW INTEREST RATES, PENALTIES FOR TAXPAYERS

Agricultural producers and others who handle their tax and Social Security reports face higher interest rates on delinquent taxes and penalties for failing to file certain information forms. Beginning Feb. 1, the IRS will start charging a 20 percent annual interest rate on delinquent tax accounts, but it will also pay the same 20 percent interest on overpayments. There is also a \$10 penalty per statement for taxpayers who fail to file information returns (Form 1099). An immediate deadline for agricultural producers is the filing of Form 943 (Employer's Annual Tax Return for Agricultural Employees) by Jan. 31, notes an economist with the Texas Agricultural Extension Service, Texas A&M University System.

Bud Thetford In Race for County Judge

W.W. (Bud) Thetford has announced that he is a candidate for county judge of Coke County.

In making his announcement, Thetford said, "I believe that with our high rate of inflation and ever increasing taxes, there is a great need for county-wide cooperation and effort in combating these ills in our economy. This can be accomplished, only, by an honest, open minded policy in which the citizens of Coke County can place their confidence."

"I maintained that confidence during my tenure in office," Thetford said, "by implementing a policy of fiscal responsibility. A tight budget was submitted annually to the commissioners court, and through their cooperation along with the other County Officials, we managed to operate within that budget."

Thetford was raised in the Edith community west of Robert Lee; finished high school at Robert Lee; and spent four years in the armed services during World War II. After the war, he returned to Texas Tech where he received a Bachelor of Science degree and a Master of Education degree with a minor in economics. He taught school nine years, the last two years being in the Bronte School System before entering Coke County politics in 1959.

"I am proud of my relationship with the people of Coke County," Thetford said, "and will make a sincere effort to contact each voter personally in seeking their support in the upcoming election."

Thetford's candidacy is subject to action of the Coke County voters in the May Democratic Primary.

Reports from Washington

State of the Union

In his State of the Union message to the nation President Reagan outlined a comprehensive program to address the nation's domestic concerns. His message was characteristically straightforward. There are no quick fixes to the problems that have been festering during decades of runaway government spending.

What has been proposed is a major reshaping of the fiscal relationship between the federal government and the states. The program, involving some \$47 billion in federal grants-in-aid, is intended to sort out the responsibilities properly assigned to each governmental level. Those responsibilities will, in turn, be directed back to the states along with the revenue sources needed to fund them. The end result will be greater efficiency and economy for the states and federal government.

In many ways, the proposals outlined in the State of the Union message represent the fifth installment of the President's mandate. Last year, with the help of a bipartisan Congress, we brought about a reduction in the growth of government spending, personal and business taxes were reduced and regulations which cost billions of dollars annually were cut. Out national defense was strengthened. By his own words, the next thing he wanted to do was return power to the states. This fundamental realignment of the federal system is a dramatic and bold initiative and one that certainly will dominate debate in Congress.

The plan has two major components: A "swap" of Medicaid to full funding by the federal government. In return, the states would assume responsibility for the food stamp and welfare programs like Aid to Families with Dependent Children (AFDC). Secondly, the plan calls for "turnback" programs in education, community development, transportation and social services along with funds from a \$28 billion federal trust to be financed by existing federal excise taxes. The program, as proposed, is to be phased in over eight years starting in fiscal year 1984.

Congress will likely begin reviewing new federalism legislation by spring. The reaction to the proposed program changes by Members of Congress turns on politics and ideology. I, and many of my like-minded colleagues, firmly believe that the programs that will become the objects of debate can be more effectively administered by the level of government nearest the people served.

Be assured that this is no abdication of federal responsibility. It is, rather, a clearly stated opportunity for the states and local governments to sort out their mutual responsibilities.

It is my belief that "new federalism" may not even be the best term for what is about to happen. It is in its purest sense a return of government to the people. At the local level, we will have the opportunity to prevent the growth of a super bureaucracy that wastes energy and siphons off dollars that could be better spent on people and programs. Time and again, Washington has demonstrated that it is too far away from the states to see local problems with a clear eye.

I support the thrust of the President's message and applaud his boldness. As he said, we must summon the strength to continue the course we have charted. I believe we will and I shall do my very best to see that this next phase of the "new beginning" becomes a reality.

Commissioners Exemptions Of Homesteads

Coke County Commissioners' Court had a light agenda when its members met Monday and the business of the day was soon accomplished.

The four commissioners and the county judge had a discussion of the options they have in deciding the type of homestead tax exemption is granted to citizens of the county.

"The commissioners court," said Judge D.W. Sims, "wants to determine what kind of exemption would benefit the most people in our county."

The decision must be reached before the commissioners reach a conclusion, the judge said.

County Tax Assessor-Collector O.B. Jacobs met with the court and explained new state laws on delinquent tax rolls and other new tax laws.

Registration List Posted At Courthouse

The Selective Service System is continuing to make available for public inspection lists of registrants and their tentative local board assignments. This is in keeping with the intent of Selective Service that its procedures be open to the public, according to Gene Hinnard Coke County board member.

The lists cover registrations processed through Sept. 30, 1981, and include men born in 1960, 1961, 1962, and 1963.

Local board assignments are arranged by ZIP code based upon the registrant's permanent address.

The requirement to register applies to U.S. citizens, and to aliens residing in the United States, born on or after Jan. 1, 1960. Men born in 1960 and 1961 were scheduled to register during July 1980; men born in 1962 were scheduled to register in January 1981; those born in 1963 were scheduled to be registered during 1981. Men born in 1964 are required to register within 30 days of their 18th birthday. They may do so at any U.S. Post Office.

On Jan. 7, 1982, President Reagan announced his decision to continue peacetime Selective Service Registration. In announcing his decision, the President declared a grace period during which late registration would be accepted without penalty. That grace period extends through February 1982.

Anyone who was scheduled to register previously but has not yet done so is encouraged to register immediately at any U.S. Post Office in order to avoid any possible penalty.

TEXAS CRAWFISH INCREASE

Texas crawfish supplies are increasing, and that's good news for consumers. Crawfish are now available at markets and in restaurants over a longer period of time because they are being raised in farm ponds. This also produces a better product than those raised in the wild, says a fisheries specialist with the Texas Agricultural Extension Service, Texas A&M University System. Farm-raised crawfish have been in good supply since November, and this supply should continue into June or July. More than 5,000 acres are devoted to crawfish farming along the Upper Texas Coast from Orange to Wharton County.

Hurley Store In Bronte Is Burglarized

Hurley Pharmacy in Bronte was burglarized Monday night and numerous amounts of narcotics were taken from the store. Elmer Hurley, owner, said the loss was estimated at approximately \$200, plus the cost of replacing the door.

Sheriff Marshall Millican said entry was gained by breaking through the front door of the store. Monday night's burglary occurred only two days less than a year after the pharmacy was last burglarized.

The sheriff said he believed a recent big drug bust in San Angelo had driven dealers into smaller area towns to obtain merchandise for their trafficking in the drug business.

Sheriff Millican said a car theft occurred about midnight on Wednesday of last week. A suspicious looking car was noticed and was later wrecked in south Robert Lee, with the two occupants. They escaped apprehension and stole a 1977 Mercury Cougar belonging to Dubbie Bosworth and made their way out of town in a high speed chase.

The wrecked car they left in Robert Lee had several packages of cigarettes, candy and chips left in it. Thursday morning Joe Ross reported these items missing from his service station. Bosworth's car was recovered Thursday night in San Angelo, but the tape deck and several odds and ends in the car were gone.

A transport truck belonging to Basin, Inc., of Midland was heavily damaged about 4:40 a.m. last Thursday when it ran off the roadway between Robert Lee and Silver and overturned once. The oil-loaded transport didn't lose a drop of oil, Sheriff Millican said, but the tractor was totaled. The driver received only minor injuries, he said.

There were some fender benders in Bronte and Robert Lee during the past week, as well as a couple of mishaps on the Colorado River bridge south of Bronte during the icy weather last weekend. Sheriff Millican said he felt Coke County citizens were fortunate in not having more mishaps when streets and highways were glazed over with ice last Thursday night and all day Friday and Friday night.

Research indicates nitrogen efficient in oil & gas recovery

COLLEGE STATION — Laboratory studies indicate nitrogen could be used to recover more than 90 percent of the oil and natural gas left in reservoirs, says a Texas A&M University researcher.

Encouraging test results show that using nitrogen as a replacement for natural gas injection increases recovery of oil, condensate and gas reservoirs, said Dr. Paul Crawford, professor of petroleum engineering and assistant director of the Texas Petroleum Research Committee headquartered at Texas A&M University.

Nitrogen has been tested in the laboratory to displace volatile oils. The oil recovery was about 97 percent with nitrogen injection compared with 99 percent recovery for natural gas and 98 percent with condensate.

Nitrogen will both stretch our limited carbon dioxide supplies and reduce costs, Crawford said.

TAXPAYERS MOVING SHOULD NOTIFY IRS AND POST OFFICE

Taxpayers who move after filing their federal income tax returns and are expecting a refund should notify the post office serving the old address, the Internal Revenue Service says.

The IRS center where the return was filed should also be notified in writing of the address change. This will help the IRS to forward the refund check to the new address as soon as possible. When advising the IRS of the address change, the taxpayer's Social Security number should be included in the correspondence.

San Angelo Stock Show To Be Held

SAN ANGELO-- The 1982 edition of the San Angelo Stock Show & Rodeo will debut here March 8 with the registered Quarter Horse Show, Halter and Performance classes.

This year's presentation will celebrate the 50th anniversary of the annual event. Back in 1932 a handful of area ranchmen gathered to put on the first stock show at Henshaw Polo Field. 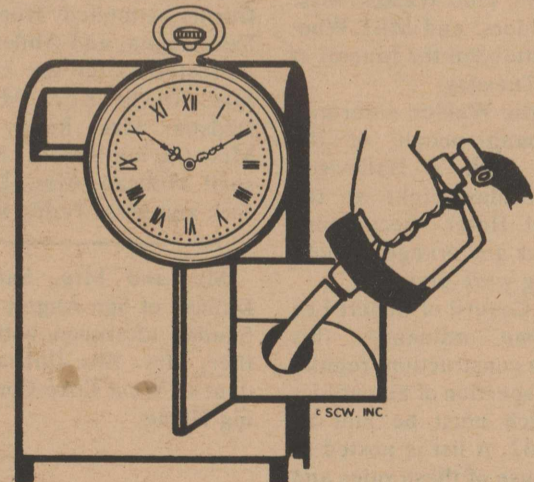
