Voting In Democratic Runoff Election Saturday

Texas voters will go to the polls Saturday to vote in runoff elections which will determine Democratic and Republican nominees for various offices ranging from precinct to statewide level.

Only a Democratic runoff will be held in Coke County, since Republicans here have no contests to decide.

The two local races where nobody received a majority in the first primary are expected to draw a heavy vote. An unusually high 61.3 per cent of the register-

ed voters cast their ballots in the May primary.

Everyone in the county is interested in the race between incumbent Judge D.W. "Dub" Sims and Aubrey Denman. Sims led the ticket in the first primary but W.W. (Bud) Thetford received enough votes to cause a runoff.

In addition to the judge's race, voters of Precinct 4 have a double interest in the Saturday election. They will cast their ballots to decide if James Arnold Tidwell or Willie Carper will serve as their commissioner the next four years. Tidwell led the ticket in the first primary but was not far enough ahead of Carper to prevent a runoff. Jerry Parker was the other Precinct 4 candidate.

A couple of hot races are expected at the state level, also. Jim Mattox and John Hanna will

be slugging it out for attorney general, and Sen. Pete Snelson and Garry Mauro want to be nominated commissioner of the General Land Office.

Two runoffs for court of criminal appeals will see Charles F. "Chuck" Campbell go up against John E. Humphreys and Bill Black against Chuck Miller. Dick Criss and Bob Gammage will run against each other for associate justice, court of appeals.

Polling places will be as follows: Precinct 1: Rec Hall in Robert Lee. Precinct 2: City Hall in Bronte. Precinct 3: Courthouse in Robert Lee. Precinct 4: Community Center in Tenneson. Precinct 5: Old Depot Building in Bronte. Precinct 9: Pecan Baptist Church Annex at Green Mountain.

County Clerk Ettie Hubbard said 130 persons voted absentee before the deadline June 1.

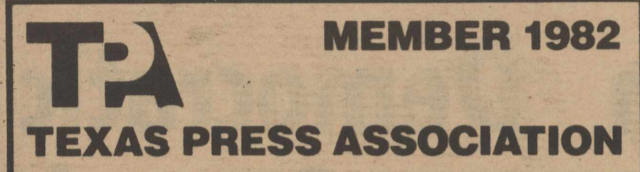

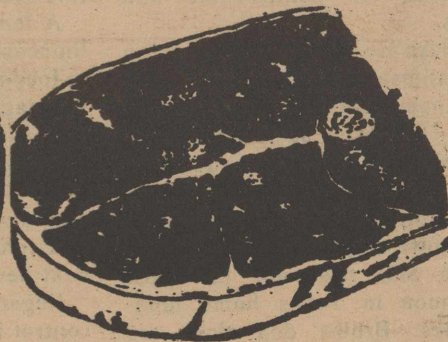

Warm Weather Brings Ticks

Tick populations increase dramatically with warmer weather, causing inconvenience and health hazards for homeowners and pets.

Ticks are biting, blood-sucking parasites, and their bites may become inflamed and infected due to toxic secretions. Tick paralysis, tularemia and Rocky Mountain Spotted Fever may be transmitted through tick bites.

Brown dog, American Dog and Lone Star ticks are the most common in Texas home landscapes. Brown dog ticks are reddish-brown while american dog ticks are yellowish-brown when unfed and slate gray when engorged. The brown dog tick

rarely occurs in rural areas; instead, it hides in crevices around buildings. American dog ticks are most often found along roads and trails. The Lone Star tick has a characteristic white spot on its back and commonly referred to as a spot backed tick.

A female tick may lay several thousand eggs, beginning a two-to four-month life cycle. Remaining stages--six legged larva (seed tick) and eight legged nymph and adult--generally develop on separate host animals. After each feeding the tick drops off the host and temporarily hides until the next development stage.

Regardless of the species, control is basically the same for all ticks. Heavy infestations in the home may require treatment by professionals. Household sprays containing diazinon, Dur-

span, Baygon, resmethrin or Vapona will provide excellent control of light infestations.

Outside the home where vegetation is thin, use 5 percent carbaryl (Sevin) dust at 20-25 pounds per acre. Increase the rate as vegetation thickens. If using a spray, mix five tablespoons of 25 percent diazinon emulsifiable concentrate (EC) in one gallon of water. Apply one gallon of spray per 1,000 square feet.

Chloryprifos (Dursban) is also suggested for tick control. Apply 1.5 ounces of material per 1,000 square feet of treated area. When spraying, pay particular attention to roadsides, animal trails, paths and pet resting areas. Retreatment may be required if tick populations continue to be observed. Always read the label on the insecticide container for application instructions. Properly store any unused portion of the insecticide under lock and key to prevent accidental child poisoning.

Most species of ticks can't survive in cleared areas where they are exposed to excessive sunlight and predators. Keeping areas clear of debris is important in tick control.

Pet owner need to examine their animals frequently. Light infestations can be controlled by rubbing carbaryl dust into the pet's hair. Also, treat the animal's sleeping quarters every week if ticks are common.

If a tick becomes attached to the skin, remove it with a slow, steady pull. Be careful not to break off its mouthparts. A drop of chloroform, isopropyl alcohol, ether, acetone or fingernail polish rubbed over the tick may help remove it. It can be removed a half-hour later with less damage to the skin because its oxen

supply is cut off.

Always apply an antiseptic to tick bites. If your hands touched the tick, wash them thoroughly with soap and water to reduce the risk of spreading disease.

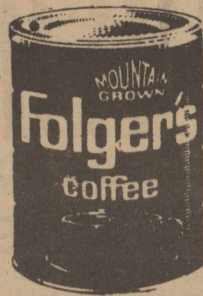
