Two local teenagers were injured in a one vehicle accident in the early morning hours last Saturday. The wreck occurred on Highway 208 midway between Robert Lee and San Angelo.

Randy Bohannon, son of Mr. and Mrs. Richard Bohannon and Jamie Sawyer, son of Mr. and Mrs. Tom Sawyer, were first brought by ambulance to Robert Lee's West Coke County Hospital and later transferred to Shannon Hospital in San Angelo.

The boys, both seniors at Robert Lee High School, required surgery for their injuries.

Sawyer, driver of the compact pickup, suffered a broken jaw and various contusions. His surgery on Saturday morning included wiring the jawbone which will prevent his eating solid foods for 8 to 10 weeks. He was released from the hospital to convalesce at home on Monday afternoon.

Bohannon required extensive facial surgery; he also sustained a back injury. At press time Tuesday, he remained hospitalized in San Angelo.





During noon, the Elanco Company is providing a free Bar-B-Que meal before the Beef Program commences.

Both Bishop Ranch and the Chadbourne Ranch are actively engaged in embryo transplants. Dr. John Hodges, D.V.M. and Sally Buxkemper, producer, will provide current information on the Embryo Program, and where it is headed.

To wind up the tour and field day, Dr. Jerry Cowley, Extension Livestock Specialist, will explain current uses of ear implants, Pyrethroid eartags and brucellosis up-date.

Similar to the economic conditions of this year, I toured the Center and addressed the cause. That was five round-ups ago. With all my other businesses and daily problems, my staff and clients say to me: "You're going to have to slow down and maybe drop some of those road trips for Rehab."

Let me share something with my readers out there. I may be forced to slow down or drop a client down the road somewhere, but it won't be WTRC. It's like the printer's ink that's been in my veins for 25 years, the religion in my soul as a Presbyterian or being a Republican, a weird combination, granted, yet it's very much a part of my life!



## CRIME: IT'S THE VICTIMS WHO ARE LOCKED UP

I want to talk to you this week about an issue that troubles me greatly and which I know is of great concern to Texans. It seems that whenever I have spoken about crime in the past 12 months I have gotten a strong and troubled response. No matter where I am—Jewett, Roma or Dalhart—people tell me they are angry and afraid about crime in our state.

This anger and fear concerns me for two reasons. First, because this kind of anger and fear serves as a sort of jail" for innocent people. They are the ones locked in their homes at night while criminals go free. The second reason I am concerned is because unless something is done to stop the crime epidemic, people will be ripe for the kind of politician who will play on citizens' fears. The result could be that Texans lose their liberty in return for their "safety". In that sense, the crime problem is like a cancer gnawing at democracy.

The incumbent Lt. Governor's response to the crime issue has been shameful. While he has been in office the crime rate has risen 131%. He has done nothing to attack crime in a substantial way. In fact, he has fought stronger anti-crime measures. He openly opposed the new wiretapping law designed to catch drug dealers. He openly opposed the Governor's anti-crime package by putting it in a legislative committee run by a hostile Senator, who promptly bottled it up. Much of the package passed anyway and now Mr. Hobby has the gall to go around the state taking credit for it!

His sympathies in the fight against crime are evident. Not long ago he allowed the American Civil Liberties Union (ACLU) to hold a fundraiser in his Houston mansion and he proudly defends it. The ACLU has consistently opposed laws that would make it easier to deal with the crime problem.

I think such two-faced maneuvering is disgraceful. It is obvious that if we are going to attack the crime problem, if we are ever going to give law officers, judges and prison guards the tools they need to make us safer, Bill Hobby will have to go.

The time to begin this planning and implementation of these programs is now because it could take decades to find solutions, and we don't have time or water to waste.

Just remember, as we depend upon our current water supplies and resources today, our children will be dependent upon the same resources and supplies tomorrow. I would like to think that some day my grandchildren will be concerned only with the locations of the best swimming holes and fishing holes.



### **How To Grow** Bluebonnets

The '64 Study Club, as a beautification project, has bought and distributed bluebonnet seeds among its 25 me- ers Besides planting seed at their homes, the members are distributing information about planting and encouraging others to plant them. A club project is to make Robert Lee a city of bluebonnets. The club is especially interested in getting bluebonnets along the main thoroughfares of the city such as the two highways through town as well as on the streets to the park, schools, and hospital.

Following is a brief list of basic steps for growing bluebonnets successfully.

1. Prepare the seeds before planting by soaking in tepid water for three or four days, changing water daily.

2. Plant the seeds at the right time.. in the right place, which is late summer and early fall where the soil is warm enough to germinate the seeds.

3. Cover seeds when planting and firm up the soil- do not throw or broadcast seeds as birds and insects eat them, and it takes as long as four years for the ones that survive to come up.

4. Water thoroughly, but gently, after planting, and afterwards too if it is dry. The following year if rains are skimpy in August keep soaking bluebonnet patch.

A heaping tablespoon (about 1,000 seed, more or less) for 200 square feet ... \$2.98.

A cupful (approximately 5,000 seed) which will cover 1,000 square feet ... \$8.95.

A double-cupful (about 10,000 seed) which will turn 2,000 square feet blue...\$13.95.
