4-H Club Week In Progress

This is National 4-H Club Week, a time when 4-H Club members throughout the nation will be recognized for their involvement in one of the world's largest youth organizations.

The basic purpose of 4-H Club work is to develop leadership in youth and give our youth an opportunity to share some experiences that will help them develop into responsible citizens.

The organization began approximately 65 years ago in Texas. Today, every county in the state and every state in the nation has 4-H clubs. The four H's in the four leaf clover used as the 4-H emblem stand for head, heart, hands and health. The 4-H program promotes the development of the mind, body and physical potential through project work, club meetings and numerous special 4-H programs.

The Coke County 4-H Clubs-Bronte Senior and Junior, Robert Lee Junior and Future Leaders-recently held their first meetings of the new program year. A total of 201 members were enrolled at the club's first meetings. During the course of the year the club members will be involved in individual projects and group activities. The more common projects are foods and nutrition, clothing, livestock feeding, rifle and horse. They will be participating in food shows, stock shows, fund raising, judging events, camping, recreational programs and others.

Enrollment in the 4-H program is open to all youth between ages of 9 and 19. It is given leadership by the County 4-H and Youth Committee, 4-H Leaders, the County 4-H Parents Association and the Coke County Extension Agents.

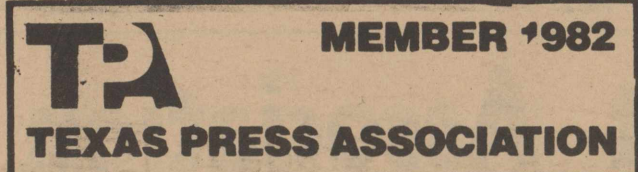

Soil Conservation District To Have Election To Name Director

An election for a director to serve in zone 4 on the Coke County Soil and Water Conservation District Board is scheduled for October 12, 1982 at the Tennyson School announced Joe Rawlings, chairman of the board.

The election will be held at 7:30 p.m.

State law decrees that to be eligible to vote in a soil and water conservation district directors election, a person must own agricultural land within the sub-div-

ision where the election is being held. The person must also live in a county all or any part of which is in the district and the voter must be 18 years old.

Legal qualifications state that a candidate for the office of a soil and water conservation district director must own land in the zone he represents, be 18 years of age and be actively engaged in farming or ranching. He must also live in a county all or part of which is in the district.

Zone 4 of the district includes the south-east part of the district south of the Colorado River and west nearly to Highway 208.

Current members of the board of directors are: Joe Rawlings, Royce Fancher, Horace L. Scott, Wilbern Millican, and Fimmel Smith.

The purpose of the Coke County SWCD, with headquarters in Robert Lee is to promote sound soil and water conservation programs on farm and ranch lands within the district and to serve as a voice for farmers and ranchers on conservation matters and other issues affecting private property rights of landowners.

All conservation programs managed by the district are of a voluntary nature to the landowner or operator.

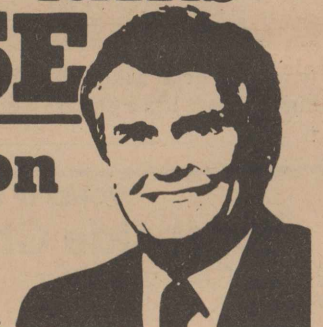

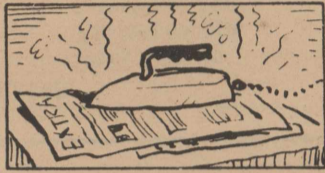

COKE COUNTY DESIGNATED DISASTER AREA BY SBA

Governor Bill Clements today announced that the Small Business Administration has declared 68 West Texas and Panhandle counties disaster areas and eligible for emergency economic injury loans. The SBA loans will aid cotton gins, warehouses, implement dealers and other agribusinesses affected because heavy rain and hail damaged area crops last June.

These loans would have been automatic at the end of this crop year, when exact amount of crop losses are determined and Farmers Home Administration loans are made available. Governor Clements requested the SBA loans be made available now, because these small non-farm businesses need the financial aid immediately. The loans will carry an eight percent rate of interest.

Coke, Nolan and Runnels counties are among the counties listed as eligible for the loans.

INTEREST RATES ON VETERANS' LOANS 8%

The interest rate on loans to veterans purchasing land through the Veterans' Land Program was set at eight percent Thursday by the Veterans Land Board.

Land Commissioner Bob Armstrong, chairman of the board, said he was impressed that the strength and stability of the program brought such a favorable sale of \$74 million in bonds last week that the board can offer eight percent loans to veterans.

Under the program, qualifying Texas veterans can borrow up to \$20,000 over 40 years to purchase 10 or more acres. The interest rate is determined by the price at which the bonds are sold.

Armstrong said last week's bond sale was the first since June, 1980. "During the interim the bond market stayed at a much higher level than we thought the return could afford. The market was also above the ceiling set by the Legislature for veterans' bonds during some of that period. But this sale puts us in a good position and I'm glad we have the program funded at such a favorable rate," Armstrong said.

The board has also voted to start accepting requests for loan applications again after a moratorium of more than a year, but Armstrong said the more than 9,000 veterans currently waiting for loan applications will be sent applications first. All requests must include the \$10.00 application fee and be mailed to the Veterans Land Board, 1700 North Congress, Austin, Texas 78701.

A&M economist says lower productivity can cause inflation

COLLEGE STATION — While most economic reports focus on inflation, interest rates and layoffs, one economist says a vital, but often ignored, statistic has been the continual decline in productivity.

Productivity increased at an average annual rate of 2.8 percent between 1948 and 1966, dropping to 1.6 percent between 1966 and 1973 and even further to an average .8 percent annual rate between 1973 and 1978, says Dr. M. L. Greenhut, who holds the title of Distinguished Professor of Economics at Texas A&M University. Inflation will follow decreasing productivity, even if the budget is balanced, provided the Federal Reserve increases the money supply to recent rates, he said.

"The current period of protracted inflation began around 1966 and was initiated by greater commitments in Vietnam without any timely changes in our tax and other policies," said Greenhut, co-author of a recently published book, "Economics for the Voter," which put current economic thoughts in layman's terms.

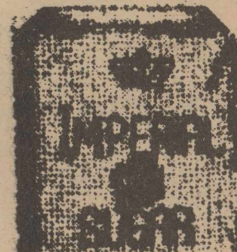
