HEAVY RAINS COVER COKE **DURING PAST SEVERAL DAYS**

It was Christmas in October last Thursday, October 20, when the skys finally opened up and spilled a long-awaited rain on parched Coke County and other regional counties. Intermittent showers fell around on Wednesday, but it really got down to business in the early morning hours on Thursday, dropping 3 inches officially in Robert Lee and 2.7 inches in Bronte. This brings the yearly total to around 10 inches in addition to the 9-10 inches of snow in January.

Rain was heavier north and west of Robert Lee, with the J.P. Jameson Ranch reporting 6 inches. David Drennan around 5¹/₂ inches, and on toward Lubbock, heavy hail and 7-8 inches. Colorado City and east to Sweetwater received 4-5 inches. Bert Blaylock gained 3¹/₂ inches and Sanco's reports varied from 4-6 inches.

ELECTION BE HELD NOVEMBER

Coke County voters will go to the polls Tuesday, November 8, to vote in the Special Constitutional Amendment Election. There will be eleven proposed amendments on the ballot. In addition to the amendments, Coke Countians will vote on Local Option Bingo Enabling Act. If passed this act would allow authorized organizations (religious societies, non-profit organizations or volunteer fire departments) to use bingo as a way to make money. This does include such school organizations as the Band Boosters, Athletic Boosters. etc. Absentee voting is now in progress. It started October 19 and will end November 4. Absentee voting takes place in the County Clerk's Office or you can contact the clerk and have a ballot mailed to you. If you receive a ballot by mail, you must return it by mail.

Brenda Gray Still In Hospital

Brenda Grav remains in Shannon Hospital in San Angelo following a one-vehicle accident on Highway 158 between Robert Lee and Sterling City on Wednesday evening of last week. Traveling on a rain-slick highway, she lost control of the pickup she was driving and overturned several times. She was taken to San Angelo by the Sterling Emergency Service ambulance.

Her condition has been upgraded from critical to fair condition at this time. According to her father, Les Gray, she sustained a fractured leg, both arms were broken, and multiple lacerations requiring some 90 stitches. Surgery was performed to place a rod in her thigh to support her leg, which will not have a cast at this time.





A thorough cleaning of your garden this time of the year can give you a head start for next spring.

A fall clean-up attacks many of the insect and disease problems that could cause you grief next year.

A good sanitation program includes pulling up all spent annual bedding plants, cutting off the tops of perennials, raking the ground to collect surface debris, and removing these materials from the garden. Also, plants that are now being dug and divided should be carefully cleaned and all injured, diseased or dead leaves and stems removed.

Removing this plant material will eliminate many insects and disease organisms that otherwise would overwinter on the fallen debris and be waiting to attack plants when new growth appears in the spring.

These clean-up practices, coupled with the use of resistant plant varieties, will eliminate the need for many of the chemical spray applications usually necessary to maintain healthy garden plants.

> **BEWARE OF ACORN POISONING IN CATTLE**

Acorn poisoning generally occurs when acorns fall prematurely while they are still green. Most cattle like acorns and tend to seek them out. This will be true this year more than usual due to lack of other feedstuff. The quanity tolerated by an animal is influenced by the protein content of its diet.

Animals affected by acorn poisoning have a lack of appetite, appear dull, become constipated and suffer weight loss. They also pass blood in the feces and may bleed from the nostrils. Profuse diarrhea may follow constipation. Animals affected will also drink large amounts of water and urinate excessive amounts of clear urine.

Many animals go down after three to seven days of symptoms. If animals do not die, they will require 2-3 weeks for recovery. Treatment is of little value in severely affected animals. Giving calcium hydroxide and increasing the protein content of the diet may help.

Acorn poisoning can best be prevented by removing cattle from areas with oaks and acorns during the time they have recently fallen. Try to reserve these pastures for late fall and winter grazing.


Oren Fletcher Services Held




