## Kirk McWilliams Writes Home Occasionally

Mr. and Mrs. J. B. McWilliams received a letter from their son, Kirk, this week. It was mailed from Japan. They had not heard from their son since he visited here in July while on a furlough from the Air Force.

In his letter, Kirk gave the following account of his experiences:

22 September 51.  
Dear Mother, Daddy:

I guess I had better let you folks know where I am as I'm not where I was the last time you heard from me. As it stands right now I'm in Japan. That's a little bit of news I guess. I'll start from the day I left home and bring you up to date.

As you know I left home the 12th of July at 7:00 in the morning and I arrived at Santa Fe at 4:00 in the afternoon of the same day. That night I saw the Santa Fe Traildays Rodeo. I arrived at El Vado at 3:00 the next morning. The 6th of August I received orders to report to Camp Stoneman the 11th of August. On the way to Stoneman I stopped at Oakland, California for 2 days. I didn't do much there except go to a few shows and sleep. The 18th of August I received orders to ship to Japan on the USS Bayfield. It took us 15 days to make the trip across the ocean. On this trip we lost a full day at one whack, but we gained back 6 or 7 hours. I don't remember which. I arrived at Yokohama the 3rd of September but I did not get off the boat until the 4th. I got off at about 2:00 in the afternoon and boarded an electric train. I got off the train about 5 hours later at a base about 17 miles out of Tokyo. It was called Fugie I think. I wasn't there long enough to find out. I stayed there long enough to eat chow and then I boarded a bus bound for Tokyo. When I got to Tokyo I boarded another train bound for Furumaki about 300 miles above Tokyo. I had a pullman but it was made for Japs because it was about 2 inches too short for me. If I hadn't been real tired I never would have got to sleep. As it was I was pretty sore the next morning. I got off the train at about 3:00 the 5th of September. I got on another bus for Furumaki headed for Misawa AFB. It took me about 1 hour and a half to get to Misawa. There I was assigned to the 613th Sqn. From there I was sent to the 511th Group. From the 511th Group I was assigned to the 613th AC/W Sqn. That's where I'm at right now. I'm a CQ runner right now and I'm taking advantage of my spare time to write. Typewriters don't effect my writer's cramp like a pencil does.

By the way send Boyd my address so in case he's in Japan any time soon he might look me up. Tell him my phone number is (Misawa AFB, 613th AC/W Sqn. 2470.)

Say Daddy, I'd like for you to see the saws these Japanese carpenters use. I'll leave a space here and draw you a picture of it.

You'd be surprised at how fast they can saw through a 4x4. I watched one do it one day. I was really surprised at the rate of speed that he did it in. Their scaffold is something else you ought to see. They make it out of poles tied together with grass rope. They build their ladders right into the scaffold. Their tool boxes consists of a sack carried on their back. They carry every tool they need in this sack. It's quite a picture to watch one trotting down the street with that sack on his back.

Something else I noticed first off was that they always lead a horse wherever they go. I have not seen a pair of bridle reins since I've been over here. Even out in the fields they lead their horses. I noticed too that their draft horses aren't as heavy as U. S. horses.

Well I guess I had better sign off, as I get off in 25 minutes, I hope.

## Scrap Drive Set For October 15 To November 15

Secretary of Agriculture Charles F. Brannan asks the Nation's farmers to cooperate in an iron and steel "Scrap Harvest" October 15 to November 15 to help obtain raw materials needed in the production of essential equipment in the mobilization program.

Pointing out the importance of the farm scrap drive the Secretary said: "Our first great need is to obtain enough of the raw materials we must have to keep our defense program going forward in good order, but farmers have a very direct interest in seeing that our mills and foundries have enough scrap iron and steel. By taking steps that will add to the supply of the raw materials which are essential to steel production, farmers will be helping to guarantee more adequate manufacture of the farm machinery and equipment they need."

"Farmers have given generous support to scrap drives before. Production authorities have informed us that steel mills and foundries continue to operate with a dangerously short supply of scrap. They also point out that farms are a good source of the higher grade, heavier types of scrap the mills and foundries need in defense production. I am confident that farmers will meet this vital defense need. We are asking the Agricultural Mobilization Committees to give them every possible assistance in doing so."

The period from October 15 to November 15 coming at the end of harvest season has been selected as a time most convenient for farmers to collect scrap and sell it to dealers or to assembly points.

## Pritchard Reviews FBI Work

Ed Pritchard, Dalhart rancher, formerly with the Federal Bureau of Investigation, was the principal speaker at the ladies night meeting of the Stratford Lions Club in the Palace Cafe Monday night.

He briefly sketched the intent and purpose of the organization, and told of its work during World War II. The first assignment of the FBI at the outbreak of hostilities was to round up all alien Japanese. Those who proved themselves to be good citizens were granted their liberties. The next task was the locating of all German espionage agents. This task was almost completed when eight agents were landed on the coast by submarines. They were placed under arrest before they reached their destinations.

He stated that he believed the FBI check of communists in the United States was a about completed and that in case of open hostilities the FBI would be able to place them under arrest within a short time.

## Prolonged Maize Harvest In Progress

A prolonged maize harvest which is expected to last for another three weeks took on life this week, some yields of as high as 50 bushels to the acre being reported.

Harvest has been completed in a few fields of early maturing grain although operations have been started in only a small percentage of the fields over the entire territory.

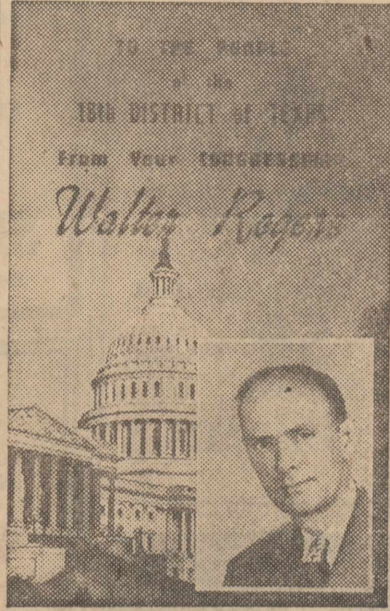
Maize in fields that were planted thin has produced sucker heads which will retard combining for at least another week. Maize that was planted thick is gradually maturing.

Grain in sandy land still looks green and no combining is expected in these sections for at least two weeks.

Fields of hegari are expected to be ready for harvest in about two weeks.

Custom combines and trucks are available to care for present operations although help may be scarce when the remainder of slowly maturing fields are ready to cut.

## Tax Exempt Expense Accounts

The Senate on September 27, by 77 ayes and 11 nays, adopted an amendment to the Tax Bill repealing tax exemptions for the President, Vice-President, Speaker of the House, and Members of Congress in so far as the tax exempt expense accounts of these officials are concerned; the amendment to be effective as of January 3, 1953. You will remember that I introduced this piece of legislation shortly after I was sworn in. The difference between the Senate amendment and the bill that I introduced is that the effective date of my bill would be much earlier than January 3, 1953. Under the Constitution it would be impossible to make any change in the expense account of the President during the term for which he is elected. It is my opinion that when this matter comes before the House of Representatives, the Senate amendment will be adopted. It has been my contention all along that elected officials are in no different category than any other individual in any event, and certainly not concerning tax matters. I do not feel that a blanket tax exempt expense account should be available to anyone, regardless of position, as it could very easily lead to a situation where a great number of people both in public and private life could employ that method as a tax loophole, and the result would be abuses that would be unfair and discriminatory. Fairness and equality in the carrying of the tax burden is an absolute must under the Democratic form of government. There are many loopholes that are being employed at the present time but these are being fast discovered and closed. The sooner all of these are closed the sooner we as individual citizens may expect some lightening of the heavy tax burden that we are carrying.

## Drew Pearson Vs. Sen. McCarthy

The great battle of charges and counter charges continues on the Washington front, and one phase of it has shifted from Capitol Hill to the courthouse, where Drew Pearson is suing Senator McCarthy of Wisconsin, and nine other defendants. The case grew out of an altercation at the swank Sulgrave Club here in Washington. Whether or not the Sulgrave Club is swank is hearsay with me, as I have never had the occasion to visit it. I have talked to several of those who were present at the dinner the evening of the difficulty between Drew Pearson and Senator McCarthy and I have heard several stories, all just about alike, except a little difference in detail. The case is now in the pre-trial stage, that is the testimony of the interested parties is being taken. A move was made by the defendants to prevent the proceedings or the testimony so taken to be published. I was rather surprised at this move on the part of Senator McCarthy and the Times-Herald as it certainly would have been at least a limited infringement upon the freedom of the press. The Judge, however, refused to allow the proceedings to be secretive. The testimony growing out of this proceeding is affording the residents of this section of the country some juicy reading material. From the local newspaper accounts it would seem that the entire proceeding is going along on the theory of "everytime you call me a bad name, I'll call you a worse one." It seems that name calling and accusation throwing are becoming fine arts. This would probably develop into a new field for public relations firms. One bit of testimony that caused some furor in the Pearson vs. McCarthy case was that brought out by Pearson's attorney Roberts to the effect that Senator McCarthy's income

### Western Nations Merged In Asiatic Treaty

The most puzzling aspect of the San Francisco meeting at which the Japanese peace treaty was ratified by 48 nations was the relative mildness with which the Soviet spokesman, Andrei Gromyko, made his protests. Mr. Gromyko is an able parliamentarian and on many an occasion in the past has shown a rare talent for throwing monkey wrenches into the wheels of progress. When he and his large delegation arrived at the conference it was almost universally expected that a first class display of fireworks would follow. But Mr. Gromyko's attitude was calm and academic, by comparison with past performances. He

made his objections — all of which were based on the thesis that the treaty was designed by the West as a prelude to World War III — in the manner of a man who was just going through the motions. The other Iron Curtain delegates echoed the boss in the dullest possible fashion.

Various reasons are given to account for this. First of all, the meeting was extraordinarily well organized — even Mr. Acheson's bitterest critics have praised the job he did as chairman. He and his assistants didn't give the Russians an inch, and they were obviously ready to deal firmly and toughly with whatever might transpire. Second, the Russians knew that they had no chance at all to stop the ratification and so, perhaps, Mr. Gromyko appeared just for the sake of the record. A third speculation is potentially the most important, and only time can tell whether it is right or wrong. It is that the Russians have decided that there is no future in diplomatic negotiations, inasmuch as they are sure to be overwhelmingly outvoted at any international parley, that in the future they will ignore such negotiations, and that they will follow a policy of direct action whenever they feel it may be profitable. This, of course, could greatly increase the risk of global war — if the Russians want to take that terrible chance.

In any event, Japan is now back in the company of nations. Signing the treaty, naturally, didn't solve the Asiatic problem. The worst disappointment was Nehru's decision to keep India from participating. Nehru is certainly no pro-Communist. At the same time, he is not pro-West either. He has a strong distrust for all the great powers. And today he must face the reality of militant Red China on the Indian border.

Yet, in the face of all this, the fact remains that 48 nations, despite the many differences in points of view and national interests, signed the Japanese peace treaty — and signed it in exactly the form it was offered, without a single change. Those who follow the Communist line say this seeming unanimity was achieved by the U. S. blackjack. A far more logical view is that, to the contrary, it was the result of a growing feeling that the free nations must submerge their differences and act in concert — that it is a question of hanging together or hanging separately. Russia's clear in-

tention ever since World War II has been to divide the West. But, instead, Russia's very actions and policies may prove to have

been the biggest factor in consolidating it. When actual survival is the question, people stop their quibbling over the cut of

one's hair and the fit of one's clothes. As the Oregon Daily Journal said in concluding an editorial on the San Francisco

ROBERT GEORGE THOMPSON

Alert citizens and law enforcement agencies throughout the nation have been requested by the FBI to assist in locating Robert George Thompson, one of the convicted Communist Party leaders who are now fugitives from justice. A description of Thompson is as follows:

Age, 36, born June 21, 1915, at Grants Pass, Oregon; height, 5 feet 9 1/4 inches; weight, 170 pounds; eyes, dark brown; hair, brown, thick, straight; complexion, light; build, muscular; race, white; nationality, American; scars and marks, bullet wound left knee, appendectomy.

His complexion is sallow and he walks with a slight hop or limp from the wound in his left knee. In the past he has driven a 1948 green Chrysler four door sedan, New York license 4C5674.

He has worked as a machine operator in a linoleum factory in California and as a laborer in a cannery. He has also worked at wheat harvesting and lumbering in Oregon. He speaks slowly and usually carries a briefcase.

Thompson was convicted on October 14, 1949, for violation of the Smith Act and was sentenced to three years' imprisonment and a \$10,000 fine. A bench warrant was issued for his arrest on July 2, 1951, when he failed to appear in Federal Court for commitment to prison.

Any person having information which may assist in locat-

ing Thompson is requested to immediately notify the nearest FBI office.

TAKE NOTICE that an election will be held in Sherman County Road District No. 3 on the 27 day of October, 1951, on the proposition and at the place more particularly set forth in the election order passed by the Commissioners' Court on the 26th day of September, 1951, which is as follows:

"AN ORDER CALLING AN ELECTION ON THE PROPOSITION OF THE ISSUANCE OF \$125,000.00 OF BONDS OF SHERMAN COUNTY ROAD DISTRICT NO. 3.

WHEREAS, there has been presented to this Court the petition of Ernest Cummings and 41 other persons, representing themselves to be resident, qualified electors of Sherman County Road District No. 3, who own taxable property in said district and who have duly rendered the same for taxation, praying that this Court order an election in Sherman County Road District No. 3, on the question of the issuance of \$125,000.00 of Road Bonds, which said petition was heretofore filed in this Court; and

WHEREAS, heretofore on the 10th day of September, 1951, the Commissioners' Court passed an order fixing a time and place for a hearing on said petition, to-wit: September 26, 1951, and directed the County Clerk to issue a notice of such time and place of hearing to inform all persons concerned of their rights to appear at such hearing and to contend for or protest against the order of such election; and

WHEREAS, the County Clerk has heretofore duly executed said notice by posting true copies of said order in three public places within said Sherman County Road District No. 3, and another copy thereof at the Courthouse door of said County for ten days prior to the date fixed for the hearing, and said notice has also been published in a newspaper of general circulation in said Sherman County Road District No. 3, namely "The Stratford Star", one time on the 13th day of September, 1951, which was at least five days prior to the date fixed for said hearing; and

WHEREAS, this Court, having met at the time and place set for the hearing of said petition, proceeded to hear such petition and all matters in respect to the proposed bond election, to hear the contentions for and protest against the calling of such election, and it is found by the Court that the said petition is signed by a majority of the qualified electors who own taxable property in Sherman County Road District No. 3, and who have duly rendered the same for taxation, and that the notice required by law to be given of said hearing has been given; and

WHEREAS, pursuant to the hearing held on said date and from the evidence submitted at said hearing, the Court has determined that the proposed improvements would be for the benefit of all taxable property situated in such Sherman County Road District No. 3, and that it is desirable and necessary to issue the bonds of said Sherman County Road District No. 3 in the amount of \$125,000.00, to construct said improvements and that said election should be ordered; and

WHEREAS, the Commissioners' Court further finds that the amount of said proposed bond issue, together with all outstanding bonds heretofore issued on the faith and credit of Sherman County Road District No. 3 will not exceed one-fourth of the assessed valuation of the real property of said District; and

WHEREAS, said Sherman County Road District No. 3 has heretofore been legally created by order of the Commissioners' Court passed on September 2, 1949;

THEREFORE, BE IT ORDERED BY THE COMMISSIONERS' COURT OF SHERMAN COUNTY, TEXAS:

1. That an election be held in said Sherman County Road District No. 3 on the 27 day of October, 1951, which is not less than thirty days from the date of this order, to determine:

"Whether or not the bonds of said Road District No. 3 of Sherman County, Texas, shall be issued in an amount not to exceed \$125,000.00, bearing interest at a rate not to exceed Four (4%) per cent per annum, and maturing at such time as may be fixed by the Commissioners' Court, serially or otherwise, in not to exceed thirty (30) years from the date thereof, for the purpose of the construction, maintenance and operation of macadamized, graveled or paved roads and turnpikes or in aid thereof throughout the Road District No. 3 of Sherman County, Texas, and the levy of a tax sufficient to pay the annual interest on said bonds and provide a sinking fund sufficient to pay the bonds at their maturity."

2. The metes and bounds of Sherman County Road District No. 3 are set forth in the order fixing the time and place of

hearing on the petition for the issuance of bonds which was passed on the 10th day of September, 1951.

3. The said election shall be held under the provisions of Chapter 16, Acts of the First Called Session of the Thirty-Ninth Legislature.

4. All persons who are legally qualified electors of this State and of this Road District who own taxable property in the District and who have duly rendered the same for taxation shall be qualified to vote, and all such electors shall vote in the election precinct of their residence and all voters desiring to support the proposition to issue the bonds shall have written or printed on their ballots the words:

"FOR THE ISSUANCE OF BONDS AND THE LEVYING OF THE TAX IN PAYMENT THEREOF"

And those opposed shall have written or printed on their ballots the words:

"AGAINST THE ISSUANCE OF BONDS AND THE LEVYING OF THE TAX IN PAYMENT THEREOF"

5. That said election shall be held at Bob Burgess Place, within said District and the following named persons are hereby appointed directors of said election:

George Bradley, Presiding Judge,  
Rollo Newman, Judge,  
J. D. Hester, Clerk,  
Oma Ellison, Clerk.

6. The manner of holding said election shall be governed by the General Laws of this State regulating general elections when not in conflict with the provisions of Chapter 16, Acts of the First Called Session of the 39th Legislature, hereinabove cited.

7. Notice of said election shall be given by publication of a copy of this order in a newspaper of general circulation in Sherman County Road District No. 3, for three successive weeks before the date of said election, and in addition thereto, there shall be posted copies of this order at three public places in said district, and one at the Courthouse door of the County for three consecutive weeks prior to said election.

8. The County Clerk is hereby ordered and directed to post said notices and to cause same to be published as hereinabove directed. Further orders by this Court are reserved until the returns of said election executed by the duly authorized election officers, are received by this Court.

**Wanted: Pioneers!**  
Lesson for October 7, 1951

IT IS on record that a Virginian in the 18th century wrote to his family that he was moving "to the far west," meaning the neighborhood of what is now Bull Run, Va., not far from Washington, D. C. Well, the "far west" moved and moved, till it reached the Pacific. Beyond that ocean is the Orient, crowded past belief. Where now can the pioneer go? For pioneering is always in the blood of man. Not in every one's, to be sure; there always are contented stay-behinds; but also there always are the restless souls, not content with what has been or is. How shall pioneering instincts have their way when all frontiers are closed?

**Un-Traveling Pioneers**  
THE traveling pioneer has about had his day; what we now need is the un-traveling pioneer.

Such explorers are of various sorts. One is the mental pioneer, moving to new frontiers of the mind. These can be found breaking out new trails in various directions. In science there are the men whose minds produced X-rays and plastics, the men and women who did the brainwork that lay behind the splitting of the atom; in government the men on the judge's bench, in lawyer's offices or in professors' chairs, who have been and are still thinking out the undiscovered meanings of democracy; in education the men and women who have pioneered in new ways of teaching, such as Dr. Laubach, great scholar and missionary, who has led the way in teaching the "silent billion" to read and write; these are all pioneers of the mind. God send us more!

**Moral Pioneers**

WE need also pioneers of the moral life. "Time," says a line in a poem by J. R. Lowell which has made its way into most hymn-books, "makes ancient good uncouth." For instance: once upon a time, practically all Christian people supposed that slavery was not only a good thing, but that God had commanded it for all time. Whitfield, a famous evangelist, said that what America needed for its development was more slaves imported from Africa, and more home-brewing of liquor. Today this sounds so ridiculous that it is hard to believe that a Christian could have said it. Time has made ancient good uncouth. But time alone will not do this. There must always be some moral pioneer, some one who will run the risk of being called "bad" by going out in front of popular opinion.

Between Whitfield's time and ours there have been moral pioneers, notably a Quaker named John Woolman on whose mind and heart God laid the message: Slavery is a wrong.

**Pioneers of God**

WE need also spiritual pioneers. Persons who will move forward to new discoveries of God. For most persons, God is still an "undiscovered country"; and no man can discover God for another, though he may testify to his own discoveries. So in the realm of the spirit each must be his own pioneer; and some men and women, even from sickbeds, unable to walk as far as the door, have made great discoveries of God. The man who is honored as a saint by three religions—Christianity, Judaism and Mohammedanism—Abraham, is sometimes known for the wrong thing. He may be thought of as a traveling pioneer because he moved several hundred miles during his lifetime. But he was not a pioneer in the "old American" meaning of that word, for the Canaan to which he went was no unsettled wilderness but a well-populated civilized country, and he never owned the land he lived on.

Abraham's pioneering was in the realm of the spirit. We know from Joshua 24:2 that even Abraham's father was an idolater; Abraham moved out from the pagan religion of his father and his people, to the discovery of the One True God. No more important journey was ever taken. The traveling of Abraham's feet was of little importance by comparison. It was the traveling of Abraham's spirit that has most blessed us all. 


