

"Public Water Supply Approved" signs will be erected on U.S. highways 54 and 287 by the Southwestern Public Service Co. Highway Department.

V. M. Ehlers, Director of the Bureau of Sanitary Engineering, has informed Chester Guthrie that the water works plant in Stratford has earned the honor. A portion of the announcement letter follows:

"This Department is in receipt of a report from V. T. Hancock, Engineer Assistant, covering the sanitary survey of the public water system serving the City of Stratford, which is owned and operated by the Southwestern Public Service Co.

Your records will reveal that the City of Stratford was recognized as having State approved water facilities on October '23, 1937, in view of the high sanitary standards of water works operation and maintenance which existed at that time. Your company officials were also authorized to erect "Public Water Supply Approved" signs on highways entering the City, upon attainment of this honor

It is our understanding, however, that strict compliance with recommended operating practices has not existed during the past few years, and also that your company has found it necessary to expand these facilities to meet the increasing water demands of the City of Stratthews and Vernan of Fort ford. # Service Men Have **Free Vote Privilege**

Former members of the Armed Forces, the U. S. Maritime Service or the U.S. Merchant Marine who have seen active duty within the last 18 months are entitled to vote in the August 28 run-off primary without the payment of the poll tax, according to a ruling by Attorney General John Ben Shepperd.

Shepperd said the waiver also applies to any person who is now on extended active duty as a member of any of the reserve components of the Armed Forces, a selective service draftee, a member of the National Guard, the U.S. Maritime Service or the U.S. Merchant

The Texas Constitution prohibits members of the "regular" military establishments from voting.

Voters covered by Shepperd's ruling are not required to accompany their application for an absentee ballot by either a poll tax receipt or an exemption certificate, though the county clerk may require the voter to make a statement setting forth his military status.

Christian Giving. Lesson for August 22: 1 Corintbi-ans 16: 1-2ab; II Corintbians 8: 1-9. Golden Text: Acts 20: 35.

Christian giving is an indispensable part of Christian living. No man can be sincere in his Christian life if he is not willing to give unto God that which is due. Paul was concerned in raising a collection for the poor saints in Jerusalem and he was urgent in emphazing the responsibility of converts toward the needs that were brought to their attention.

The apostle laid down a plan that anticipated by nearly two thousand years the every-member canvass and the weekly bringing of contributions to the church. Upon the first day of the week, he wrote, Christians should lay aside the part of their earnings that should be consecrated unto God.

Paul cited the example of a generous giving by the Macedonian Christians, who had given above all that he expected of them, and more, beyond all that he thought was their ability to give. He also revealed the secret of their generous giving-they first gave their own selves unto God. When a man gives himself to God, there is nothing that he will withhold from God.

But Paul, in urging the Corinthians to give freely, also cited the greater example of the Lord Jesus who was rich but surrendered his kingly glory and became poor that men might be rich.

The Legislature shall have no power or authority to in any man-ner lend the credit of the State or grant any public money to, or assume any in-debtedness, present or future, bonded or otherwise, of any individual, person, firm, partnership, association, corporation, pub-lic corporation, public agency, or political subdivision of the State, or anyone else, which is now or hereafter authorized to construct, maintain or operate toll roads and turnpikes within this State." Section 2. The foregoing amendment shall be submitted to a vote of the quali-fied electors of this State at an election to be held on November 2, 1954, at which all ballots shall have printed thereon, or in counties using voting machines such machines shall provide for the following: "FOR the Constitutional Amendment problibiling the Legislature from lending the credit of the State or granting public money to, or assuming any indebtedness of, any one authorized to construct, main-tain, or operate toll roads or turnpikes in this State;" and "AGAINST the Constitutional Amend-ment prohibiling the Legislature from lending the credit of the State or grant-tending the credit of the State or grant-

Each voter shall mark out one of said clauses on the ballot, leaving the one ex-pressing his vote on the proposed amend-ment; and if it shall appear from the returns of said election that a majority of the votes cast are in favor of said amend-ment, the same shall become a part of the Constitution of the State of Texas. Section 2. The Governor of the State of Texas shall issue the necessary proclama-tion for said election and have the same published as required by the Constitution and laws of this State.
