IT RESOLVED BY THE LEG-LATURE OF THE STATE OF TEXAS:

Section 1. That Section 24 of Article III of the Constitution of the State of Texas be amended so as hereafter to read as follows:

read as follows: "Section 24. Members of the Legis-lature shall receive from the Public Treasury an annual salary of not ex-ceeding Four Thousand, Eight Hundred Dollars (\$4,800) per year and a per diem of not exceeding Twelve Dollars (\$12) per day for the first one hundred and twenty (120) days only of each Regular Session and for thirty (30) days of each Special Session of the Legislature. No Regular Session shall be of longer duration than one hundred and forty (140) days. PROPOSED CONSTITUTIONAL AMENDMENT TO BE VOTED ON AT AN ELECTION TO BE HELD ON NOVEMBER 8, 1960. HOUSE JOINT RESOLUTION NO.

Dollars and Fifty Cents (\$2.50) for every twenty-five (25) miles, the dis-tance to be computed by the nearest and most direct route of travel, from a table of distances prepared by the Comptroller to each county seat now or hereafter to be established; no Member to be entitled to mileage for any extra Session that may be called within one (1) day after the adjournment of a Regular or Called Session." HOUSE JOINT RESOLUTION NO. 8 proposing an amendment to Section 24 of Article III of the Constitution of the State of Texas allowing an an-nital salary of not to exceed Four Thousand, Eight Hundred Dollars (\$4,800) per year and a per diem al-lowance of not to exceed Twelve Dol-lars (\$12) per day for the first one hundred and twenty (120) days only of each Regular Session and for thirty (30) days of each Special Session of the Legislature as the maximum com-pensation for Members of the Legis-lature; limiting the Regular Session to one hundred and forty (140) days; and prescribing the form of ballot and providing for the necessary proclama-tion and publication. Sec. 2. The foregoing Constitutional Amendment shall be submitted to a rote of the qualified electors of this State at an election to be held on the Sth day of November, 1960, at which election all ballots shall have printed thereon the following:




