# **Cisco Junior College Payroll Is Largest In Eastland County**

The payroll of Cisco Junio. College - \$1,706,055 for the current year - is the largest in Cisco and probably in Eastland County, President L. D. Woolley of the board of regents told the group at their regular monthly meeting last Monday night.

Ralph Glenn, vice president and business manager, revealed the payroll figures in the monthly financial statement to the board. The payroll amounts to \$142,000 month.

In addition to the \$1,706,055 per year in Cisco, the college has a substantial payroll in Abilene for their campus there and for Clyde for the third campus. The Abilene payroll amounts to \$43,000 per month or \$516,177 for the current year, while that in Clyde is \$5,963 per month or \$71,558 per year.

In other action, the board awarded contracts for repair and remodeling projects to be done during the summer. Contracts were awarded low bidders as follows:







# Warrants Issued For Two Of **Three Armed**. Burglars

Two suspects have been identified and investigators are still seeking the identification of a third responsible for the Wednesday armed robbery at Beskow Jewelry store in Eastland.

According to the Beskows (Charles and Billie), they were in the process of closing the store for business that day when the trio entered the store and asked to look at some expensive jewelry.

One of the two men drew a pistol and shoved the Beskows to the back where they were bound and gagged and pushed behind the drapes that seperate the store areas.

The woman then preceeded to clean out the display case that contained the diamond jewelry and took items from several of the other cases before they left the store.

The robbery took place around 4:30 p.m. and after freeing themselves, the Beskows notified the police, and a bulletin was issued for a watch for the two young males and one female, described as 'very dirty', and armed with a small caliber pistol.

A man seeking a parking place in the area at about the time the trio fled the scene, told police investigators that he saw three people that possibly fit the description. He stated that they left in a brown colored car, possibly an Oldsmobile.

After further investigation it was determined that the suspects had purchased the pistol that day from a local pawn shop. The sales ticket, which contained identification from the drivers license, was used to produce information from the Abilene

Police Pepartment that included photos of a white male, 5'8", 150 lbs. with brown hair and eyes, and that of a white female, 5'6", 145 lbs. blue eyes and blond hair. The two have been positively identified by the photos by the Beskows, a salesman at the pawn shop and by an Olden man who said the three stopped near his home about 5:15-5:30

### **Early Treatment** Recommended For Arthritis

Watching for early warning signs and seeking medical treatment promptly when they appear is the best way to control arthritis, according to Jerry Gerard, Abilene salesman for Pfizer Drug Manufacturing Co. in a talk last Thursday noon at the Cisco Rotary Club's

weekly meeting. Appearing on invitation by Dr. Tim Boersma, program chairman, Mr. Gerard had a picture slide presentation concerning the disease that causes discomfort for one of every seven living Americans - some 37,000,000 people.

Arthritis caused the average sufferer to lose two and a half days of work last year at a total cost in excess of half a billion dollars, Mr. Gerard said. Americans spend one billion annually for medications and another billion goes for quack remedies, he added, in efforts to control pain and suffering from arthritis.

Athritis is mostly an ailment that affects and inflames the joints of the body. Early warning of arthritis problems might be any pain that persists, stiffness of joints or low back pain, the presentation noted. If such discomfort lasts for six weeks, see a doctor, was the advice. Arthritis usually gets progressively worse if nothing is done.

While there is no known cure for arthritis, proper and prompt treatment can considerably relieve suffering, it was pointed out. New medications are in prospect, the speaker added.

# Winning By Losing - 'Fit For Life' Style

COLLEGE STATION --Weight control is a concern of many Texans, who realize that they can win by losing. Since 1985, the Texas Agricultural Extension Service has helped more than 3,000 Texans control their weight and improve their overall fitness and eating habits through a comprehensive 12-week educational weight control program call-ed "Fit For Life."

"The goal of any successful weight control program is not only to lose weight but also to maintain long-term, permanent weight control," explain Dr. Mary Ann Heussner, health education specialist, and Dr. Alice E. Hunt, nutrition specialist, both with the Extension Service. After the lesson series, those taking part had lost an average of 4 pounds for a total of 12,000 pounds-or six tons!

A follow-up survey with participants of the "Fit For Life" program showed that they not only maintained weight loss but continued to lose an additional 3.7 pounds each and 5.6 percent of body fat one year after completing the program, the specialists add.

Heussner and Hunt note that although Americans spend billions on weight loss programs, most of those who lose weight gain it back within a few months. The "Fit For Life" pro-

gram not only helps individuals and their families

lose weight and keep it off, the lesson series also focuses on control of blood pressure, follow dietary guidelines, improving cardiovascular fitness and increasing flexibility.

#### "The improvements in health and fitness equate to improved economic health for Texas," the specialists emphasize.

"Good eating and exercise habits are critical to the control of obesity. In addition, obesity is a risk factor for at least 5 of the 10 leading chronic diseases which account for the majority of health and medical dollars. Controlling weight and improving fitness reduces the risk health problems," says Hunt and Heussner.

Since cost of health care is one of the major financial concerns of families today, the Extension Service began a two-year research study in 1984 which involved 50 counties throughout Texas. Extension health and nutrition specialists developed the 12-week weight control lesson series incorporating research-based nutrition, exercise and behavior modification principles.

These Extension specialists in turn trained county Extension agents to conduct the lesson series throughout the state. The impact of the weight control and fitness program was evaluated by measuring changes in body weight, per-

cent body fat, flexibility. muscular strength and endurance, and cardiovascular fitness. At the end of the 12-week program, participants had achieved statistically significant improvements in these fitness its many associated health problems," the specialist areas

Success of the program is based on making small, practical, easily adopted changes in exercise and eating habits, which add up to lifelong weight control,' the specialists say.

# **Golden Triangle Royalty** And Oil, Inc. Hold Meet

A record number 115 persons attended the annual stockholders' meeting of Golden Triangle Royalty & Oil, Inc., at their Cisco home offices on June 5th and applauded news that the firm has acquired additional over-riding acreage and that oil income has started coming in from their Australian holdings.

The stockholders meeting was held at Kamon House, and, in addition to business sessions, the group enjoyed a Texas barbecue lunch (Oscar Weeks) and music by the Ghost Riders, C&W band, and tours of the com-

pany's home office facilities. Robert Kamon, GTRO president, presided at the meetings and the board reelected him as their leader for the coming year. He reported on recent trips to Queensland, Australia, for business transactions. Dr. Thys B. Johnson was reelected board chairman, Lloyd L. London was renamed executive vice president, and Effie Kamon was re-elected secretary. Re-elected to the board of

directors were Dr. Johnson, Mr. Kamon, Mr. London, Howard Siegel, Bernard Kosser and Mrs. Kamon. The directors named Karen Lee as a vice president, and Joetta Schuman was appointed company treasurer.

The board declared a five per cent stock dividend for distribution to stockholders as of Aug. 31, 1987. This was the 5th consecutive year for such a dividend to be declared, reported Mr. London

The company told stockholders that they have acquired 264,960 net royalty acres of over-riding royalty in the Eromanga Basin of Queensland, Australia's most active and prolific onshore oil producing basin. These acquisitions increase the gross surface acres under which GTRO holds over-riding royalties to some 68,808,640 acres and brings the net over-riding royalty acres to some 3,694,544, stockholders were informed.

The purchase by Exxon of a 25 per cent interest in a large producing block in the Eromanga Basin of Queensland was of considerable interest to GTRO. Mr. Kamon told the stockholders. Exxon paid

### **Cisco Receives** 2-3 Inches Of **Rain Last Week**

While recent rains, including some two and a half to three inches during the past week, have benefitted lakes and ponds and the moisture situation generally the county's peanut and grain farmers are facing problems, County Agent **DeMarquis Gordon reported** Friday.

Lake Cisco gained approximately a foot of new water during the past week for a total of about five feet in the past month, city water department workers reported. The city's Battle Creek pump station was running Friday as it had been all week

Mr. Gordon said the county peanut growers usually plant between May 15 and June 15 and it has rained some 15 inches over the county during the past two months. He estimated that only about 15 per cent of the approximately 22,000 acres normally planted were put in the fields during the past three weeks.

Grain fields of wheat are ripe and ready for harvest and could be lost unless dry weather soon prevails, Mr. Gordon said.




If flood waters have covered a garden some produce may be unsafe to eat. This depends on the kind of produce, maturity of produce at the time of flooding, time of year, severity of flooding, duration of flooding, bacterial content of floodwater, and likelihood of contamination from sewage or other bacterial contaminants.

In general, fruits and vegetables that were immature at the time of flooding should be safe to eat by the time they are ready for harvest. For added safety, clean produce well, and cook before eating.

If flood waters covered the vegetables that were ready for harvest there is a dnager of bacterial contamination. These vegetables should be disinfected, peeled and thoroughly cooked. Some vegetables are more susceptible than others to bacterial contamination.

Leafy vegetables, such as lettuce and cabbage and fleshy vegetables and berry fruits such as, tomatoes, summer squash, strawberries and peppers would be highly susceptible to bacterial contamination.

Root, bulb and tuber crops such as, beets, onions, and potatoes would be less susceptible to bacterial contamination. Disinfect these vegetables, peel and cook them thoroughly before eating.






