Johnson sank a 12-foot putt for a birdie and both Nichols and Thiberville missed putts of some 25 feet.

In the first flight, Johnny Coate and C. Deffenbaugh of Abilene had a 142 to win top honors. Second place went to T. Lambert and P. Downey with a score of 144. K. Peresh and Allen Rhoads of Breckenridge came in third with a 145. Consolation honors went to three teams that tied with 146s. Craig Kent and Buddy Ramirez had a 153 to win the second flight. R. Stobbs of Olney and Orville Robinson of Cisco won second with a 154, and third went to Kevin Winnett and Kirk Evatt of Cisco with a 155. Mike Blackburn and Danny Kent of Cisco won consolation with a 166.

A total of 140 teams participated in the two-day event. Play was slow Saturday due to heavy rains Friday night.

According to Director Myer the play is a hilarious comedy in which true love eventually triumphs, but the question is "Who has the true love?" Theatergoers can find out on opening night, Thursday, June 11. The play runs through Saturday of this week with a Saturday matinee at 1:30 p.m. in addition to the evening performances at 7:00. # Maner Scholars Named, New Ag Teacher Hired For Schools

Trustees of the Cisco Independent School District awarded four Leon Maner college scholarships, accepted the resignation of the agriculture teacher and named his successor and studied plans for building a new athletic track at their regular monthly meeting Monday night.

Maner scholarships were

awarded to three Cisco and one Eastland youths for the 1981-82 school year. Kenneth Watson, Jr., a graduate of Cisco Junior College, was the Eastland youth named for the scholarship.

Kenneth Hawari, 1981 graduate of the University of Texas in Austin, was approved for a Maner scholarship to help him attend law school

this fall at UofT. His brother, Andy Hawari, a 1981 graduate of CJC, also was approved for a Maner scholarship, as was Oscar Lopez, another 1981 CJC graduate.

The board accepted the resignation of Tommy Toland, a veteran of some 30 years as an ag teacher at Cisco High School. Mr.

Toland has ranching interests in this area and plans to continue living here, Supt. James Couch reported.

Grant Robinson, 1970 graduate of Cisco High School, was named as Mr. Toland's successor as ag teacher. A graduate of CJC and Tarleton State University, Mr. Robinson has been teaching agriculture at San Saba High School for several years. His wife is the former Donna Reynolds, daughter of Mr. and Mrs. Don Reynolds, and they have an 18-month old son.

Mr. Couch said that school officials have determined that it would be too costly to move the stands at Chesley Field to build a new track there. Also, space is too limited in the Chesley Field area, he said.

A surveyor will be here Thursday to study a location just west of the junior-senior high school. An area 240x600 feet would be required for a regulation track plus adequate parking facilities, Mr. Couch said.

Other routine business was discussed by the board.

# Lake Cisco Gains Four Feet, Planting Delayed

Lake Cisco gained more than four feet of new water as rainfall that measured up to seven inches fell in this region during a three-day period ending last Saturday. More than four inches of rain fell Friday night.

City Manager R.J. Turpin reported that four feet and three or four inches of new water was gained by Lake Cisco, and the creek between Lake Bernie and Lake Cisco is expected to run a good stream for another week or more. Lake Bernie was virtually full after the Friday night deluge.

The Battle Creek pump station began operating Friday night and ran most of Monday, city officials said. One of the two big pumps at Battle Creek was out of

operation.

Mr. Turpin said the heavy Friday night rain did considerable damage to city streets and to the sewer system. City street department crews were hauling in new gravel and had machinery working Monday and Tuesday to repair wash-outs and rough streets.

County Agent DeMarquis Gordon said the rainfall was general over the county, measuring from three to six inches last week.

Peanut planting will be delayed a week or more as the ground dries, but the need for moisture was such that nobody is complaining about the delay, Mr. Gordon said. He estimated that 35 to 40 per cent of peanut acreage had already been planted

and some will have to be replanted. The county plants between 35,000 and 40,000 acres each year in peanuts.

Peanut seed is plentiful but expensive, Mr. Gordon said.

Mr. Gordon estimated that some 25 percent of the 1981 grain crop remains to be harvested, and this is being delayed by wet fields. Fortunately there was no hail or high wind, minimizing damage to ripe wheat, Mr. Gordon said.

County stock tanks were in excellent condition, the county agent said.

# Appraisal Work Begins June 3

The appraisal work for the Cisco area was started Wednesday, June 3. Field appraisers for McMorries and Company arrived and quickly set about the task required of them in helping the taxing districts of the county meet 1982 property tax requirements. As stated in earlier articles, the work being done will have no effect upon 1981 values, it will be for the 1982 tax year.

There are several crews working at the present time in the Cisco area. The rural crews have started in the South part of the district while the others are working the City. The work is expected to take several weeks and property owners should

be expecting the appraisers.

Each piece of property will be measured and classified, if the owner is not at home; a card with proper identification will be left so the owner will know the appraisers have been there. Your cooperation is requested, as the more help the appraisers have with each piece of property, the better or more accurate job of classification and valuing can be done.

Representatives of the firm have stated that they do not need to go into the houses. The measurements they need will be of the outside. If you have any questions concerning the appraisal work, please contact the Cisco ISD tax office.

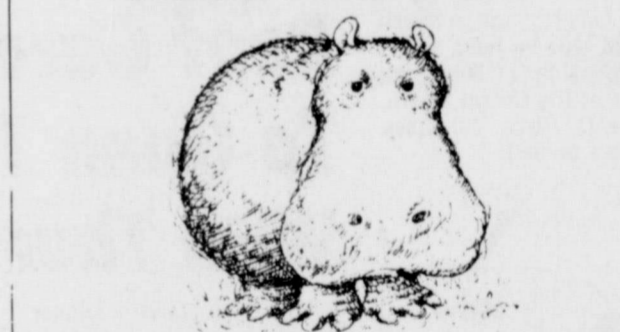

## Savings Bonds Interest Rates Increased

Secretary of the Treasury Donald T. Regan today announced a new one-percent rise in the interest rate for U.S. Savings Bonds and Savings Notes, effective Friday, May 1, 1981.

The interest rate on Series EE Bonds purchased beginning May 1 is being increased from 8 percent to 9 percent, compounded semiannually, when the bonds are held to original maturity. The term to maturity is being shortened from 9 to 8 years.

The interest rate on Series HH Savings Bonds purchased beginning May 1, is being increased from 7-1/2 percent to 8-1/2 percent to their original maturity, which remains at 10 years. Interest on these bonds is paid semiannually by check.

The action will also increase the yield to maturity on outstanding Savings Bonds and Savings Notes. Approximately \$70 billion in bonds and notes is presently held

by 23 million American households.

In announcing today's decision, Treasury Secretary Regan said: "The billions of dollars in Savings Bonds held by Americans in the Savings Bonds Program are extremely important to our government; they help finance the enormous national debt in a relatively stable, cost-effective and less inflationary manner. Savings Bonds are important to our citizens because, through payroll savings, they provide an easy and convenient way to put money aside regularly and save for the future. I am pleased to announce this yield improvement and hope that today's action will inspire Americans to purchase more bonds, particularly through the popular Payroll Savings Plan."

Informed of the decision by Secretary Regan, James G. Affleck, 1981 National

Chairman of the Industrial Payroll Savings Committee said: "I'm delighted with the increase in the interest rate on Savings Bonds. This action provides every American with greater incentive to save. I urge all citizens to buy bonds now. They'll be saving for their own futures - and equally important - the future of our country."

Outstanding unmaturing Series E, EE, H and HH Savings Bonds, as well as outstanding Savings Notes (Freedom Shares) will also benefit from a 1 percent increase to their next maturities. The redemption value of E and EE Bonds and Savings Notes and the interest on H and HH Bonds during periods before their maturity will be improved. In general, the increase will be effective with the first semiannual interest period that begins on or after May 1, 1981. Maturity periods for these bonds and notes will not be changed.

The rate increase will not be applicable to Series E Bonds issued from May 1941 through October 1941. These bonds will reach final maturity and cease to earn interest between May and October 1981, on the 40th anniversary of their respective issue dates. Owners of the maturing bonds are en-

couraged to consider exchanging them for Series HH Bonds. All Series E Bonds and Savings Notes, and EE Bonds over six months old, are eligible for exchange, in minimum amounts of \$500 redemption value. The exchange offer permits the owner to continue to defer reporting the accrued interest on the E and EE Bonds and Notes for Federal income tax purposes, until the Series HH Bonds are redeemed or reach final maturity.

Present legislation permits the Secretary of the Treasury, with the President's approval, to raise interest rates up to one percent during any 6-month period. The last increase was November 1, 1980. U.S. Savings Bonds, Series E and EE, have had twelve rate increases since the program's inception in 1941.

The new 9 percent rate for EE Bonds and 8-1/2 percent rate for HH Bonds will be guaranteed minimum yields to their original maturities.

Continuing benefits of Series EE Bonds include their exemption from State and local income taxes, the option to defer Federal income taxes on accrued interest, the low minimum purchase price of \$25, and the right to redeem the bonds any time after six months at issue price plus accrued interest.

## Japanese Youth To Visit Gorman

The R.C. Harrington family of Gorman will have a special guest in their home this summer - a teenage Japanese youth. This young man is part of the 4-H/LABO exchange program established in Texas several years ago.

In April of 1966, LABO Teaching Information Center was organized with the purpose of creating an awakening of international understanding and

awareness among Japanese children through language. The goal of its language education is to enhance human relationships and cultural exchange in the international community.

In keeping with its goals, an exchange program was initiated in 1972 with the 4-H Clubs of America. From this beginning, the program has expanded to include 1,000 people from Hawaii, Korea,

Japan and the U.S.

The Harrington's from Gorman applied as a host family for a Japanese youth several months ago. Recently they were notified that they would be hosting a young man close to the age of their teenage son, Olin, who is a member of the Gorman 4-H Club. This Japanese youth will stay approximately a month (from mid-July to mid-August) with this local family.

This will not be Eastland County's first experience with the LABO program. In 1979 the Ronnie White and John Kidd family hosted three Japanese youth. Last year, Robin White, from Eastland 4-H, traveled to Japan for a month to stay with her LABO exchange, Tomoko Uchida. Eastland County is fortunate to have this international experience with Japanese youth for the past few years. 

**FACTS YOU SHOULD KNOW**  
**THE TEXAS REAL ESTATE LICENSE ACT**

"SECTION 15. The commission may, on its own motion, and shall, on the verified complaint in writing of any person, provided the complaint, or the complaint together with evidence, documentary or otherwise, presented in connection with the complaint, provides reasonable cause, investigate the actions and records of a real estate broker or real estate salesman. The commission may suspend or revoke a license issued under the provisions of this Act at any time when it has been determined that:

"(1) (A) the licensee has entered a plea of guilty or nolo contendere to, or been found guilty of, or been convicted of, a felony, in which fraud is an essential element, and the time for appeal has elapsed or the judgment or conviction has been affirmed on appeal, irrespective of an order granting probation following such conviction, suspending the imposition of sentence; or

"(B) a final money judgment has been rendered against the licensee resulting from contractual obligations of the licensee incurred in the pursuit of his business, and such judgment remains unsatisfied for a period of more than six months after becoming final; or

"(2) the licensee has procured, or attempted to procure, a real estate license, for himself or a salesman, by fraud, misrepresentation or deceit, or by making a material misstatement of fact in an application for a real estate license; or

"(3) the licensee, when selling, trading, or renting real property in his own name, engaged in misrepresentation or dishonest or fraudulent action; or

"(4) the licensee, while performing an act constituting a broker or salesman, as defined by this Act, has been guilty of:

"(A) making a material misrepresentation, or failing to disclose to a potential purchaser any latent structural defect or any other defect known to the broker or salesman. Latent structural defects and other defects do not refer to trivial or insignificant defects but refer to those defects that would be a significant factor to a reasonable and prudent purchaser in making a decision to purchase; or

"(B) making a false promise of a character likely to influence, persuade, or induce any person to enter into a contract or agreement when the licensee could not or did not intend to keep such promise; or

"(C) pursuing a continued and flagrant course of misrepresentation or making of false promises through agents, salesmen, advertising, or otherwise; or . . .

## Cucurbit Diseases

Due to the recent rains experienced in our area, disease pressure or the likelihood of disease occurrence has increased greatly. Most of the disease encountered in the garden are caused by Fungi. Fungi which attack plants utilize living or dying tissue for their nutrient requirements. Plants in the Cucumber family (Cucumbers, Squash and Melons) are susceptible to a variety of Fungal Diseases. One of the more predominant diseases of this group is Downy Mildew caused by *Pseudoperonospora Cubensis*. This disease is characterized by angular yellow spots appearing on the upper side of the leaf. During periods of high moisture, the under side of the leaves, opposite of the yellow spots, becomes covered by a grayish white mold.

This mold is actually the fruiting structures and spores of the Fungus. The spores are the reproductive

structures or "seeds" of the Fungus. The spores are more noticeable early in the morning, especially if a heavy dew is present. Spores are easily detached and carried by the wind from diseased to healthy plants.

Cool temperatures along with available moisture are ideal for infection and disease development. Hot and dry weather will reduce or stop the disease development. Fungicide applications of Maneb should be applied before disease symptoms appear.

Another disease of Squash which occurs during prolonged damp weather is *Wet-Rot*. This disease is caused by *Choanephora Cucurbitarum*. The Fungus is usually confined to the Blossom end of the Fruit. The Blossom ends of Squash Fruits turn black, water soaked, and covered by a Fungal growth that resembles numerous black-headed pins. Under favorable conditions the Fungus may destroy the entire fruit. Diseased Fruits

should be removed and Benlate Fungicide applied. Always follow label instructions for rates and time between application and Harvest. For additional information regarding this and other pests, contact the County Extension Office.

## Senator Glasgow Reports

The one hundred and forty day session finally drew to a close, and I am happy to be able to go back to the District for awhile.

Of course, as you know, the House and the Senate failed to reach an agreement in Conference Committee on Congressional redistricting and the medical practices act, and this will force us to reconvene in a special session sometime this summer. Other possible subjects for special session scrutiny include the higher education construction fund, abolition of state ad valorem taxes, the water plan and changes in the Peveco tax plan.

Overall I was pleased with my legislative program as several measures that I either sponsored or co-sponsored have been signed by the Governor or are awaiting signature.

Probably the most important bill of statewide

significance that I carried, the oral confessions bill, passed and was signed into law. Texas is now the fiftieth state to allow oral confessions into evidence in a criminal trial. Additionally, the bill has more safeguards to prevent abuse than any other state's oral confessions law of which I am aware.

I was Senate sponsor of H.B. 364 that expanded the definition of aggravated rape in order to close loopholes in that statute. Also, I was co-sponsor of S.B. 126 which enhanced the penalties for child abuse and sexual abuse of children.

Three bills that I sponsored relating to oil field equipment and crude oil thefts passed and are awaiting signature by the Governor. Another crime bill awaiting signature is a measure providing for reformation of judgments in death penalty cases.

Two new District Courts have been created in the 22nd District, the 266th in Hood and Erath Counties and the 271st in Wise and Jack Counties. The 29th District Court moved wholly into Palo Pinto County, the 235th wholly into Cooke County and the 16th entirely into Denton County. Two new District Attorneys were created for the 266th and 271st.

Senate bill 561 providing for minimum standards for protective clothing for firemen was passed. This would set standards for clothing, boots, gas masks, etc. for full-time firemen.

Counties received some financial assistance from the state as both the lateral road fund and increased share of license receipts passed. These measures were sponsored by Senators Farabee and Traeger respectively, and I was a co-sponsor of both measures.

In the health care field I was the sponsor of the acts continuing the LVN licensing board and practices act and also the chiropractic licensing board and practices act. These two boards were subject to the Sunset Act review and necessitated new legislation in order to continue their existence.

Local bills that I sponsored that were passed included

creation of a water district in Graham, creation of juvenile board in Palo Pinto County, amendment to Cisco Hospital District dealing with leasing hospital facilities, and a bill dealing with bonded indebtedness for the Alvarado school district.

During this session twenty-three senate bills and seventeen house bills that I sponsored have been passed by both houses of the legislature.

Of course you have some bills that are very important and that you feel that should become law but they fail to pass.

One was Senate Bill 197 that would have repealed a special interest bill passed in 1979 that allowed private water utility companies to include property given to them by their customers in the rate base. This has been a particular problem in the Lake Granbury, Parker County and Johnson County areas served by Tarrant Utility. The people were right but because of strong lobby and special interest pressures, the votes were against repeal of the 1979 legislation.

Another measure that failed to pass was a wrongful death act that would have allowed recovery for mental anguish and loss of companionship with a minor child

is wrongfully or negligently killed. Presently, there is no recovery for wrongful death of a minor child except for funeral expenses under exceptional circumstances. This bill died in the rush on the final day.

An additional disappointment in the session was losing Young, Montague, Cooke, Hill and part of Denton Counties in the redistricting. These counties were part of a very homogeneous district with similar interests and needs that made it easier to represent. I do want these areas to know that I am still their elected representative until January, 1981, and will continue to represent them as diligently as I have in the past.

I am looking forward to being in the District during the interim and hope to see as many of you as possible.

## 'Carelessness' Leads To Lawn Mower Accidents

"Carelessness" is the main factor in the more than 50,000 people injured each year in accidents involving power lawn mowers.

Proper mower servicing, observing standard operating precautions, and picking up rocks and other objects from the lawn prior to mowing will eliminate most accidents.

"The lawn mower should be routinely serviced each time before taking it out of the garage to mow the lawn," says Dr. Richard Duble, turfgrass specialist with the Texas Agricultural Extension Service, Texas A&M University System. "A properly operating mower is safer to use and cuts grass better than one in poor shape.

Routine service includes checking the blade for nicks or cracks, checking the blade to be sure it is securely attached to the shaft, checking the crankcase oil level in 4-cycle engines, and filling the fuel tank with fresh regular gasoline.

"Always disconnect the spark plug wire before examining the blade," cautions Duble. "The condition of the blade is critical to the mower's operation and safety. Remove, sharpen and balance the blade several times during the mowing season. Replace damaged blades.

Service the carburetor air cleaner and change the crankcase oil after every 25 hours of operation, or at the manufacturer's recommendation. Duble also suggests cleaning the mower after

each use to reduce rust and corrosion and to prevent overheating, both of which reduce the life of the mower.

Another reason for keeping your mower clean is to reduce the amount of dirt getting into the engine. Clean the outside of the engine, the cooling fins on the cylinder wall, and blade housing with a stiff brush and soap and water or a degreaser.

Also clean the muffler and exhaust parts to that the exhaust system does not become restricted. Cleaning the mower regularly will extend its life and will also aid in detecting worn or broken parts before they cause extensive damage, adds the specialist.

Before mowing scout the lawn closely and remove any objects that might be picked up by the mower blade, advises Duble.

While operating the mower, follow these precautions:

-Never allow children to pay in the area where you are mowing since the blade can pick up and throw rocks and other objects.

-Avoid mowing up and

down slopes—always mow across the slope to prevent slipping under the mower housing.

-Always push rather than pull the mower.

-Never leave a mower running while unattended.

--When starting the mower, put your foot on its housing to pull the starter cord.

Caution and common sense will prevent most lawn mower-related accidents," says Duble. "That means keeping your lawn mower in good condition and using good judgment."

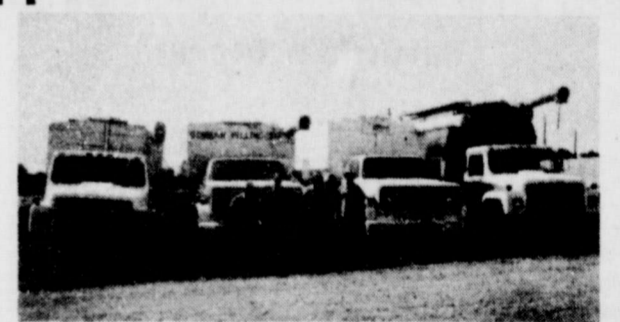

**Congressional Comment**

WASHINGTON, D.C.—A four-year omnibus Farm Bill has been formally voted out of the House Agriculture Committee that, if passed by this Congress, is in many ways unacceptable to U.S. farmers and ranchers.

I have personally fought many of the proposals in that bill throughout the drafting process and, having failed to revise some of the more unacceptable elements, will introduce an amendment calling for the expiration of the legislation at the end of the 1982 crop year.

The Farm Bill, as approved by the Committee, does not address the current problem facing agriculture and that is profitability in the marketplace. We must have programs that will enable the farmer to receive a reasonable profit on his investments. The question that I have continued to raise is why we should continue the same programs that have placed our farmers in such critical financial conditions. We need to look at alternatives that will address this problem in a more favorable and realistic fashion.

As a farmer, I know and realize that we cannot continue to operate as we have in the past if we are to survive. We cannot produce at an unprofitable level indefinitely. We must have agriculture prices on a paying basis if we are to continue to have a plentiful supply of food and fiber.

As a Congressman, I just don't believe that we have done our best for the farmers of this country through this legislation and in calling for the unusual one-year bill I hope that we can at least "cut our losses" to the greatest extent possible.

I strongly favor a permanent change from the traditional practice of drafting new agricultural legislation in the opening days of a new administration and a new Congress.

The first few weeks of a new Congress and a new administration are very chaotic under the best of conditions and this is certainly no time to be writing legislation of the importance of the 1982 Farm Bill. Congress and its committees need several weeks to organize and to become effective. At the same time, a new administration usually takes several weeks or months to get personnel on board and even longer to determine specific policy goals.

Due to the requirements of the Congressional Budget Act, we find ourselves in the position of writing four-year legislation before any one has a good idea of what direction they want to go.

I believe that by passing a one-year bill this session and a four-year bill next year, Congress can give the legislation the careful consideration it deserves.

The framers of our Constitution created a new system of government they called federalism. Simply stated, this new concept provided for a strong national government to do those things that only such a government can do — defend our shores, deliver the mail, regulate currency and other truly national functions.

But while the powers of this national government were considerable in its area of responsibility, all other powers were left to the states. Thus, the states, and in turn still more local jurisdictions, were responsible and sovereign in those areas which were more appropriately handled at that level.

Not only was this revolutionary, but also it worked. We Americans have enjoyed the benefits of a unified national government while preserving the maximum amount of autonomy to run our own affairs at the level closest to us.

But over the past half century, the federal government has slowly encroached upon powers intended for lower levels of government. It wasn't an insidious plot. Well-intentioned people saw needs and misguidedly thought only a federal law or regulation could meet them. The only problem was that often a national program failed to meet the needs of individual states or citizens because national rules don't allow for differences in local needs. As money became more centralized through federal taxes to pay for federal programs, more and more things were turned over to the national government — a classic vicious cycle.

The Reagan Administration has developed a plan to systematically reverse this trend, to restore federalism in its true meaning.

With the reams and reams of laws and regulations involved, it could take years to accomplish the process if only a hit or miss system was available. So the Administration has created two groups — the Coordinating Task Force on Federalism and the Presidential Advisory Committee on Federalism. The Task Force is comprised of the highest level presidential advisors and cabinet members. The Advisory Committee is composed of governors, state legislators, mayors, county officials, U.S. Senators and Representatives and private citizens. Both are chaired by Sen. Paul Laxalt of Nevada.

These people will be in a unique position to review current laws and regulations, draft proposals for new legislation and executive orders and help see that necessary actions are taken in timely fashion.

As President Reagan has said, too often the federal government has treated "elected state and local officials as if they were nothing more than administrative agents for federal authority."

Working out ways to reverse the trend, without loss of vital services and without returning responsibilities but not revenue sources, is a task little short of Herculean. But I am convinced it can be done. The Administration is

**Watching Washington**



If you're looking for a clear-cut example of government over-regulation, consider Section 404 of the Clean Water Act. This section, which sets Dredge and Fill Permit policy, has resulted in a bureaucratic nightmare of red tape and delay for private landowners, farmers and ranchers, and state and local governments across America.

As part of the effort to clean up our nation's rivers, lakes and streams, Congress included Section 404 in the 1972 law to require permits signed by the Army Corps of Engineers for work on "navigable" waters.

But "a dam broke loose" later when federal courts ruled that the term "navigable waters" extends to virtually all waters of the United States.

As a result, every farmer and rancher who wants to alter the use of his land, every city that wants to lay a water line, every county that wants to build a drainage ditch could wind up need-

ing a federal permit from the Corps of Engineers. An interpretation of this broad is certainly something that Congress never intended when the law was passed.

Since 1976 I have tried to amend this law to define "navigable waters" in the way the term has been traditionally understood. "Navigable" should mean what the dictionary says it means—deep and wide enough to afford passage to ships and barges.

Congress repeatedly has failed to draw a clear line between those dredge and fill permit requirements that are in the national interest and those that represent federal encroachment on the everyday lives of this nation's citizens.

The process for obtaining a Section 404 permit can drag on for an interminable amount of time, driving costs for even the smallest project through the roof.

Although the current law seeks to restrict dredge and fill permit review time to 90 days, a recent General Accounting Office study of three Corps of Engineers district offices shows that average permit processing time ranges from 120 to 300 days.

And, although the law also lets States take responsibility for granting certain kinds of permits, not a single State has undertaken such duties because the Corps, the Environmental Protection Agency and the Fish and Wildlife Service each retain an effective veto over any State proposal.

In Texas, for example, the Fish and Wildlife Service has successfully joined forces with the EPA to declare private "playa" lakes subject to the Section 404 process. Playa lakes, common in arid parts of the West, are small bodies of water which form after rainfall.

Clearly, with the 404 program loosely structured—as it is under current law—it lends itself to misinterpretations in the Courts and abuse by the bureaucracy. The time has come for Congress to re-establish its will and define a clear and workable program.

In the 97th Congress, I have proposed legislation again that would clarify and restrict the authority of the federal government under Section 404. I am hopeful that this Congress will take the action needed to unravel the red tape clogging America's waterways.

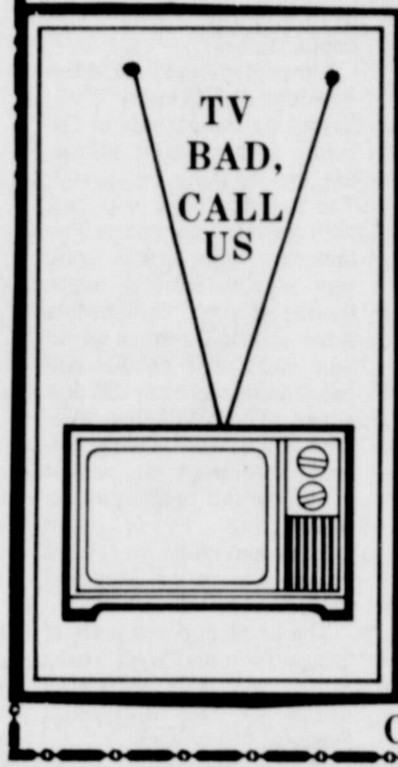

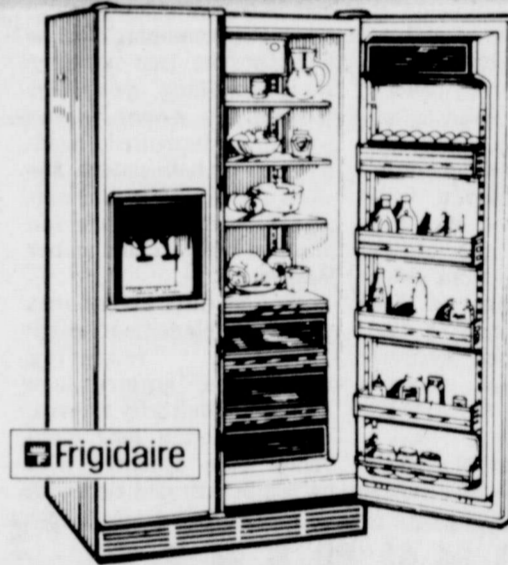
