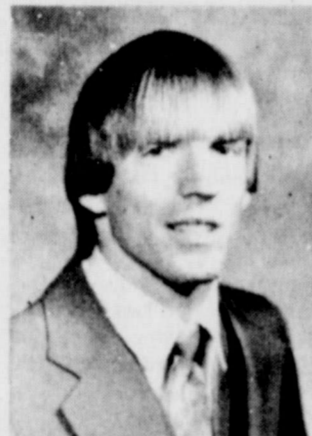

### Eastland Air Service Being Investigated

Eastland County air traffic is heavy and is growing daily. If enough concrete evidence of support is provided immediately, Eastland County could be a major link in the very important commuter airline network, proving again that Eastland County is truly the hub of a vast domain.

## Public Asked For Help In Local Murder Probe

Authorities investigating the kidnapping-murder of Mrs. Debra Garcia, Cisco convenience store clerk, appealed to the public again this week to report "any little thing" that might help them find the person or persons responsible for the crime.

"If you saw anything or anyone that looked the least bit suspicious or unusual during the early morning hours Sunday, Nov. 29, we would appreciate a call to the Cisco police department or the Eastland County Sheriff's office," the authorities said.

Texas Ranger Gene Kea is assisting Cisco police and the sheriff's office with the investigation.

A man arrested in Brownwood Sunday and charged with possession of a .22 calibre Mungum gun was questioned by Ranger Kea and Sheriff Johnny Morren and cleared of any connection with the local crime, according to a report Tuesday.

Mrs. Garcia was apparently kidnapped at about 6:45 a.m. Nov. 29th from Quickway Grocery where she was on duty alone. Her body was recovered some 60 hours later in a roadside

creek some three miles west of Cisco.

Authorities said they were going over all details of the case again, hoping to find something. They have questioned a dozen or more people and a number have taken polygraph tests.

A total of \$3,600 in reward money has been offered to anyone for information leading to the arrest and conviction of the murderer.

An autopsy report said that Mrs. Garcia had been dead less than 24 hours, and this would indicate that she was held somewhere in this area for a day and a half or longer before being shot, one investigator said.

"Perhaps somebody saw something that didn't look right at a house or cabin in this area," the investigator said. "If so, give us a call."

### Mayor Urges Donations To Reward Fund

Cisco Mayor Eris Ritchie urged all individuals or businesses in Cisco again this week to contribute to the reward fund for the murderer of Debra Garcia. He issued a plea for contributions last week and has again asked for such help.

The reward is presently at \$3,600 for information leading to the arrest and conviction of the murderer.

Mayor Ritchie said he would like see the reward get to at least \$5,000 in the hopes it would persuade anyone who might have seen something, to come forward and turn in their information, no matter how insignificant it may seem.

Three alarms were answered by Cisco Volunteer Firemen on Monday and a car fire was extinguished, a house blaze was put out, and firemen stood by while an injured youth was removed from a wrecked auto.

A car owned by Floyd Craft of 505 East 8th Street caught fire and was damaged. Firemen went to the Lester Williams home at 406 West 7th Street to put out a kitchen stove blaze.

Firemen were called to put out a grass fire east of Cisco Dec. 4th, and they answered a false alarm on West 13th Street on Dec. 6th.

# Taxation Takes No Holiday

(ED NOTE: We apologize in advance for bringing this subject up during the holiday season, but it's a subject of common interest.)  
It has been said there is nothing certain in this world but death and taxes. Few people enjoy either one. Yet most people agree that taxation is a natural right of government, and necessary to maintain an organized society.  
But the subject of whom and how and how much to tax occupies the minds (and pocketbooks) of most

citizens these days. In the state of Texas, especially, the topic of taxation has been the subject of discussion and legislation - including the approval of Bill 621 (Peveto Bill), and Constitutional Amendment 3.  
A massive state reappraisal program, in which all property will be listed at 100% of current market value, is almost complete. All Eastland County property has been reappraised except a small portion. In 1982 a new listing on the total value of the property, and its taxation, will be carried by

the Eastland County Appraisal Office. Steve Thomas is in charge of this Office, which is located in the Courthouse in Eastland.  
State-wide figures indicate that the Texas oil and gas industry is the highest single contributor to the state in terms of money paid for taxes. In the last fiscal year this industry paid 28.3% of the total state collections, amounting to \$2.2 billion. In addition, this industry paid the state \$1.5 billion in sales taxes, as compared to \$2 billion paid by the general public.

The Texas Mid-Continent Oil and Gas Association states that the industry is the largest single taxpayer on a local level as well, accounting for 22% of local taxes on a state average. It is undoubtedly much higher in Eastland County. For the oil wealth of this area is considerable, and shows up immediately on the tax survey.  
In 1981 the value of all Eastland County minerals were listed on the County rolls at \$184,165,450.00. Property values (land, buildings, personal property, etc.) were listed as \$86,734,254.00.

The County tax levied reflects these figures: The Mineral Roll was assessed as \$551,759.51 for 1981, and the property tax, \$259,973.93. Municipal tax rolls do not break down the mineral and personal property categories, yet even here the oil industry undoubtedly contributes much. On the school taxes, however, we have concrete figures on the amount paid. They are:

Property Tax - \$90,604.00  
Other taxation, such as that for Water Districts and Colleges, continues the trend. The Mineral Rolls for Cisco Junior College alone contributed \$102,256.15 to maintain this institution.

The development of Eastland County energy resources, then, has contributed not only to the economy, but has undoubtedly assisted in keeping the local tax base at a lower level than in other parts of the state. This has made the area a favorable place for anyone seeking relocation of a home or business.

## University Announces Scholarship Program

KINGSVILLE-A University Scholars Program, which will provide scholarships to students with outstanding academic backgrounds, has been announced at Texas A&I University by Dr. Bill Franklin, president.

The scholarships are another phase of Texas A&I's "Excellence in the '80s" program, which was initiated last year.

The new program will provide scholarships for two freshmen students in each of the University's five undergraduate Colleges.

Ten new scholarships will be available annually. Each scholarship is for \$4,000, payable at the rate of \$500 each semester until graduation as long as a 3.0 grade point average (on a 4.0 scale) is maintained.

Applicants for the scholarships must have a minimum score of 25 on the ACT or 1100 on the SAT, must show pro-

mise of success in the major field as determined by tests and selection committee, must have made a scholastic record that would justify consideration for a scholarship and must be in the upper quarter of his or her graduating class.

"We believe that the intellectual vitality of any university depends essentially on three things: the academic quality of the students, the quality of the faculty, and the resources that are available to support the teaching/learning process. This University Program is designed to attract some of the academically most capable students in the State to our University as a means of enhancing the quality of education we provide for all our students," state Dr. Franklin.

Donations from six business, totaling \$40,000, have allowed the University Scholars Program to be in-

itiated. The businesses are the Kleberg First National Bank, Kleberg County Savings and Loan, Mesquite Oilfield Services, B.W. Currow and Co., the Kingsville Publishing Company and Arthur Brothers.

## Letter to the editor

Dear Editor

Once again Christmas Greetings come to you from south of the equator. Swimming and ice cream is the vision we get on Christmas Eve rather than "sugar plums" and stockings hung by a roaring fire. No, we don't have a swimming pool at our station, but occasionally some of the missionaries mix business with pleasure and visit the Til Corp Estate where a nice pool is available. (I've been swimming once this year.) It helps to think briefly of diving into a cool pool... (snow and cold wintry winds are too remote to even be considered.) on a very HOT day.

We came back to our Mission to work because we know how badly we are needed. During the war about two thirds of our missionary staff left the country most of whom were re-assigned to other countries. But the needs are just as great here now as before...in fact greater. Since the war there is so much reconstruction to be done both spiritually and in buildings. Sanyati Mission Station was not destroyed. This includes the 85 bed hospital, 1000 student school, boarding facilities for some 400 of those students and homes to accommodate workers for these 2 big institutions. These buildings were built because of sacrificial giving through the years to Lottie Moon Offering. God protected these facilities in a miraculous way due to a few heroic African Medical Assistants and their Aids. But the hospital especially is in sad need of repairs and refurbishings. Little by little progress is being made in this direction. But the mission station at Sessami where we used to work was razed to the ground with only a pile of rubble as mute testimony to the long hard years we spent trying to make the love of Christ known. 5 other clinics where Rob used to be flown are also a pile of rubble. So with Sanyati as our headquarters and administrative duties as well as medical duties here, Rob is going back to try and reconstruct those 6 clinics. It reminds me of a quote from Rudyard Kipling's poem "If"... "If you can see the things you gave your life to broken and stoop and build them up again with worn out tools..."

His worn out tools include inadequate funds furnished by the government coupled with endless red tape, machinery and tools which he had collected through the years all destroyed, stolen or sold during the war and the money sent to the Foreign Mission Board where it was used in other countries with no hope of any replacement. Not the least of Rob's worn out tools is a heart that was somewhat damaged in his 1979 heart attack. So he wears titles of 4 very full time jobs previously held by 4 very busy missionaries. These titles are Hospital Administrator, Hospital doctor and surgeon, Clinic doctor and Superintendent of Construction for 6 clinics which must be built by March 1982 or the funds will be withdrawn. He needs lots of prayer for only the miraculous power of our Lord and Saviour can make all this possible.

I have the challenge of a life time. I'm teaching Bible at the High School. I teach 9th graders three 40 minute periods a week, 10th and 11th graders for 40 minute periods a week. I have 7 different classes so paper grading is something else! Approximately one fourth of the student body made decisions for Christ in the September Crusade. Since then 5 more 10th grade girls have come to me privately and asked me how to be saved. As an outgrowth of these decision I have 7 girls in discipling classes. I'm also teaching a New Believers class at a preaching point some 15 miles from here. The total commitments during the Crusade for the Sanyati area came to about 1100. Following up on these new converts is a tremendous task.

Political storm clouds are brewing but right now we are in no way limited in our presentation of the gospel. During the war many churches were closed and people are being taught to go back to their old spirit worship. We must try to reclaim the back slidden and deepen the roots of the disciples while the doors of opportunity are open. We must not worry about the cloud... "He that observeth the wind shall not sew and he that regardeth the clouds shall not reap." So keeping our eyes on the Savior we will go forward with the challenge before us.

May all of you and your loved ones have the special blessing as the angels sang "Joy and Peace" in your hearts at the time for celebrating the birth of our Lord.

# Eastland County Pecan Show

Eastland County's finest pecans will be on display Friday and Saturday, December 11 and 12, in the Courthouse lobby in Eastland. The special event will be the 29th Annual County Pecan Show. The pecan show will include about 200 entries of

high quality pecans representing over 40 different varieties. It will also include a bake show featuring delicious pecan pies, cakes, candy, nut bread and cookies. There will also be a pecan centerpiece class.

The show is being sponsored by the Eastland County Pecan Growers Association and the Eastland Chamber of Commerce. James Wright, Chamber of Commerce manager, says visitors will see some of the best quality pecans in Texas, as well as prize baked goods.

Plaques will be given for the Champion In-shell pecans, Champion Shelling pecans, and the Champion natives. Ribbons will be awarded to the first three place entries of each variety. In addition, ribbons will be given for the largest pecan and the smallest pecan.

Dan Childress, President of the County Pecan Growers Assoc., says this should be one of the better pecan shows ever held in Eastland County. This year's crop is much larger than last year's crop.

Show pecans not going to the regional show will be sold after the county show closes at noon Saturday. Shelled pecan kernels will also be sold at the close of the show.

Anyone producing pecans may enter the Pecan Show. Each entry consist of 43 pecans. All entries must be entered at the Extension Service office by 4:00 p.m. Thursday.

On Friday morning, the pecans from each entry will be weighed, shelled and kernels weighed to determine the number of pecans in 1 pound and the percent kernel.

Chamber of Commerce members and pecan growers will shell and weigh the pecans.

The weight of the pecans and the percent kernels are two important factors in determining winners, along with appearance, color, uniformity, and texture. Judges will be Horticulturists and Extension Specialists from Texas A&M University.

## Pecan Show Entry Rules

1. All pecans entered in the show must have been grown in 1981.
2. All entries of nuts must be entered by 4:00 p.m. on Thursday, December 10. However they may be sent or left at either the county Agent's office in Eastland or at the Cisco Chamber of Commerce or at the Ranger Chamber of Commerce prior to December 9. Entries should be marked with owner's name, variety and the grower's address.
3. Growers are limited to one entry of each improved or papershell variety. (example: John Jones may enter one of Burketts, one Mahans, one Western, one of Stuarts, ect.) If only one en-

try is entered in any class, the entry will be judged with "other varieties".

4. There is no limit on number of entries of seedling or natives. (example: John Smith has 5 different seedlings or natives. He can enter them all).

5. Nuts must have been grown by the person showing them.

6. First place nuts will be sent to the Regional Pecan Show in Arlington. First 3 entries of the Regional Show will be sent to the State Show.

7. All entries become property of the Eastland County Pecan Show. Entries not winning a ribbon will be sold to pay expenses of the show.

8. Each entry must consist of at least 43 nuts. (They are displayed on a paper plate).

9. Any alteration of pecan shells by marking, filing, or polishing will disqualify the entry so treated. However, exhibitors are encouraged to remove all traces of husks and foreign matter from the shells.

10. Classes will be made for any variety if there are at least 2 entries.

First three place entries in each class will be awarded ribbons. Plaques and rosettes are courtesy of the Texas Pecan Growers Association and the Eastland County Pecan Growers Association.

## Some Income Earned By Self-Employment May Not Affect Social Security

Some income received by a self-employed person after retirement may not affect benefit checks, Glyn Hammons, Social Security district manager in Abilene, said recently.

The general rule is all self-employment income received by a person in a year can affect his or her right to benefits. An important exception to this rule applies to income received after retirement which was earned before retirement.

Under this rule, income received in a year after the year of retirement which is not attributable to services performed after the month benefits start does not count for the annual earnings test, the measure used to decide if benefits should be paid.

Those affected by this exception include:

- Farmers who sell carryover crops in a year after the year of retirement but were raised, harvested, and stored before then.
- Self-employed life insurance agents who receive renewal commissions after retirement from policies sold before then.

• Retired partners who receive a share of the partnership income after retirement.

• Silent partners who may never have worked in the partnership but who receive a share of the income based on their investment.

• Other retired self-employed people who receive self-employment income solely from the ownership of an income producing enterprise.

The exception does not apply to any tax liability including Social Security self-employment tax. The exception does apply to all tax years after 1977.

More information about the annual earnings test, including this exception, can be obtained at the Abilene Social Security office. The people there will be glad to answer any questions. The office is located at 142 S. Pioneer and the telephone

number is 698-1360. Those living outside of Abilene can call toll free 1-800-392-1603.

A Social Security Representative will be in Cisco on Wednesdays at 1:30 p.m. of each month. They will be there on these dates Jan. 13, 27, Feb. 10, 24, and March 10, 24. The meeting will be held at the Chamber of Commerce.

A representative will be in Eastland in the Courthouse basement on Tuesdays 10 a.m. on Jan. 5, 19, Feb. 2, 16, and March 2, 16.

In Gorman, a representative will be in the city office on Mondays at 1:30 p.m. in the months of Jan. 25, Feb. 22, and March 22.

In Ranger a representative will be at the Joseph Bldg. on Main St. Wednesdays at 10:00 a.m. on Jan. 13, 27, Feb. 10, 24, and March 10, 24.

# USDA Charts Conservation Course

**Part 2: Resource Trends**  
(Editor's note: The U.S. Department of Agriculture has identified the critical soil and water resource problems of the nation, analyzed them, and proposed a national conservation program to address them. This is the second in a series of three articles that outlines the conservation problems, trends and analyses, and the proposed national program.)

Continuing present nationwide soil and water conservation trends would mean serious future conservation and farm production problems, according to a U.S. Department of Agriculture (USDA) report.

The finding is based on an analysis of the condition and trends of the soil, water and related resources of the United States. The analysis was part of a report required

by Congress in the Soil and Water Resources Conservation Act of 1977 (RCA), explains Ron Bailey, district conservationist for the Soil Conservation Service (SCS) at Eastland.

The analysis shows that the demand for food and fiber produced in the United States would increase while technological advances in agricultural production would decrease.

Without better technology to boost production, the demand to produce more food and fiber will mean that more acres of marginal land will be farmed. The result will be increased soil erosion rates and other resource problems.

If this happens, the productive capacity of American agriculture would decrease and production costs would increase.

The report says that these resource problems need to be addressed most quickly: Excessive erosion rates, upstream flood damages, groundwater depletion, and deteriorated water quality.

To project future conditions, the USDA analysts used a computer model to simulate the nation's agricultural productivity related to erosion. Although the model's results can't be taken as absolute indicators of what will happen, they do show the relative direction of American agriculture and the possible magnitude of future resource conditions and problems.

RCA Appraisal Part II, the second of three major RCA documents, contains the detailed analysis of the trends in the use and condition of America's oil and water resource base. A copy of this and other RCA documents is available for reference use at SCS and Agricultural Stabilization and Conservation Service offices throughout the state.

A short leaflet summarizing the RCA finding and proposed conservation program is also available at these USDA offices. The leaflet contains a pre-addressed, postage-paid response form that may be used to send comments to USDA. Responses should be mailed by January 15, 1982.

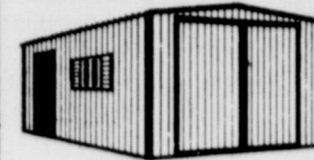

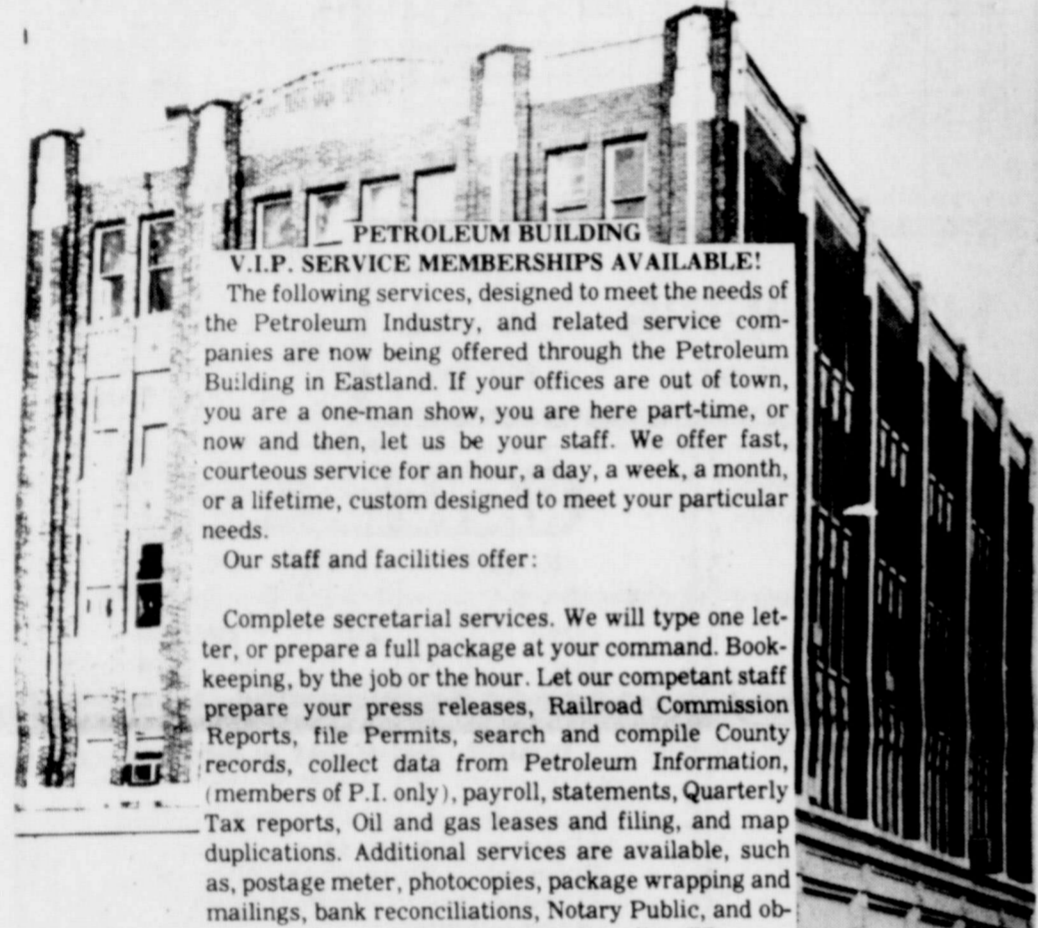

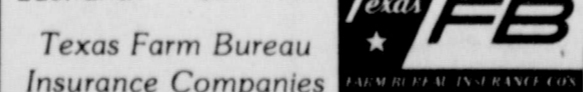

Drug Smuggling into the United States continues on the upswing, with vast quantities coming in from South America through the high seas along the Texas Gulf Coast.

Earlier this year I had the General Accounting Office look into this problem and the results were disturbing.

The GAO found that in 1979 the Coast Guard seized 208,000 pounds of marijuana in Texas coastal waters. But in 1980, when Castro flooded us with refugees, the Coast Guard diverted boats and manpower to Florida and they seized only 68,000 pounds of drugs along our coast.

This year Texas again has Coast Guard resources and we're intercepting more drugs than ever; twice as much as in 1978, before the Cuban sealift.

What disturbs me, though, is that the number of Coast Guard cutters has dropped by 27 percent over the past decade. They're intercepting only 15 percent of the narcotics destined for our coast. So, we've got smuggling on the increase and the ability of the Coast Guard to combat it on the decline.

Coast Guard officials have told me that they need 400 more ships and 350 more aircraft to fight these illegal smugglers, but at a time when we're cutting government spending, there isn't enough money for all this.

Many of the Coast Guard cutters are engaged in search and rescue, boating safety and oil spill prevention. If we want to control the flow of drugs into this country we must either provide the Coast Guard with more resources or reduce their responsibilities in other areas.

But there is an even better, more effective way to intercept drug traffic on the high seas and it can be done within existing laws and existing funding levels.

Most of the marijuana entering this country comes from Colombia and other South American countries. It is loaded aboard large mother ships and then—when they are near the U.S. coast—the cargo is divided between smaller boats.

All of that traffic must approach our coast through four "choke points" in the Caribbean—four narrow channels. With current resources, the Coast Guard can only cover those choke points about 18 percent of the time.

But, by drawing on the resources of the U.S. Navy to monitor these sea lanes, we can provide full coverage. We can spot, identify and trail the mother ships before they divide their criminal cargoes.

Earlier this year I wrote the U.S. Attorney General and urged that the United States use our Navy in the fight against these illegal drug smugglers on the high seas.

Recently Attorney General William French Smith responded to my idea with whole-hearted approval. He added that the Secretary of Defense is eager to cooperate.

Using the Navy to intercept drug smugglers on the high seas, the Attorney General reports, is going to be part of the drug-fighting policy of this Administration.

This can dramatically boost our ability to control drug smuggling. The U.S. Navy will make it harder for smugglers to continue their vicious trade.



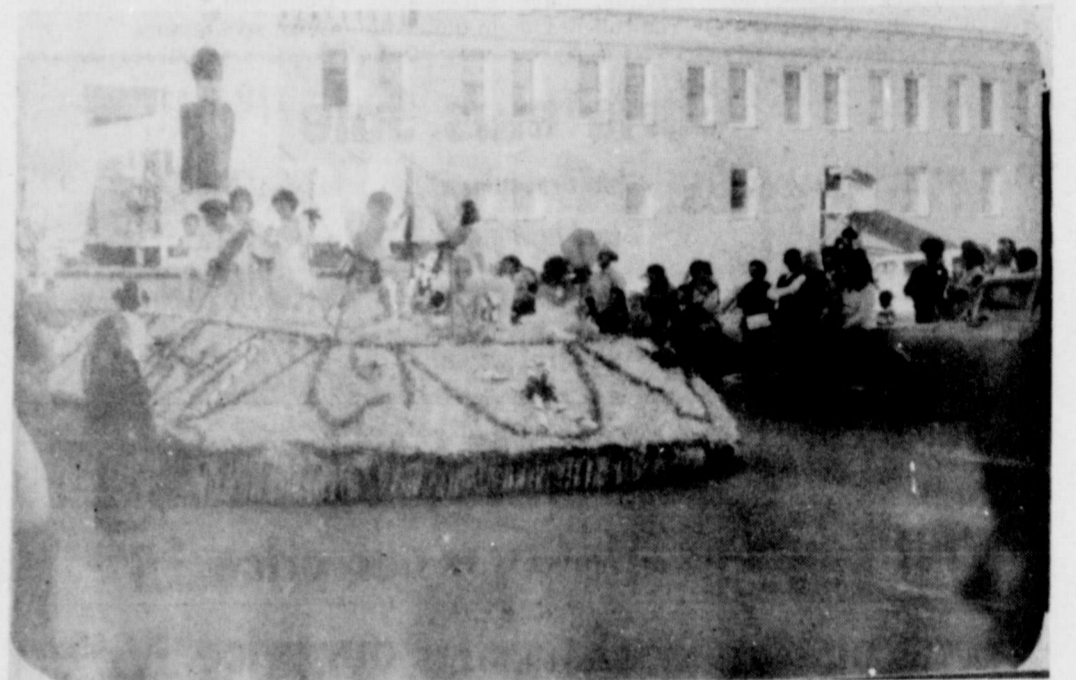

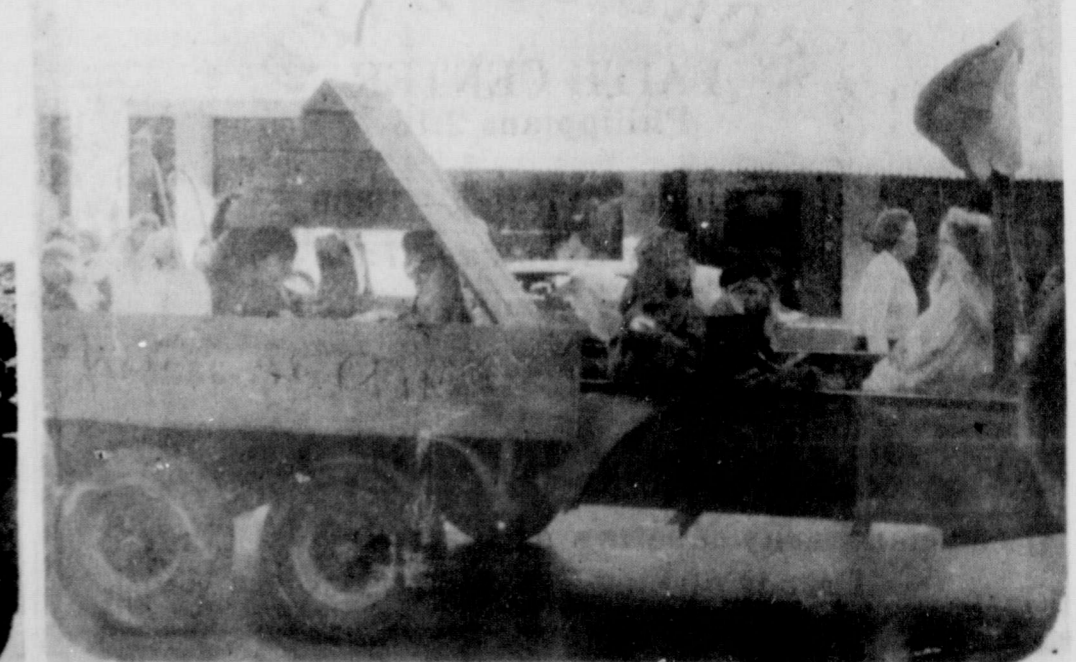

## Insulating Your Garden

We hear so very much today about the "R" factor and insulating homes to retain heat in the winter and the coolness in the summer in order to conserve energy.

We have the same problems in our gardens and flower beds. But here the insulation is called mulch.

Mulch performs many functions, it helps to retain moisture year round. In the heat of summer it helps to keep the plants cool and in the winter it helps to keep the plants warm and offers protection from freezing. There are many different products offered for sale for mulching your beds. We

must look for the best product to perform the above described functions and then we must consider the appearance of that particular mulch in our beds. There is one additional consideration and that is will the mulch we use counter-act any of the elements (acidity) that is in the beds or will the mulch enhance these elements.

Lets look at the most popular mulches in this area. They are pine, bark, cedar bark, rice hulls - sugar cane, red wood, corn cobs and leaves/grass clippings.

The pine bark mulch is by far the most popular due to the abundance of the product and the lower price. Pine bark mulch will protect the plants and will offer a good appearance in the beds. But we do have a problem with pine bark mulch it will leach the nitrogen out of the soil.

The cedar bark mulch is becoming a very popular mulch. It performs well in the protection of your plants and offers a good appearance and smell to your beds. Cedar bark mulch is 5.2 acid and will enhance the soil from this acidity stand point. There is also one unproven advantage to cedar mulch. It seems to retard insects in the beds. You must remember Grandmother's cedar lined closets to keep out moths, some of this insect retarding qualities seems to have carried over to the cedar mulch.

Let's examine the rice hulls and the sugar cane together. These two mulches are quite popular along the coastal areas. The sugar cane may attract ants to your beds and the appearance is not as pleasing as other mulches. The rice hulls have a pleasing appearance but the water retention is not as good as the other mulches and there is a blowing problem with rice hulls.

The red wood bark mulch is the most pleasing of all the mulches to the eye but it is the most expensive of all the mulches. Over all the red wood bark mulch is an excellent mulch.

Ground corn cobs make an excellent inexpensive mulch but the appearance is not pleasing until the corn cobs have aged by the weather while in the bed.

Grass clippings and or leaves have one very serious problem. They need to be ground up to very small particles where they will decompose rapidly. This mulch will build up heat during decomposing and can create very serious problems.

Your Garden Editor has attempted to present both the advantages and disadvantages to the most popular mulches that are available in this area.

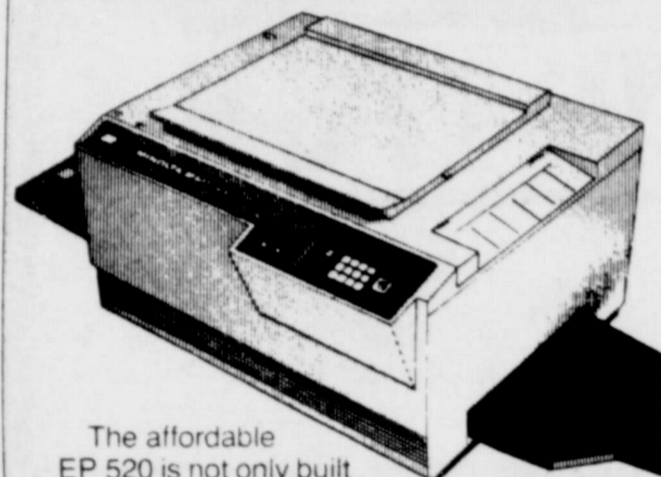

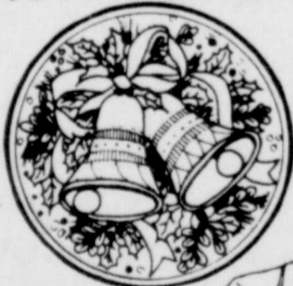

## Trae Martin To Work In Lieutenant Governor's Race

She is a 1981 recipient of the Texas Federation of Republican Women's Tribute to Women Award, was included in Young Women in America in 1975 and 1980 and is a member of the American Businesswomen's Association.
