## City Approves Street Lighting

Cisco City Council met Tuesday, 7:00 p.m. July 26, in the meeting room of City Hall. Present were Mayor Pro Tem Ivan Webb, City Manager Mike Moore, Councilmen Linton Batteas, Brad Kimbrough and Bobby Ingram; City Secretary Ginger Johnson, and City Attorney Bill Wright. The meeting was presided over by Mayor Pro Tem Ivan Webb.

On the business items, the Council approved a five year contract with West Texas Utilities for Street Lighting

Service. The City will continue to monitor this lighting, as it has become a substantial cost. Recent checking of city lights revealed that 37 locations the city is paying for are not operational. These will be repaired as soon as possible. Manager Mike Moore requested that citizens contact the City as soon as they notice a light which is not working properly.

Also passed on the first reading was an ordinance to abandon and vacate a portion of Wright St. between

FM 2943 and Leggett St. This has never been operated as a Street, so what the ordinance does is to basically vacate the property.

On New Business the Council passed several actions. The Council authorized the City Manager to advertise for bids on upcoming water improvements. There is a substantial problem with water pressure at this time, creating a fire hazard in the city. Steps on water conservation were set forth.

Manager Mike Moore

stated that the City was moving forward on the problem as rapidly as possible. Plans for upgrading the system are being reviewed in Austin by the Texas Dept. of Health and the Texas Dept. of Water Resources at this time. When approved, advertising for bids will begin.

This is anticipated in August, with bids awarded in September and construction to begin in October.

On Item Two, the Council approved a contract change order on Front Street. Old brick and debris will be

removed between 6th and 8th Sts. A brand new road base, curbs and gutters will be laid. Additional cost: \$9,286.

Item 3, approved pursuing a Community Development Grant, through the Texas Department of Community Affairs. There will be a public meeting Aug. 1 at 6:00 p.m. at City Hall to discuss this application. All are requested to attend.

Item Four was a Budget Session. Approximate \$1,250,000 was listed as the total budget for the current

year. The City Manager was directed by Council to move in three areas - a 5% cost of living increase in wages of City employees, an

upgrading of the City Retirement System, and a limitation of no more than 3% increase in tax revenues.

City Manager Moore stated that he would bring the budget back to the Council the later part of August, and that it would be a tight budget. Meeting dismissed.

## Low Water Pressure Creates Problems

"Low water pressure has caused a critical problem in Cisco," stated Mike Moore,

City Manager. Moore and other officials expressed

grave concern about a situation which could hamper the Fire Department in an emergency.

"We regret inconvenience to people of the City," said

the Manager, "But water and fire protection is our number one priority right

now. Our pumping capacity will not allow our City to

pump as much water as is being consumed."

Residents are directed to take two steps to conserve water during this hot, dry time. Do NO outdoor watering until Monday, Aug. 1.

After that, residents of odd-numbered houses are requested to water only during the morning hours of odd-numbered days.

At even-numbered houses,

after Aug. 1, the residents may water during the mornings of even-numbered days. No one may water outside at all during the afternoons or evenings.

On indoor water use, conserve all water possible.

"We urge total compliance with this rule," said Moore. "If we work together we can have adequate services."

"I believe the people of

Cisco, realizing the gravity of the situation, will cooperate to the fullest."

Moore said the City is working to upgrade the water delivery system as rapidly as possible, and construction should begin in the fall.

"This should be the last summer with this sort of water curtailment due to low pressure," he stated.

## Ambulance Service Extends Membership Drive Deadline

"Personal involvement is our greatest investment in Eastland County," Tommy Patterson says of his ambulance service as he announced emergency extension of the cutoff deadline for memberships for the coming year.

Because of the early-August check receiving time for many senior citizens, the membership deadline has been extended until Aug. 15, he said, adding that a definite decision will be made at that time as to whether the firm can continue to operate next year.

In its annual membership drive, Patterson Ambulance Service is attempting to secure 1,600 members in

Eastland and Cisco, and has only signed up 615 members in both towns at mid-week.

"In the event we are not able to secure enough members," he said, "we will refund the money to those who have already re-newed their membership for the coming year."

Patterson Ambulance does not receive any subsidy from either city or from the county, and in fact, pays a fee to the Eastland County Dispatch to provide central one-number calling for the service.

"Our family is here. We love it here," Patterson said, "and we want to be able to continue our ambulance service here. We feel an enormous obligation to our membership and want to be able to provide the best service possible, but we have to have the membership in order to operate."

Memberships for the 1983 year which are valid 24 hours after purchase are in effect until July 31, 1984. Cost

is \$39 for family, \$39 for husband and wife, and \$39 for an individual. Membership provides ambulance service to any hospital (for admittance only) within a 60-mile radius of Eastland, as many times as necessary with no further financial obligation to the patient or guardians and will accept third party assignments.

Reduced rates are available to members for clinical or medical facilities requiring an ambulance locally or out of town.

A coupon for membership appears in this issue of the newspaper and mail and be mailed to Patterson Ambulance Service, Post Office Box 912, Eastland, 76448, or may be taken to the City Hall in Eastland or Cisco.



They also visited Universal Studios, The Queen Mary, and the Spruce Goose, biggest airplane in the world.


Mrs. Ferguson also visited a friend she hadn't seen in many years, originally from Baird.



## Guest Slot

DO FAMILIES still pack up and "go to Yellowstone?"

Well this one did, and judging from the crowds there, thousands of others still do too, from all over the world. Many orientals, but virtually no blacks. Yes, we found cool, (cold) weather, but did not see a single bear, nor did we see Interior Sec. James Watt. It was a trip we'd been looking forward to a long, long time - and it was well-worth the effort. We know many here who have gone (Old) faithfully many times over the years and had heard such glowing stories that we deemed it wise to visit now. We'll try to outline some changes that have taken place. (We'd been close to the first National Park once back in '76, but decided we didn't have time to do it justice, and were glad of the decision later when we read of floods in that area. Even in mid-July we found lots of water, flowing streams, rivers and full waterfalls thanks to heavy rains and a heavy snowfall melt.

Sitting down in a comfortable car never feels quite as good as it does after you finally get everything in order (as near as possible) to leave for a vacation. This is especially true if you don't get around to doing much of the actual packing until the last day or two. It's funny how all of your bills get paid earlier when you're leaving the second week of the month (even those due before the 10th of the month) are mailed early.

Of course there are the hastily-jotted notes (of things not to forget to do to take.)

Never plan to drive far the first day. There are always more things to do and close out or down (like your house) than you can imagine.

From Eastland you can do it in three giant leaps: from here to Dalhart (lovely for rest); thence on the second day, through N.M. at Raton, all across Colorado (Int. 25 through Denver) and into the fourth state of the day, at Cheyenne, Wyo. On the third day, you do the due west through nothing (on Int. 30) to Rock Springs, Wyo., the jumping off place to the Tetons.

Third night found us in Jackson Hole, Wyo., a little "Gatlinburg" of the Tetons - offering train rides, float trips, rafting, tram ride, horseback riding, etc., etc., all geared to the tourist, based on a Western theme.

The Tetons and lakes surrounding them were our next attraction. We took the scenic route around them to Colter By Village and Jackson Lake. We spent one night here in a spotless, two bedroom rustic cabin with all the comforts of home. This location with beach and marina and Tetons is the background provided an excellent picture-taking spot. Amy enjoyed the heated pool at nearby Jackson Lodge.

On the drive (north) from the Tetons into Yellowstone, we stopped at a beautiful picnic area on West Thumb of the Yellowstone Lake near Grant's Village. We took the lower geyser basin tour with the spectacular Old Faithful; observing other geysers, the pools, etc., there on our way to our head-

quarters at the Canyon Lodge and Village area (near the center of the park). This area includes a campground, (only places to cook out in the park because of fire hazards in remote or cabin areas of the park). Only hard-sided vehicles are now allowed in this campground because of bears (we didn't see one.)

The first evening at Yellowstone, during dinner, we became rather "shook" when a fire alarm (as it turned out) became stuck and kept blowing. Soon after this, there was a good rain, cooling off our first and only day of warm (hot) weather while there.

Awakening in a "cold" cabin the next morning we wasted no time in finding the thermostat and plugging in the coffee pot.

The upper loop of the park was the choice for this cold, drizzly day. We had brought hamburgers and Wieners for cookouts. The weather didn't hamper much but we wasted no time getting back in the warm van away from the threat of bears in this northern campground to enjoy 'burgers cooked over an open fire.'

We never imagined Yellowstone to have scenery similar to Yosemite but alas, found it to be true! Perhaps partly due to the weather, but driving through clouds and views through the haze at mountain passes were gorgeous, very reminiscent of Yosemite. The winding Yellowstone River and rapids at bottom of mountains and the green, lush hills dotted with reflecting lakes, provided views to excite the most 'jaded' tourist. Switzerland is no better - just different.

Naturally, the geological aspect of Yellowstone is fascinating (even to those of us who know little about such things) and it's not just a little disconcerting to learn that there are numbers of minor (?) earthquakes daily in that area. Also to read about the speculations of "what happened" to cause such scenic phenomena, and to wonder what's still going on to cause all the steaming, bubbling and to imagine what really causes the geysers to "gys."

After returning from the upper loop, including Roosevelt and Mammoth

Lodges, we decided to finish our 'cookout' with a wiener and marshmallow roast in the Canyon campground. We did it quickly and ate in the van again as the weather was getting colder. We didn't realize how cold until back in one of the shops at the village, Amy exclaimed,

"Mom, it's snowing out there." It melted quickly, but that night was the coldest. We were glad for extra sleeping bags we had brought and even after turning up the thermostat, piled on extra coats and robes to sleep.

That day we saw the Canyon area, including upper and lower falls. This is probably the most spectacular of all the scenery at Yellowstone.

We observed much


wildlife: elk, moose, deer, chipmunks, etc. and chiefly buffalo, usually from a distance, in the park. It was amazing how many people stopped in the middle of the roads to get pictures--causing more traffic than wildlife danger.

There'd been plans for fishing, but after H.V. and Vance read all the requirements (catch and return, no live bait, etc.) decided against it.

On departure day, bound for Cody, Wyo., we saw most of Yellowstone Lake, had a picnic in a Bay Bridge area - and remembered our friends who have told us so many wonderful stories about Fishing Bridge - which is now known as No-Fishing Bridge.

#### To Be Held

#### August 5

COLLEGE STATION--Stallions Unlimited at Brenham will be the site of the 1983 South Central Texas Mare-Foal Clinic Aug. 5.

Some changes in the Texas brucellosis program which will allow for more freedom of movement of cattle, along with changes in procedure for establishing a certified free herd, have been approved by Commissioners of the Texas Animal Health Commission.

The changes were approved at a recent Commission meeting in Austin.

Present for the commission session were newly-appointed commissioners Mrs. Mary Nan West of Batesville, Laurence Bostick of Brookshire and Robert Bartlett of Canton.

Three changes relate to movement of cattle and include:

1. In a consignment in which there is a vaccinated

animal that is a suspect on the brucellosis test will now proceed in this manner: In such a situation, negative cattle in a consignment in which there is a vaccinated card test positive but rivanol or complement fixation negative suspect, may move.

2. In a non-infected herd of cattle which has been adult vaccinated, those animals that are card test negative at the time of movement may move without restriction.

3. A change was made relating to testing requirements from a C state or area or within the Texas C area. This change would allow movement of non-vaccinated cattle if they are tested negative within 30 days prior to movement and

either be from a herd in which all test eligible cattle have been together for at least 120 days and have been subjected to one negative test as a herd within the previous 365 days, or be from a non-quarantined herd and have been subjected to a negative test not less than 60 or more than 365 days before the test for movement.

Changes in procedures for establishing a certified free herd concern both dairy and beef cattle operators.

For dairy herds, the Commissioners made the change to require a minimum of four consecutive, negative milk ring tests conducted at not less than 90 day intervals. Previously, three negative tests were required.

Regulations also were changed to make it easier to

establish a certified free herd of cattle originating from a certified herd as follows: All or part of a certified free herd purchased and moved directly to premises without other cattle may qualify without a test.

A proposed change yet to be approved by Commissioners relates to movement of cattle to slaughter from a quarantined herd without testing of that herd, when the cattle are to be sold exclusively for slaughter. This regulation, however, must conform to federal rules—and at present federal rules require that all cattle from a quarantined herd be tested.

The tiny sorghum midge can be devastating to grain sorghums.

The midge, a tiny black and orange fly, survives in Johnsongrass until grain

sorghum begins to bloom; then the midge population explodes.


Adult midge lay eggs in grain sorghum during the bloom stage. Hatching larvae destroy the developing grain, so populations can drastically reduce yields.

An average of one midge per sorghum head can cause economic losses.

This pest can only damage sorghum when it is in bloom. Late blooming sorghum is usually more susceptible to damage because of larger populations of midge later in the season.

Because of the potential damage from midge, producers should check their sorghum fields frequently while the crop is blooming.

## History of Cisco Public Library

Having started in the early 1890's, with only Lew Wallace's, "Ben Hur", Mr. Frank Vernon had collected and processed for circulation 300 volumes by 1900, by which time the Twentieth Century Club "Ladies" assumed their "responsibilities of caring for the Cisco Public Library". Their historian, Mrs. C. H. Fee, said, "Small as it was, it became a problem to find a suitable home for it. Thus, early in the life of the Club was born a determination to build a Library Building; a home for our precious books."

In order to secure the necessary funds, the Club gave many parties and home talent plays and sponsored Lyceum Courses, etc. in Cisco. Making plans was difficult task. In Cisco, communicating in any way was not easy. "There were no telephones, no taxis and few of had a 'horse and buggy'." But such deprivation often turned into Advantage Unaware - because of it, "Cisco had no picture shows, Country Club, no Golf Course - thus, our efforts to furnish entertainment met with hearty support, and our Library Fund grew."

"In 1915, the Club bought a lot in what is now (1950) the Federal Post Office block and built a small wooden building which we proudly designated as the Cisco Public Library and for which we had a paid Librarian. Judge Butts obtained a Charter for the Club, with the following named Trustees: Mmes. Wm. Reagan, C.H. Fee, J.J. Butts, J.J. Winston, G.B. Kelly, and H.L. Winchell. In 1935, the property was sold to the United States Government for site for the Post Office Building. With the money thus obtained, the Library and Club Room, as it now exists, was built with very little outside help." Mention should be made of a \$500.00 gift from Mrs. J.E. Chesley as redemption of a promise made by her husband who had died before the Library Building became a reality.

How times have changed! Today the usual way for a Club to earn money is by Garage, Rummage, Book or Bake Sales and/or with memorial or other cash contributions. A person seeking a zoning change should be well prepared to justify why such a change would be beneficial to the community according to research conducted by the Texas Real Estate Research Center.

If you anticipate neighborhood opposition to a proposed change, you should use diplomacy. In many communities, neighborhood opposition is very effective in stopping any amendments to the zoning ordinance.

Your first step should be to examine the land-use plan of the community. If your proposed change is contrary to the land-use plan, you may find it very difficult to convince the decision makers to agree with your proposal.

Nevertheless, the planning staff of the municipality or county can be very helpful. Land-use plans are not cast in concrete, and some very good reasons for modifying a plan may have arisen.

SELLING OWN HOUSE CALLS FOR SPECIAL SKILLS

If you are considering handling the sale of your own

house, here are three items to think about. First, do you really know what your property is worth in the local market? Buyers will be discouraged if you set a price that is unreasonably high. On the other hand, you will lose money if you set a price that's too low.

Secondly, do you have the skill to deal with potential buyers? Can you present your property in a professional manner, pointing out how it meets the particular needs of each prospect?

Finally, will you be readily available to answer questions while you're attending to your own work and dealing with the difficulties of moving to another residence? Knowledge, skill and time. Evaluate yourself against each of these requirements before deciding whether or not to use a broker when selling your home.

### ADVISE LENDER WHEN FACING DEFAULT

If are facing default on your home mortgage, there are a number of steps you should take. First, you should let the lender know as soon as possible that you have run into serious difficulty in making your payments.

Second, seek counsel. Various counseling agencies, legal service groups and the local office of the Federal Housing Administration can help you. Using their advice, try to work out an arrangement with your lender to make up your overdue payments. If the lender agrees to the plan, the lending institution may hold off or forebear from taking legal action to get back the money.

If satisfactory arrangements cannot be worked, foreclosure is the legal process by which the lender takes the house from you and sells it to pay off the money you owe. Foreclosure means you lose the house, the

money you put into it and your credit rating.

### RESIDENTIAL CONSTRUCTION INCREASES IN '83

If building permits are a reliable indicator of construction activity, 1982 was a big year for residential building in Texas. Permits were granted to construct over 200,000 dwelling units, a 48 percent increase over 1981's volume.

More than half the permits were for apartment buildings of five or more units. This apartment total represented an 86 percent increase over 1981. Continued high rates of migration into the state and rising rental rates are encouraging buildings to produce more apartment units.

The metropolitan areas of Houston and Dallas-Fort

Worth combined to produce two-thirds of the apartment unit permits in the state. The Dallas-Fort Worth total was over 2½ times the number for 1981. While residential building may have been slow for most of the country, Texas builders have been busy.

### INSIST ON GENERAL WARRANTY DEED WHEN BUYING PROPERTY

The seller of a parcel of real estate normally gives the buyer a deed, but a buyer should view an offer of a quit claim deed with caution.

Anyone can legally sign a quit claim deed for any piece of property. The deed simply conveys the rights of the signing party without guaranteeing that the signing party has any rights at all.

A quit claim deed has

legitimate uses. Suppose a parcel of land belonged to a person who died without leaving a will. If that person's heirs all agree to relinquish any possible claim on the land to that person's son or daughter, then they can execute a quit claim deed in favor of the son or daughter. However, outright transfers of a title for sale normally involves a general warranty deed backed by title insurance. If you buy property, get legal counsel before signing any agreement.

# Telephone Conducts Trial Billing Procedures

thereafter in 1983, Cox advised customers to be sure to call the office number shown on that portion of the bill in order to obtain prompt handling and the desired information on questions

regarding long distance calls. he said that this trial will benefit the company in determining how best to handle its new environment and help introduce customers to the ways of the future.



# County Students Must Have Immunizations

The Texas Department of Public Health requires that all students enrolled in Texas schools have the following immunizations before entering school:

3 DPT shots, plus one booster shot given after the child's 4th birthday.

3 Oral Polio immunizations, plus a booster after the child's 4th birthday.

Measles immunization given after the child's 1st birthday.

Mumps immunization after the 1st birthday, and up to 12 years.

Rubella immunization given after the child's 1st birthday, and up to 17 years of age.

A Physician's Verification of Measles/Mumps Illness must be on record with their school.

A Tetanus/Diphtheria booster shot is required every 10 years.

The TDH will not accept the year that the immunization was given, the month, day and year are required on the child's record.

With the influx of out-of-state students coming into Texas, our schools are getting so large that the school officials are within their rights not to enroll a student until his/her immunization record is up to date.

All parents with children in school are urged to contact their school principal or school nurse to determine the immunization needs of their child or children before the 1983-84 school year.

## No. 1 Booz To Be Spudded Near Romney

A wildcat for oil or gas is scheduled to be spudded four miles southeast of Romney in Eastland County. Weatherford-based Nic-Well Resources Inc. is the operator. The explorer well carries permit for 3,650-ft. total depth. The drillsite will be in a 163-acre lease in the J.M. Grigsby Survey A-1045. The well is designated as the No. 1 Booz.

Pumping 19 barrels of crude and 120,000 CF gas per day on open choke, the No. 2 J.C. Harrell has been brought on line in Eastland County's Ranger Field.

Northridge Corp. of Grand Prairie is the operator.

Located six miles northwest of the Ranger city limits, the Harrell well was drilled to total depth of 3,406 feet. It will produce from a set of Black Lime Formation perforations 3,307 to 3,316 feet into the hole.

Drillsite was in a 108-acre lease, Ben Willis Survey A-1212.

A total of four developmental wells are scheduled for spudding in the Eastland Regular Field, one mile southeast of the Pioneer townsite. T-Square Petroleum of Rising Star is the operator.

Each of the wells carries permit for total depth of 2,600 feet. The operation is in a 79-acre lease in the ETRR Survey A-1894. The wells are designated as the Nos. 5 through 8 Taff.

Comanche Investments of Cisco has filed for permit to drill a 4,000-ft. developmental well in the Eastland Regular Field. Location is in an 84-acre lease in the J.M. Griffin Survey A-1845, four miles east-northeast of Ranger. The well will be known as the No. 1 C.E. Lowrance.

Breckenridge-based Smile Energy Inc. has filed first production potential for a new producer in the Northwest Ranger Field, Eastland County.

It is the No. 1 R.L. Cantwell "C", pumping 10 barrels of oil along with 75,000 CF casinghead gas daily on an open choke. It bottomed at 3,577 feet and will produce from a set of perforations in the Marble Falls Formation, 3,493 to 3,499 feet into the wellbore.

Location is in a 35-acre lease in the F.W. Harms Survey A-161, five miles northwest of Ranger.

Operating out of Louisburg, Kan., D.B. Warren has completed a new producer in Eastland County's Warren Field one mile north of Gorman. Warren's No. 1 D.B. Warren showed potential for two barrels of oil and 100,000 CF gas per day on a 15/64 choke.

The well bottomed at 585 feet and will produce from Gardner Formation perforations 535 to 544 feet into the hole. The well showed flow pressure of 65 PSI.

Drillsite was in a 120-acre

lease in the H&TCRR Survey A-195.

The No. 1 Isenhower Estate, a shallow well in the Eastland Regular Field, is ready for spudding four miles east of Putnam. Located in an 87-acre lease, CC&SFRR Survey, the well is slated for 500-ft. total depth. A. Muzny of Putnam is the operator.

The Dallas Group Inc. of Mesquite has staked location to drill the No. 1 G.W. Williamson in the Eastland Regular Field. The location is in a 257-acre lease block in the William Van Norman Survey A-545. Projected total depth: 3,800 feet.

Eastland County's REB Field will be seeing more developmental action when C.R. Gallagher Jr. of Lubbock starts making hole for his No. 1 Johnson. It will be a 3,900 ft. test aimed at pay in the Marble Falls Formation. The well will be spudded in a 42-acre lease in the H&TCRR Survey Sec. 35, Blk. 4, about five miles north of Eastland.

Jack Warren Co. of San Angelo is preparing to spud a 1,700-ft. well in the Eastland Regular Field, six miles southeast of Eastland. It will be known as the No. 1 Pip-

pen. Location is in an 80-acre lease in the H&TCRR Survey Sec. 16 Blk. 2.

North Ridge Corp. of Grand Prairie has staked drillsite for a 4,000-ft. developmental well in Eastland County's Ranger Field six miles northwest of Ranger. It is aimed at oil production in the Black Lime West Formation.

Location will be in a 40-acre unit in the Mary Fury Survey A-127.

Sun Exploration and Production Co. of Abilene has completed a pumping oiler in the Eastland Regular Field four miles west of Ranger. The well is designated as the No. 527 North Central Ranger Unit.

It pumped two barrels of crude and 127,000 CF casinghead gas per day on open choke.

It bottomed at 3,600 feet and will produce from a perforated interval 3,433 to 3,456 feet into the wellbore. The operation is in a 3,370-acre lease assembly in Eastland County's John York Survey A-557.

Shillelagh Corp. of Wichita Falls has filed first production figures on a new oil well in the Stephens Regular Field. The No. 1 H Wilson "E" showed potential to

make 30 barrels of oil per day on a 6/64-in. choke. Tubing pressure came in at 250 PSI.

The operator has 35 acres leased, with drillsite in Stephens County's TE&L Co. Survey, four miles north of Necessity.

The well will produce from an interval 2,775 to 2,795 feet into the wellbore. Total drilling depth was 2,995 feet.

At a location within the city limits of Parks, Lariat Oil & Gas Inc. of Mineral Wells has finished a new oil wildcat in Stephens County.

The well is designated as the No. 1-C Brooks, flowing oil at the rate of nine barrels per day on a 12/64-in. choke. Tubing pressure was 480 PSI. The well also showed potential for 240,000 CF of casinghead gas per day.

Location is in a 265-acre lease in the TE&L Co. Survey. Bottomed at 4,272 feet, the well will produce from perforations 1,948 to 1,952 feet into the hole. The well plugged back to 2,380 feet.

Jackson Oil Co. of Ranger has filed first production figures on two new oil wells in the Jackson Strawn Field. Location is eight miles south of Caddo in a 160-acre lease in the T&PRR Co. Survey.

The No. 22 Robert Jackson showed potential to pump nine barrels of oil per day on open choke. Bottomed at 1,779 feet, the well will produce from perforations 1,714 to 1,730 feet into the hole.

The No. 24 Robert Jackson indicated the ability to pump 10 barrels of oil per day on open choke. The well will produce from an interval 1,678 to 1,705 feet into the wellbore. Total drilling depth was 1,792 feet.

At a location one mile west of Caddo, Shillelagh Corp. of Wichita Falls has finished a new gas producer in the Stephens Regular Field.

Showing potential to make 329,000 CF gas daily on a 1-in. choke, a wildcat gas well has been completed two miles southwest of Mineral Wells by Juniper Operating of Dallas.

The well is designated as the No. 1 Baum.

## RR Commissioner Reports Figures

AUSTIN—Railroad Commission Chairman Mack Wallace has announced that Texas oil and gas well produced 439,716,283 Mcf of gas in April, down 14.53 percent from field runs a year earlier. That brings the total gas production for the year to date to 1,822,436,927 Mcf of gas.

Marketed gas production in April totaled 359,407,312 Mcf and reflected a 16.82 percent decrease from the April 1982 volume. Marketed production is the total gas to transmission lines and for carbon black, plant fuel and lease use.

Gas exported from Texas in April totaled 209,510,690 Mcf. Exports of Texas-produced gas in April totaled 168,310,478 Mcf, and reflected a 19.55 percent decrease from the year-earlier month.

Texas gas production in April came from 234,674 oil and gas wells.

In March 1983, Texas wells produced 452,822,019 Mcf of gas. Marketed gas production in March totaled 374,065,184 Mcf. March exports of Texas-produced gas totaled 151,310,472 Mcf.

# People n Things

A DAY AT the horse races was a highlight of our visit in Ruidoso, New Mexico, and the highlight of the day was meeting a man who talks to horses. The man, an elderly gent from Arkansas, was sitting next to us in the grandstand at the horse track. He had a program of the day's 12 races and a small notebook. His wife and daughter were with him.

We noticed that the man consulted his little notebook as each race on the day's program came up. After a few of the races, we inquired if he had been picking winners. He said that it wasn't often that he didn't have a winner.

Did he have a system, we inquired. Yes, he said, he talked to the horses.

Thinking about this for a time, we observed: "You talk to the horses?"

Yes, he said, he went to the horse barns during the morning and visited here and there. Did they let folks in to look at the horses? Yes, he said, if you get to know the trainers and track people. This, he added, was how to find out what horses would win the races.

The man used his wife and daughter as his runners. He gave them money and told them which horse to bet on.

"Bet this \$20 on Mr. Chronicle - on the nose," we heard him say. And his wife took the money and departed for the parimutuel window.

"On the nose ... you bet on a horse's nose?" we inquired. He explained that this meant simply that he wanted to bet on the horse to win. You can bet on them to win, come in first or second (place) or come in first, second, or third (show).

The horse he selected won. The man sent his wife to collect on the ticket. She came back and gave him \$22. The horse paid 11 to one. The man literally blew up. It turned out that instead of betting \$20 on the horse, she had bet the minimum \$2. He lectured her the rest of the afternoon...in rather strong terms.

The Arkansas man told us that he usually handled his own bet placing but he had driven 16 hours the day before and was tired. When the day ended, he had a pretty good roll of bills and said he figured to make several thousand dollars before going back to Arkansas.

We placed a \$2 bet on every race and only lost \$8 for the day, which we figured was pretty good. Next year, when we spend a day at the races we hope to arrive early enough to talk with the horses.

IT WAS NICE and cool in Ruidoso. When we went to

bed in our travel trailer, we covered up with a sheet. An hour later, we woke up shivering and got up and put on pajamas with long sleeves and legs. Another hour later, we woke up again and added a blanket to the covering sheet. And two hours later, a second blanket was added.

Daytime temperatures run in the 70s and 80s. And it's 48 to 55 at night. ... Truly Clark, who moved to Ruidoso a couple of years or so ago from Cisco to go into the electric business, is no longer a resident. He has joined General Electric as a field man and travels to work with GE dealers.

AT ALBUQUERQUE, we dropped in at a coin laundry and found a black man seated in front of an air conditioner. He was drinking a bottle of beer and had two empty bottles nearby.

"I'm supervising while my wife does the weekly wash," he explained.

And we saw a sign in an office window that said this: "Rules of the House - 1. The boss is always right. 2. When the boss is wrong, see rule 1."

AT FARMINGTON, New Mexico, we enjoyed a couple of days at the golf course and visiting friends and relatives. Next, we hope to see some of Colorado and to experience some cool weather. The nights are nice in New Mexico, but the days are pretty warm.

## Derwin Honea Buried In Rites Held Friday



## Record High Temperature Brings High Utility Bills

The fact that hot weather and high utility bills go hand in hand apparently is being proved again by West Texans.

Electric energy usage in the West Texas Utilities Co. system soared to new records this past week as temperatures throughout the territory hit the 100-degree mark.

A new record was set on Monday, July 25, when WTU customers used 19,286,000 kilowatt-hours during a 24-hour period. This record was broken the following day when consumption totaled 19,318,000 kilowatt-hours. The old record was 19,216,000 KWH recorded on July 23, 1981.

The peak demand this year still had not reached the all-time record of 994,000 kilowatts, which was set at 5 p.m. August 27, 1982. Peak demand is the largest amount of electricity being used at any given moment during the day. Highest peak so far this year was 982,000 kilowatts on Tuesday, July 26.

"We expect the demand to go higher, but we should have no problem supplying our customers' needs," said Don Welch of Abilene, WTU vice president and director of customer services.

"But we do hope our customers realize that the more energy they use, the higher their bills will be," Welch added. "We urge them to use electric energy wisely and to conserve when possible."

WTU's on-system generating capacity currently is 1,059,000 kilowatts. This

means that with last year's peak demand the Company had a reserve capacity of 6 percent, while the safe reserve is considered to be 15-20 percent.

To assure a reliable supply, WTU has contracts to purchase power when necessary from neighboring electric companies until the Oklahoma Power Station comes on line in late 1986. This station, now under construction near Vernon, will increase WTU's generating capacity by about one-third.

## Cisco JC To Hold Band Camp

The annual Cisco Junior College "Drive-In Band Camp" will be held August 8-12, 1983 on the CJC campus. Registration will take place at 9:00 a.m. on Monday, August 8 in the band hall which is located on the second floor of the Harrell Fine Arts building. Courses to be offered during the camp include theory, rhythm, band rehearsals, and section rehearsals. Cost for the camp will be \$30 per student for five days of instruction and a noon meal in the cafeteria each day.
