



PROPOSITION NO. 1 ON THE BALLOT (H.J.R. 108)

House Joint Resolution 108 proposes an amendment to the Texas Constitution relating to the appointment and terms of notaries public. The proposed amendment would:

-Require the Secretary of State to appoint a convenient number of Notaries Public for the state; and -Authorize terms of of-

fice of Notaries Public of not less than two years nor more than. four years.

A temporary provision of the proposed constitutional amendment provides that the amendment would take effect January 1, 1980; that each person who was appointed a notary public before January 1, 1980, would continue to serve as a notary public for the term for which the person was appointed; and that this tem-

porary provision would ex-pire January 1, 1982. The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to provide for the appointment of notaries public for the state and for a term of not less than two years nor more than four years as provided by law."

PROPOSITION NO. 2 ON THE BALLOT (H.J.R. 133)

House Joint Resolution 133 proposes an amendment to the Texas Constifution to provide for legislative review of the process of rulemaking by agencies in the executive department. The proposed amendment would allow the Legislature to enact laws:

-To provide for legis-lative review of the process of rulemaking agencies in the executive department; -To prescribe conditions for rules to take

effect: -To provide for suspension, repeal, or expira-tion of rules;


