Bobby Boone of Robert Lee caught a plane from San Angelo to Dallas Tuesday evening on the first leg of a trip half way around the world to Korea. Wednesday morning he took a flight to Houston and joined the Texas squad of athletes and coaches and flew to Califor-The California and Texas athletes and coaches departed Wednesday at 3 p.m. for Korea.

Bobby, who graduated from Robert Lee High School in May, was invited by the International Sports Exchange to participate as a high jumper in a track and field meet against the Korean National High School team. Bobby excelled in high jump competition in 1985, culminating in a tie for second place at the State Meet. He gained 6'10" in one meet and 6'8" many times this year.

The main purpose of the exchange is to promote athletic competition between United States athletes and other nations while giving individuals the one-in-a-lifetime opportunity to observe

other cultures firsthand. Since the International Sports Exchange is a nonprofit organization, Bobby was told he would have to raise the \$1800.00 required for plane fare, hotels, meals, and etc. A number of individuals offered assistance to the young high school athlete and the total was raised in just over a

week, enabling him to accept the invitation.

Bobby is expected to return to the United States about June 14. In addition to the track and field competition, the group will spend 2 days sight-seeing in the Republic of China.

The fishing pressure on Oak Creek has been heavy these past few weeks and with good reason-a lot of nice fish are being caught and the ones catching the fish are coming back and often bring a friend. It don't take long to gather a crowd when you have this going on.

Jack Hazard of Sweetwater took a fine string of fish both on Sat. and Sunday of this past weekend. The fish (bass) Sat. tipped the scales at 6 lbs 3 ozs, 4-2 & 3-0. Sunday his bass came in at 4-8, 3-13, 2-14 & 2-12.

This was the best overall string of bass weighed in at the Sportsman's Lodge this past weekend but by no means the only one. Gary Stracner of Sweetwater got four bass with the top two going 4 lbs. 3 ozs & 3-8. Sam Wright, also of Sweetwater, best bass tipped the scales at 3 lbs 4 ozs.

The Kermit Bass Club was in for a tournament and caught a lot of bass in the two and three pound range but nothing as large as the Sweetwater fishermen were able to land.

W.A. (Shine) Kuck of Odessa has been a weekend resident of the Sportsman's Lodge for a number of years and knows how to catch fish in this lake. When he goes after fish to eat he will use a number of different methods and when they all work you can get more fish than you want to process. Using a

trotline, he got 16 channel cat ranging from 2 to 4 pounds, using minnows caught a nice string of crappie with fish up to a pound and trolling got several nice white bass.

The way Harold Kennedy of Oak Creek has been catching cat fish he could eatum ever meal and still stock his deep freeze. The people thats been working their trot lines as they should these past few weeks have caught a ton a fish.

Oak Creek received a second stocking of small mouth bass last week, when 50,000 fry were placed in the lake by the Parks & Wildlife people. We want to thank Bill Follis for this and since we have our own hatchery going again this year v hope to have 50 to a 100 thousand Florida bass to add a little later. The future bass fishing in Oak Creek looks great from where we sit.



When it comes to the extravagant, misleading and sometimes dangerous claims from manufacturers of dietary products, government consumer protection goes only so far.

Three federal agencies have some jurisdiction over all advertising and labeling, and the merchandising of mail-order products. They are the Food and Drug Administration (FDA), the Federal Trade Commission (FTC), and the U.S. Postal Service. All three agencies handle complaints on a case by case basis.

The FDA can block interstate commerce of unproven drug products. It can also seize products which are hazardous or misbranded with false healing claims.

But the FDA has been stopped by Congress and the courts from requiring that high-dosage vitamin supplements be labeled and regulated as drugs.

Although the FDA is empowered to prosecute when false claims occur on product labels, it has no power to prevent the making of false claims through broadcasts and publications. These claims are protected by the U.S. Constitution's First Amendment provision for freedom of speech and expression.

Both the FDA and FTC also have difficulty in regulating printed matter because manufacturers are careful in their claims. They know the loopholes in the regulations and consumers don't. In addition, for the FTC to follow-up on a complaint, the agency must

deem it "within the public interest."

The Postal Service investigates mail fraud and mailorder complaints on an individual basis. They have been successful in halting some diet schemes, such as the grapefruit pill diet, while the regulators and the manufacturers go to court. But their authority extends only to dietary products sold by

The government can help some, but for the consumer, the motto "let the buyer beware" still applies to all diet products. Before starting any new diet, consult your physician or a registered dietitian. Protect yourself from fraudulent schemes.





Tips for mildew

You may have to live with the summer heat and humidity, but you don't have to live with the unsightly mildew growth it produces on the exterior of your house, says housing specialist Dr. Peggy Owens. She suggests a cleaning solution of one quart liquid chlorine bleach, one-third cup of powdered laundry detergent and three quarts of warm water. Use the solution with a fairly soft brush to scrub affected areas and then rinse well with clean water. Because this cleaning solution is strong, the Texas A&M University Agricultural Extension Service specialist advises wearing rubber gloves and protective clothing to avoid contact with the skin. Shrubs and grass near the wall should also be covered with

Low-income households may be eligible for funds

Austin-Some low-income Texas households may be eligible for help in paying their cooling bills this summer through the Home Energy Assistance Program, according to Texas Department of Human Resources Commissioner Marlin Johnston.

Commissioner Johnston said the one-time payment is available to many lowincome households which this month received food stamps, Aid to Families with Dependent Children, Supplemental Security Income, or needs-tested Veterans Administration benefits.

Potentially eligible veterans are those who receive payments under Section 415, 521, 541, or 542 of Title 38 of the U.S. Code or under Section 306 of the Veterans and Survivors Pension Improvement Act of 1978.

Eligibility is limited by gross income. For instance, aid is available for a one-person household having less than a \$371.49 gross income per month. The gross income limit is \$608.49 for a two-person household, \$835.49 for a three-person household, \$1030.49 for four persons, \$1,216.49 for five, and \$1,422.49 for six.

Eligible households must be suject to electricity cost increases-because of higher bills or rent due to rising electricity costs.

Households in privately owned or rented housing are eligible if the cost of electricity is included in the rent payment or if the household pays a portion of its electricity costs.

Energy assistance checks are sent directly to the people who are eligible for assistance. However, the checks are made payable to the electricity company for the benefit of the eligible person.

Households receiving one of these energy assistance checks should mail it or take it in person to the electricity company business office with the regular utility bill. The check can be cashed only by the electricity company. If the HEAP check is more than the electricity bill. the additional amount will be credited to the person's account for the next month's bill. If the electricity bill is higher than the check, the person is responsible for paying the difference.

Johnston said application forms are mailed automatically to households receiving food stamps, AFDC, and SSI. Households receiving needs-tested veterans benefits must request an applica-.....

tion from DHR in June.

Those who have not received an application and think their household may be eligible should contact a local DHR office.
