Voters will decide fate of district

Coke County voters will have the opportunity to vote for or against the formation of the Coke County Underground Water Conservation District in the near future. Governor Mark White signed the House Bill 2418 on June 15, 1985 building the next step for a called county-wide election to form the water district.

A group of interested persons met early last spring in the county courthouse to discuss the need to form a county underground water

district. Notices were published notifying the public of the meetings and inviting interested persons to attend. At the third meeting held, a slate of temporary directors were named. Heading the board was M. Royce Lee of Bronte. Others named to the board were Arch Mathers and Horace Scott, both of Robert Lee, and Otis Smith and Billy Tounget, both of Bronte. Drew Durham of Sterling City was retained as temporary attorney for the district. Eph Cummins of

Robert Lee serves as temporary secretary.

Attorney Durham prepared the bill for presentation to the Texas Legislature. A group of Coke County representatives accompanied Durham to Austin and appeared before the House and Senate Natural Resources Committees to make the presentations April 23 & 24. Making the trip to the state capitol in support of the bill were M. Royce Lee, Martin Lee, Otis

Smith, Billy Joe Luckett and James A. Tidwell. District 66th Representative Dick Burnett and Senator Bill Sims assisted and pushed for legislative passage of the bill.

The efforts of this temporary board was supported by resolutions written and presented by the City Councils of the cities of Bronte and Robert Lee; the Coke County Commissioners Court; presidents and board members of Robert Lee Independent School District and the Bronte ISD.

Chairman M. Royce Lee stated to this newspaper that the board will meet on or before Oct. 15th and call an election to confirm the creation of the District. The election can not be held in less than 30 days nor more than 120 days after Oct. 15th, 1985. Notice of meeting will be published. Lee also said a permanent board of directors will be voted on at that time.

Lee explained that the purpose of forming the water district was for conservation reasons. The proper utilization, development and production/distribution of all water is extremely important to every person in Coke County. Fresh underground water is certainly no exception. "Quality awareness and control shall be a top priority of the District" according to Lee.

All citizens of each county/district should have a voice in the control of their destiny as far as it applies to their present and future water, especially underground water supply. Therefore, several prominent landowners/citizens of Coke County saw the need to keep control on the LOCAL level instead of leaving or turning the task over to the State. Therefore they have taken the necessary steps to create the District.

By creation and confirmation (election) we will maintain locally all the pertinent information concerning underground water in Coke County. This information will include the location, depth, thickness of strata, manner of completion, potential volume, usage, and quality of all underground water going produced within the District.

The District will be in a position to evaluate and assist any and all landowners/

citizens within the district whenever any possible contamination of fresh underground water occurs.

The primary point and objective of the District is to positively assure the citizens that the elected directors are their voice in the direction and execution of their District function. The elected directors will cooperate, encourage, aid and assist all efforts of each individual in their efforts to protect and develop underground water in Coke County.

The Coke County Underground Water Conservation District does have taxing powers. However, those powers will never be abused, according to Lee.

The intent of the temporary Board of Directors is to ask for one cent (\$.01) per

hundred dollar valuation in the confirmation election. "Your elected Board of Directors will not, in my opinion, be a wasteful Board in the representation of your District, and its desire to monitor and represent the underground water of Coke County," Lee added.

Mr. Lee firmly stated, "Provided no other message is conveyed in this news release, we the temporary Board want the water users of this county to know that we will not hinder your efforts and determination to develop underground water. Rather than hinder, We help."

If any citizen or landowner of the county wishes additional information or wants to ask questions, a board member may be contacted.

Three-year-old Sara has a number of Coke County residents, including aunts Geneva Simpson and Bobbie Arrott of Bronte. Her father, Warren Tomlinson, was born and raised near Bronte.

Pruitt's share European tour experiences

Editor's Note

(Mr. and Mrs. Noah Pruitt, Jr. recently took an extended tour spending 6 days on their own and 18 days as a part of an organized tour through Europe. They kindly consented to share their interesting travels with our readers.)

Globus Gateway was selected as the company to host our holiday which would take us into nine countries in Europe.

We left May 15 from Midland on American Airlines and met our traveling companions Mr. & Mrs. Ben Jones of Portland, Oregon for our non-stop flight from D.F.W. to Gatwick Airport, London, England. We had a night flight with arrival at Gatwick at 10:40 a.m. May 16.

Our reservations were in a downtown hotel near Victoria Station in the heart of where all tourists want to visit. We found the travel system to be excellent and with a London map, toured many places such as Tower of London, Crown Jewels, London Bridge, Buckingham Palace, Big Ben, 10 Downing Street, Scotland Yards, Thames, Harrolds, Piccadilly Circus, Trafalgar, Westminster Abbey, Hyde Park, House of Parliament and St. Katherine's to name only a few. We spent one day near Harrow on the Hill, where Churchill received his formal education. Our next venture was directed to Bovington, England where the same Baptist Church was still occupied that Jones' grandfather founded and pastored about 1880. The same furniture was still in use, including the organ his great aunt played during worship services. He located a distant cousin from a letter written about 20 years ago.

We joined our tour on Sunday May 19, and left London with 43 people in the group on a luxury motor coach for 18 days of traveling. We headed for the English Coast leaving Dover and crossed North Sea on a hovercraft, landing at Calais, France. The landing station first caught our eye on the beach in France, immediately followed by the many bunkers used by the enemy in W.W. II. Most all the bunkers in Europe were left as they were at the end of the war, because too much damage was caused trying to

erase the marks of war by dynamiting the bunkers.

We left Calais, France traveling through Dunkerque, France where K.D. Pruitt was stationed.

We crossed into Belgium and spent the night in Antwerpen, a city famous for the diamond industry, toured Van Moppes diamond factory to watch the cutting and polishing of these precious stones.

Upon entering Holland we saw the traditional Dutch windmills and fields of tulips, visited the Flower Auction and cruised aboard a roofed launch through the canals of Holland's Golden Age. Amsterdam, the 700 year old capital, was most interesting as well as Rembrandt's masterpieces in the Rijksmuseum. On an excursion to Vollandam we saw cheese being made and wooden shoes at the same local factory and found many exciting boutiques at the seaside center. We caught a ferry and went to Marken, a tiny island made by man and visited a typical Holland family home. In the home each tile used in the fire place had a different verse of scripture with book and verse included on each tile. Then to Zuiderzee. Rotterdam proved to be interesting as well as Den Haag and the many buildings housing the different governments.

From Amsterdam we traveled toward Germany. Our first stop was the border where we exchanged our money to different currency we would need for each country we would travel in. Through the province of Utrecht and W.W. II battle fields near Arnhem, we headed for the German Rhineland. A visit in Cologne to see the spectacular Gothic Cathedral which was rebuilt after the bombings, train station and many other places of interest. A moment of meditation at the "Bridge At Remagen," a memorial to peace of all U.S. service men who fought and died so valiantly at the Remagen Bridgehead March 7-17, 1945.

In the afternoon we boarded an excursion streamer and cruised on the historic Rhine River, passing many castles too numerous to name, on crested cliffs, along with terraced vineyards-trimmed in half tim-

bered towns. Roadbound again, we continue to Frankfurt of the River Main.

In Frankfurt we were met by Mr. & Mrs. Wallace Emory and went to dinner at a unique restaurant where embassy personnel often dine, and later for a visit in their home at embassy housing. The Emory's are employed at the airbase where the hostages landed. In Heidelberg, Germany the oldest university town of "Student Prince" fame, we stopped at its castle for a splendid view of the city below. In Munich a visit to Nymphenburg Palace, 1,000 foot high Television Tower and Olympic Stadium were the Jewish team was killed during the games.

Near Garmich, in the Bavarian Alps we crossed the Austrian Tyrol and traveled to Innsbruck, Austria, among many things seeing the "Golden Roof" and where the Olympic games were. We attended a Folklore evening about the native way of life and the grand finale consisted of a musical tribute to each nation present with each country joining in on their respective national song. Brenner Pass took us through the mighty barrier of the Tyrolean Alps to Italy.

In Venice a visit to St. Marks Square, Clock Tower, Byzantine Basilica with 1,000 year old gem-studded gold altar piece, Doges Palace, the Bridge of Sighs. A lifelong desire came to pass as the Jones and Pruitts rode the gondola and were serenaded on the sparkling Grand Canal of Venice. The picturesque Tuscany hilltowns, vineyards and olive groves attract attention as we head for Siena-the city of Palio, and annual medieval style horse race around the town square. We proceed to Grosseto along the Mediterranean Sea coast to Rome-and truly all roads do lead to Roma. The main highlight for us was the Colosseum-site of gladiatorial combats, chariot races and early Christian Martyrdom. The Forum-Hub of ancient Rome, St. Peter's Basilica, Sistene Chapel, Veduta Fontana Di Treve's (Three Coins and the Fountain). A side trip to Tivoli and a visit to the

elaborate gardens of Ese Villa.

Florence, Italy-the cradle of Renaissance, among many other places of interest we visited Michelangelo's celebrated David in the Gallery of Fine Arts. Shopping time for the famous Florentine leather goods and market square. The Leaning tower in Pisa was a high point. The Pruitts climbed all the way to the top which proved to be a real experience. Our next stop was Christopher Columbus' Genoa, Italy to view the explorer's birthplace and the Flower Monument. Italian and French Riviera resorts dotted our route to Monaco.

We enter the principality of Monaco, following the winding streets and hairpin bends of the Grand Prix circuit, a visit to the Prince's residence, church and garden and then a night at the Casino at Monte Carlo.

Along the scenic coastal road to Nice, France the sophisticated "Queen of the Riviera" was a beautiful sight to behold. The sunrise was breath taking. Grosse, France is renowned for its Parfum Factories which we toured and was given the opportunity to shop for Perfumes, soaps and etc. This was a scenic day in one of France's loveliest areas. Views of the sun-drenched Provence first, as we drive through the Var Valley to Entraux. Next to the historic Napoleon Route through Dauphine to the Olympic winter sports resort of Grenoble. Beneath the towering Mont Blanc-Europe's highest mountain, we cross the Swiss border and arrive in beautiful international Geneva. The different government buildings and the International Red Cross building was interesting and Lake Geneva was breath taking. Berne, the Swiss capital, the Parliament buildings and the Bear Pits was exceptional. Picture-book Lucerne, Thorwaldsen's great sculpture, the Lion Monument, the 14th century covered wooden bridges and time to shop for Swiss-made items. An excursion to Mt. Pilatus, 7,000 ft and plenty of snow to play in before we descended by cog car many times at 48 degree angle decline, the longest and steepest cog-wheel train in the world. Tidy villages and prosperous

farms are our last Swiss impressions before we re-enter France near Basle.

Through Burgandy we view some of the world's most renowned vineyards, via Fontainebleau Forest we later reach the country's splendid capital, Paris. A night illumination drive of the city was beautiful; among many of the places visited were Eiffel Tower, Arc de Triomphe, Opera, Madeleine, Notre Dame, Versailles Palace and a Parisian Gala night at the world famous Moulin Rouge. Both banks of the Seine beckon with attractions, the gardens of Luxembourg and Tuileries. Recent history comes alive on our drive north through Picardy and the valley of the Somme, scenes of dramatic W.W. I battles. Past Arras we proceeded through fertile farmlands to the French coast for our hovercraft flight across the English Channel. The fog had lifted and the White Cliffs of Dover were beautiful.

Arriving back in London, our Tour Director announced besides our air travel, we had traveled over 3,500 miles by coach. We all said goodbye to our new-found friends.

After the tour departure, we spent two more days enjoying the city. We visited St. Katherine's, where all the records are kept for anyone who had ancestors ever born, married or died in England. This institution was filled with people frantically searching their genealogy. Our last remembrance of London was a lengthy visit to St. Paul's Cathedral. After touring the cathedral we climbed 544 steps to the top of the dome, the outside view was spectacular also. We then sat in the Tuesday evening service given by the boys' choir.

The flight home was restful and with a fast goodbye at D.F.W., the Jones returned to Portland and we returned to Midland. After a short visit with our children in Odessa, we returned to Bronte, tired but filled with many experiences and memories.

WTU Customers can expect refunds, lower rates

West Texas Utilities Co. customers may receive refunds as well as slightly lower fuel rates as early as next month.

A tentative agreement was reached this past week in meetings with the Public Utility Commission staff in Austin, and the matter is expected to go before the Commission July 26 for a final order hearing. That would be just in time for the refunds to go on the August bills for all of WTU's retail customers.

The full amount to be refunded now stands at \$17.6 million. This is an increase of \$3.9 million over the amount in WTU's original request, which included only fuel costs savings achieved from August 1984 through May 1985.

The new figure includes savings made in June and an additional \$2.3 million representing a lump refund of fuel costs savings balance, plus interest, realized before last August. Refund of those total savings had begun in mid-November and were scheduled to be completed in November 1985.

WTU estimates that the total refund now will result in a \$41 credit to the average residential customer's bill. The refund is made possible by WTU being able to spend less for power plant boiler

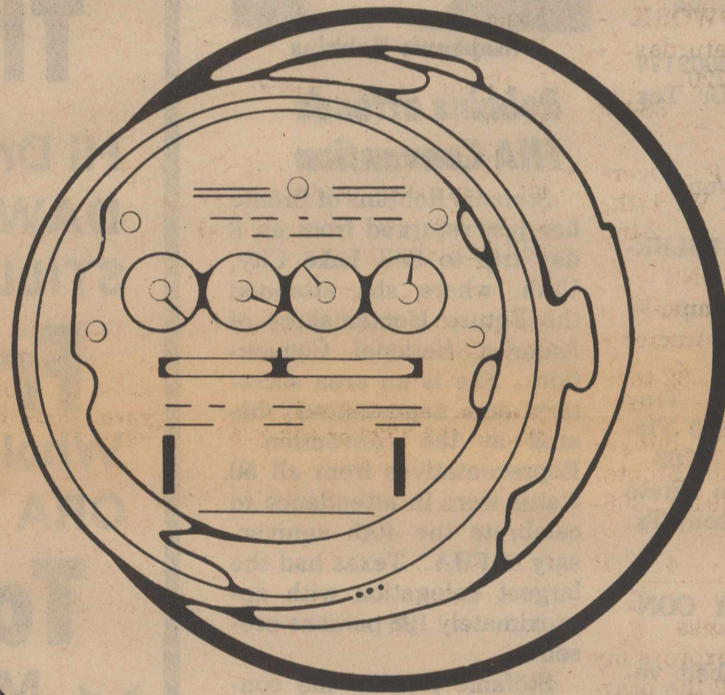
