Prospects 'dim' for dove opening

Mourning Dove season opens in Coke County, Sunday, Sept. 1, and hunting looks dim for the third year in a row. Three droughty summers plus the hard freezes of the last 2 winters have apparently diminished the number of birds in the western states. Good nesting conditions early this year were reported by the Texas Parks and Wildlife Department but the hot, dry summer has made the prospects poor for a good hunting season. Since the county has some harvested fields and pasture weeds, hunting could improve after the first cool fronts send birds farther south.

Ron George, dove program leader for the Texas Parks and Wildlife Department, said hunters may not find the birds where they found them last year. "Many of the grain crops around the state already have been harvested, and the dry weather may have moved the birds out of some areas where they were seen earlier," George said.

George said the season may be a "boom or bust" situation, with those hunting in areas where the birds find both food and water getting good shooting action. "If the dry weather continues, hunting around stock tanks and other water sources

should be good," he added.

Coke County falls into the Central Zone with a 60 day season from Sunday, Sept. 1, until Oct. 30. Shooting hours for Mourning Doves are ½ hour before sunrise to sunset. Bag limit statewide is 12 birds. A hunting license is not required for those who will be hunting in the county of their residence. Shotguns must be plugged back to a three-shot capacity for Mourning Doves, which are migratory.

The same conditions facing area hunters caused the TPWD to cancel the White-wing Dove season in South Texas for 1985.

Local drowns while fishing

An accidental drowning claimed the life of Homer E. "Buck" Ivey, 83, of Bronte. Mr. Ivey was pronounced dead at 12:20 p.m. Saturday by Peace Justice Opal Jacoby of Robert Lee.

A neighbor of Mr. Ivey became concerned and alerted local relatives when he noticed that there had been no lights in the home for a couple of nights and his pickup was missing. Knowing that Mr. Ivey liked to fish, a search was made of his fishing spots and his body was discovered floating

in a dirt stock tank located southeast of Robert Lee on property belonging to his brother, Cumbie Ivey, Sr. He had been fishing from a small homemade boat which was still upright with tackle box inside.

The drowning was investigated by Coke County Sheriff Marshall Millican and Deputy Jeff Barnes.

Funeral services for Mr. Ivey were held in Bronte on Monday at the First Baptist Church with burial in Fairview Cemetery.

Council adopts budget

Following budget and revenue sharing fund hearings the Bronte City Council adopted the proposed 1985-1986 budget and revenue sharing fund proposal.

Revenue sharing funds in the amount of \$7000 are earmarked to be spent in the following manner: Approximately \$4600 on a trash collection vehicle and around \$1200 each for two fire hydrants and a fire proof

filing cabinet for the city office.

The tax rate was set at .39/\$100 compared to the 1984 figure of .46/\$100, which will generate approximately the same amount of revenue for the city due to an increase in valuations. Estimated expenditures will be \$87,547.-general fund, \$97,597.-waterworks, and \$13,226.-sanitary sewer fund.

Landon death ruled suicide

Andrew John "Jack" Landon, 49, died at his home on Lake Spence near Robert Lee on Thursday night, Aug. 22, of a gunshot wound to the head.

Sheriff Marshall Millican and Deputy Jeff Barnes investigated the incident after being notified by the ambulance crew summoned to the residence.

Landon was pronounced dead at the scene by Coke County Peace Justice Cova Sparks at 11:00 p.m. She ruled the shooting death self-inflicted.

According to Mrs. Landon, her husband had been incapacitated by a motorcycle accident in February. He had been in a depressed mental state after several surgeries on his leg had failed to allow him to get around well. She stated that she was in the home asleep at the time of the shooting.

The couple had lived at Lake Spence since February, 1985.

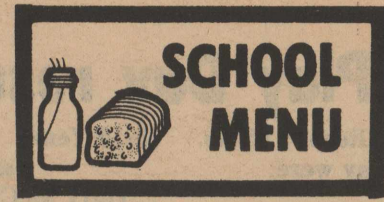

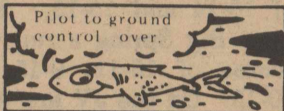

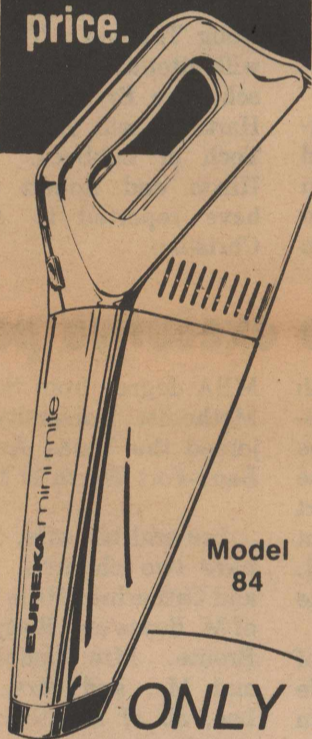

European leadership trip chosen

Editor's Note: Denia was an employee of the Observer/Enterprise during the summer of '84. She is the daughter of James and Dean Ash of Bronte and '84 Bronte graduate. A journalism major, Denia is active in the drama department at Howard College.

Eighteen people from Big Spring travelled to Europe on the first college-credit trip ever offered by Howard College.

ALSG-American Leadership Study Group-sponsors many of these trips every year to many different countries. We chose a nine day trip to England and France.

We left June 4 from DFW on British Caledonian Airlines. An eight hour flight took us to England landing at Gatwick airport. From there we took a train through the industrial district into the heart of London. We were met by an ALSG representative who accompanied us to our hotel, The London Metropole, and met our tour guide. ALSG guides are often college students earning extra money. Our guide was an Oxford graduate studying to be a barrister in the English Parliament.

That evening we had our first taste of English cuisine at a near-by pub and we walked through Trafalgar Square and the Theatre district to Covent Garden.

The next morning we took a bus tour around the city stopping at several places, including: Houses of Parliament and Big Ben, Old Scotland Yard, Hyde Park, St. Paul's Cathedral, Fleet Street, London Tower Bridge and the Thames River.

That afternoon, among typical misty English weather, we shopped at Harrods, Fortnum and Mason's Piccadilly Square, and Oxford Street. In the evening we attended an American musical comedy called "Little Shop of Horrors", about a plant that feeds on humans.

The next morning several of the group took a cab to Westminster Abbey to hear the Westminster Boys Choir. That afternoon we travelled out of London to Windsor where we expected to tour the Royal Apartments at Windsor Castle. Unfortunately the royal family was arriving that very afternoon - so, we were satisfied with a walk around the grounds and the town of Windsor. Among the sights in Windsor was the Eton Public School and we viewed a game of lawn bowling.

On the way back into London we drove through Rummyfield where King John signed the Magna Carta.

That evening five of our group were entertained by a hilarious English production of "Noises Off" at the elegant London Savoy.

We left London the next morning to travel into France stopping on the way at Canterbury Cathedral, where St. Thomas-a-Beckett was martyred, and walked the final yards the pilgrims used to make on their knees annually.

We crossed the English Channel on a ferry from Dover. As we pulled away from the shore the White Cliffs of Dover was our last view of England.

We docked at Calais and drove four hours through the French countryside in Paris. The next day we toured around Paris which included

a stop at Notre Dame for Sunday morning mass. The Arc de Triumph, the Place de la Concorde, the Champs Elysees, the National Academie of Music, and the Eiffel Tower were also included on the tour.

That afternoon several of our group toured the Louvre and viewed the Mona Lisa, the Venus de Milo and the Winged Triumph. In the evening we took a moonlight ride down the River Seine.

On our second full day in France we travelled out of Paris and into the Loire Valley, where we toured several cathedrals and chateaus. One of the chateaus, Chateau Chenanceaux, is still inhabited by a French family who has opened the bottom floors to tourists.

We stopped for dinner that evening outside Orleans-made famous by Joan of Arc. We arrived back in Paris late that night and took an illuminated drive around the city.

Our last day in Paris, we went out to Versailles - the palace of Louis XIV. Thousands of people were there, all speaking a different language, quite an experience.

Some of us went to Montmestre' where the artists set up their easles every day. Many people stand and watch for hours as the paintings come to life.

Our last night in Paris found us at the Moulin Rouge, a famous follies show.

From the Charles de Gaulle Airport we flew back to London's Gatwick Airport, and returned to DFW. June 12 found us back in Dallas trying to adjust from the cool weather and beautiful green countryside to the hot, dry West Texas land we call home.

Working mothers often have two full-time jobs—one outside and one inside the home. Yet, many working women continue to carry the full burden of running a household, saying they "Can't get the family to help," or "it's easier to do it myself."

The key method for spreading out household responsibilities is getting the family organized. Begin by analyzing and listing the daily household tasks such as bedmaking, preparing meals, or kitchen clean-up. Also list daily family tasks like driving the children to

school. Then list weekly tasks, which might include grocery shopping, vacuuming, or mowing the lawn.

Sit down with the family and go over the lists. Considering the age and skills of each person, let the family decide together who will be responsible for what task. They may want to make "permanent" assignments or rotate them among members.

Once family members know what tasks are their responsibility, help them develop workable routines. Offer advice if it's needed, but don't criticize the results. And lower your expectations—especially if the task is new to that family member. For example, your teenage son may not vacuum as thoroughly as you do, but at least he got it done.

Be liberal with praise for family members who develop new skills, or do a job

tips for barbecued chicken

Chicken barbecue is an all-time favorite and long summer evenings are ideal for polishing up the fine art of barbecuing, says a poultry marketing specialist with the Texas Agricultural Extension Service, The Texas A&M University System. For great-tasting chicken barbecue, follow these steps: split birds in half and sprink-

le generously with salt and black pepper before placing on the pit, make sure coals are white-hot before barbecuing, use a basting sauce during cooking that contains no tomato or sugar product because such sauces burn easily, and apply a finishing sauce during the last 20-30 minutes before cooking is complete.

National Registry Exam set for Saturday, October 5

The National Registry examination for Emergency Medical Technicians will be given at the TSTI Abilene Extension, Saturday, Oct. 5.

All licensed EMTs who have received certification in the last 24 months or have completed an EMT refresher course within the past two years are eligible to take the written exam. All applicants must have passed the Basic Skills Exam in the past year.

EMTs who have six months service on an ambulance or emergency rescue unit in the past year may receive ambulance certification. Military medical corpsmen who have had six months field experience in the past six years are also eligible for this certification.

All applications must be received no later than September 15.
