Absentee balloting to start Monday

Absentee balloting begins on Monday, March 17, in both Robert Lee and Bronte for city, school, and hospital district elections and will continue thru April 1 for the Saturday, April 5 election. Absentee voting hours will coincide with the business hours of the polling places.

Robert Lee city hall will serve as the polling place for absentee balloting with Edna Havins as clerk. On the ballot for mayor is Wilson Bryan with Alice Beaty and Jim Naico for 2 slots on the city council.

Mildred Reese will serve as absentee clerk in the county clerk's office, courthouse, for both the hospital district and the school election.

Barbara Chesney filed last Wednesday, the filing deadline, for a spot on the hospital board of directors ballot, bringing to three the candidates for three places, including Bill Helwig and Linda Arledge. The board of trustees ballot will have two vacancies, with three candidates to vie for them - Ray Aldridge, Jeffie Roberts and Wayland Drennan.

In Bronte, Jerry Proctor will be absentee clerk for the voting for the hospital district board of directors at the Bronte Nursing Home - Noel Percifull, LeDrew Arrott, and Eddie Alexander are candidates for the three existing places on the ballot.

Pat Martindale in the Bronte City Hall will be the absentee clerk for that early voting. Mayor J.T. Henry and council members Harold Dunn, Ed Hart, and Wesley Gibbs will appear on the ballot as candidates to fill the places they now hold.

Absentee voting for school trustees will take place in the school superintendent's office with Glenda Draper as clerk. Jim Morrow and Lynn Phillips are the only candidates for the two vacancies.

Bronte Sesqui activities

Balloons, red, white and blue decorations and a festive air will be the theme of the Texas Birthday Party sponsored by the Bronte Sesquicentennial Committee on March 22. Activities will begin on Saturday afternoon at 3:00 at the mini-park in downtown Bronte, or in case of inclement weather spirits won't be dampened, as the party will be held indoors at the Bronte Community Center.

The celebration will feature three main events: a cake decorating contest, a bicycle decorating contest, and registration for a beard growing and mustache growing contest.

The bicycle decorating contestants must have their bicycles appropriately decorated in the Texas 150th Birthday theme and present their bikes for judging at the city hall by 2:00 p.m. on March 22nd. Prizes will be awarded to 1st, 2nd and 3rd place winners.

The beard or mustache growing contest rules state that the contestant must be clean shaven at the time of registration at the city hall between the dates of March 17 - 22. A \$1.00 registration fee will be collected and categories in the contest are: best groomed, most hair,

The Shumard Oak is a member of the red oak family. The largest Shumard Oak in Texas is 120 feet tall and has a trunk circumference of over 15 feet. It grows on the Alabama-Coshatta Indian Reservation near Livingston.







Postal Pointers

By: Coe Lewis, Postmaster, Robert Lee What can we do to help? If you are having any problems with your mail, come in and talk to us. We strive to give A-1 service at all times. A few things which may be of interest to you are: (1) - If you want your Silver or Bronte mail to go direct either hand it to us at the window or drop it in the local slot. We have a direct sack to Bronte and send Silver mail by Star Route Carrier. (2) We have certified notices and return receipts on our lobby counter so that you can fill them out before coming to the window, thus saving both of us a lot of time. (3) We do not hand out mail to anyone from the boxes. We

do it at all. (4) We have a service called "SPECIAL HANDLING" for parcels. If you want your parcel to get special treatment and not get mixed up with other parcels you can pay a small fee \$1.10 up to 10 pounds and \$1.60 over 10 pounds and your parcel will go in a separate sack from others, thus speeding up delivery. (5) All business mail such as bills and other bundles should be handed to us at the counter and not put through the

The U.S. Geological Survey and the Colorado River Municipal Water District are joining in a study of salinity problems along the Colorado River and its substantial tributaries from Lake J.B. Thomas to confluence of the Concho River.

The three-year evaluation will cost approximately \$300,000, which will be shared equally by the agencies. Field work will be done by the USGS through its San Angelo office, and reports will be available.

Water gain and loss investigations will be made on the Colorado, also on major tributaries such as Beais Creek, Elm Creek and the Concho River. Salinity levels will be determined during several specified three-day intervals during summer low-flow stages and winter medium-flow periods.

Water wells within a few miles of the river will be investigated and tested for water levels and salinity. All possible sources of saline intrusion will be explored, including natural salt seeps, discharges from improperly plugged oil wells, disposals, etc.

All field data collection will be directed by Raymond Slade, hydrologist with the USGS in San Angelo. Field personnel will be contacting land and well owners to take advantage of their knowledge.
