Tech names Ray to Ag Ambassador post

The Texas Tech University College of Agricultural Sciences today named Stan Ray of Robert Lee coordinator of Texas Tech's Ambassadors for Agriculture. He replaces Tom G. Maynard who vacates the position in May after three years of service as coordinator.

The Ambassadors for Agriculture are a group of students majoring in some phase of agriculture who offer their services as speakers to various organizations in Texas and Eastern New Mexico. Members are selected on their merit as speakers in the Future Far-

mers of America and 4-H organizations.

According to Associate Dean of Agricultural Sciences Marvin J. Cepica, the mission of the program is to increase public awareness and appreciation of agriculture and agricultural issues and to motivate and inspire young people. In 1985-86, the Ambassadors travelled more than 10,000 miles reaching thousands.

Ray is a junior agricultural communications student who gained his public speaking expertise in FFA. He served about 59,000 FFA members as vice president of the Texas FFA, the nation's largest state association. He is currently vice president of Texas Tech's Agricultural Communicators of Tomorrow organization.

In addition to scheduling speakers, Ray will produce the Ambassador's public television talk show, Food, Fiber and You. He will also coordinate children's agricultural workshops and the extensive leadership development programs offered by the Ambassadors.

Dr. and Mrs. Philip Ray of Robert Lee are Ray's parents.

State announces unclaimed monies

The Texas Treasury has about \$80 million in unclaimed money, safe deposit boxes, oil royalties and stocks and bonds that it wants to return to about 100,000 Texans, according to Treasurer Ann Richards.

Persons who find their name on the list may reclaim their property by calling the State Treasury, toll free at 1-800-321-2274 or by writing to the State Treasury at PO Box 12608, Capitol Station, Austin, Texas 78711.

"There is no set time limit for making a claim," Treasurer Richards emphasized. "We will hold the account in the owner's name forever."

She said that last year, the State Treasury published a similar list and about \$50 million was reunited with owners.

The Unclaimed Money Fund list was first published when Treasurer Richards took office in 1983. Since that time, the State Treasury has returned 73 percent of all the money ever returned since the law took effect 26 years ago.

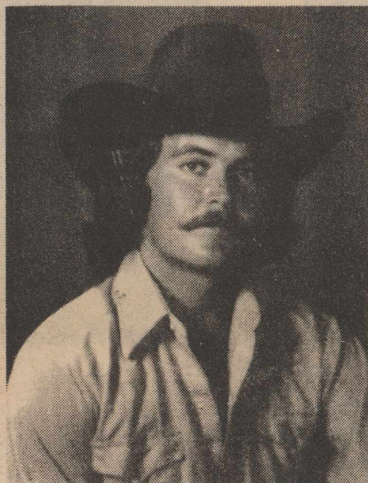



and tied the score at 37 to put the game into overtime.

Jamie Powers came alive to score all of his 8 pts. in the 4th quarter, two baskets in the final minutes tied the game. Irion County had four tries at one and one free throws and missed all four.

In the overtime period Kirby Hartman and John Morrow added baskets to outscore the Hornets 5-3 in overtime.

Leading scorers for Bronte were: Stephen Lee 16, John Morrow 11, Jamie Powers 8.

Bronte's record went to 27-3 while Irion County ended their season 28-5.

Fertilizing pecan trees

FERTILIZING PECANS

Because pecans do not begin new root growth until the soil is very warm, they can be fertilized at a later date than other trees.

April, May and June are the optimum times to apply nitrogen fertilizer to pecan trees. In our Coke County soils, ammonium sulfate 21-0-0 will give the best results. On bearing trees, apply one pound of fertilizer per inch of trunk diameter and place this around the drip line. To avoid burning of grass, water fertilizer in with at least 2 inches of water or place fertilizer in 6 inch deep holes and water in.

Young trees should re-

ceive small applications beginning the second year. A one-half cup application can be made the first year in June if the tree has made over six inches of growth on the strongest shoot. The second year apply one-half cup in April, May or June. The third year, apply 2 cups each month and the fourth year through seventh year, add 4 cups during April, May and June. Do not apply nitrogen after June because it can result in freeze damage during November or December. Also, if young trees are not growing fast, discontinue fertilization after the first application.

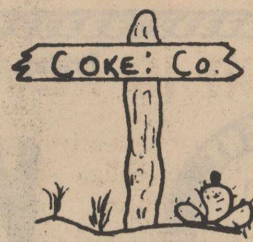

GROW YOUR OWN GARDEN TRANSPLANTS

Get you spring garden off to a good start by growing your own transplants indoors. The key to growing transplants successfully is to plant seed at the proper time so the young plants will be ready to set out when your garden is ready and weather conditions are favorable.

For the best survival and quick recovery after planting in the garden, transplants should be young, sturdy and in good nutritional condition.

Usually four to six weeks is sufficient time to grow most transplants. Vine crops take two to three weeks to develop two to three true leaves while lettuce takes three to four weeks. Tomatoes need five to seven weeks to reach transplanting stage.

To determine the optimum seeding time for most transplants, figure back four to six weeks from the average last spring frost date in Coke County, which is around March 24th.

Some transplants such as cabbage, cauliflower, broccoli, lettuce and onions can be set in the garden four to six weeks before the last frost date.

When starting plants indoors use a soilless or synthetic soil mix available at garden centers or nurseries.

Seed can be started in almost any type of container such as flower pots, milk cartons or cake pans. Be sure the container has holes for adequate drainage. Other popular containers are seed flats, peat pots and peat cubes or pellets.

Once you've got the need-

ed materials and planting time is at hand, fill the containers with the synthetic mix, firm it in well and then water thoroughly. Space the seed evenly, cover lightly and water again.

To improve germination, slip the container into a plastic bag and place it in an area at room temperature but out of direct sunlight. Remove the bag when the seed first emerges and place the container in sunlight.

Once the container has been removed from the plastic bag, add water to maintain good moisture. Frequent watering will be necessary but use care to avoid saturation.

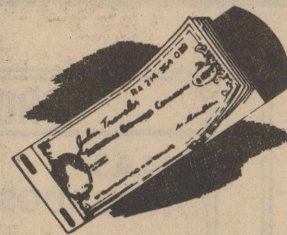
When plants are of adequate size and outside conditions are suitable for plant growth, transplant them into the garden area and you've got a jump on the planting season.

Documentation is key to hiring

Proper documentation is the key to hiring workers under the new Immigration Control and Legalization Amendments Act of 1986.

"Employers should ask for and make copies of documents presented for all employees hired since Nov. 6, 1986," points out Dr. Richard Edwards, economist with the Texas Agricultural Extension Service, The Texas A&M University System. "Applicants should not be hired without proper documentation."

As far as agricultural employees are concerned, Edwards notes these provisions of the new legislation:

-- It is illegal to knowingly hire, recruit or refer for a fee any person not authorized to work in this country. There are stiff penalties for violators. All employers are affected regardless of size or number of workers.

-- Employers must inspect documents and attest to the legal right to work of every person hired. There are penalties for employers who do not comply with this paperwork requirement even if no illegal aliens are employed.

-- Most agricultural workers will be able to attain legal status. Workers can obtain temporary resident status and, after two years, become permanent residents if they can show they have worked 90 or more mandays in producing and harvesting perishable agricultural commodities during the year beginning May 1, 1985. Those who have worked 90 mandays in the same capacity in each of the three years ending May 1, 1984, 1985 and 1986 may become residents after one year. The number allowed permanent status under the three-year consecutive years of work provision is limited to 350,000. Once either group has obtained permanent status, however, they have no obligation to continue to work in agriculture.

-- Anyone who can show continual residence since Jan. 1, 1982, can be granted temporary status for 18 months and may be granted permanent status after that period.

-- During a four-year period from 1989-1993, a limited number of aliens will be admitted to perform field work in fruits, vegetables and other perishable commodities if it is determined they are needed. Those admitted are obligated to do at least 90 mandays of such work for three consecutive years. They then can stay in

the U.S. permanently but have no further obligation to work in agriculture.

Types of Documentation

Edwards points out that any of the following documents or combination of documents are proof of resident status as set forth in the law:

- A U.S. passport.
- Certificate of U.S. citizenship.
- Certificate of naturalization.
- Resident alien card or other alien registration card with photo that is evidence of authorization to work.
- A current foreign passport with a current endorsement allowing the applicant to work in the U.S.
- Social Security card and a driver's license or other identification card with photo issued by the state.
- U.S. birth certificate or birth certificate which established U.S. Nationality at birth and a driver's license or other state-issued identification card with photo.

Penalties for Employers

"Employers who knowingly hire unauthorized aliens can be fined between \$250 and \$2,000 for each such employee for a first offense," Edwards points out. "The second violation carries a fine of \$2,000 to \$5,000 per employee found in violation, and fines range from \$3,000 to \$10,000 per offense after more than two previous citations."

If the attorney general rules that an employer is engaging in a pattern or practice of violations, that employer may face criminal charges which carry fines or jail sentences.

No citations will be issued through March 1987, says the economist. During the subsequent year through March 1988, a first offender will be cited, but no penalty will be assessed. Second and subsequent violations found during this year, however, will be penalized as previously outlined. After March 1987, all violations

are subject to the full measure of the law.

For seasonal agricultural employees (90 mandays in producing and harvesting perishable commodities), no penalty will be imposed for violation until the application period for the seasonal agricultural worker program has ended in October 1988, notes Edwards.

The new law also addresses workers employed through a labor contractor. If a farmer knows the employees are not authorized to work in the U.S., he is

considered to be the one doing the hiring. Any sanctions imposed will be against the farmer.


Employers who do not adhere to the documentation requirements also may be fined, adds Edwards. The law mandates employers to maintain a record keeping system that verifies they have examined documents presented. Employers may photocopy the documentation. Those employers found in violation shall be fined between \$100 and \$1,000 for each individual in violation.

MANAGE LAWNS TO CUT WATER BILL -- Proper lawn management can keep summer water bills from skyrocketing says a turf-grass specialist with the

Texas Agricultural Extension Service, The Texas A&M University Service. Water bills can be reduced as much as 40 percent by watering, fertilizing and

mowing lawns properly. Water only when grass starts to show signs of drought stress--discoloration, wilting and leaves rolling up in late afternoon. Soak the soil to a depth of 6 to 8 inches. Do not use nitrogen fertilizer during the summer as this will only make the lawn grow faster and use more water. Finally, mow less often and cut grass at taller heights.

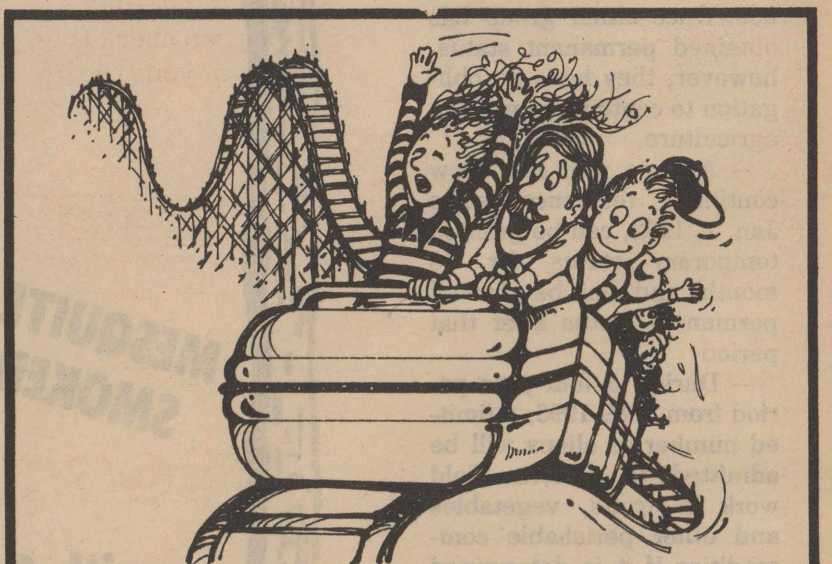

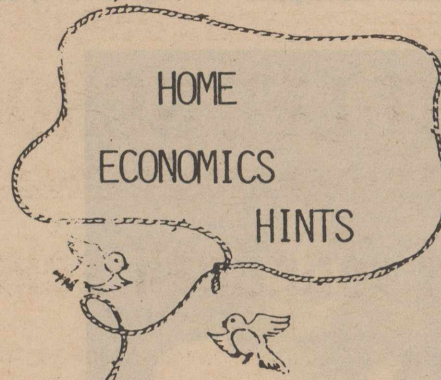

CHOICES IN CARING FOR AN ELDER PARENT

A common stereotype about aging in our culture is that the elderly go from being independent straight into a nursing home. That's simply not true. Only 5% of the aging population live in nursing homes, and the vast majority of them are over 85.

In selecting care for an elderly parent who needs assistance, you have many options from which to choose.

* You can bring some new or additional help into your parent's home. This might take the form of a home health aide sitter, or visiting nurse.

* You or another family member may invite the parent to live with you. You can convert a room or build on a "granny flat" to accommodate both you and your parent's needs.

* Perhaps someone else in the family is elderly and needful. If your parent shares housing and caretaking services with that person, the joint household may relieve several family problems at once.

* You can arrange for your parent to live in a boarding home that specializes in caring for frail or elderly people in a homelike setting.

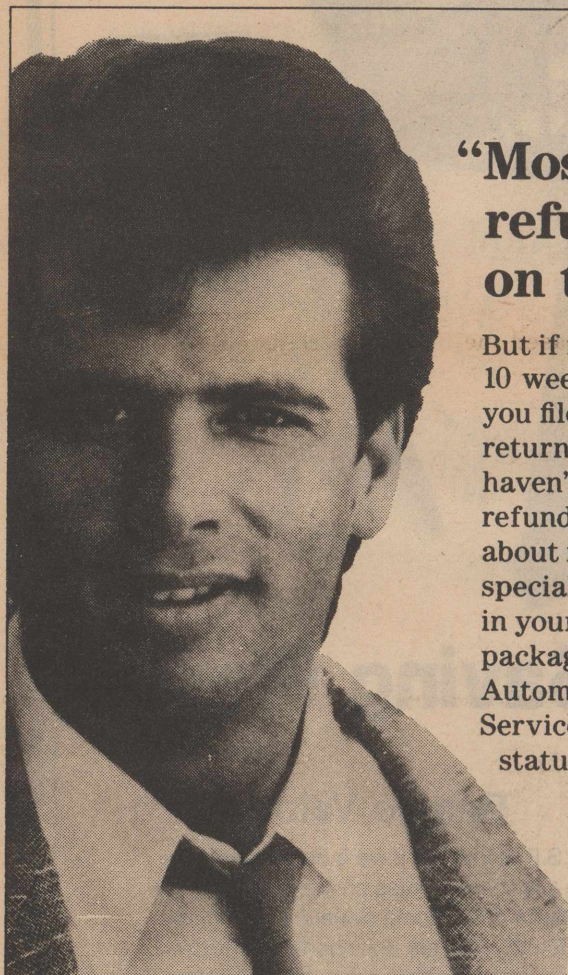
You may find you need to place your parent in a more sheltered environment where nursing and perhaps

medical care is available on a reliable basis. This may be a home for the aged or a nursing home. If you are concerned about the attention your parent is receiving, you may hire an adult sitter to relieve you.

These are just some of the options available. The best choice will depend upon your parent's needs and preferences as well as your own.

SODIUM LABEL REGULATIONS TAKE EFFECT IN JULY

Consumers should find it a little easier to cut back on sodium in their diets, thanks to a new Food and Drug Administration (FDA) regulation, says a Texas A&M University Agricultural Extension Service nutritionist. Beginning July 1, 1986, the FDA will require that the sodium content be shown on any food that provides nutrition information on the label, reports Mary K. Sweeten. "The regulation should be of real help to people who are concerned about the hidden sources of sodium in processed foods," she says. According to the nutritionist, sodium content will be listed in milligrams per serving. Consumers can use that information to see if they are staying within the recommended sodium intake of 1,100 to 3,300 milligrams a day.

IT'S TIME FOR CHICKEN BARBECUE

Chicken barbecue is an all-time favorite, and the spring and summer seasons are ideal for polishing up the fine art of barbecuing, says a poultry marketing specialist with the Texas Agricultural Extension Service, The Texas A&M University System. For great-tasting chicken barbecue, follow these steps: split birds in half and sprinkle generously with salt and black pepper before placing on the pit, make sure coals are white-hot before barbecuing, use a basting sauce during cooking that contains no tomato or sugar product because such sauces burn easily, and apply a finishing sauce during the last 20-30 minutes before cooking is complete.

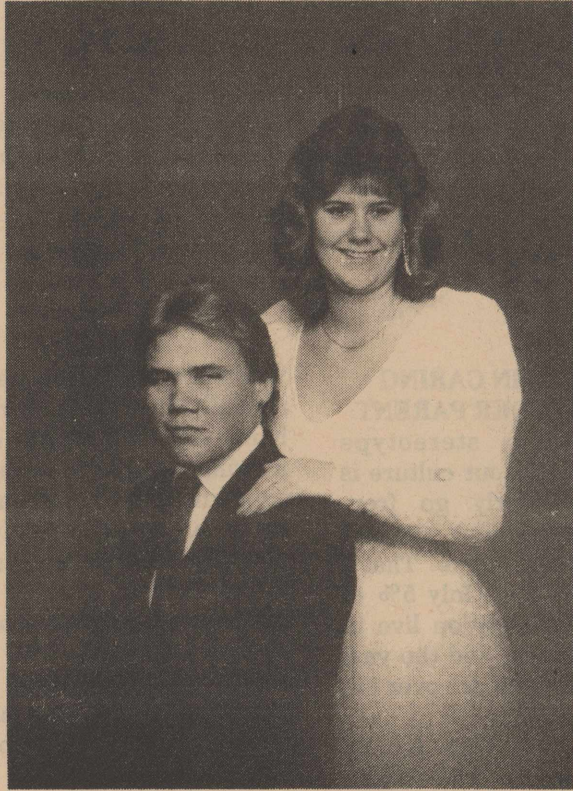

tain Council properties.

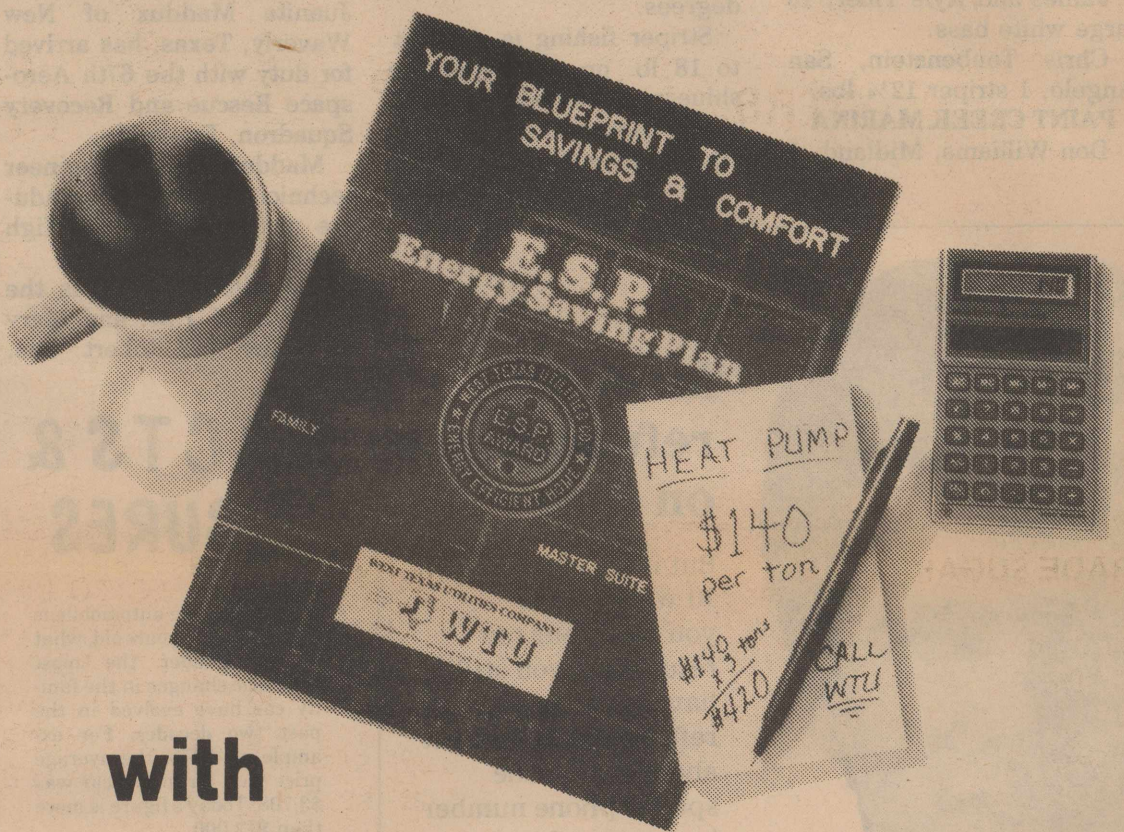



Social Security

People who delay applying for Social Security retirement or survivor benefits for some time after they become eligible may miss out on some checks, Franklin H. Upp, Social Security manager in San Angelo, said recently.

This is because the number of months for which back payments can be made is limited.

In general, people who apply for retirement or survivor benefits after they reach 65 can get back benefits for up to 6 months before the month they apply, but not before the month of their 65th birthday.

People who apply for reduced benefits before 65 generally cannot get benefits for any month before the month they apply.

People who apply for benefits because they are disabled -- workers, adult children, widows, and widowers -- can get benefits for up to 12 months before the month they apply if they are eligible in all other ways.

People can save time when they do apply for benefits if they have the necessary documents ready, Upp said. This includes the person's Social Security card or record of the number, birth or baptismal certificate, W-2 forms or self-employment tax returns for the past 2 years, and marriage and death certificates, if appropriate. Also, if you're not sure of what documents you will need, call the Social Security office and find out what you will need. If you choose, you can file your application for benefits by telephone or you can make an appointment to apply at a later date that is more convenient for you.

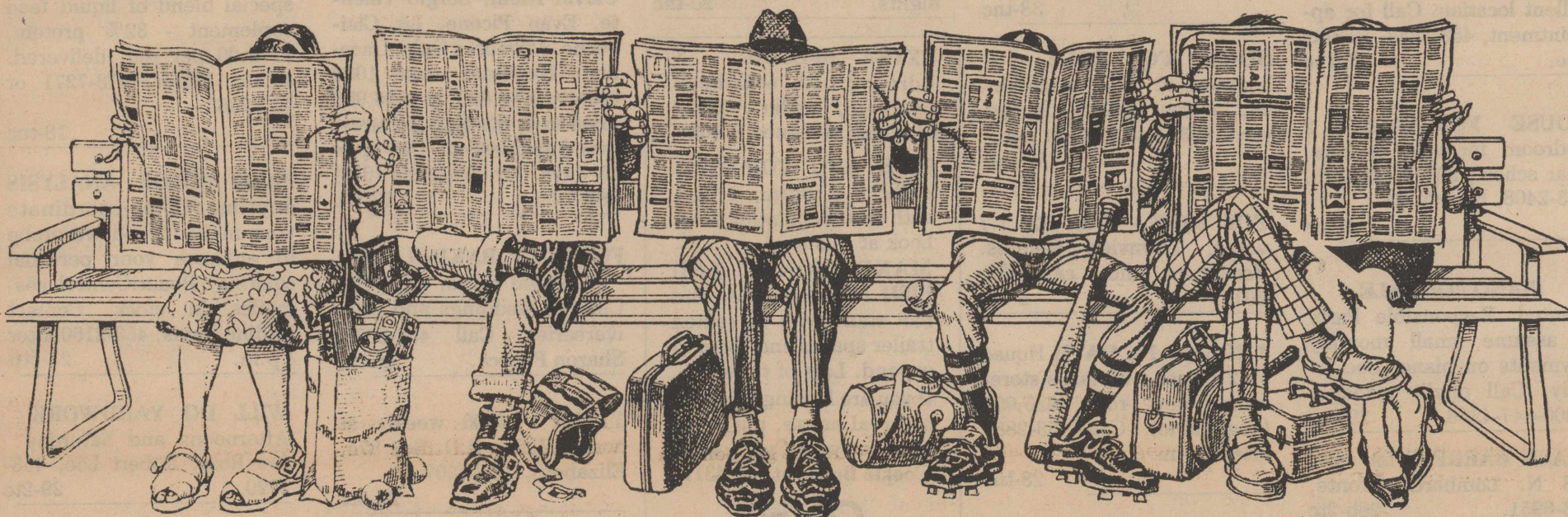

[Editor's Note: Following are representative questions answered daily by VA counselors. Full information is available at any VA office.]

Q - The dividend on my G.I. Life Insurance was not the same this year as last. Why is that?

A - The amount of life insurance dividends is determined by the annual return on invested insurance funds, less the insurance policies paid out. Since both of these items vary each year, so will be the dividend.

Q - What is meant by the transfer or sale of property subject to an existing VA mortgage?

A - The sale or transfer of property subject to an existing VA mortgage generally means that the purchaser does not become personally liable for repayment of the mortgage debt. The veteran whose guarantee entitlement secures the loan remains liable.

Q - My husband died while on active duty in the military. Our son is getting married soon. Will his eligibility for VA education benefits be terminated?

A - No. A child's marriage is not a barrier to entitlement.

Criteria threatens rural medicine

Dear Editor

Is this happening in your community?

Due to recent circumstances in our rural community, Archer City, Texas, our attention has been drawn to the questionable sanctions imposed upon the doctors of rural areas, in particular, by the Texas Medical Foundation's Peer Review Organization. The criteria set down by this organization is to stringent that no physician could possibly be in compliance with all aspects included.

These sanctions in many cases will result in the closing of many rural hospitals, leaving a large percentage of our population without immediate medical care.

I am interested in finding out how many other communities share our same problems.

Only by cooperation of all Texans and their legislators can something be done to rectify this situation. Many

of the legislators are aware of the problem and are investigating the workings of the Federally Funded Texas Medical Foundation.

Due to the stigma this imposes upon the physician the public is not always aware of the situation until it is too late.

We're fighting for our doctor, R.D. Schlomach, M.D. and our hospital, Archer County Hospital. I hope you will be equally as concerned because this could also be pertinent to you, your physician, and your hospital(s).

The number of hospitals closed January 1, 1986 Through December 31, 1986 is 25. A large number of Texas doctors have been sanctioned and many more are waiting official sanctions. If the hospital or

hospitals in your county and/or town are presently being threatened, or any of the doctors are being investigated and/or sanctioned I would like to hear from you.

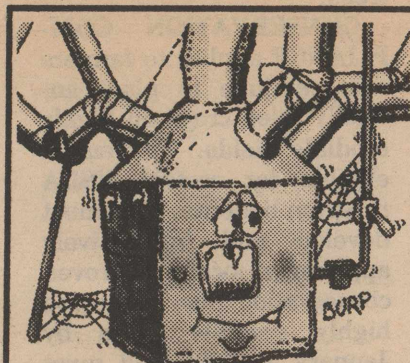

Paving contract awarded

A contract for seal coating 202 miles of highways in 13 central West Texas counties has been awarded by the State Highway and Public Transportation Commission.

Seal coating consists of applying thin coatings of asphalt and rock to the pavement. This process provides some added skid resistance and protects the highway from deterioration by sealing cracks in the surface.

In a way, this tar-and-gravel application acts like a new roof to protect the highway and its foundation. Water seeping into the road base, freezing and thawing, and the effects of traffic eventually lead to the creation by potholes.

Strain Brothers, Inc. of San Angelo received the contract on a low bid of \$1,842,959.41. According to

a rule of thumb worked out by the Federal Highway Administration, the work will generate the equivalent of 43 fulltime jobs during the life of the contract.

Dan Gower of San Angelo is the highway department's engineer in charge of the work.

Highway sections to be improved include:

Coke County -- Texas 70 from the Nolan County line to US 277.

Tom Green County -- US 87 from the Coke County line to 1.9 miles northwest of Sanitorium; frontage road sections on US 87 from Loop 378 in San Angelo to Sanitorium; US 67 from 0.8 mile northeast of RM 380 to 0.5 mile northeast of FM 1692; US 67 from RM 380 eastward 0.8 mile; FM 2105 from US 87 to US 277.

The Shoestring Ranch has used Dr. Newkirk the new Veterinarian to treat two sick cows. He also dewormed the rest of the cow herd. He recommends we worm the sheep herd at least quarterly as we will probably have more worms this year due to the excessive moisture. He also recommends a vaccination program for sheep and calves.

SCS Update

Here is an update on some of the newest programs being administered by the Soil Conservation Service (SCS) of the U.S. Department of Agriculture in 1987; Food Security Act of 1985:

Several provisions of the Food Security Act of 1985 make the goals of USDA farm and conservation programs more consistent. These new provisions encourage the reduction of soil erosion and the retention of wetlands, and will reduce production of surplus commodities. The provisions are known as the Conservation Reserve Program, conservation compliance, sodbuster, and swampbuster.

The Conservation Reserve offers producers help in retiring highly erodible cropland and establishing it to permanent grasses, legumes, trees, windbreaks, or wildlife plantings.

Bids have now been accepted in Texas on a total of 4,086 farms totaling 1,137,454 acres. Much of this land is being seeded to permanent plants this spring. New bids are now in the process of being considered for 1987 and 1988 CRP contracts.

For land accepted into CRP, farmers will receive their per acres bid annually for ten years. They will also receive 50 percent cost-share assistance for establishing permanent vegetation or trees.

CONSERVATION COMPLIANCE applies to farmers who continue to plant annually tilled crops on highly erodible fields. To remain eligible for certain USDA program benefits, they must develop and be actively applying a locally approved conservation plan for those highly erodible fields by January 1, 1990 and must have the plan fully implemented by January 1, 1995.

SCS employees are now experiencing a heavy workload in helping farmers prepare conservation plans because of this provision. Of the 33.3 million acres of cropland in Texas, nearly 20 million is estimated to be highly erodible. SCS hopes to write one-third of the needed conservation plans during 1987, one-third in 1988, and one-third in 1989.

Sodbuster applies to farmers who plant annually tilled crops on a highly erodible field that was not used for

crop production during the period 1981-85. If they plow out such a highly erodible field, they must do so under a conservation system approved by the local conservation district in order to remain eligible for USDA program benefits.

TAKE PRIDE IN AMERICA

This is a national public awareness campaign designed to encourage wise use of the lands and resources shared by all Americans. Many federal, State, local and private sector organizations are working together on the "Take Pride" campaign to generate a greater sense of citizen ownership, pride and responsibility for America's natural and cultural resources and to encourage good stewardship attitudes and behavior. Through national advertising, public-private partnerships, a national awards program and other activities, the campaign seeks to provide a boost for stewardship action and awareness efforts around the Nation.

SCS VOLUNTEER PROGRAM

Thousands of men and women volunteers are needed to help battle soil erosion and other natural resource problems. People who volunteer their time and talents either in the office or in the field to help SCS and local conservation districts can put more conservation on the land while keeping federal costs down. Even though there is no compensation for service, people will have the satisfaction of carrying out some of the most necessary work in this country. They will receive recognition for work hours and will have legal and insurance protection for any work-related injuries.

Anyone may apply--retirees, professionals and non-professional, students--anyone interested in conservation. Volunteers must be at least 16 years of age. Supervisors must adhere to appropriate federal, state, and local laws and standards regarding the employment of minors. There is not maximum age limit.
