Candidates respond to filing deadline

According to Coke County Democratic Chairman Patti Ivey, the Monday, January 4, deadline brought a flurry of political filings for places on the ballot in the Primary Election on March 8, 1988. Eleven candidates have now filed for office with Mrs. Ivey-- seven of those on Monday.

Frances Pierce, chairman of the Coke County Republican Party, was out of town at presstime but no Republican candidates have been reported.

Announcing their candidacy earlier were incumbents Coke County Sheriff Marshall Millican; Precinct 1 Commissioner George Newby; Bob Fields, Precinct 1 Constable; and Wayne Arrott, Constable of Precinct 2.


Seeking his third term as County Attorney is Bill Helwig. Before he was elected to his first full term, he filled the unexpired term of Bob Owens. A Miles native and a graduate of Miles High School, Helwig has been a resident of Robert Lee since January 1980. He graduated from Texas A&M University in 1976 with a n Agriculture Economics degree and gained a law degree from Texas Tech University in 1979. He and his wife, Audrey, a Robert Lee native, have two children, Chad, a first-grader and Jodee, 4 years old.

Paul Burns, area rancher, announced Monday he is a candidate for Commissioner, Precinct 1. Burns stated, "I want to express my desire for this public office and will do my best to do a job for the people of Coke County that will be respected and appreciated. I have depended on this County for a livelihood for approximately 50 years and would like to offer in return a job of honesty, integrity and hard work.

I solicit your vote for Precinct #1."

Promising to be the most contested county race is the campaign for Commissioner of Precinct 3. Incumbent Finis Millican has declined to run again.

Tim Millican will be bidding for his first political office in his candidacy for Commissioner, Precinct 3. A resident of Coke County since the age of six, the Millican families are pioneers in the west part of the county. Animals will be weighed and tagged beginning at 8 a.m. on Friday. Judging will start at 5 p.m. with the breeding sheep followed by market lambs at 5:30.

Yarbrough

Funeral services for Jessie Newton Yarbrough, longtime Coke County educator and historian, were held on Monday, Dec. 28, in Robert Lee. Services were conducted at 2 p.m. at the First United Methodist Church with burial following in Robert Lee Cemetery, directed by Shaffer Funeral Home.

Mrs. Yarbrough, 95, died on Saturday, Dec. 26, in the West Coke County Nursing Home following a lengthy illness.

Her parents, J.C. and Sophronia Ann Newton, came to Coke County in 1889 from Burnet County. Mrs. Yarbrough was born Oct. 31, 1892, one of 10 children, near Old Edith. The family moved to Robert Lee to better educate the children where Mr. Newton, a mail carrier, purchased the local paper, "Coke County Rustler".

Mrs. Yarbrough began teaching school at age 16 and never looked back. In 1981 when her book "A History of Coke County - Home of the Rabbit Twisters" was published, she related that teaching, and her students, had been the joy of her life.

After her early teaching years on a simple "certificate",

Mrs. Yarbrough returned to school for her B.A. degree from Sul Ross College in 1936. In 1953, she attained her MA degree there also.

In 1920, she was married to a fellow teacher, William Bryan Yarbrough. They taught a number of years together. Mr. Yarbrough also enjoyed farming when he was not teaching. Her career in education ended after 48 years.

Mrs. Yarbrough was a member of the Coke County Historical Commission, took part in research, writing, and civic affairs as long as her health permitted, and was an active member of the Methodist Church. She was generous with donations to

Civic leader James Slayden Maverick, the elder statesman of one of San Antonio's best known families -the Mavericks -- died Friday at age 96.

Mr. Maverick was the last surviving grandson of Samuel Maverick, signer of the Texas Declaration of Independence and the individual who coined the word "maverick". He also was the brother of the late San Antonio mayor and congressman Maury Maverick Sr. Maverick's daughter, Jamie Maverick, described her father as high-spirited and generous. He had a keen interest in Texas history, much of which coincided with his family history. Maverick had an illustrious business, and civic and arts career.

He was preceded in death by his wife, Hazel Davis Maverick, and daughter, Hazel Dean Stengele.

Other survivors include, daughter Ellen Dickson, and sister Mary McGarraugh, both of San Antonio. He also had 11 grandchildren and 14 great-grandchildren.



BTR trains residents

The Bronte Training Residence is working a few of their residents out into the community to live on their own. They will no longer be under the authority of the Training Residence. These people are generally old enough to be drawing Social Security and the residence puts them in contact with other aide organizations if needed.

Upon leaving the residence they will no longer receive any financial support from the training facility and will be responsible for paying their rent and other needs from their own income. "They are still welcome to visit and join in recreational activities", stated residence social worker, Gene Elliot.

Institute of Cognitive Development operates the residence and according to Elliot, the main function is to train the mentally retarded or handicapped people to function in the community.

Stamps available

Something is new at the Bronte Post Office. They now have a stamp booklet vending machine. In an effort to add to the service they perform a \$2.20 booklet of stamps vending machine was installed on Monday, Jan. 4. This machine will only sell \$2.20 books of stamps and it will give change when more than \$2.20 is deposited in it.

For example, if you put \$3.00 in, you will receive one book and \$.80 change or if you put \$5.00 in, you will receive 2 books of stamps and \$.60 in change. This machine must only be used to purchase stamps, it is not a change machine, at best \$2.20 must be deposited to receive any stamps.

Postmaster Ray Barnett hopes this service will aid customers to obtain stamps after hours and on weekend, when there is no window service available.





Mental illness myths

MYTHS ABOUT MENTAL HEALTH AND AGING

yards.

Old age isn't a time of mental illness. Yet, if you believe many of the common myths about aging, it would certainly appear to be so.

Accepting a stereotype of generally poor mental health among the elderly often causes us to deal ineffectively with elderly parents and family members we care about.

One of the greatest myths is that the incidence of serious mental illness increases with age.

It is true that if you count the number of adults who are mentally ill and grow old, the rates of mental disorders will rise steadily and peak in the oldest age group. However, when the one-year rates of new episodes of mental illness are counted, the rates are lowest after age 65.

In other words, a mentally f healthy adult is likely to be a

mentally healthy elder. While the older adult may have to cope with more life stresses than at earlier ages, the aging process itself does not lead to serious mental illness.

Many people also think that confusion and memory loss in the elderly must be due to inevitable and irreversible brain disease.

While it is true that confusion is a symptom of Alzheimer's disease, stroke and brain tumors, they can also result from less serious, treatable conditions.

According to the specialist, acute reactions to fever, medication interactions, high blood pressure, or anemia can produce confusion which may be reversed with treatment.

Assuming that poor mental health is a natural part of old age means family members may not seek professional help when it could greatly contribute to the quality of life for both the elder and the rest of the family.

Things are looking up with the recent rains but, we are not out of the woods yet. With the rapid lush growth we received in spring and summer our grasses have lower protein levels than usual. In several clippings taken around this area, protein content in improved fertilized or prescribed burned pastures runs about 5-8%. Most native pastures will be lower than this. Also, the digestibility of these grasses are lowered resulting in cattle and sheep taking up to twice as long to digest their intake. There is lots of grass but in these conditions the more they eat the longer it takes to digest resulting in weight loss, lowered reproduction and especially lowered lactation.

The only solution is painful. We must put some type of protein supplement out there to speed up the break-down of these dry ranch grasses and allow the animal to better utilize the things they do eat.

The nutrient require-

ments for a 1000 pound dry or pregnant cow is 1.05 pounds of crude protein per day. If she is lactating it increases to 2-2.05 pounds per day. On a 120 pound ewe, the requirements are .33 pounds per day for a pregnant ewe and .45 pounds for a lactating ewe.

These figures are for maintenance and you can see what happens with a low protein forage. The ewe or cow will lose weight, likely not breed and if they have offspring, milk production falls rapidly, so she not only loses herself but cannot wean a good baby.

The Greatest Running Back

Recently I was interviewed by Frank Gifford during the halftime of a Monday Night Football broadcast. We talked about great running backs and I gave my opinion that the top running back of all time was Jim Brown.

Fans love to debate who was the greatest player at each position. Naturally I've heard from some who would pick Tony Dorsett, O.J. Simpson, Walter Payton, or any one of several other fine running backs over Jim Brown.

It was a reminder to me that a lot of people just don't remember Jim Brown. If you are 30 years old today, Jim Brown quit playing when you were ten. Another factor is that because of expansion to new cities and increased television coverage, the National Football League has attracted many new fans who never saw Jim during his great years with the Cleveland Browns.

When you consider the conditions Jim played under, his records are even more phenomenal. He played in an era where the defense's primary purpose was to stop the run first and the pass second. Today, it's the other way around and that helps the running back.

When Jim took a handoff, he was likely playing on a frozen or muddy field. There were no domed stadiums or artificial turf fields back in the 1950s and 1960s. I feel the good track artificial turf pro-



Back then the hash marks were out where the college hash marks are today. Officials spotted the ball on the hash marks and there was always a short side of the field. Defense slanted to the wide side. You simply didn't run to the short side because the sideline is the best tackler a defense has going for it.

Jim ran from a split backfield where he started from about three yards behind the line of scrimmage. He didn't have the luxury of starting from seven yards deep, as in the "I" formation, and the advantage that gives you in picking your holes. And, of course, he played when the NFL season was just 12 games.

Even with those disadvantages, Jim set records that lasted for nearly two decades. He was that rare player who combined all the talents desired in a running back. He had moves and speed, and he also had the power to run over defenders.

Of today's running backs, I would choose Eric Dickerson of the Indianapolis Colts as the best of those still at the top of their game. Walter Payton of the Bears will be retiring this year after a great career, and Tony Dorsett has had many fine years with Dallas. But there's no doubt in my mind that Jim Brown was the greatest of all time II


