needs.

## Bronte voters urged to vote this Saturday

Even though the three elections to be held in Bronte this Saturday, May 7 are all uncontested elections, exercise your rights and go VOTE!

In the City of Bronte election, incumbent Mayor J.T. Henry is running for re-election unopposed. Three Alderman positions are up for election and there are three

candidates, Edward Hart, Harold Dunn and Wesley Gibbs.

For Bronte I.S.D. Trustees, three positions are up for election. Those running are Nick Arrott, Andra Cooper Arrott and Michael White.

The East Coke County Hospital District also has three positions to fill for Directors

On the ballot are Eddie Alexander, LeDrew Arrott and Noel Percifull.

Though none of the Bronte races are contested, voters still have the option of write-in candidates. Voting for all three races will be underway at the City Hall on Saturday, May 7th.

## Three elections slated for RL

Three local elections are slated in Robert Lee for Saturday, May 7. Voters will elect governing panels for Robert Lee Independent School District, the city of Robert Lee, and the West Coke County Hospital District.

Absentee balloting for all the districts ended, Tuesday, May 3 with strong voter interest indicated in the hospital district and school district elections.

A slate of 7 candidates will be on the ballot for the school board of trustees for the three (3 year term) seats on the panel. These include incumbents, Mary (Herring) Grim, Gaylon Pitcock, and Donnie Robertson plus new candidates Jim Clendennen, Edwin (Butch) Davis, Richard Daves, and Donna Millican.

Absentee balloting produced a surprising 31 votes. Voting will take place Saturday, May 7, in the school foyer.

The Robert Lee City Council election has been scrambled by the withdrawal of one candidate, B.W. Baucum, who has left the city. Although he filed a statement with the city that he cannot serve, the legal date to withdraw has past and he will be on the ballot. Two vacant seats on the city council exist. A.L. Brasuell, incumbent, and candidate Joe Barrett will be on the ballot, along with Baucum's name. Incumbent Mayor Wilson Bryan will be the only candidate on the city ballot for mayor.

Absentee balloting totaled 10 votes. Voters must reside in the city limits to be eligible to cast ballots in the city election which will be held at the City Hall May 7.

The hospital district board election ballots will show 5 candidates for 3 slots on that panel. Incumbent Bill Helwig, Barbara Chesney, and Linda Arledge, plus newcomers Pat Brasuel and Judy Williams will be vying for the seats on May 7.

Absentee election judge Mildred Reese reported Wednesday that 25 votes were cast in the early ballot. The election on Saturday will be held in the commissioners' courtroom in the county courthouse.

The Coke County Underground Water Conservation District election will also be held on May 7. Coke County Clerk Ettie Hubbard reported a total of 18 absentee votes were cast in her office for the district's directors. Three places on the board are open for the two year terms.

For the Director at Large position, J.D. Harmon and M. Royce Lee are candidates for the position. M. Royce Lee is the incumbent director.

Arch Mathers and Larry Jameson are running for the director position in Precinct 1. Arch Mathers is the incumbent director.

Otis Smith is running unopposed for the director from

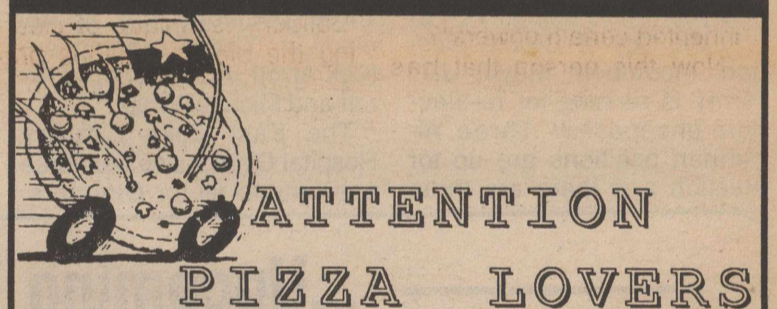

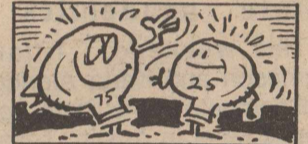

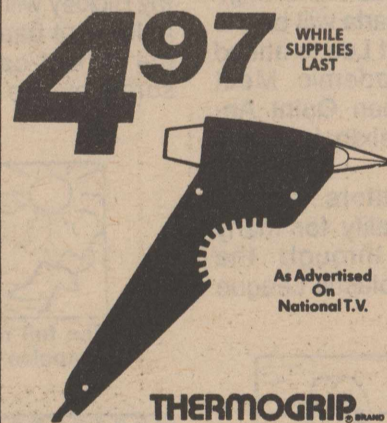

## Linksters qualify for state tournament

The Robert Lee Steer 'A' team qualified for the State Boys Golf Tournament by placing second in the Regional Golf Tournament April 26 & 27 in Abilene. The Steers finished only 8 strokes behind Baird (639-2 day total) to take 2nd with a 647. The squad will compete in Austin May 12-13.

Austin-bound team members and their Regional scores are Stevie Ebenstein, 77-80; Robert Runnion, 84-78; Jason Herring, 77-80; Joel Herring, 86-97; Clint Smith, 91-85.

Members of the Steer 'B' team who placed 7th at Regional are Stephen Epper-son, 86-85; Jon Rogers, 99-91; Jason Wink, 94-84; Michael Lee, 94-99; Brent McPeek, 91-90.

## Students set for state academics

This weekend, Tiffany Jameson and Karla Aldridge will compete in the State Academic Meet in Austin, Texas. Tiffany placed third in feature writing, and Karla placed third in persuasive speaking at the Regional Academic Meet in Abilene on April 23, and their rankings qualified them for state competition. Also traveling to Austin will be Lisa Bower who placed fourth in informative speaking; she qualifies to state as an alternate.

Jesse Powell, a senior informative speaker placed sixth at the regional competition. Also competing at regional were Brent McPeek (typing), Brent Gibbs (poetry reading), Rachel Lopez (headline writing), and Wes Horn (persuasive speaking). Tiffany Jameson also competed in prose reading, and Karla Aldridge competed in headline writing.

Tiffany and Karla will be the first from Robert Lee to attend the State Academic Meet since 1983 when Quint Anthony placed sixth in ready writing.

The competitors at the State Meet qualify for many scholarships through the Texas Interscholastic League Foundation.

The Lady Steers also did well at the Regional tourney. They placed 3rd with a 838 total in a field of 15 teams.

Squad members and their results are: Brooke Boone, 94-90=184; Becky Padgett, 116-100=216; Shannon Skipworth, 112-98=210;

Stephanie Poehls, 121-107=228; Debra Bell, 122-126=248.

Brooke Boone was named 1st Medalist at Regional with her 184 total and qualified for the State Golf Tournament in Austin May 12-13.

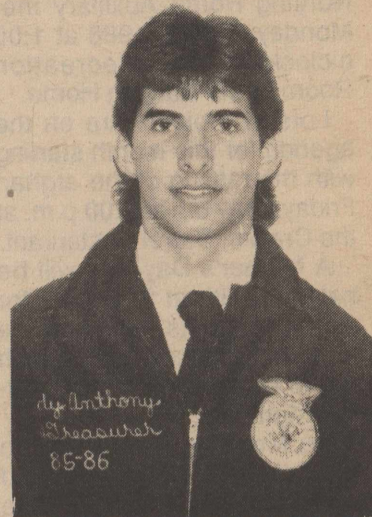

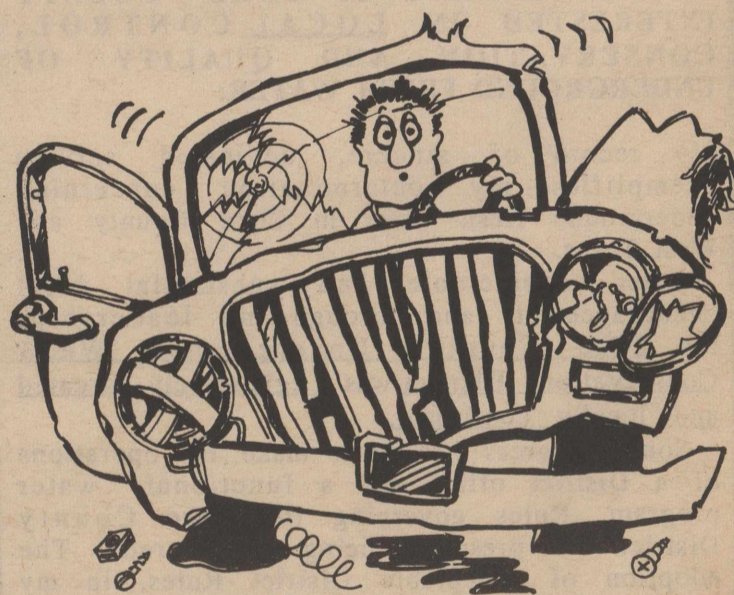
although not placing a chair, did achieve first alternate in the trumpet section.

How long will it take this to get there? A good question, but it depends on what this is and where there might be.

If this is a letter and it is going within an approximate 250 mile radius, I would say overnight. Over 250 miles up to about 750 miles it should take two days to get there. Over 750 miles is a three day delivery. Now this is just a rule of thumb and my thumb is not as big as others might be.

I say this because areas around large airports such as O'Hara at Chicago and JFK in New York put them into the two day delivery area. The transportation into these areas is much better or at least more frequent than the more rural areas.

A parcel is different and is divided into two classes. Priority (this used to be airmail parcels) and fourth class parcel post.

## VA Questions

Q - I applied for a VA-guaranteed home loan. I was advised it could not be processed until I paid an outstanding debt for education benefits. Is that true?

A - Yes. It is the policy of the VA to reconcile all outstanding debts to the U.S. Government prior to approving a home loan application.

Priority mail has a scheduled delivery standard of two days to the Continental United States. Parcel post can be figured at about one day for each zone. This zone is not the time zone but corresponds more with the 250 radius rule. Thus, 250 miles would take 1 to 2 days; 500 miles would take 2 to 3 days and so on until you reach a foreign border or an ocean. If it gets to either of these, I refuse to guess.



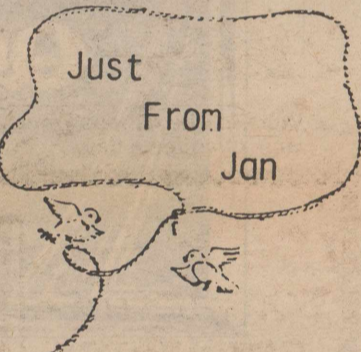

You may think of reading a bed-time story as a pleasant quiet time which gets your child ready for sleep. But it's a lot more important than that.

Early childhood educators have found that reading with children is an important foundation for later reading achievement. They emphasize the need to read with, rather than to children, since talking about the story, asking and answering questions are as important as the story itself.

This parent-child interaction applies both to the content of the story and spontaneous discussions about letter, words and phrases that help children become familiar with the medium of print. For example, when the child says, "That's a 'B' like in my name," that may lead to parent-child talk about letters and sounds.

The researchers tell us that regular reading with children 9-10 minutes a day for 4-7 days a week is associated with both high reading achievement and positive attitudes toward reading. The positive feeling that goes along with the shared interactions between parent and child also includes children's success in learning to read.

Many young children begin their learning-to-read process by "pretend" reading -- turning pages, following lines of print with their fingers and retelling the story as they view the pictures. Make-believe play also encourages children to adopt the role of being a reader. For example, in playing "school" or "library" they may pretend to read.

Don't forget that parents also model reading behavior. If you read for pleasure and information, your child is more likely to have positive attitudes and achievement in reading as well.

## Dealing with child stress

A sequence of ordinary little events -- like spilled juice, thrown toys, an overflowing sink and ringing phone -- can quickly lead to a screaming child and a distressed parent.

Stress is something that parents of young children can not avoid; it is the reaction to stress that counts.

Parents should be aware of the symptoms that signal stress-pile-up and potential danger.

Some people react by developing physical symptoms, they may cry, become fatigued, sad, angry, very irritable or feel depressed and guilty. It is not unusual for a parent experiencing stress to feel helpless and doubt his or her worth as a parent.

Lack of adequate sleep often contributes to parents' stress. Sleep requirements may vary from person to person, but it is easy for any parent to lose sleep because of a young child's erratic sleep schedule.

Stress relievers:

\* After putting the child in a safe place, such as his crib or room, step away until you feel you are again in control. You may want to count to ten, sit down and rest or close your eyes for a few minutes.

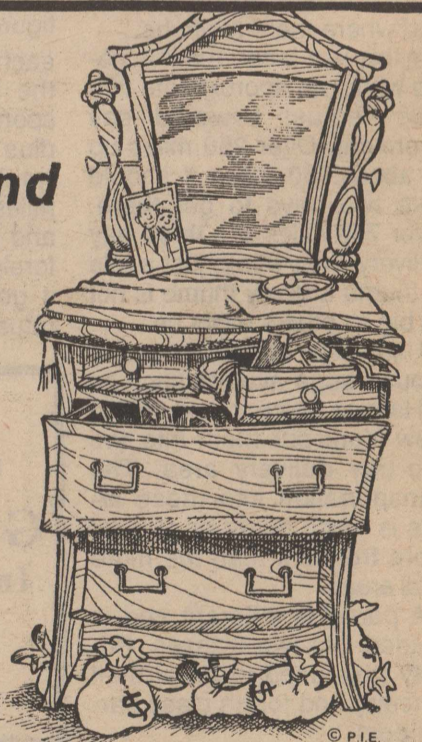
\* Share your frustration with your spouse or telephone a friend and talk briefly about how you feel. Sharing your inner feelings is not a sign of weakness; it is good therapy when you are upset.

\* Work off your anger by doing something very physical. Instead of hitting the child, pound a mattress, scrub the floor or dig in the garden.

\* Give in once in a while. If the child resists picking up his toys, for example, let the toys stay where they are temporarily.

\* Avoid trying to be the superhuman parent who has a perfect child. In that case you can actually cause much of your own stress.

Uncontrolled, termites can cause extensive damage to wooden parts of the home.

Quite often termites and certain ants swarm at the same time, and it is important to be able to tell the difference between these two insects. Carpenter ants swarm in the springtime and can cause some structural damage to wood. However, termites are much more destructive and require different control measures.

Termites have a broad waist while ants have a narrow, constricted waist; termite wings are the same size and shape but winged ants have a front and back pair of wings of different lengths and shape; termites have straight antennae (feelers on their heads) while ants have elbowed antennae.

Termites may be attracted to your house by dead tree limbs, stumps, old lumber and other sources of termite food, it is advisable to remove such material. If soil is above the point where wood or brick meets the foundation, termites have easy access to your home. Anywhere that wood meets dirt (siding,

wooden steps) is a potential spot for termite entry into the home.

Termites have the ability to build mud tunnels over non-wooden structures to reach a food source. These tunnels (about 1/4 inch wide) may extend several feet up concrete surfaces. On a slab home, these may be seen on foundation concrete between soil and brick. On homes built above the ground, these tunnels can be found on piers or pipes that go from soil to structure.

The bath trap in homes built on a slab is another source of termite entry. Plumbing in this situation has contact with soil under the slab, and termite tunnels may be found in this area.

Although a thorough inspection is best done by a professional, a homeowner can make a quick check for termite infestations. If termites or damage is found, contact a local pest control company. This is one insect pest that should not be handled by a "do-it-yourselfer". Commercial pest control companies have the necessary equipment and experience to effectively rid a home of termites.

## Wait for you SS check

A person whose Social Security check does not arrive on the day it is expected should wait for two more mail deliveries before contacting the San Angelo Social Security Office, Franklin H. Upp, Social Security manager in San Angelo, said recently.

This will take care of a good share of delayed checks. If the check still has not arrived after 2 days, the people of the San Angelo office can begin action.

The most common cause of failure to receive a check is failure to report a change of address. Many people fail to notify Social Security when they move, even though they rely on their Social Security checks as their primary source of income.

Some people think it is enough to report their change of address to the post office. The post office, however, will forward mail to the person's new address for just 1 year. After that, they will send the check back to the U.S. Treas-

ury.

If the person's check is returned and the new address provided, it usually takes about 4 or 5 days for a new check to be sent. If the check was not returned, a stop order will be put on it, and the matter will be transferred to Washington, D.C. to see if the check has been cashed.

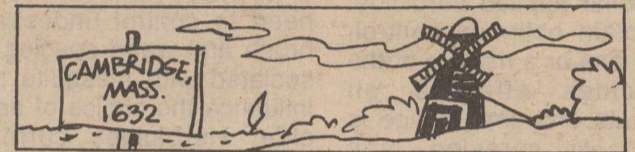
If it has not been cashed, a new check will be sent right away. This process can take up to 3 weeks. If it has been cashed, a new check cannot be sent until the person who cashed the check is identified.

Even though a person's check is deposited directly into his or her account in a financial institution, he or she should notify Social Security of any change in address.

MESQUITE CONTROL WITH FOLIAR HERBICIDES

Now is the time of year that many ranchers and others begin to ask if this will be a good year to spray mesquites. Conditions are not as favorable for control of mesquite with foliar applied herbicides as they were in 1987. The amount of rainfall received throughout most of the state since last fall has been below normal. Thus, according to research conducted several years ago by the Texas Agricultural Experiment Station, control of mesquite in 1988 may be only average at best. However, soil moisture is only one of the factors that influences the degree of mesquite control achieved with foliar applied herbicide. To obtain optimum control, select one or a mixture of the herbicides effective on mesquite and time foliage is ready for spraying, soil severely moisture stressed. With careful planning optimum control of mesquite can be obtained.

Proper timing of herbicide application is critical if good control is expected. Mesquite leaves should be fully extended and should have turned from light green to dark green in color before herbicide is applied. Usually this occurs about forty days after budbreak. When the leaves have matured, the plants begin to restore carbohydrate reserves. Research reported by Texas Tech University shows that food reserves are utilized during the period of pod elongation. An application of the herbicide during the period usually results in poor control. After the pods have elongated, storage of food reserves is resumed and excellent control is obtained during this period. About 90 days after budbreak the degree of control with foliar applied herbicides decreases because of build up of wax on the leaves and a general decrease in growth activity of the

plants.

Occurrences that affect mesquite foliage just prior and during the spray season will affect results obtained. Frequent rains during the spray season may result in the development of new leaves. For optimum control, the new leaves should be allowed to mature before spraying. Damage to mesquite foliage caused by insects, disease, hail and/or a late frost will result in poor control if new foliage is not allowed sufficient time to mature.

Several choices of herbicides and mixtures of herbicides are available for mesquite control. This provides an opportunity to better match range objectives and economics with the herbicide or herbicide mixture. Also, the need to control undesirable brush and weed species associated with mesquite may influence the choice of herbicide. Herbicides currently registered and effective for control of mesquite by foliar application are: Grazon ET (triclopyr), Banvel (dicamba), Reclaim (clopyralid) and Grazon PC (picloram). Grazon ET, Banvel, and Reclaim may be used alone. Research information indicates the highest degree of control may be obtained by using Reclaim. Grazon ET and Banvel may be mixed with Grazon PC in a 1:1 mixture. This mixture will provide good control equivalent or slightly better than that obtained if Reclaim is used alone. Reclaim does not provide good control of brush species other than mesquite. Thus, if control of mesquite and associated species is desired, the Reclaim: Grazon PC mixture should be used. The success of controlling mesquite with foliar applied herbicides depends on many factors. To obtain the maximum benefit from money spent, herbicides should be applied at the proper time with the proper method and followed up with good range management.

VA to issue monthly pension checks

The Veterans Administration has eliminated a "Catch-22" caused by quarterly or semiannual issuance of VA pension checks, Dr. Stephen L. Lemons, Director, Waco VA Regional Office, said today. The solution is to issue checks monthly if a VA pension recipient requests it.

"This doesn't sound like a major problem or a major solution, but for a retired veteran or surviving spouse living on Supplemental Social Security, it can be very important."

Lemons gave the example of a veteran's widow who received \$323 per month from Supplemental Social Security and \$10 per month from her husband's VA pension. She was told her monthly income could not exceed \$360, or her Social Security Insurance and Medicaid benefits would stop.

Because her VA pension was only \$10 per month, VA regulations required her pension check to be issued twice a year, in the amount of \$60 each time. So twice a year, her monthly income exceeded limits imposed by Social Security, making her ineligible for Medicare. In addition to losing food stamps and Medicaid benefits for a month, she had to reapply the next month to re-establish her eligibility for them, he said.

"The VA regulations were designed to save taxpayers' money by issuing VA pension checks less frequently," Lemons said. "But in those few cases, other federal benefits were denied because the timing of VA payments increased the recipients' monthly incomes, during those months, beyond the standards set by other federal

agencies.

"One way out of this 'Catch-22' was for us to seek a change in VA regulations," he said. To prevent other federal benefits from being denied, VA pension recipients who receive VA pension payments quarterly or semiannually may now tell the VA in writing that they need a monthly check.

"Our goal is to provide excellent service to veterans, and this simple change in VA regulations enhances that goal," Lemons said. "If you need to have your pension checks paid monthly, write to the Waco VA Regional Office."

VA pension is a benefit paid to veterans because of age or non-service-connected disabilities, Lemons said. Generally, low-income retired veterans age 65 or older are eligible, if they spent 90 days or longer in military service during wartime. The amount of pension is based on income, though changes in marital status or dependency status affect the amount payable. Non-service-connected pension is also payable to surviving dependents upon death of the veteran if they meet the income limitations established by law.

## Moros Y Cristianos (Black Beans with Rice)

Make this treat from the tropics. It can surrender you into doing a calypso on those early spring days!

8 cups	cold water	1/2 cup	rioja or very dry wine
1 pound	black beans	1 tbsp.	vinegar
	1/2 medium green pepper	1 tbsp.	sugar
	1 medium diced onion	1	large bay leaf, crumbled
1 tbsp.	olive oil	2 tsp.	oregano
1 tbsp.	oil		freshly ground black pepper
1 1/2	medium green peppers, chopped		
4	large cloves fresh garlic, minced		

Soak beans and 1/2 green pepper in water for at least two hours. Bring to a boil and cook 1 to 1 1/2 hours or until beans can be mashed with a fork. Discard the green pepper.

Saute chopped green pepper, onion and garlic in oil. Add 1 cup of mashed beans to mixture and blend. Add to the rest of the beans, along with the remaining ingredients. Bring to a boil. Cover and simmer on very low heat for 1 1/2 to 2 hours. Uncover to dry. Serve over rice.
