Speakers this year included: Dr. Calvin Kent, director of

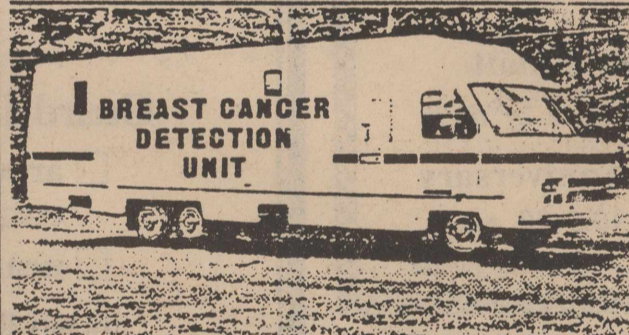

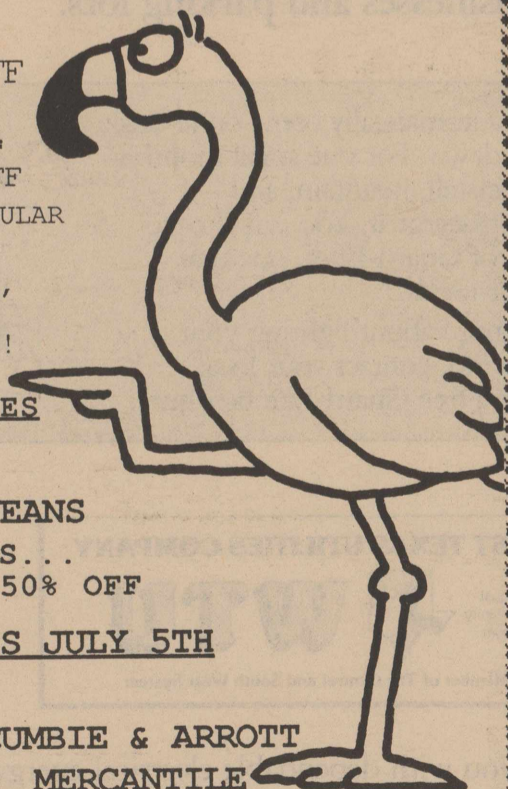

According to the American Cancer Society, one out of ten women in the United States will develop breast cancer sometime in her lifetime. It is currently estimated that over 37,000 women die each year as the result of breast cancer.

Ninety percent of breast cancers are diagnosed by women or their physicians finding a lump in the breast. Women who are diagnosed with a lump large enough to feel have a 50 percent five year survival rate. A woman who is diagnosed as having breast cancer by mammography, before a lump can be felt, has a 97% five year survival rate and a 90% 10 year survival rate.

A mammogram can detect a cancer this small even before it can be felt.

The American Cancer Society has established guidelines for mammography in asymptomatic women. (Women who have no symptoms of disease). Those guidelines have been adopted by the American Academy of Family Physicians, American College of Obstetricians and Gynecologists, and The American College of Radiology. Those guidelines are:

I. 35-40 years of age - One baseline mammogram.

II. 40-50 years of age - A mammogram every 1-2 years depending on breast type and risk factor.

III. 50 years of age and over - An annual physical examination and annual mammogram.

IV. Asymptomatic women under 50 years of age with significant high risk

factors should be examined at appropriate intervals. These risk factors include previous breast cancer and family history of cancer.

V. A symptomatic woman should have a mammogram at any age when she experiences a mass, nipple discharge, skin changes or unexplained breast pain. A screening mammogram is an x-ray of the breast using extremely low dosages of radiation (usually comparable to dental x-rays) and is designed to find very early cancers.

A female technologist who is highly trained in mammography will perform the examination.

The charge for the screening mammogram is \$50.00. The Unit accepts cash, check, Visa, Mastercard and American Express.

**The Way I See It**

The Supreme Court in all of its infinite wisdom has now given our public utilities the closest thing to unregulated monopolies that this country has ever seen. In case you don't know what happened, let me explain: Electric companies that do business in more than one state are exempt from any regulation by either the states, counties, or cities there-in. It becomes the jurisdiction of the Federal Government. Although this does not have any immediate effect on us here in West Texas right now, it is a good bet that it eventually will. All that is necessary is for any electric company to affiliate with a company that does business interstate.

This is not to say that we have had much in the way of regulation as far as the public interest is concerned with what we have now. I can't recall the PUC ever questioning the need for any rate increas-

es. The only question that is asked is how much. It has gotten to be a predictable game at best. It goes something like this:

Electric Co.: We want a 10% rate increase so let's ask for 25%.

PUC - There's no way they need a 25% increase. We will study this carefully.

3 months later:

PUC - We will only approve a rate increase of 15%. We have the public interest to look after.

Electric Co.: Well if we must settle for this, we will, but we will probably have to come back next year.

And so it goes, but we do still have the possibility, albeit slim, to change or at least slow the process down. Given the Federal Government's capacity to give our money away we may very well see it turn into an "ask and thou shall receive" program.

And that's the way I see it.

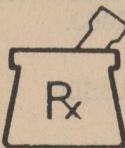

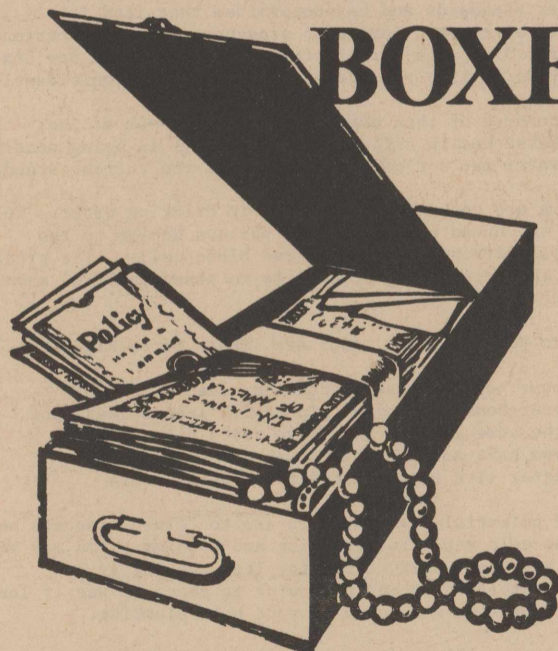

#### PUBLIC NOTICE BRONTE CITY WATER CUSTOMERS

The United States Environmental Protection Agency (EPA) has adopted requirements that all public water systems notify their customers about lead exposure. This notification is intended to educate and inform consumers on this issue in light of the fact that your drinking water may be a potential source of lead exposure. This is being done even though your water system is not in violation of the current standard. There are also other potential sources of lead contamination in the environment.

The United States Environmental Protection Agency (EPA) sets drinking water standards and has determined that lead is a health concern at certain levels of exposure. There is currently a standard of 0.050 parts per million (ppm). Based on new health information, EPA is likely to lower this standard significantly.

Part of the purpose of this notice is to inform you of the potential adverse health effects of lead. This is being done even though your water may not be in violation of the current standard.

EPA and others are concerned about lead in drinking water. Too much lead in the human body can cause serious damage to the brain, kidneys, nervous system, and red blood cells. The greatest risk, even with short-term exposure, is to young children and pregnant women.

Lead levels in your drinking water are likely to be highest:

1. if your home or water system has lead pipes, or
2. if your home has copper pipes with lead solder, and
  - if the home is less than five years old, or
  - if you have soft or acidic water, or
  - if water sits in the pipes for several hours

Ways to avoid potential lead exposure are to "flush" faucets before use and to use cold water for drinking and cooking. You may wish to have your home tap water tested for lead content by a competent laboratory. You may also wish to check to see if lead pipes, solder, or flux were used in your home plumbing.

The City of Bronte will continue to monitor lead levels in our raw water source, Oak Creek Reservoir, and throughout our distribution system to provide early identification of potential lead level increases. Early identification will enable the City to develop a timely program to mitigate adverse effects of increased lead levels should it become necessary.
