The facts closely examined present a quite different picture.

Elected governor in 1974 after promising not to raise taxes.

- Six months after taking office he pushed through a \$500 million tax increase.

- Sales tax raised from 3% to 5%.

- Income tax on interest and dividends raised from 9% to 10%.

- A "temporary" 7.5% surtax imposed on personal income.

- A 10% surtax placed on corporate income taxes and on bank and trust and utilities companies.

- Taxes on gasoline, cigarettes, and alcoholic beverages raised.

By the time Dukakis was rejected by his own party for a second term, Mass. was commonly referred to as Taxachusetts.

He consistently opposed tax cuts. He opposed (while King was governor) the tax-cut initiative, proposition 2 1/2.

Nevertheless, the people of Mass. passed it overwhelmingly.

The economic upturn in Mass. is usually dated from the passage of the tax-cut initiative, proposition 2 1/2, rather than being credited to Gov. Dukakis' policies.

When Dukakis took office in 1975, Mass. ranked 22nd in the nation in tax burden.

By the end of his term, only four states had higher tax burdens.

Dukakis boasts that he has cut taxes five times in the last four years.

According to Jack Flood, the Democratic head of the Mass. House Taxation Committee, "All of these tax cuts were proposed by our committee, except the unemployment insurance cuts, which were mandated by surpluses."

Similar experiences told

Houston--James Vanover and Patsy Lee frequently share similar stories about their bouts with cancer of the larynx because they feel so fortunate not to have lost their voices.

Preservation of their normal speech--after having parts of their voiceboxes removed--is the result of conservative surgery combined with radiation therapy performed at The University of Texas M. D. Anderson Cancer Center.

"We are now able to offer voice-saving therapy to almost 70 percent of the patients referred to us. For some patients with early cancers of the larynx, radiation alone can cure them and no surgery is necessary," noted Dr. Helmuth Goepfert, chairman of M. D. Anderson's Department of Head and Neck Surgery.

Both Vanover and Lee admit they were not too surprised to develop cancer since both had smoked cigarettes for many years and were aware of the potential health hazards. Lee described herself as "a moderate to heavy smoker, while Vanover said he smoked "two packs a day for 34 years" and also chewed tobacco.

"Like most people, I took talking for granted all those years, commented Lee, who enjoys greeting customers in the family's furniture upholstery business and occasionally works part-time in a busy Houston restaurant.

Vanover was a heavy construction worker until injured in a cave-in four years ago. Now he is an active church volunteer and coordinates Sunday School classes in Porter, a Houston suburb. "I'm very lucky that my voice was spared," then grinned as he quipped, "but my wife probably would rather I didn't talk quite so much."

Their first symptoms--sore throats, coughs and raspy voices--prompted both patients to seek medical attention, Lee in the spring of 1984 and Vanover in late 1986. Because they were diagnosed with fairly small tumors, each was able to have a partial laryngectomy followed by six weeks of radiation.

"Any patient with a persistent sore throat and lingering voice changes should see a doctor as soon as possible. We know that more than 90 percent of our patients have smoked, so it is imperative that smokers be alert to these first symptoms. When the cancers are small and detected in an early stage, it is theoretically possible to do voicesaving treatments for almost all of them," Dr Goepfert explained. estimated 12,200 Americans annually, tobacco use is linked to causing other oral cavity cancers, including tumors of the pharynx, mouth, tongue, and lip. Dr. Goepfert stressed that an early diagnosis for these types also gives the majority of patients a better chance for conservative treatments.

Vanover, who also had a tumor removed from a lymph node in his neck, said he feels "really good" about the outcome so far and spends a lot of time talking with adolescents and teenagers about the dangers of smoking.

Lee, who like Vanover has four grandchildren, also urges others not to start smoking to to seek help in kicking the habit. "I used to think I couldn't quit, but learning that I had cancer was a teriffic motivator," she said.

Pumpkin boom

It's boom time in the Texas pumpkin patch and although the crop may be small, it offers just what consumers need for carving, fall decorations or eating, said Dr. Roland Roberts, Extension vegetable specialist at Lubbock. The crop, grown mostly in the South Plains area, is producing excellent quality pumpkins with good yields.

Thornless berry

Gardeners can now grow blackberries without the fear of getting jabbed or scratched. Thornless blackberries have become a reality through field studies by the Texas Agricultural Experiment Station and Texas Agricultural Extension Service, reports Dr John Lipe, Extension horticulturist.
