1989 is 200th inaugural

1989 marks the 200th anniversary of the first U. S. presidential inauguration. George Washington, the nation's first president, was inaugurated April 30, 1789, at Federal Hall in New York City, according to historian John Riley of Mount Vernon Ladies' Association.

Statesman, soldier and tobacco farmer, Washington served as commander in chief of the Continental Army and eventually led the American revolutionary troops to

victory in their drive for independence from British rule. After being unanimously elected president of the Constitutional Convention, George Washington was overwhelmingly elected the first president of the newly formed United States of America.

Washington, who was born Feb. 22, 1732, is now honored with a public holiday celebrated each year on the third Monday in February.

Hefty crowd hears Junell

A hefty crowd of over fifty Coke Countians gathered last Thursday night to meet with their 66th district state representative, Robert Junell, at the Courthouse in Robert Lee.

County democratic chairman Patti Ivey opened the meeting, and introduced Junell to the group. Junell began the meeting with a brief update concerning the current legislative session, and the remainder of the meeting was spent answering questions and concerns from the group.

Several of the more important topics which were discussed were education, worker's compensation, state mental health questions, and other proposed legislation during the current session.

Of particular interest to those present was the discussion which centered around the water issue, which is vitally important to West Texans. Junell announced that he had been named to the Natural Resources Committee, which deals with all

water issues throughout the state. Junell also stated that he was the only West Texan on the committee, which made the committee assignment even more critical, due to the fact that the water issue is boiling down to an urban versus a rural issue.

A reception followed the question and answer session.

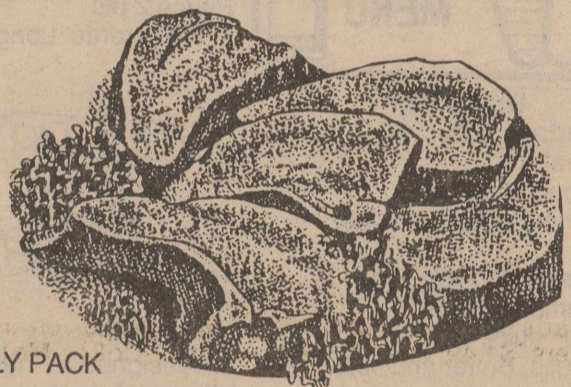

COUNTRY AGENTS NEWS

The last of four shortcourses designed to help farmers and ranchers use their computers for record keeping and accounting will be held in Sweetwater, Feb. 22-24 at the Texas State Technical Institute (TSTI) campus.

The three-day course will be taught by the Texas Agricultural Extension Service with the cooperation of TSTI. It will teach basics of financial statement preparation, double versus single entry accounting, and cash versus accrual financial records.

It will emphasize establishment of a computerized accounting system in a typical farm and ranch situation, processing typical transactions and handling special problems. Part of the program will assist in making computer purchase decisions and evaluating possible accounting software.

Participants will gain hands-on experience with a full featured double entry accounting software package which is commercially available.

Course enrollment will be limited to 15 to insure the opportunity for hand-on computer use and a high staff participant ratio. The \$125.00 fee will cover educational materials, four meals and refreshments.

Persons interested in enrolling should contact their local county extension agent.

December 7, 1961 New Post Office to be Dedicated Today

Out of town and local dignitaries will participate in the formal dedication of Bronte's new post office today. The dedication program will be held at First United Methodist Church, for the most part, beginning at 2 p.m. and will be concluded with a flag raising ceremony at the site of the new building. Bronte Lions Club is sponsoring the program.

Congressman O. C. Fisher will be on hand for a talk, and will also present a new flag to Postmaster Noah Pruitt, Jr. Dale Buckley, district postal official from Fort Worth, will also be among the out of town guests and will make a talk at the dedication. The complete program is listed in an adjacent column on this page.

The Bronte post office building is part of a program under which more than 2,000 new post offices have been or will be constructed. Use of private capital to construct the buildings, and private ownership of them saves large outlays of money by the Federal government and at the same time allows the property to be placed on the local tax rolls.

The program has been underway for several years but was accelerated by an order from President Kennedy to speed up the program. Purpose of the speed-up was to give the nation's economy a boost from the expenditure on the buildings. An estimated \$270,000,000 will be spent before the program is

complete.

Bronte's new post office is of brick and concrete construction. Located at the corner of Washington St. and Oliver Ave., the building occupies a site formerly occupied by South Texas Lumber Co. The building has fluorescent lighting throughout and boasts year-round air conditioning.

Part of the old equipment is being used in the new office, but most of the equipment is new.

The public is invited to attend the program.

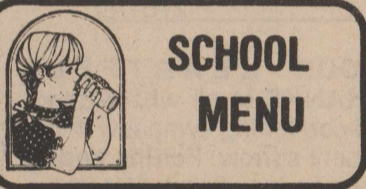

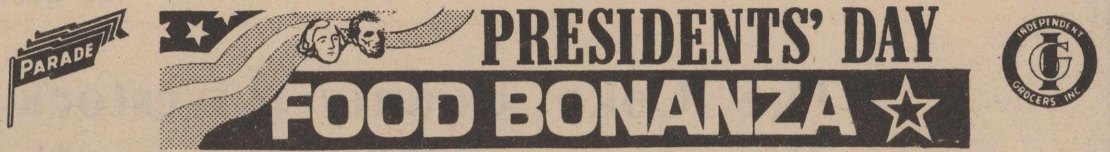
