WCCCD discusses current activities

Thirty seven townfolk turned out Monday for the regular monthly meeting of the West Coke County Community Development.

Several items were reported upon, one being the recent participation in the Great Texas Trash-off. Bill Helwig reported it was a success with

all but a small portion being cleaned. The EMS cleanup was not such a success with outside help of only four persons. The Development promised valid help in future endeavors.

Lucile Bryan reported the plans for a homecoming tea and visitation the afternoon of

July 22, in connection with the Pageant and birthday celebration of Coke County, sponsored by the Coke County Historical Commission. The EMS will sponsor a bar-b-que supper before the show.

A Labor Day extravaganza is in the planning stages. The president urged members to help with plans and forward ideas to D'Ann Eubanks.

Helwig discussed plans by the West Coke Hospital Board to secure a van for the transfer of patients to the doctor and other appointments, alleviating the burden on the EMS. He informed the group of a reception to be held in April for former directors of the West Coke County Hospital District.

A community calendar was suggested by Helwig to be organized each month and made available to the public. This might enable any interested parties to plan for upcoming events.

Phyllis Cole reported that a garage sale is to be held in April as a fund raising project for the upkeep and repair expenses of the scout building. The Scouts, 4-Hers and the S.A.D.D. groups will hold the sale.

Wilson Bryan was the designated speaker of the meeting, presenting facts and figures from the Upcoming City Ordinance on trash pickup service. The service will begin May 1st. He faithfully answered many questions from the group concerning the service.

RESOLUTION

BE IT FURTHER RESOLVED, that The Coke County Historical Commission shall be duly informed of all celebration plans within the county in order to avoid duplications or conflicts, and thereby to create a Master Plan, with information regarding all activities made available upon contacting the Chairman of the Historical Commission.

- News from Oak Creek Lake -

What a difference a week makes when it comes to catching fish. We had two bass clubs in for a tournament the last weekend of March and they found the fishing tough, caught a few good fish but had to work hard for even the small bass. The Blackwell Volunteer Fire Dept. sponsored what we hope will be an annual affair, their first bass tournament here on Oak Creek. As for as the number of bass caught it was second only to the Bronte tournament of 88 and scheduled again the 15th of this month.

There were 64 entered and fished the tournament with 26 catching bass that qualify to weigh. The competition was keen with the final outcome

not determined until the last five minutes. Don Houlihan took first place with a two fish string going 10.59 lbs. Both of these bass were over five pounds but we knew Johnny Houser had at least one big bass yet to come to the scales. As it happened Johnny also had two fish with a total going 9.03 good for second place. He also had the big fish going 7.14 that was worth an additional 320 bucks. Richard

Cooper looked like he would win the big fish award with his seven pounder but not so. As it turned out he finished in sixth place. The other three finishing in the top five and their total string weight, Joel Shipp 8.18, Dennis Calverly

7.92, Delbert Hutchings 7.20. There were two bass going seven pounds or better and ten going over five pounds.

The white bass are moving into the shallow water to spawn and there are some good strings being caught. A lot of these fish are going over two pounds. The catfish are being taken on both rod and reel and trotlines with some of the blues going 18 pounds. There have been some good strings of crappie caught but most believe the best fishing is yet to come.

If you enjoy fishing, Oak Creek is going to be a good place to put a hook in the water these next few weeks.

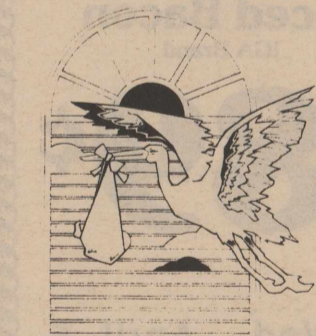

PUBLIC NOTICE

Pursuant to Section 52.151 of the Texas Water Code, the Coke County Underground Water Conservation District gives public notice of the promulgation of Rules and Regulations relevant to the District. A brief resume of the rules are as follows:

- RULE 1-DEFINITION-Provides definition of terms within the rules.
- RULE 2-WASTE-Provides that no person shall commit waste nor shall they pollute or harmfully alter the underground water.
- RULE 3-PERMIT REQUIRED-Provides that a permit is required for wells in excess of 25,000 gallons of water per day.
- RULE 4-DEPOSITS-Provides that each application for a permit to drill a well shall be accompanied by a \$50.00 deposit to be returned when a well log is received by the District.
- RULE 5-ISSUANCE OF PERMITS-Provides for developing an application form for permits.
- RULE 6-REQUIREMENT OF DRILLER'S LOG, CASING AND PUMP DATA-Provides that logs, casing and pump data be delivered to the District within 60 days of completion.
- RULE 7-MINIMUM SPACING OF WELLS-Provides that no well shall be located nearer than 300 feet from the nearest property line, and no more than 16 wells per section.
- RULE 8-EXCEPTION TO SPACING RULE-Provides that the Board may grant an exception to the above spacing regulations.
- RULE 9-PLACE OF DRILLING A WELL-Provides that a well must be drilled within 10 yards of the location specified in the permit.
- RULE 10-REWORKING OR REPLACING A WELL-Provides that no person shall rework, redrill or re-equip a well without first making application to the Board.
- RULE 11-TIME DURING WHICH A PERMIT SHALL REMAIN VALID-Provides that permits shall be valid if the work has been completed within 4 months from the filing date of the application.
- RULE 12-CHANGED CONDITIONS-Provides that decisions made by the Board may be reconsidered upon its own motion or motion showing changed conditions.
- RULE 13-RIGHT TO INSPECT AND TEST WELLS-Provides that any representative of the District shall have the right to enter upon the lands for the purpose of inspecting and testing wells.
- RULE 14-OPEN WELLS TO BE CAPPED-Provides that the owner or operator shall be required to close or cap the well permanently, except when said well is in actual use.
- RULE 15-FINAL ORDERS OF THE BOARD-Provides that orders of the Board in noncontested proceedings shall become final on the day the order is entered by the Board.
- RULE 16-REHEARING-Provides any person whose application is denied, or who is not granted relief, may file a motion for rehearing within 15 days from the Board's decision.
- RULE 17-RULES GOVERNING PROTESTS-Provides that any person who wishes to protest or oppose any pending matter shall make written notice to the Board before the date the matter is set for hearing.
- RULE 18-GENERAL RULES OF PROCEDURE FOR HEARING-Provides that hearing shall be conducted in such a manner as the Board deems suitable, and technical rules of legal and court procedure need not be applied.
- RULE 19-GENERAL RULES-Provides for computing time, time limit, and show cause orders and complaints as covered by this rule.
- RULE 20-WELL VALIDATION-Provides a method of well validation on existing wells when location and wellhead equipment is determined by district personnel.
- RULE 21-TRANSPORTATION OF WATER FROM THE DISTRICT-Establishes a procedure for transportation of water from the district.
- RULE 22-WELL DRILLING, COMPLETION, CAPPING AND PLUGGING-Provides for standards of completion and location of domestic, industrial, injection and irrigation wells, and provides standards for completion and production of undesirable water.
- RULE 23-REPORTING UNDESIRABLE WATER-Requires reporting undesirable water encountered while drilling or deepening of wells.
- RULE 24-DISPOSAL AND STORAGE OF WASTES-Requires a permit for disposal and storage of wastes and provides for exceptions.

Complete copies of the proposed Rules and Regulations can be obtained and inspected at the Coke County Underground Water Conservation District office in Robert Lee, Texas. The above listed Rules & Regulations were reviewed and discussed at a Public Hearing held on March 27, 1989, after which the Board of Directors adopted same for the district. The rules will go into effect April 14, 1989.

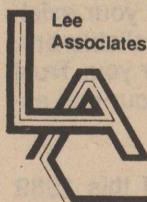

MINED THE NECESSITY OF ADOPTING NEW RULES FOR THE ROBERT LEE SANITARY LANDFILL:

Now, therefore, be it ordained by the City Council of the City of Robert Lee that:

SECTION 1: The landfill shall be opened the days and hours designated by the city as follows:

OPEN: THURSDAY 9 A.M. TO 5 P.M.

SATURDAY 9 A.M. TO 5 P.M.

SECTION 2: The following charges shall be in force for dumping at the landfill:

There shall be a \$5.00 minimum charge for (1) cubic yard or less. In excess of one (1) cubic yard the charge shall be \$3.00 per cubic yard thereafter.

Any home owner with a current water and/or sewer bill on which he is being charged for refuse collection who wants to dump grass, leaves, tree trimmings, and other household trash may do so at no charge.

SECTION 3: The city shall employ an attendant to be on duty when the landfill is open.

SECTION 4: No containers with burned trash will be accepted.

SECTION 5: No loads from outside of Coke County will be accepted.

SECTION 6: There shall be no hazardous waste accepted.

SECTION 7: The city shall reserve the right to refuse the dumping of anything considered undesirable by the city.

SECTION 8: This ordinance shall go into effect on the 1st day of May, 1989, and shall be subject to change as determined by the City Council.

SECTION 9: All ordinances and resolutions and parts thereof heretofore adopted and in conflict herewith are hereby expressly repealed insofar as they conflict herewith.

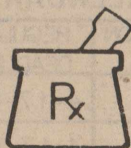

has determined that the alternatives available are best handled by self-service through city-authorized collection service;

THEREFORE, BE IT ORDAINED AS FOLLOWS;

The City of Robert Lee shall furnish garbage and trash collection service pursuant to the understated rules, regulations, and stipulations as specified in this ordinance and as may be amended, to wit:

A. DEFINITIONS: The following terms shall be defined for the purpose of this ordinance as follows, to-wit:

1. Garbage - All animal matter, vegetable matter, waste materials from kitchens, refuse from kitchens, residential waste material, grocery store waste material, restaurants, cafes, hotels, and such other waste and/or discarded material as may be discarded from residential and/or commercial locations in and about the City of Robert Lee.

2. Trash - Rubbish, including but not limited to, yard cleanings, grass clippings, leaves, tree trimmings, tin cans, paper boxes, grass, shrubbery, and other such discarded residential and/or commercial material as may be discarded by residential occupants and commercial businesses in the City of Robert Lee.

B. CONTAINERS REQUIRED

1. Each and every owner, occupant, tenant, and/or lessee using or occupying any building, house, or structure within the City for residential usage, church utilization, schools, lodges, commercial establishments, businesses, and/or other purposes not receiving sanitation container system service as described herein, shall provide and maintain garbage cans and receptacles of sufficient number and size to hold garbage and trash and not allow accumulation on the premises. The capacity of each container shall not be less than 10 nor more than 32 gallons and shall be constructed of substantial materials, with tight-fitting lids and/or cover equipped with handles sufficiently strong for city personnel to empty such cans into containers and/or trucks during pickup times. Garbage cans and/or receptacles which have been worn and/or damaged to the extent that there is leakage or unfit for intended purposes or the existence of sharp edges capable of inflicting injury to city employees will be picked up by the employees of the City Sanitation Department and destroyed after reasonable notice, by certified mail, return receipt requested, as to the existence of such sub-standard garbage can and the request for replacement thereof.

2. Disposable bags may be used in lieu of garbage cans but said bags shall be constructed of substantial plastic and/or polyethylene or equivalent material, having the same characteristics. Said bags shall be leak-proof, waterproof, and sanitary and shall be of sufficient strength so as not to break or tear during normal use by the Sanita-

tion department in the collection and disposition of the same. Wherever disposable bags are used in lieu of containers, they shall be sealed before being placed in collection locations. It shall be unlawful for any person to use a disposable bag when the same is torn or unsealed.

3. An exception to the above provisions requiring cans and containers may exist as to commercial and public institutions when not required to use sanitation container systems described herein. If such an exception shall exist, the written application of the commercial or public institution shall be filed with the City Secretary for consideration by the City Council as to an exception to the requirement of containers or bags through the disposal of garbage and/or trash by the commercial or public institution as to onsite methods, including but not limited to, incineration units. Upon receipt of said application, the City Council, through committee duly appointed, shall cause an investigation of the premises and the trash and garbage disposal systems to determine if the proposed garbage and trash storage facilities and disposal facilities are sanitary, unoffensive, and will not create a nuisance and will substantially comply with state, federal, and city health requirements and it may be in the best interest of the City as to economical considerations in allowing exceptions to be made to the provisions of this section so long as statutory and regulatory compliance exists. If exceptions shall be approved, such written exceptions shall be provided to the commercial or public institution which said exception may be revoked at any time subject to 15 days written notice of revocation of exception due to the storage facility for trash and garbage and/or disposal of the same being unsanitary, offensive, or nuisance. In the event of cancellation of the exception, the establishment shall be required to provide containers and/or bags as required herein.

C. CEILING - COVERING OF CONTAINERS

All lids and/or covers of containers and/or garbage cans as described herein shall be kept secure and fastened so that flies, insects, dogs, cats, raccoons, skunks, opossums, and/or other animals shall not have access to the contents of the containers and that the lids shall be sealed thereon until such time as City shall make "rounds" in collection of the same for emptying and removal of the trash.

D. DESIGNATED PICKUP POINT FOR CONTAINERS AND/OR TREE LIMBS FOR REMOVAL

As to all houses, buildings, and premises from which garbage is to be collected and removed which are adjacent and adjoining to an alley, the owner, occupant, tenant, and/or lessee of the premises, shall be required to keep the garbage cans/containers at the entrance from the alley

in order that it may be easily accessible to the City in its collection and removal of garbage. In the event it is not practical to collect or remove garbage from an alley as to those locations and/or sites where said alley is not fully "developed", "opened", or other obstruction may exist, the owner, occupant, tenant, or lessee of the premises shall place cans and/or sealed bags at points designated by authorized agent of the City, said point being accessible as to the City Agent.

The designation of the location of garbage cans and/or other disposable materials as designated herein shall be at the sole and complete discretion of the City in regard to the most accessible point for collection and removal of the same. The decision of the city in regard to the location of the designated point shall be final.

In the event trash and/or garbage is of the nature that it cannot be placed in the receptacle, including but not limited to, tree limbs and/or hedge cuttings, such materials shall be tied in bundles of less than 50 pounds and less than 4 feet in length to facilitate removal and collection by the City of Robert Lee.

E. WET GARBAGE

All garbage and/or trash that is mixed with water and/or other liquids shall be drained before being deposited in the container or receptacle.

F. AUTHORIZED PERSONS TO COLLECT AND HAUL GARBAGE AND TRASH

The City of Robert Lee, by and through its duly authorized agents, licensees, permittees, franchisees, and employees shall be the only authorized person to empty garbage cans and/or trash receptacles and convey, haul, and transport the same through the streets, alleys, and public roads of the City of Robert Lee. The collection charges for garbage and/or trash service shall be made to all residents using water and/or city sewer within the City of Robert Lee, regardless of whether or not the residents have garbage cans and/or bags of trash and/or garbage for collection. The fee for garbage hauling shall be considered a part of the city services, unitized as to the water and septic service.

G. COLLECTION CHARGES:

No rate adjustment will be made for temporary non-use of the service unless the water meter is disconnected and/or the sewer service discontinued and at such time, said charge shall be prorated as to the date of the month of water and/or sewer service disconnection.

Failure to pay the garbage collection fees shall be sufficient grounds for the discontinuance of city water and/or sewer services.

The following monthly rates and charges shall be, to wit:

(a) Premises used for private residences, single or double unit apartment houses, single mobile home sites and/or locations, shall be charged \$7.50 per month per family unit as to occupied residences, apartments, and units, with one collection per week, limited to 3 containers,

32 gallon each.

(b) Premises used for commercial, business, and/or public purposes not receiving sanitation container service as described herein shall be charged \$7.50 per month for 1 collection per week, limited to 3 containers, 32 gallon each.

(c) Premises used for commercial, business, or public purposes not receiving sanitation and commercial services and requesting collection services greater than the average collection shall be charged \$15.00 per month, with two collections per week, with a limit of 3 containers, 32 gallon each.

H. WHOM TO BE BILLED

All persons, businesses, commercial institutions, and/or public agencies inside the city limits who are served by city water and/or city sewer service are required to pay garbage collection fees.

I. CONTAINERIZED SANITATION SYSTEM

1. After the effective date of this ordinance, certain public, private, business and/or commercial locations and sites, including certain private residences shall be designated by the authorized agent of the City of Robert Lee to receive sanitation container system service for the removal of garbage and trash container system service for the removal of garbage and trash under the rates and rules hereinafter set forth. Pursuant to the sanitation container system services, the City will furnish collection and/or removal of garbage and trash. The following charges for two collections per week shall be effective:

3 Cubic Yards \$22.00 per month

4 Cubic Yards \$29.00 per month

2. It shall be unlawful to make a fire or burn any material in the sanitation container furnished by the City or to paint or mark on the same or to place any poster, placard or sign upon the same.

3. Whenever it has been determined as set forth above that any owner or occupier of premises will receive sanitation container system service for the removal of garbage or trash, it shall be unlawful for such owner or occupier to al-

low any accumulation of garbage or trash around said container or in the vicinity of said container and it shall be required to place all garbage or trash in said container. The use of any other system of garbage container for collection by the Sanitation Department when said container service is provided shall be unlawful.

J. METHOD OF BILLING

The City shall, through its garbage and water and/or sewer departments, include the fees for the service herein provided on monthly bills to such persons receiving water and/or sewer from the City. In the event any person is not receiving water and/or sewer services, the charges for garbage services shall be directed to the person receiving the garbage service.

K. PROHIBITION AGAINST BURNING OF TRASH, LEAVES, AND/OR GARBAGE

It shall be specifically banned and prohibited from the effective date of this enforcement, all open air burning of trash, leaves, grass, shrub clippings, and/or other garbage.

L. SEVERENCE OF PROVISIONS

In the event any provision of this ordinance shall be deemed invalid, all remaining provisions of the ordinance shall remain in full force and effect.

M. CRIMINAL PENALTIES

The ordinance shall be enforceable, as to the specific prohibition stated herein by criminal penalties prosecuted through the Municipal Court of Robert Lee. All such violations of this ordinance as to its specific terms, shall render the defendant, as filed upon by the City Attorney, liable for fines, not to exceed Two Hundred Dollars (\$200.00).

N. EFFECTIVE DATE

This ordinance shall be effective on the 1st day of May, 1989.
