Rickey Dill, Enforcement Officer from the Odessa field office, will be at the Coke County Courthouse Conference Room, from 1 pm to 2 pm. The doors will be open to the public and there will be no charge.

"I'm sending my employees out to help people with ques-

tions, filling out forms, and working out problems on a local, one-to-one basis. There's some things you just can't do as well over the phone or through the mail," Bullock said.

Bike-a-thon set April 22

Bike-a-thon chairman, Jody Johnson, today asked Bronte residents to join the St. Jude Children's Research Hospital "Wheels for Life" Bike-a-thon slated for Saturday, April 22.

Mrs. Johnson said this ride honors Jaime, a leukemia patient at St. Jude.

"With every turn of the wheel, riders become 'spokes'-men for all the kids with cancer, like Jaime, who want to know they aren't in this battle alone." "People willing to give time to create more time to children crying for help stimulates a better event and raises more money for the hospital. Riders are really needed. They make or break a Bike-a-thon," said Mrs. Johnson.

Sponsors donating a sum for each mile completed are enlisted by riders. Those who raise \$25 receive a St. Jude t-shirt. When \$75 is raised, the rider receives a barrel tote bag and t-shirt. Sponsor forms may be picked up at the Bronte Elementary School from Mrs. Johnson.

Riders for the Bike-a-thon are asking Bronte citizens to pledge a contribution for each mile they ride.

"Every mile our bikers go earns money bringing us closer to a cure for cancer," said Mrs. Johnson. "Let's show that we care. Please help this cause. Your generous pledges encourage the riders, and after the event, please help the riders collect the money quickly," asked Mrs. Johnson.

The ride will start at 9 am. Riders and volunteer helpers will meet in the parking lot at the football field. "Each rider will get a lap card at registration," Mrs. Johnson explained. "Every time riders pass the checkpoints, we will initial the card. At the end of the ride, we will check and

sign it to show that the rider earned what the sponsor pledged."

Riders will return to their sponsors after they have ridden in the Bike-a-thon.

Those who wish to participate as riders may see Mrs. Johnson at school.

Johnson to chair "Wheels for Life"

St. Jude Hospital's dramatic progress has been made possible primarily by voluntary contributions raised through events such as the "Wheels for Life" bike rides organized by concerned citizens all over America.

wonderful prizes donated by merchants and individuals from Robert Lee, San Angelo and other areas. To all these folks, we extend our heartfelt thanks.

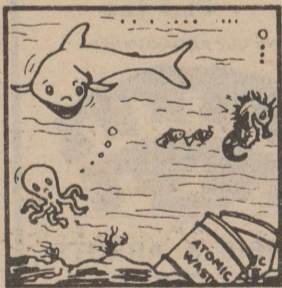

The Way I See It
by Johnny Sevier

Congratulations Robert Lee. We have now joined the ranks of the elite cities, i. e., Odessa, San Angelo, Abilene etc. We have now entered the era of Big City ordinances, Big City regulations, Big City enforcement and of course, big city Taxes. If you think that the cost of this first ordinance is not a tax just remember that just as the saying "A rose by any other name is still a rose" so does it apply as well to taxes.

Now, in the interest of fairness, it should be said that taxes are necessary in order to have the services that we expect or want from government, be it city, State or Federal. If we want these things then we must expect to pay for them, but we do not always have the privilege of paying for what we want or need, but for what some-one else perceives that we want or need, like it or not. Such is the case now it would seem since a very large majority of the people that I have talked to have expressed their opposition to the afore-mentioned city ordinance. Most have taken exception to the cost first, the implementation procedure, second, and that they had nothing to say about it.

As far as having had the opportunity to have input, I should point out that the dates and times of city council meetings are posted in the lobby of the city building and anybody could have attended. The subject matter was not put in the paper and of course the council has no le-

gal obligation to do so, moral maybe, but legal no. So if you didn't know it, it's your own fault for not going to city hall finding out what was going on. (The preceding statement is not my sentiment and was told to me by other people).

As for implementing the ordinance on such short notice I can only surmise that it was meant to minimize any opposition and have it in operation before anyone really knew what happened, which by the time this makes print the mechanics to enforce will have been put in place, that is to issue citations, levy and collect fines for any non-compliances of said ordinances.

The cost of course is of concern to everybody and so to give you an idea of where we stand as compared to other cities, the following is a comparison to other towns. This information was gathered and given to me by another party also interested in seeing that you, the people of Robert Lee, have information on which to base your opinion.

Robert Lee \$7.50 + tax for 1 collection per week, resident furnish & maintain their containers;

Ballinger \$6.47 inc. tax for 2 collections per week, dumpsters furnished;

Big Lake \$7.00 + tax for 3 collections per week, dumpsters furnished;

El Dorado \$7.50 for 3 collections per week, dumpsters furnished;

Mertzon - closed land fill;

San Angelo \$6.40 + tax for 2 collections per week, dumpsters furnished;

Sonora has no collection - operates community dump;

Sterling City has no collection - operates community dump;

Abilene \$5.78 inc. tax for 2 - 3 collections per week, dumpsters furnished; and

Odessa \$7.50 + tax for 2 to 3 collections per week, dumpsters furnished.

As you can see we rate right up there with the best, we undoubtedly are as well or better off than the best.

The one other question asked the most is this, do we have any options and the answer is, not many. If you don't like what you are getting I would suggest that you spend \$.25 and write a letter to the city council expressing your opinions and let them know how you feel and see if you get any results. The only other option is to get an injunction filed in district court to prevent the implementation for a period of time in order to more closely examine the ordinance.

Now, regardless of what happens there is a lesson to be learned, we better pay a lot closer attention to what is being planned for the town of Robert Lee because if you think that this is the only city ordinance you are going to have, you may be in for another surprise. There could very well be others you will like even less.

....and that's the way I see it.

Vandals Hit Old Cemetery at Ft. Chadbourne

The old Fort Chadbourne Cemetery, located adjacent to Highway 277 in the northeastern part of the county was vandalized and desecrated last week. More than 50 tombstones and other markers were turned over and some were broken into pieces. Officers working on the case theorized that it happened last week on Wednesday or Thursday night.

A reward of \$1,000 for information leading to the arrest and conviction of the guilty party or parties has been offered by Ed Richards of the Wylie Ranch, on which the cemetery is located. Mr. and Mrs. Richards have done much work on the historic old cemetery in recent years.

The Fort Chadbourne Cemetery was one of three cemeteries in that vicinity before 1877. This one is still in use and contains recent graves as well as those of citizens of the area who were buried there as early as 1878. It holds the grave of the first officer to be buried at Fort Chadbourne.

The Enterprise has heard reports that there may be others who have relatives buried at Fort Chadbourne, who will

offer additional reward money for the arrest and conviction of the vandals.

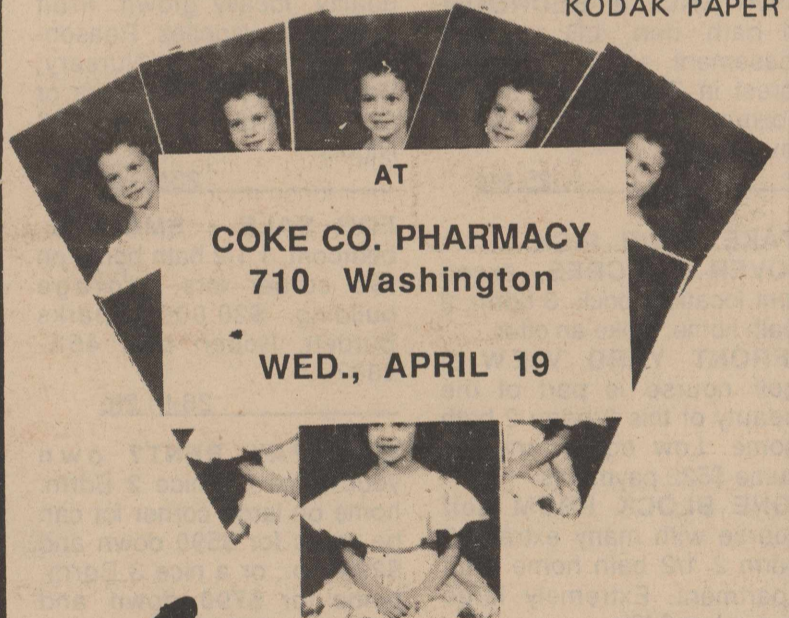
