## Robert Lee Homecoming activities slated

Theme for Homecoming '89 at Robert Lee High School, to be observed Friday, Oct. 13, is "The Steer Express - Get On Board or Get Out of the Way".

The bonfire will be held on Thursday night immediately following the Robert Lee Dogie and Grape Creek Jr. High football game to be played at home, beginning at 6 p.m.

Friday's activities begin with the annual parade at 2:30 downtown and proceeding to the school. Prizes will be awarded to the chosen best 3 floats - \$25, \$15, and \$10. For entry in the parade or float information, call the high school principal's office at 453-2333.

The Pep Rally will follow the parade finish, at the high school gym. Festivities will resume at the 8 p.m. football game between the Steers and Abilene Christian High School. Recognized at half-

time will be high school royalty including the 1989-90 Homecoming Queen and King.

Homecoming Queen candidates are Becky Padgett, Theopa Rodriguez, and Shannon Skipworth. Nominations for Homecoming King include Rickie Wheat, Warren Brasher, and Jason Wink. The honors remain a secret until the crowning. They will be

crowned by the '88 Queen and King, Kim Hood and Joel Herring. Miss and Mr. RLHS, Tiffany Jameson and Jon Rogers will also be presented during the half-time show.

Final event of the day will be a dance in the Coke County show barn immediately following the football game. Music will be provided by RED-LINE.

## Bronte awarded grant

The city of Bronte has been awarded a \$169,000 Emergency Need Grant by the Texas Department of Commerce for water systems improvements. The grant money is to be matched with \$20,000 from the city of Bronte to rebuild the city's raw water intake barge.

On March 4th a high wind storm caused the already structurally unstable intake

barge to collapse on one side, partially submerging the barge and rendering it unusable. The city has since operated a single low valve submersible pump at the place of the intake as a temporary solution.

This grant will allow the city to rebuild the intake barge and bring it back into compliance with Texas Department of Health standards.

## Fire Prevention Week, October 8-14

Noting the tragic loss of lives and property from fire in Texas, State Fire Marshal Ernest A. Emerson today urged Texans to help reduce the number and severity of fires by learning effective methods of fire prevention and safety during Fire Prevention Week, October 8-14, 1989.

"Fire continues to be a major threat to all our citizens, particularly the young and the old," Emerson said.

Fire departments in Texas responded in 1988 to more than 102,849 fires which killed 299 people, injured more than 2,400 and destroyed in excess of \$340 million in property, according to data from the Texas Fire Incident Reporting System (TEXFIRS), operated by the State Board of Insurance, State Fire Marshal's Office. Three hundred and eight fire departments, protecting 74 percent of the state population reported fires to TEXFIRS in 1988.

"Much of this tragic loss could have been prevented," the fire marshal said. "We have the knowledge and technology today to prevent much of the needless loss of lives and property in this state and we urge every Texas citizen to practice fire prevention every day in an effort to conserve our valuable Texas resources."

This year marks the 67th anniversary of National Fire Prevention Week. The week-long observance was first established in 1922 by President Warren Harding in memory of the so-called "Great Chicago Fire" of October 9, 1871.

That conflagration killed 250 people and destroyed 17,430 buildings at a cost of \$168 million. People began thinking in terms of fire prevention in addition to fire fighting as a result of this fire.

## AWAKENING set for SA

Forty-five hundred United Methodists from Southwest Texas will gather at the Municipal Auditorium in San Antonio, Texas on Saturday, October 28, for AWAKENING '89, a day long celebration of faith.

## Longhorns bring back win from Roby

The Longhorns traveled to Roby this week and came away with the victory after losing four fumbles and three interceptions. Captains this week were Brandon Marshall, Curtis Moore, and Sean Conway.

The Horns kicked off to Roby to begin the first quarter. Roby started on their own 33 yard line and moved the ball to the Horns 3 yard line before the Longhorns defense held them on fourth down. The Horns moved the ball out to the 33 yard line before they had to punt. Punter Darrell Lucas booted the ball to Roby's 42 yard line without a return to end the quarter.

In the second quarter with 9:42 on the clock, the Longhorn defense held Roby on a fourth down on the Bronte 43 yard line to gain

possession. After four plays, quarterback Justin Phillips suffered his first interception. The next play Roby fumbled the ball and James Badgett recovered it. Two plays later running back Tim Davis fumbled the ball back to Roby on the Roby 38 yard line. The Horns again for the third time in the half held Roby on fourth down after they missed a 13 yard field goal try with 3:26 left in the half. With 0:59 left in the half Bronte suffered a great loss when Tim Sims suffered a broken leg.

The second half did not start good for the Horns when they fumbled on the first play on their 46 yard line. Five plays later Lucas recovered a fumble on the Horns' 33 yard line. The teams exchanged punts twice. Bill Windham then returned a Roby punt 26 yards to the Roby 20 yard line. With 0:02 left in the third quarter, the Horns had first and goal on the two yard line

before they lost a fumble. In the fourth quarter, Marshall recovered a fumble on the Bronte 34 yard line with 8:51 remaining. The Horns moved the ball quickly to the Roby 25 yard line, before being stopped on a fourth down attempt. The Horns held Roby to four downs and Tim Davis returned the punt 20 yards to the Roby 34 yard line. On the next play Davis scored the only touchdown of the game with 5:46 remaining. Davis also ran for the 2 point conversion. Bronte led 8-0. The Horns defense held off Roby when Gary Blair recovered a fumble on the 50 yard line. Bronte ran the clock out.

Tim Davis had his third century game with 123 yards on 18 carries. Defensive standouts were Conway, Windham, Casares and Jason Pierce.

The Bronte Jr. High Volleyball team continued their winning way by defeating Water Valley, Monday night.

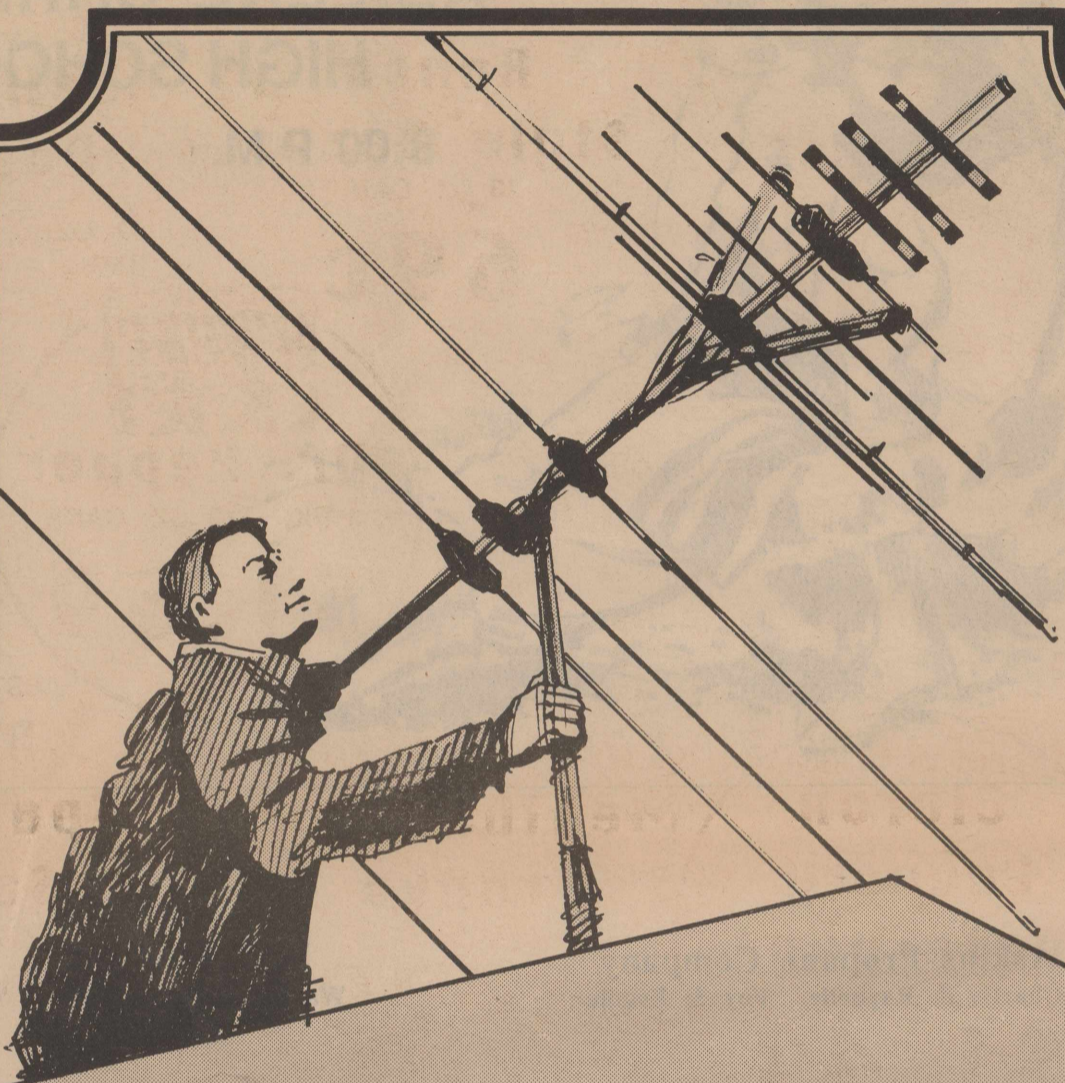
The first match saw Bronte come out on the court cold and were defeated 15-6.

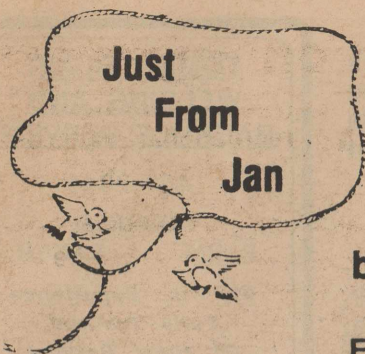

This study investigated heart disease at 15 sites. Dr. Fred Mattson examined high-fat diets consumed by residents of Crete where heart disease is rare.

Mattson found the islanders consumed much fat from olive oil, which is high in monounsaturated fatty acids. Mattson also examined effects of saturated, monounsaturated and polyunsaturated fatty acids in other studies.

Although more studies are in progress, Mattson's evidence indicates that diets low in saturated fatty acids and

high in monounsaturated may help prevent heart disease.

Mattson also said that replacing saturated fatty acids with the monounsaturated fatty acids effectively lowers overall cholesterol in the blood and decreases the LDL while not decreasing the high-density lipoproteins (HDL), the "good" cholesterol.

Consumers looking for monounsaturated fatty acids now have additional choices. Until recently, olive oil was the only readily available fat high in monounsaturated and low in saturated fatty acids. New va-

rieties are beginning to appear on store shelves such as high oleic sunflower and safflower-see oils and canola oil.

Although olive oil has a distinctive color and aroma, the culinary properties, appearance and taste of the other monounsaturated fatty acid oils are identical to oils presently used in the United States.

An additional advantage is the new oils' resistance to spoilage, a common problem of the polyunsaturated fatty acids oils now used by many health conscious consumers.

## Hunter Directory now available

The 1989 edition of the Texas Hunter's Clearinghouse Directory is available. It lists nearly 1,000 available leases covering a total of 5.3 million acres in virtually every region of the state. The Texas Hunter's Clearinghouse is a joint project of TDA and the Texas Parks and Wildlife Department.

"Many of the listings in this year's edition are new, and a considerable number of them have never been hunted on a lease basis before," said Deputy Commissioner Mike Moeller.

Directory listings cover all types of game, from spring turkey to whitetail deer and exotic game species. Each listing provides hunters information such as the distance to the nearest airports and hotels and services and amenities provided such as bunkhouses and guide services on leases.

"We started this program three years ago to help farmers and ranchers earn some badly needed additional income from their land," Moeller said. "Last year farmers and ranchers who leased their land through the clearinghouse program added an average of \$2,200 to their incomes."

Farmers and ranchers with land available to lease may apply to TDA for a free listing in the directory and in the series of directory supplements that are published during the year.

## Windbreak trees for sale

One aspect of West Texas weather that can always be counted on is the wind. Although it provides such benefits as cooling breezes and power for windmills, it can also cause a variety of problems for Coke County residents. Wind erosion strips bare fields of valuable topsoil and deposits it where it is neither needed nor wanted, such as fencelines or Mama's dining room table. Cold winter winds raise utility bills and are dangerous to unprotected livestock.

Windbreaks help reduce many of the problems associated with the wind. Field windbreaks significantly reduce soil erosion. Windbreaks around a homesite help reduce dust and protect the home from cold winds. Likewise, properly placed windbreaks protect livestock in confinement or in open pastures.

In an effort to assist landowners in this area, the Coke County Soil and Water District, in cooperation with the Texas Forest Service, are providing tree and shrub species for conservation planting. First-year seedlings of evergreens (6 - 12 in.) and barerood hardwoods (10 - 18 in.) are available at a reasonable rate.

### Evergreens

Evergreens are sold in multiples of 15 only. No order for less than 15 can be accepted. The following species come in a 28 cu. in. felt container and sell for \$20.00 per 15. Afghan pine, Arizona cypress, Ponderosa pine, Austrian pine and Redcedar.

In addition, smaller Afghan pine and Arizona cypress seedlings are available in a 10 cu. in. "bullet" and sell for \$12.50 per 15.

### Hardwoods

Hardwoods are sold in multiples of 25 only, sell for \$15.00 per 25, and are available in the following species. Bur oak, Green ash, Pecan, Catalpa, Honeylocust, Red oak, Cottonwood cuttings, Little walnut, Russian olive, Desert willow, Osage orange, and Sandcherry.

All prices include sales tax. Payment in advance is due at time of ordering. Statewide interest in the program is up and the quantity of available species is down this year. Interested parties should place their orders as soon as possible.

Orders can be placed at the Coke County SWCD/Soil Conservation Service office at 11 East Sixth Street. The seedlings are scheduled to be delivered to the office on February 14, 1990. To help insure successful establishment, they should be collected and planted as soon as possible after delivery.

The district is also investigating a program to provide drip irrigation supplies at a reasonable price. Drip irrigation greatly increases the seedlings' chance of survival, particularly in the first two years. Drip is a highly efficient way to water and has many applications in areas with low availability of high water cost. More information will be provided as arrangements are made.

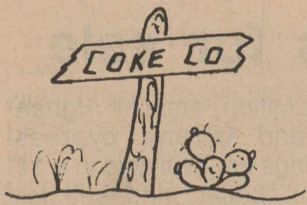

**Create Instant Landscape with Container Plants**

Container plants continue to gain popularity because of their versatility, portability and limited space needs.

Colorful flowering plants, as well as vegetable and fruit producing plants, can be grown in containers.

Container plants have been used for landscape enrichment throughout history. They can be highlighted in a prominent spot when at their peak and hidden from view when not needed or when in less than attractive condition.

In addition, a wide variety of plant species have different cultural requirements and may be grown on the same premises since individual soil, watering, pH, fertility, light and other environmental requirements can be provided for each container.

Almost any plant can be used as a container specimen as long as its cultural requirements are met.

Placing a plant in a container tends to dramatize it and make it more important visually. Deciduous or evergreen trees, shrubs and vines, annual and perennial flowers may be used.

The key is to determine where the plant will usually be located and the availability of sunlight, moisture and protection. Annual flowers usually prefer at least a half day's full sun, but most tropical and evergreens do well with less.

Design of the overall area should be considered. When selecting from the wide variety of containers on the market today, choose those of simple design that do not compete with the plant but tend to feature it. For instance, plants in plain terra cotta clay pots often are featured on beautifully designed terraces, patios and entrances. Fortunately, some of the most appropriate containers such as clay products are often moderately priced.

Care of the plant is quite important. Container plants usually require more care than those grown in the ground. Frequent watering, often on a daily basis, is necessary for most species, especially during hot weather. Arrangements should be made for their care during vacations, or they can be partially sunk into the ground in a shady, moist area.

Once the plant is well established, add small amounts of complete fertilizer, periodically.
