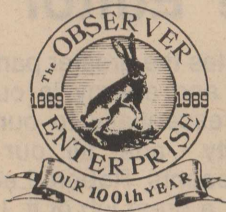

Stover Taylor will be available at the courthouse to sign-up or recertify you in the afternoon of December 4th, 6th, and 8th. The Emergency Food Assistance Program was established by federal legislation. Through this program, the Texas Department of Human Resources contracts to provide needy people with commodities donated by the United States Department of Agriculture. If applications are welcome regardless of race, color or creed.

Kendrick

Greer (Judge) Kendrick, 72, of San Angelo died at his home November 19, following a lengthy battle with cancer.

Service was conducted at 2 pm Tuesday in the Robert Massie Riverside Chapel with Bryan Briley, a Church of Christ minister, officiating. Burial followed in Lawnhaven Memorial Gardens.

Mr. Kendrick (Judge, as most people knew him) was born in Dover, Arkansas, on July 6, 1917. He moved with his family to Eola, Concho County, Texas, in 1937, where he was a farmer and trucker until he retired because of bad health in 1980.

He served as staff sergeant in the Asiatic-Pacific campaign during World War II. His decorations and citations were a Campaign Medal with one Bronze Star, Good Conduct Medal, Victory Ribbon, one service stripe, six overseas service bars and a lapel button.

He married Lois Broadstreet February 25, 1957, and moved to San Angelo still as a self-employed farmer and trucker. He was a member of the Northside Church of Christ and the Disabled American Veterans.

He is survived by his wife, Lois; three daughters, Jan Kendrick of Dallas, Mrs. Charles (Shirley) Meredith of Oklahoma City and Mrs. Wayne (Judy) Davis of San Angelo; one son, Ron Story and his wife, Judy, of Elko, Nevada; seven grandchildren; six great-granddaughters; two sisters, Verina Morrison of San Angelo and Vonna Kendrick of Anson; one brother, Clell Kendrick of Anson; and many nieces and dear friends.

Survivors include a sister-in-law, Mrs. Mildred Wallace of Robert Lee.

Wilton Glenn Robertson, 55, of Lindsay, Oklahoma died Tuesday, November 14, in an Oklahoma City hospital after suffering an aneurysm several days earlier.

Memorial services were held on Thursday, November 16, in Lindsay. Funeral services were conducted in Robert Lee at 2 pm November 18 in the Robert Lee Baptist Church with burial following in the Robert Lee Cemetery directed by Shaffer Funeral Home. The Rev. Ray Aldridge

and the Rev. Roy Epperson officiated the rites. Nephews were pallbearers.

Mr. Robertson was born October 10, 1934 in Robert Lee to James Brantley and Bonita Brown Robertson. He was a Robert Lee High School graduate and was married to LaRue Walker October 5, 1953 in Robert Lee. The couple made their home in the Odessa area for nearly 20 years. He was employed by Oxy, formerly Cities Service, for 34 years, much of that time as operations manager. The couple was transferred to Lindsay, Oklahoma 15 years ago.

He was a member of the Goldsmith Masonic Lodge, a 32nd Degree Mason, and a member of Scottish Rites.

Survivors include his wife, LaRue, of Lindsay, Oklahoma; one son, Wilton G. Robertson, Jr. and his wife, Carolyn, of Garland; two daughters, Claudia Williams and her husband, Bob, of Odessa and Kim Robertson of Oklahoma City; four brothers, Donny Robertson and J.B. Robertson, both of Robert Lee, Clifford D. Robertson of Lindsay and Jesse Robertson of Rockport; six sisters, Billye Talley of Cleburne, Bonita Hester of Portland, Lonell Tomes of Amherst, Elaine Bennett of Arlington, Gertrude Bloodworth of Silver and Annie B. Mitchell of Robert Lee; and three grandchildren, Brandy Michele Williams of Odessa, Ginger LeAnn Robertson, and Alisha Noel Robertson, both of Garland.

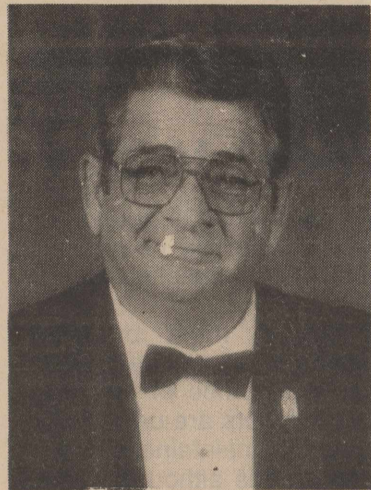

BRONTE SCHOOL NEWS

Fire is useful range management tool

Fire can be used as a tool on rangelands as efficiently today as our forefathers 100-150 years ago and the Indians before them used it. Whereas the use of fire to accomplish certain objectives is not new, there is a re-newed interest in the use of it as a tool.

Numerous objectives can be met by using prescribed burns depending on the needs of the rancher. Some of the things which burning will help accomplish include cleaning up pastures so that livestock can be more readily seen and worked, and increased production and utilization of courser grasses. Fire will also help remove chained or dozed wood material and help to control regrowth of certain species. Fire, followed by herbicide,

has been used quite frequently the last few years to assist with prickly pear control; the burning reduces the amount of chemical required to get good control of pear.

Smokey the Bear has given fire a bad name over the last couple of decades. If we understand that fire is an important component of range development and that wild fires played a role in the way that our rangelands did develop, then we get a proper perspective on the use of fire.

The Soil Conservation Service, the Texas Agricultural Extension Service and the Texas Parks and Wildlife Department all have personnel trained in prescribed burn plan development and in assistance to ranchers who are considering burns on their grasslands.

Although fire can be beneficial, unless carefully planned and conducted, they can be extremely detrimental or even hazardous to people and livestock. Pre-burn plans must include enough rest in pastures to insure that a fine fuel load of grass is grown to insure good success of the

burn. About 2,000 pounds of grass is generally needed for a burn to accomplish objectives.

Firelines must be cut around the area to be burned prior to the time of the fire. Most ranchers are using road graders or maintainers to accomplish this although some are using disc plows to do the same thing. The critical point is that the fire line must be free of vegetation to insure that the fire does not escape.

The weather conditions for conducting the burn are critical and must be adhered to in order for the burn to be safe. Generally the prescription for most range fires is a temperature of 40 to 70 degrees F, a relative humidity of 35-60%, and a wind speed of 5-12 miles per hour. Use of this prescription minimizes the risk of the fire escaping or burning areas which were not supposed to be burned.

There are certain conditions under which a prescribed burn should never be conducted. These are called "red flag conditions" and fires should never be started when one or more of these conditions exist. The "red flag conditions" include wind gusts greater than 20 miles per hour, relative humidity below 20%, air temperature above 80 degrees F, and cold front to pass through within 12 hours.

If you are planning a burn or if you think that a prescribed fire might help you to accomplish certain objectives, contact the Soil Conservation Service, Extension Service or certain Parks and Wildlife Biologists to assist you with planning and conducting the burn.

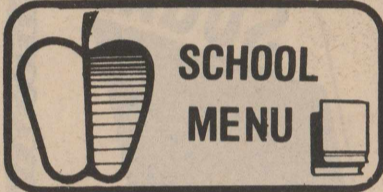

If you do not receive a new voter registration certificate by December 15, 1989, or if you have any questions about your card or registration, please contact the County Tax Office at 453-2614.

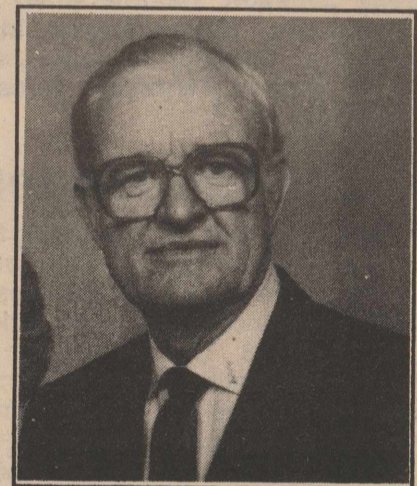

SAFE TURKEY DINNER

A whole, golden-brown roasted turkey is the crowning glory of many a holiday meal -- and one of the most common causes of food-borne illness.

Turkey is not an inherently dangerous food, but the circumstances under which it is prepared makes it a prime candidate for creating a food safety problem.

Turkey is a protein food, which means that it naturally contains bacteria which will rapidly proliferate if the bird is not kept at below 40 degrees or over 140 degrees Fahrenheit.

Yet the special conditions created by holiday meal preparations often places the turkey in the temperature "danger zone" of 41 to 139 degrees. For example, in spite of explicit package directions to thaw turkey in the refrigerator or under cold water, consumers often let it sit for hours on the kitchen counter.

Tradition has it that the whole turkey should be stuffed. That makes it very dense and even more difficult to keep hot in the middle.

After the turkey has been cooked, it may sit out on the table or kitchen counter until someone gets around to cleaning up or it is time for late night turkey sandwiches.

All this adds up to an in-

creased likelihood of bacterial growth and someone getting sick.

Consumers are advised to follow a few simple guidelines to make the holiday bird safe as well as good to eat:

* If you want a fresh turkey, buy it no more than two days before cooking it. Hold the raw turkey in the refrigerator until cooking time.

* It is best to thaw a frozen turkey in the refrigerator. But a small bird can be thawed in a microwave oven. Follow the oven manual carefully and be ready to cook the bird as soon as it is thawed.

* You can also thaw a turkey in the sink. Put the turkey, still sealed in its plastic wrapping, in the sink. Cover the bird with cold water, and change the cold water every 30 minutes, until the bird is thawed.

* If you plan to buy a stuffed, cooked turkey at the deli or grocery store, order it in advance and bring it home to serve immediately.

* If you must pick up a stuffed, cooked turkey the day before, remove the stuffing and meat from the bird and refrigerate it in small containers. A cooked, stuffed turkey is too big and dense to cool down quickly enough in a home refrigerator to prevent bacterial growth. It may not look as pretty as a whole bird

when served, but it will be safe to eat.

The stomach ache, cramps and flu-like symptoms of food-borne illness are unpleasant at best and can be dangerous for young children, the elderly and the ill. That is the best reason for taking extra care in preparing a whole turkey.

After Work Fish Fillets
1 lb. lean, white fish fillets
1 1/2 T. melted margarine
1/4 C. seasoned dry bread crumbs
1 T. Parmesan cheese
1 T. chopped parsley
1/8 tsp. black pepper
1/8 tsp. paprika
Lemon wedges
Oven Method:

Cut fillets into serving-sized pieces. Coat on all sides with butter. Combine bread crumbs, Parmesan cheese, parsley and seasonings. Dip fillets in crumb mixture. Place on broiling pan. Broil for 10 minutes or until fish flakes when tested with a fork. Serve with lemon wedges. Makes 4 servings.

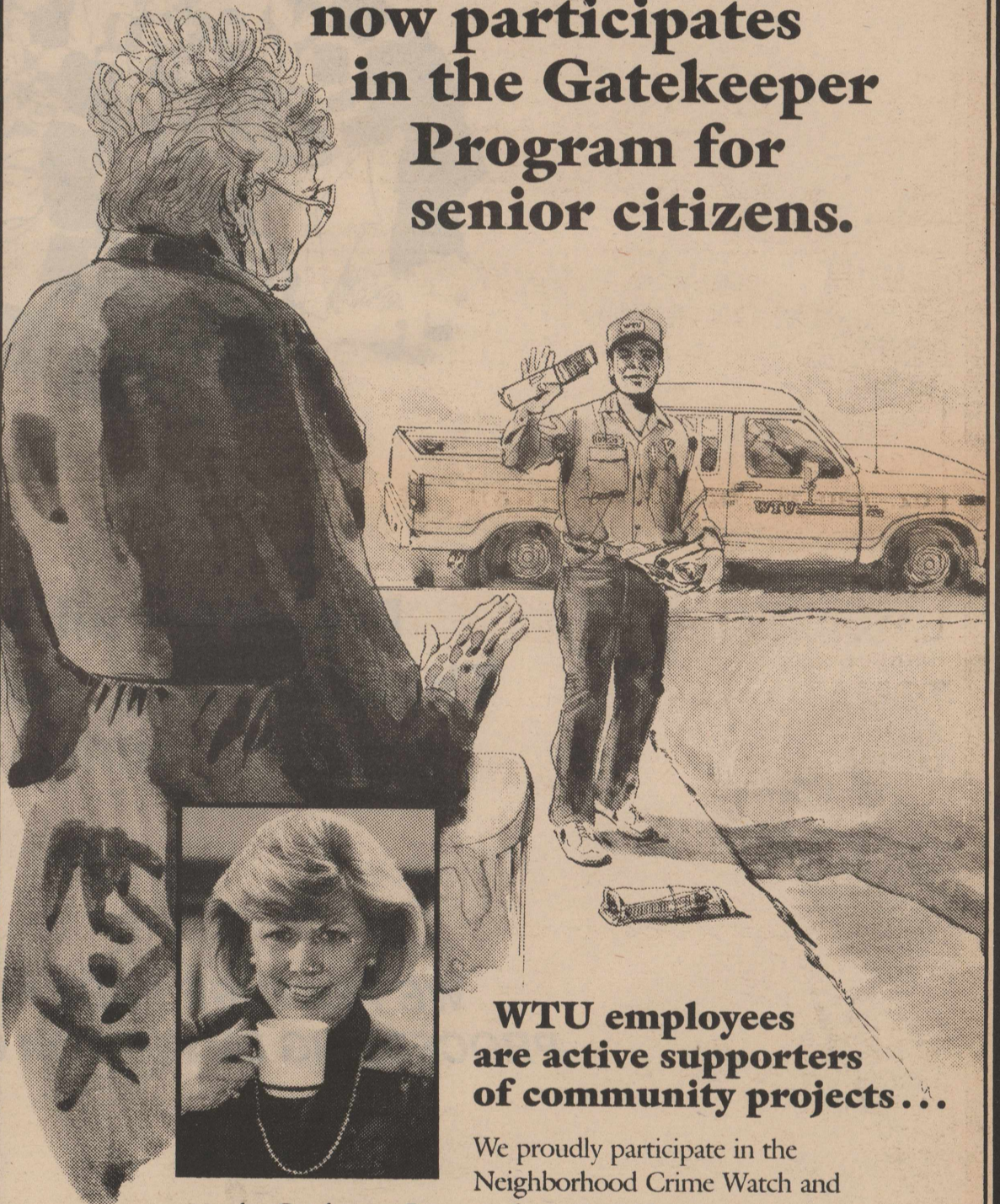

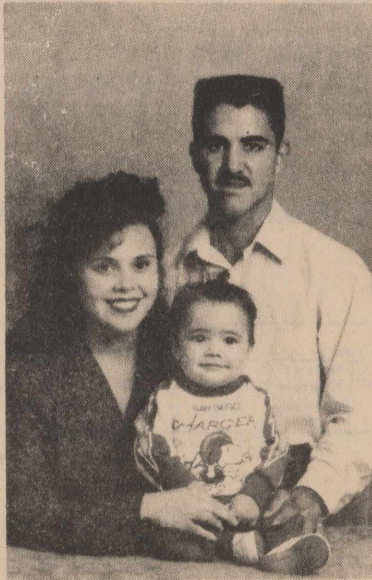
Boone had 5 steals while Burrows aided the win with 6 assists and 7 rebounds.
