Local tax entities set upcoming elections

A number of local taxing entities will hold elections on May 5 in Coke County to elect members of their various governing panels.

In the city of Robert Lee, voters will name a mayor and two council members in the election. The terms of Mayor Wilson Bryan and Aldermen Joe Barrett and A. L. Brasuell will expire. Tuesday at noon, two candidates, Joe Barrett and Keith Eubanks, had filed for the city council. At that time, no candidate had filed for the mayoral position. Remaining on the city council are C. O. Brazier, Ruth Luna, and Richard Johnson.

Robert Lee Independent School District's board of trustees has two vacancies to be filled, that of Bill Burns and Riley Waldrop. Three candidates will vie for the two positions - Bill Burns, incumbent, John T. Carver, Jr., and Darrel Pitcock. Board members whose terms do not expire are Ray Aldridge, Butch Davis, Mary Grim, Gaylon Pitcock, and Jim Clendennen.

Three vacancies exist on the West Coke County Hospital District board. Terms of Bill Helwig, Barbara Chesney and Linda Arledge expire and the three have declined to run again. Five candidates have returned petitions and will be on the ballot. Candidates include Golda Brown, Evelyn Flanagan, Ruth Robertson, Gary Jack Thomason, and John M. Sevier. Joy Bagwell and Kenneth Green remain as members of the board.

The Coke County Underground Water Conservation District will also hold an election May 5. The district will elect three directors at that time, one from Pct. 1, one from Pct.2, and a director-atlarge. Candidate filing information may be obtained from Eph Cummins, 453-2232, at

the Coke County courthouse. That deadline is in April.

School, city and hospital district filing deadlines were Wednesday, March 21.

In the City of Bronte, voters will be electing a Mayor, three Aldermen to two-year terms and one Alderman to a one-year term.

The terms of Mayor J. T. Henry, Aldermen Edward Hart, Wesley Gibbs, Harold Dunn and Gary Shaffer will expire. J. T. Henry has refiled as Mayor and Wesley Gibbs, Edward Hart and Gary Shaffer have also refiled for the two-year Alderman terms. Roenna Thomas has also placed her

Run-offs slated April 10

Texas recorded its highest primary election turnout ever in a non-presidential year on Tuesday, March 13, when 2.3 million people cast ballots in the Democratic and Republican party primaries, Secretary of State George Bayoud said.

Bayoud, the state's chief elections officer, credited county election officials, the primary candidates and their political parties, and Texas businesses, the media, and civic organizations with helping to promote voter participation.

Next step for many Texas politicians will be the runoff election on Tuesday, April 10. Coke County voters will focus on the campaigns of two Democratic runoff candidates for county judge, Royce Lee and Kenneth Green. The winner of that election will then appear on the ballot in the general election.

Democratic candidates for county offices who had victories in the primary election now advance to the November 6 general election unopposed. Those on that ballot will be county and district clerk Ettie Hubbard; treasurer Phelan Wrinkle; commissioner of Pct. 1 Paul Burns; commissioner of Pct. 2 Billy Joe Luckett; Pct. 4 commissioner James Tidwell; Peace Justice Pct. 2 Gary Shaffer, and Joan Davis for Justice of the Peace

Write-ins will be allowed voters in the November 6 general election.

Absentee voting for the runoff election will begin April 2 and end April 6. Ballots may be cast at the county and district clerk's office in the county courthouse.

Interest in the runoff election will also be high in the governor's race as Ann Richards and Jim Mattox vie for the Democratic nomination in the general election to try to stem the tide of Republican Clayton Williams in November.

NOTICE OF TARIFF CHANGE TO CENTRANET® SERVICE

GTE Southwest Incorporated gives notice of its proposed tariff changes to CentraNet® service, which is a Central Office-based service that provides PBX-type features to multi-line business customers and is currently being offered in all company wire centers where such facilities exist

to provide the service.

The Public Utility Commission of Texas approved a generic tariff for CentraNet® service up to 100 lines in Docket No. 7652. The proposed tariff revision would establish specific rates for CentraNet® service involving 101 to 400 lines. Other proposed revisions involve the rate applicable to changes, additions, or deletions to the data bases and a new rate is proposed

for additional trunks.

The names of the three CentraNet® packages have changed from Standard Premium, and Deluxe to CentraNet® 1000, CentraNet® 2000, and CentraNet® 3000, respectively. Direct Call Pickup has been added to the three CentraNet® packages while Multiple Call Park and Shared Speed Call 30 have been added to CentraNet® 2000, and Speed Call 30 and Call Forward Busy/No Answer Split have been added to Centra Net® 3000. Flexible Night Answer and Automatic Route Selection also have been added as new optional features.

The proposed changes and new

service offerings have been assigned Docket No. 9251, and pursuant to Section 43(d) of the Public Utility Regulatory Act will become effective June 23, 1990. Rates for service will be applicable to customers who subscribe to the service as well as existing customers. Therefore, there will be no effect on any other rates of the company. The company's gross annual revenues will increase by approximately \$399,600, or less than one percent annually.

The proposed rates are on file with the Public Utility Commission of Texas, and are available for public inspection at the offices of GTE Southwest Incorporated. Persons who wish to intervene or otherwise participate in these proceedings should notify the Commission. The deadline to intervene in this docket is 3:00 p.m., April 9, 1990.
