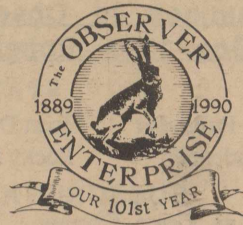

OLE COKE COUNTY-Home of the Rabbit Twisters is being rehearsed for its 14th annual performance the last two Friday and Saturday nights of July. Pre-time entertainment starts at 8:00 p.m. The flag goes up at 8:25, and the play opens at 8:30 p.m.

Prices for tickets are \$2.50 for children 5-12 years, and \$5.00 for adults. Groups of 20 or more persons receive 25% discount. Groups should call 915/453-2831.

Mountain Creek Amphitheatre, where the play is performed, is located on the north end of Austin Street, behind the second ball park. It can easily be seen by following Austin to dead end.

For those who have seen the play numerous times, the number of completely new scenes will be apparent. For new-comers, the development of Coke County will unfold in pathos and humor, fact and fancy, performed by people from all points of the county, all natives or married to natives. All are amateurs becoming professional through experience. That's the OLE COKE COUNTY way!

New sound equipment is making the scenes more exciting than they have ever been before, with expert sound and light operators.

Some literary freedom is being taken in the scene with the first train through Bronte, which involves the large crowd who attended the celebration that windy, November day in 1911. One will think the train is really passing through, judging by the

Pierce SS training told

Mickey Pierce of Bronte has just completed the initial training program for newly appointed Selective Service Systems Local Board members. Pierce was recommended for this position by governor William P. Clements and appointed in the name of the President.

Although Selective Service System boards are in an inactive status, they would be responsible for deciding claims for certain classifications such as conscientious objection, hardship, and religious ministry should a draft be reinstated in time of national emergency by the Congress and the President.

Pierce's initial training consisted of 12 hours of instruction over a 2-day period focusing on an intensive orientation to the Selective Service System, the major duties and responsibilities of Local Board members, and procedures to be followed by the Local Board.

He will receive continued training in changes in the law, regulations, responsibilities, and related agency policies and procedures.

This training ensures that the young men of Coke County who are registered with Selective Service and accept this responsibility of citizenship receive a fair and effective classification pro-

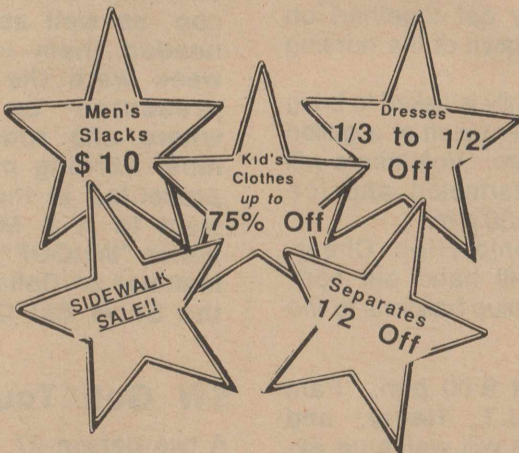

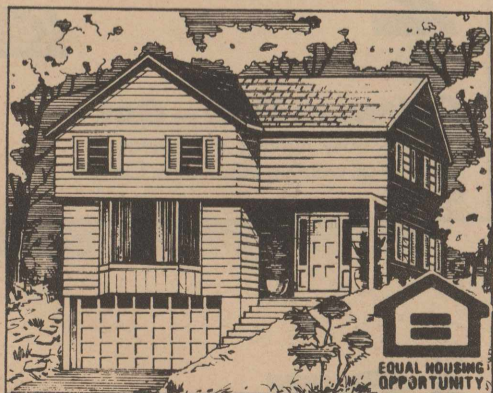
Coach Tandy will be the Head Girls Basketball Coach and assistant track coach at Lampasas.



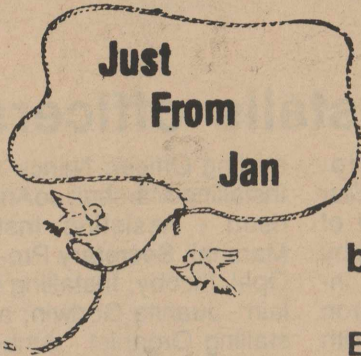

If you've taken draperies or curtains for cleaning only to have them returned with small tears or streaks, chances are sunlight or rain have taken their toll.

Sunlight, yes. But rain? It happens all the time! A window gets left open and rain blows through onto the drapery. Once it dries, brown or yellow stains from the chemical sizing used to finish the fabric may appear.

If condensation forms inside a window and comes in contact with a drape it may also cause stains and sizing streaks. In some cases, sizing streaks can be removed by dry cleaning, but not always. It depends on the age of the stain and the fabric.

To remove a water mark the drapery must be wet-cleaned, rather than dry cleaned. But wet cleaning can't be used successfully on all fabrics.

Sun is also a common culprit in drapery damage. Most textile fibers are weakened by exposure to strong sunlight. The fibers most vulnerable to sunlight damage are delustered (dulled) rayon, acetate,

nylon, cotton, silk and wool. Heavy yarns are more sun-resistant than fine yarns. Acrylic, modacrylic, polyester, nylon and glass fibers are the most sunlight resistant fibers. By selecting a fiber blend in drapery fabric, you can get both the texture and look you want along with higher sun-resistance.

Since dark colors absorb more light, they will deteriorate more rapidly. On printed fabrics, the damage will be greater in the colored areas than in the white or light areas.

The fiber damage usually occurs along the folds of the drape on the exposed side. Sometimes the damage won't be apparent until the fabric is cleaned and the weakened yarns break and fall apart in the process.

After carpeting, drapes are the next biggest investment in household textiles. So it can pay to think through your selections.

Points to consider:
* Invest in lined drapes. Most drapery liners are sun resistant and their light color helps reflect light. Generally, unlined drapes will last three years and lined drapes five.

* Look for sun-resistant fabrics or blends containing sun-resistant fabrics.

* Protect drapes with low sun-resistance by also installing blinds or other sun blockers on the window.

* Rubberized backing on drapes insulates and reflects light, but may be difficult to clean without damage to the backing.

* If you are buying a pre-owned home, ask that the draperies be cleaned and if the result is not acceptable, negotiate for a drapery allowance to replace them.

LAWN WATERING CARE

Watering is one of the basic practices in lawn maintenance and there are several factors to consider for proper lawn watering.

With the extreme hot dry conditions we are having now, it will help your lawn to survive these conditions to raise the mower height to 2" for bermuda and 3" for St. Au-

gustine. Watering needs are reduced with more efficient use of water in the soil.

Soil texture plays an important role in watering techniques. Sandy, coarse textured soils absorb water at a much faster rate than finer textured soil but retain less moisture. Sandy soils require more frequent applications of less water due to low moisture

retention. Heavier, clay type soils retain more moisture and require less frequent watering. Heavier soils should be watered at much slower rates over extended period of time.

Generally speaking, lawns in this area should be watered about once a week. This usually requires one inch of water to wet the soil to a depth of 4-6 inches. You shouldn't need to water again until the grass turns a lighter color and the leaves begin to show signs of wilting. If the top two inches of soil remains moist then watering is not required again until this area dries out.

Fertilization at this time of the year will really just require more water and more frequent mowing. The optimum time for lawn fertilization is in the fall or early spring to fulfill the fertility requirements of grass without greatly increasing water requirements.

The best time to water lawns is in the early morning before the wind and temperature rises causing increase in evaporation. Lawns should never be watered at night as this will greatly increase the chances of diseases. Also, with high soluble salt contents in the water, a deep watering with less frequency will keep the salts washed through the soil profile. Light frequent watering with salty water will cause a salt buildup on the soil surface which can damage lawns eventually.

Remember to water as infrequently as possible and water only at first signs of wilt. Apply adequate water to soak soil from 4-6 inches deep. Do not apply water to point of runoff. Avoid late afternoon or night watering and raise mower height. These tips should maintain your lawn and reduce the amount of water you have normally used.

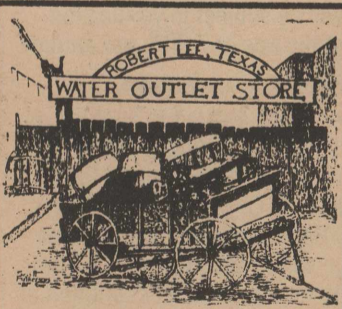

Southwestern Bell Telephone Company has instituted a Class Action Lawsuit seeking judicial approval of a settlement reached in Docket No. 7297, an inquiry of General Counsel of the Public Utility Commission of Texas into possible overcharges which occurred between September, 1976, and February, 1987, due to rounding practices on bills of intrastate WATS/800 customers sent by Southwestern Bell and other telephone companies which concur in Southwestern Bell's tariff. The suit is styled "Southwestern Bell Telephone Company, Plaintiff, vs. MCI Telecommunications Corporation, A Member of the Class of Texas Intrastate WATS and 800 Service Customers Who Paid Overtime Charges From September 1976 Through February 1987, Defendant," and identified as Cause No. 471,460 in the 126th Judicial District Court of Travis County, Texas.

Pursuant to the settlement, while not admitting liability, Southwestern Bell, the other local exchange telephone companies in Texas, and AT&T Communications of the Southwest, Inc. have agreed to pay refunds to those WATS/800 customers who paid overtime charges attributable to the rounding practices for intrastate WATS/800 services at any time between September, 1976, and February, 1987. The refunds will be based upon either the actual or estimated amount of overtime charges attributable to such rounding practices. An exact refund will be determined for customers able to produce copies of their WATS/800 service bills. For customers who do not have copies of their WATS/800 service bills to establish actual overtime charges paid, an average refund of \$4.53 to \$5.95 per WATS/800 service line per month will be applied. All claims will be subject to verification. The refunds will also include interest at the rate of 7.80% per annum.

Those customers who think they may be entitled to a refund or who desire more information must call 1-800-782-3026, 8:30 a.m.-4:30 p.m., Monday through Friday, or write to WATS Refund Pool Administrator, One Bell Plaza, Room 670, P. O. Box 650376, Dallas, Texas 75265-0376, to request a WATS Refund Information Package. The WATS Refund Information Package will contain further information regarding the lawsuit and eligibility for a refund, a description of documentation required to support a customer's claim for refund, and a refund claim form to be filled out and submitted requesting a refund. REQUESTING A WATS REFUND INFORMATION PACKAGE DOES NOT OBLIGATE YOU IN ANY WAY.

All claims for a refund must be received by the Refund Pool Administrator by Friday, October 5, 1990, and all rejections of the settlement (that is, requests for exclusion from the class action lawsuit) must be received by the Court by Wednesday, September 5, 1990. Only those who respond by filing a claim or by filing a rejection of the settlement, as explained in the WATS Refund Information Package, will receive notice of future developments in this proceeding.

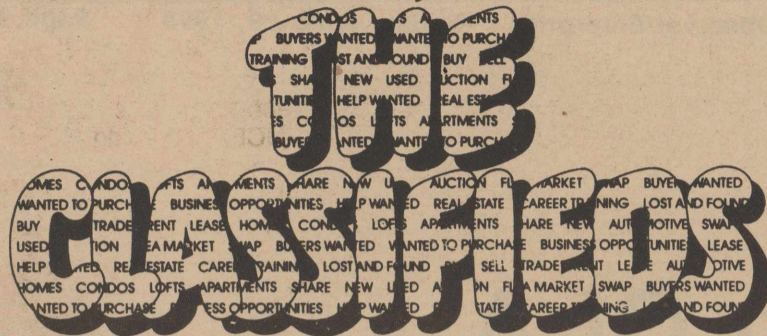

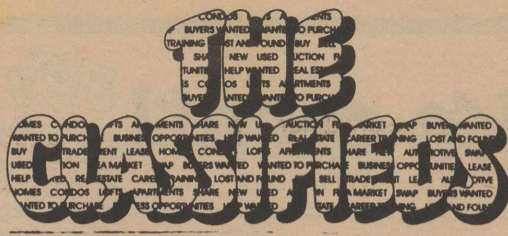

TDPS predicts holiday fatalities

The Texas Department of Public Safety has estimated that as many as 15 persons will be killed in traffic accidents during the brief July 4th period in Texas.

DPS Director Colonel Joe Milner reminded motorists that the traffic volume increases during holidays, raising the chances for fatal collisions.

"Even though July 4th falls on Wednesday this year, we believe additional patrol hours are necessary," Milner said. "All available Troopers will be on duty, closely watching for the most life-threatening violations -- DWI and speeding over-the-limit."

Milner said that the DPS 30-hour fatality counting period will start at 6 p.m. on Tuesday, July 3, and continue until midnight on July 4th.

Last year, the Independence Day driving period ran 102 hours. Thirty-four traffic fatalities were reported during the extended counting time, far below the DPS estimate of 52.

"We're hoping for the same result this July 4th," Milner added. "And we're relying on the motorists who respect Texas officers and traffic laws to help us meet the challenge."

Medic alert

Individuals who have a special medical condition that a doctor should know about in an emergency should consider wearing a Medic Alert emblem, along with a 24-hour emergency Medic Alert phone number which provides more information.

According to the American Hospital Association, one out of four Americans has a condition that may not be obvious to medical personnel in the event of severe illness or injury. This condition could affect treatment. These problems include chronic illnesses such as diabetes and asthma, visual or hearing disabilities, allergies, bleeding disorders, heart problems and dependence on special medication.

Another reminder, you cannot raise hogs in the city limits. Listen to this notice - for if you get a complaint filed against you, you will have to pay a fine.
