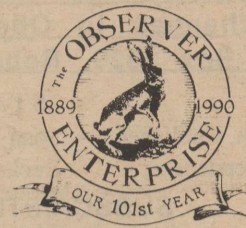

Over 1,500 attend pageant performances

The 1990 production of OLE COKE COUNTY, Home of the Rabbit Twisters, has been pronounced a great success. During the four nights of performances, around 1,500 people saw Coke County residents portray numerous incidents based on historical events which really did happen, or could have happened. Starting with Comanche Chief Sanaco's camp in 1854, on through the surveying of the first land grant in the area, arrival of early pioneers, and on through exciting eras of the past, Don Masters as Old Timer, led the responsive crowds through scenes that brought forth many laughs and a few tears.

More than 100 people were involved with the production, concession stand, souvenir booth, ticket sales, registration, etc. Coke County Pageant Association, Inc., in its effort to give the public an enjoyable evening of family entertainment, leaves nothing undone that it considers an enhancement to the comfort and pleasure of viewers. Actors from Bronte, Robert Lee, Silver, and other points in the county spent many hours in rehearsal in order to give a polished performance.

Both visitors and performers enjoyed the special sound effects created by Leonard Horwood, such as a tornado, a stampede, and the first train through Bronte. Chris Helein and Marshie Dodd provided effective lighting, adding color and emphasis.

Songs used in the "Pre-Time" choir concert were composed by Coke County citizens, most of them actors and directors in the show. Special guests who sang their own compositions were Kaylan Gardner of Robert Lee and Bryan James of Tennyson, both of whom are becoming recognized as professionals. Coke County may well be proud of them.

Wilson and Lucile Bryan, who are credited with "creating Mountain Creek Amphitheatre and the Pageant", were surprised and pleased to find that this year's production was dedicated to them "with appreciation, love, and respect for the fourteen years of the many, many hours of effort they have invested in the pageant." May the Bryans, actors, visitors, production staff, and all the other participants continue the play for many years to come!

COUNTRY AGENTS NEWS

The county extension agent is many things to many Texans. To the farmer, he's an adviser on crop production. To the rancher, he's the one who helps improve the livestock. To the homemaker, she is the person who helps stretch the family budget. To the agribusinessman, the agent is the pulse of the county's agricultural needs and potentials. To the youth in 4-H, the agent is a person willing to share dreams and experiences. To the urban dweller, the agent is a source of help on everything from lawn care to home repair.

To the world, the county extension agent is an example of educational resources meeting local needs on a personal basis.

Whatever else they may be, county agents are a gift from Texas to better life on the farm and in the home. For it was in Texas that the county agent came into being in 1906.

The local agent was the key link in the Extension teaching technique of "learning by doing" which took root in 1903 on the Walter C. Porter farm at Terrell, Texas. It was there that Dr. Seaman A. Knapp, educator and special agent of the U. S. Department of Agriculture, introduced to farmers around the world the cooperative demonstration farm. With Porter following Knapp's instruction, scientific research was applied to local field conditions by a volunteer local producer.

The success of the Porter Farm demonstration impressed farmers, educators and government officials across the land. The development of similar cooperative demonstration work was rapid. By 1904, Knapp opened an office for the "Farmers Cooperative Demonstration Work" in Houston and employed 33 agents to work directly with the farmers and farm families.

The county became the unit of work, and in 1906, the first county agent, W. C. Stallings, was employed by Smith County, Texas. His appointment was at the request of businessmen in Tyler, the county seat.

Members of the Tyler Commercial Club, recognizing the importance of Knapp's work and desiring a capable man to work exclusively in Smith County, arranged to provide \$750 toward salary and expenses of a qualified man. The club recommended and secured the appointment of Stallings, recognized in Smith County as an educated and successful farmer.

During his tenure, Stallings enlisted 500 farmers into the demonstration work. At least 350 of these continued using modern farming methods as a direct result of the efforts and teachings of the first county agent. During this time, corn yields increased from 30 to 60 bushels per acre under methods taught by Stallings. Cotton yields increased over

50%.

In 1911, the first law was passed by the Texas Legislature authorizing county commissioner's courts to appropriate money for agents' salaries. Eight years after the first county agricultural agents were appointed, the first county home demonstration agent in Texas, Mrs. Edna W. Trigg, was appointed for Milam County.

The federal Smith-Lever Act of 1914 was accepted by a joint resolution of the Texas Legislature in 1915. Thus, the Texas Agricultural Extension Service was established and Texas A&M College--now Texas A&M University--became a partner in the program with the U. S. Department of Agriculture.

Now the Texas Agricultural Extension Services, a part of the Texas A&M University System, employs a professional staff of about 950 persons, most of whom are county personnel. The Extension Service is supported by a partnership of county, state and federal governments.

Demonstrations, such as those first developed on the Porter farm and spread across the state and the world by agents such as Stallings, continue to be a major method in developing the economic and human resources on the farm and in the home and community.

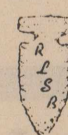

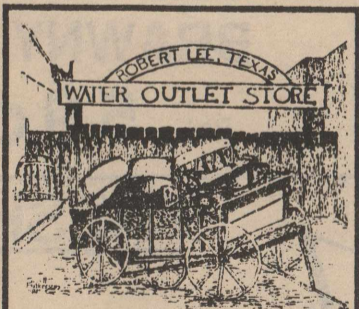

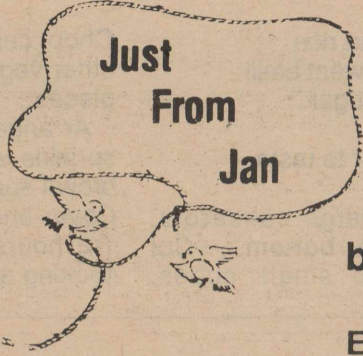

months. Several people became more sociable as their walking improved and they were able to attend meals and activities. One incontinent resident resumed independent trips to the bathroom and eventually regained continence.

For safe and enjoyable exercise with older persons:

- Exercise in pairs and groups.
- Exercise at the same time daily.
- Stop exercise if severe pain, dizziness, or other unpleasant physical symptoms occur.
- Wear comfortable clothing and good athletic shoes.
- Drink extra water before and after activity to avoid dehydration.

Before starting on an exercise program, older people need a complete physical ex-

amination from their doctor which includes:

- A complete medical history.
- Evaluation of medication levels to determine if adjustments are indicated for increased activity levels.
- Blood testing for glucose and cholesterol levels.
- An exercise tolerance or stress test to determine current level of fitness.

For maximum benefits of any physical exercise program, older people should exercise in such a way that reaches 65-75% of their maximum heart rate (number of beats per minute). This is determined by subtracting the person's age from 220. Three to five 20 to 40 minute exercise sessions a week are ideal for increasing cardiovascular fitness.

Medicare does not cover custodial care

Under the law, Medicare cannot cover custodial care of a patient or care that is not considered reasonable and necessary for the diagnosis and treatment of an illness or injury. Care is considered to be custodial when its primary purpose is to meet a patient's personal needs and when it could be provided by people who do not have professional training or skills. For example, helping a patient eat, bathe, or dress can be extremely important to the person's well-being, but these services do not require professional skill.

Even if the patient is in a participating hospital or skilled nursing facility, or is receiving care from a participating home health agency, Medicare would not cover care that is primarily custodial in nature.

Care would not be considered reasonable or necessary if the patient is admitted to a hospital or skilled nursing facility when the kind of care required could be provided elsewhere. Furthermore, care would not be considered reasonable or necessary if the patient remained in a hospital or skilled nursing facility longer than his or her medical condition required. Medicare payments would end when further inpatient care was no longer considered necessary.

The decision about whether inpatient care is reasonable or necessary is made in part by Peer Review Organizations

(PROs) in each State. Each PRO is made up of local physicians whose task is to review the care provided by their fellow physicians. Medicare hospital insurance cannot pay for any inpatient hospital care that a PRO determines is not medically necessary.

Similarly, visits by a physician to a patient that are more

frequent than is the usual medical practice in a given area would not be considered reasonable or necessary unless there were medical complications.

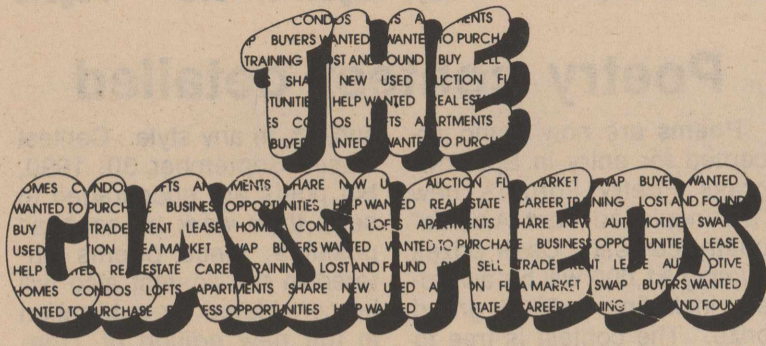

Real Lemonade for a Real Thirst

When sultry weather calls for a real thirst quencher, forgo the yellow powdered instant drink mix and go for the real thing—freshly squeezed lemonade.

Contrary to popular belief, making real lemonade isn't much more work than stirring up a batch of instant, and the taste difference can't be beat. To make one quart only requires four or five lemons.

Fresh Lemonade

Combine 3 cups water, 1 cup of freshly squeezed lemon juice (about 4 or 5 large lemons) and 3/4 cup sugar. Mix well and serve over ice. The recipe can easily be doubled or tripled to serve a crowd.

Try these variations:

- **Limeade**—Substitute lime juice for lemon juice and increase sugar to 1 cup.
- **Minted Lemonade**—Bruise fresh mint leaves in glass before adding lemonade.
- **Pink Lemonade**—Add two to three drops of red food coloring or 2 tablespoons grenadine syrup to lemonade.

The perfect mate for ice cold lemonade is the following Buttery Sugar Cookies.

Buttery Sugar Cookies

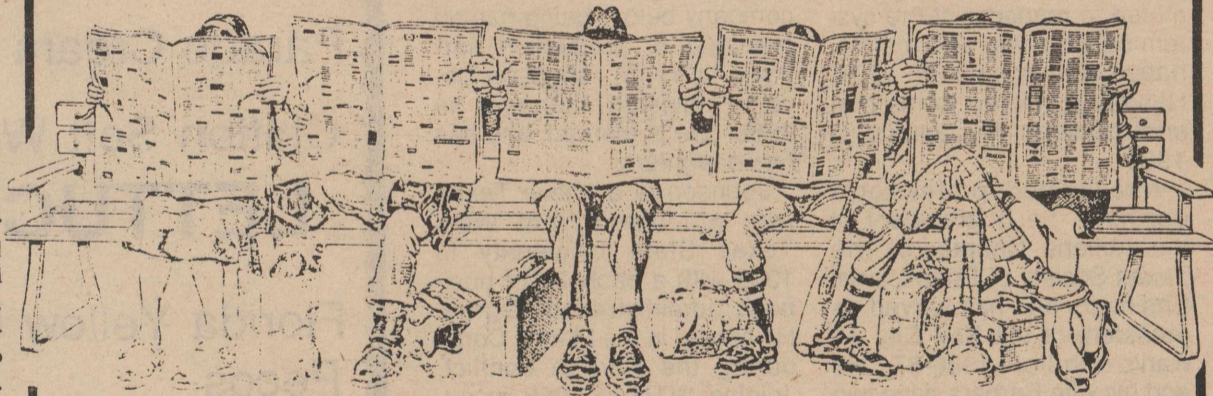
- 1 cup (2 sticks) butter or margarine, softened
- 1 cup sugar
- 2 eggs
- 1 teaspoon vanilla
- 3 cups sifted Martha White All-Purpose Flour

Cream butter and sugar together in mixing bowl until light and fluffy. Add eggs and vanilla; beat well. Stir in flour. Divide dough into two equal portions. Form each half into two rolls about 2 1/2 inches in diameter. Wrap each tightly with plastic wrap or wax paper. Refrigerate 1 to 2 hours. Preheat oven to 350°F. Slice roll into about 1/8-inch thick slices and arrange one inch apart on ungreased baking sheet. Bake 10 to 12 minutes or until light golden brown. Cool on wire racks. Decorate if desired. Makes about 64 cookies.
