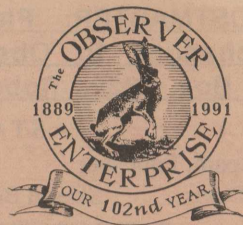

Shamrock Clinic to locate in Robert Lee

Officials of West Coke County Hospital District and Shannon Medical Center have reached an agreement to place a Shamrock Clinic in Robert Lee.

Lawrence Leonard, senior vice president at Shannon, said the clinic will be housed in the West Coke County Clinic Building across the street from the nursing home.

"We are in the process of recruiting a physician to live and work in Robert Lee,"

Leonard said. "In the meantime, we are working with Joy Bagwell and John McDermett, as well as other district officials to get equipment and supplies installed at the clinic."

Bagwell is president of the West Coke County Hospital District. McDermett is administrator of the West Coke County Hospital District/Nursing Home.

The hospital in Robert Lee closed in 1986, and the adjoining nursing home was ex-

panded into the facility. McDermett said the 86-bed nursing home's census has consistently been high. Currently there are 71 residents.

Leonard said Shannon operates four other Shamrock Clinics, two in San Angelo and one each in Sterling City and Menard. "We are pleased to have this opportunity to be associated with the community of Robert Lee," he said. "I fell there is a definite need for this type of family clinic, and we look forward to being in partnership with the people of the Robert Lee area in providing local health care services."

Although the opening date will depend on how long it takes to recruit an appropriate physician, Leonard said he expects the clinic to be functioning within the next sixty days.

SA July 4th Concert set

The City of San Angelo and the San Angelo Symphony have joined forces for the fifth year to present a free concert to kick off the celebration of Independence Day on Wednesday evening, July 3, at the River Stage. Students attend FB seminar

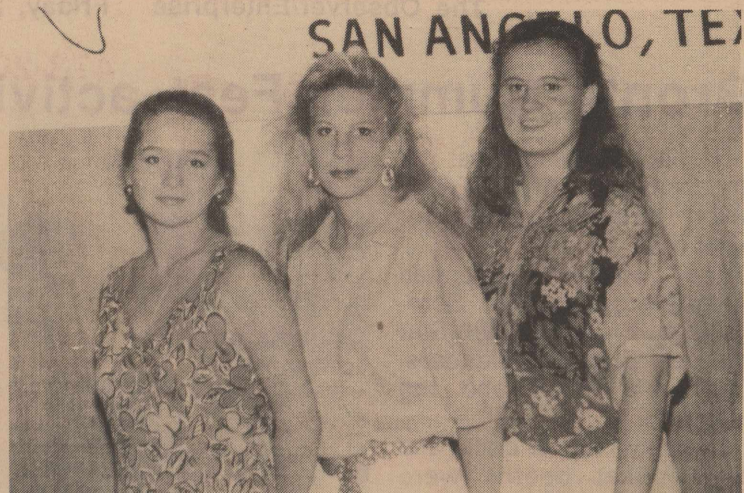
